1 AN ACT TO DIVIDE NORTH CAROLINA INTO TWELVE CONGRESSIONAL
2 DISTRICTS.

4 The General Assembly of North Carolina enacts:

5 Section 1. That part of Section 1 of Chapter 6 of the Session Laws of the 1991
6 Extra Session which rewrote G.S. 163-201(a) is repealed.

7 Section 2. G.S. 163-201(a) reads as rewritten:

8 "(a) For the purpose of nominating and electing members of the House of
9 Representatives of the Congress of the United States in ~~1982-1998~~ and every two years
