A BILL TO BE ENTITLED

AN ACT TO ALLOW THE ESTABLISHMENT OF PROGRAMS TO TRAIN LICENSED REGISTERED NURSES TO CONDUCT MEDICAL EXAMINATIONS OF VICTIMS OF SEXUAL OFFENSES, TO CONDUCT MEDICAL PROCEDURES TO COLLECT EVIDENCE FROM THE VICTIMS, AND TO ALLOW DIRECT PAYMENT TO NURSES WHO PROVIDE THIS SERVICE.

The General Assembly of North Carolina enacts:

Section 1. G.S. 90-171.38 reads as rewritten:

"§ 90-171.38. Standards for nursing programs.

(a) A nursing program may be operated under the authority of a general hospital, or an approved post-secondary educational institution. The Board shall establish, revise, or repeal standards for nursing programs. These standards shall specify program requirements, curricula, faculty, students, facilities, resources, administration, and describe the approval process. Any institution desiring to establish a nursing program shall apply to the Board and submit satisfactory evidence that it will meet the standards prescribed by the Board. Those standards shall be designed to ensure that graduates of

1 those programs have the education necessary to safely and competently practice nursing.
2 The Board shall encourage the continued operation of all present programs that meet the
3 standards approved by the Board.

4 (b) Any individual, organization, association, corporation, or institution may
5 establish a program for the purpose of training or educating any registered nurse licensed
6 under G.S. 90-171.30, 90-171.32, or 90-171.33 in the skills, procedures, and techniques
7 necessary to conduct medical examinations for the purpose of collecting evidence from
8 the victims of first-degree rape as defined in G.S. 14-27.2, second-degree rape as defined
9 in G.S. 14-27.3, statutory rape as defined in G.S. 14-27.7A, first-degree sexual offense as
10 defined in G.S. 14-27.4, second-degree sexual offense as defined in G.S. 14-27.5 or
11 attempted first-degree or second-degree rape or attempted first-degree or second-degree
12 sexual offense as defined in G.S. 14-27.6. The Board, pursuant to G.S. 90-171.23(b)(14)
13 and, in cooperation with the North Carolina Medical Board as described in G.S. 90-6,
14 shall establish, revise, or repeal standards for any such program. Any individual,
15 organization, association, corporation, or institution which desires to establish a program
16 under this subsection shall apply to the Board and submit satisfactory evidence that it will
17 meet the standards prescribed by the Board."

18 Section 2. G.S. 90-171.44 reads as rewritten:

19 "**§ 90-171.44. Prohibited acts.**

20 It shall be a violation of this Article, and subject to action under G.S. 90-171.37, for
21 any person to:

- 22 (1) Sell, fraudulently obtain, or fraudulently furnish any nursing diploma or
23 aid or abet ~~therein;~~ therein.
- 24 (2) Practice nursing under cover of any fraudulently obtained ~~license;~~
25 license.
- 26 (3) Practice nursing without a ~~license;~~ license. This subdivision shall not be
27 construed to prohibit any licensed registered nurse who has successfully
28 completed a program established under G.S. 90-171.38(b) from
29 conducting medical examinations or performing procedures to collect
30 evidence from the victims of offenses described in that subsection.
- 31 (4) Conduct a nursing program or a refresher course for activation of a
32 license, that is not approved by the ~~Board;~~ or Board.
- 33 (5) Employ unlicensed persons to practice nursing."

34 Section 3. G.S. 58-50-25 reads as rewritten:

35 "**§ 58-50-25. Nurses' services.**

36 (a) No agency, institution or physician providing a service for which payment or
37 reimbursement is required to be made under a policy governed by Articles 1 through 64
38 of this Chapter shall be denied such payment or reimbursement on account of the fact that
39 such services were rendered through a registered nurse acting under authority of rules and
40 regulations adopted by the North Carolina Medical Board and the Board of Nursing
41 pursuant to G.S. 90-6 and 90-171.23.

42 (b) Nothing herein shall be construed to authorize contracting with or making
43 payments directly to any nurse not otherwise permitted. A licensed registered nurse who

1 has successfully completed a program established under G.S. 90-171.38(b) may receive
2 direct payment for conducting medical examinations or medical procedures for the
3 purpose of collecting evidence from victims of offenses described in that subsection if the
4 payment would have otherwise been permitted."

5 Section 4. G.S. 143B-480.2 reads as rewritten:

6 **"§ 143B-480.2. Victim assistance.**

7 (a) Only victims who have reported the following crimes are eligible for assistance
8 under this Program: first-degree rape as defined in G.S. 14-27.2, second-degree rape as
9 defined in G.S. 14-27.3, first-degree sexual offense as defined in G.S. 14-27.4, second-
10 degree sexual offense as defined in G.S. 14-27.5, or attempted first-degree or second-
11 degree rape or attempted first-degree or second-degree sexual offense as defined in G.S.
12 14-27.6. Assistance is limited to immediate and short-term medical expenses, ambulance
13 services, and mental health services provided by a professional licensed or certified by
14 the State to provide such services, not to exceed five hundred dollars (\$500.00) incurred
15 by the victim for the medical examination, medical procedures to collect evidence, or
16 counseling treatment which follow the attack, or ambulance services from the place of the
17 attack to a place where medical treatment is provided.

18 (b) With the exception of assistance authorized under subsection (e) of this
19 section, Assistance—assistance for expenses authorized under this section is to be paid
20 directly to any hospital, ambulance service, attending physicians, or mental health
21 professionals providing counseling, upon the filing of proper forms.

22 (c) Assistance shall not be awarded unless the rape, attempted rape, sexual
23 offense, or attempted sexual offense was reported to a law-enforcement officer within 72
24 hours after its occurrence or the Secretary finds there was good cause for the failure to
25 report within that time.

26 (d) Upon an adverse determination by the Secretary on a claim for medical
27 expenses, a victim is entitled to judicial review of that decision. The person seeking
28 review shall file a petition in the Superior Court of Wake County.

29 (e) In lieu of any payment which may otherwise have been made under subsection
30 (b), assistance for expenses for services authorized under this section that are provided
31 for the purpose of collecting evidence from victims of crimes identified in G.S. 90-
32 171.38(b) may be paid directly to any licensed registered nurse who has successfully
33 completed a program approved under G.S. 90-171.38(b). The Secretary shall adopt rules
34 to facilitate the payments authorized under this subsection and to encourage, whenever
35 practical, the use of licensed registered nurses trained under G.S. 90-171.38(b) to conduct
36 medical examinations and procedures."

37 Section 5. This act is effective when it becomes law.
