1 A BILL TO BE ENTITLED  
2 AN ACT TO AUTHORIZE THE DIRECTOR OF THE BUDGET TO CONTINUE  
3 EXPENDITURES FOR THE OPERATION OF GOVERNMENT AT THE LEVEL  
4 IN EFFECT ON JUNE 30, 1997, AND TO EXTEND EXPIRING PROVISIONS OF  
5 LAW.

6 The General Assembly of North Carolina enacts:

7  
8 **FUNDS SHALL NOT REVERT**

9 Section 1. Section 5 of S.L. 1997-256, as rewritten by Section 1 of S.L. 1997-  
10 347 and Section 1 of S.L. 1997-401, reads as rewritten:

11 "Section 5. If the provisions of Senate Bill 352, 3rd edition, Senate Bill 352, 5th  
12 edition, or both, direct that funds shall not revert, the funds shall not revert on June 30,  
13 1997. Unless these funds are encumbered on or before June 30, 1997, these funds shall  
14 not be expended after June 30, 1997, except as provided by a statute that becomes  
15 effective after June 30, 1997. If no such statute is enacted prior to ~~August 22, 1997,~~  
16 August 29, 1997, these funds shall revert to the appropriate fund on that date."

18 **EXTEND SENTENCING COMMISSION**

1 Section 2. Section 8 of Chapter 1076 of the 1989 Session Laws, as amended  
2 by Chapters 812 and 816 of the 1991 Session Laws, Chapters 253, 321, and 591 of the  
3 1993 Session Laws, Chapter 236 of the 1995 Session Laws, Section 6 of S.L. 1997-256,  
4 Section 2 of S.L. 1997-347, and Section 2 of S.L. 1997-401, reads as rewritten:

5 "Sec. 6. This act is effective upon ratification, and shall expire ~~August 22, 1997.~~  
6 August 29, 1997."

#### 7 8 **AUTHORIZATION OF FICTITIOUS LICENSES AND REGISTRATION** 9 **PLATES ON PUBLICLY OWNED MOTOR VEHICLES**

10 Section 3. Section 23(c) of Chapter 18 of the Session Laws of the 1996  
11 Second Extra Session, as rewritten by Section 8 of S.L. 1997-256, Section 4 of S.L.  
12 1997-347, and Section 4 of S.L. 1997-401, reads as rewritten:

13 "(c) Subsection (a) of this section expires ~~August 22, 1997.~~ August 29, 1997."

#### 14 15 **LOWER NEUSE RIVER BASIN ASSOCIATION FUNDS**

16 Section 4. Section 27.8(a) of Chapter 18 of the Session Laws of the 1996  
17 Second Extra Session, as rewritten by Section 9 of S.L. 1997-256, Section 5 of S.L.  
18 1997-347, and Section 5 of S.L. 1997-401, reads as rewritten:

19 "(a) Of the funds appropriated by this act to the Lower Neuse River Basin  
20 Association for the 1996-97 fiscal year, the sum of two million dollars (\$2,000,000) shall  
21 be allocated as grants to local government units in the Neuse River Basin to assist those  
22 local government units in fulfilling their obligations under the Neuse River Nutrient  
23 Sensitive Waters Management Strategy plan adopted by the Environmental Management  
24 Commission. The funds are contingent upon the adoption of the plan by the  
25 Environmental Management Commission. If the Environmental Management  
26 Commission fails to adopt the plan by ~~August 22, 1997.~~ August 29, 1997. then the funds  
27 shall revert to the General Fund."

#### 28 29 **BEAVER DAMAGE CONTROL FUNDS**

30 Section 5. Subsection (h) of Section 69 of Chapter 1044 of the 1991 Session  
31 Laws, as amended by Section 111 of Chapter 561 of the 1993 Session Laws, Section 27.3  
32 of Chapter 769 of the 1993 Session Laws, Section 26.6 of Chapter 507 of the 1995  
33 Session Laws, Section 27.15(c) of Chapter 18 of the Session Laws of the 1996 Second  
34 Extra Session, Section 10 of S.L. 1997-256, Section 6 of S.L. 1997-347, and Section 6 of  
35 S.L. 1997-401, reads as rewritten:

36 "(h) Subsections (a) through (d) of this section expire ~~August 22, 1997.~~ August 29,  
37 1997."

#### 38 39 **SUSPEND PER DIEM**

40 Section 5.1. Notwithstanding G.S. 120-3.1, no member shall be entitled to  
41 subsistence and travel allowance on account of the Regular Session of the 1997 General  
42 Assembly on any date in calendar year 1997 after August 23, 1997. This section does not  
43 expire, notwithstanding Section 7 of this act. This section does not apply to meetings of

1 legislative commissions, study committees and commissions and travel authorized as  
2 provided by law. This section does not apply to the Reading Clerks and the Sergeants-at-  
3 Arms.

5 **CHANGES IN THE EXECUTION OF THE BUDGET**

6 Section 6. Section 11 of S.L. 1997-256, as rewritten by Section 7 of S.L.  
7 1997-347 and Section 7 of S.L. 1997-401, reads as rewritten:

8 "Section 11. The amendments to G.S. 143-27 that were enacted in Section 7.4(h)(2)  
9 of Chapter 18 of the Session Laws of the 1996 Second Extra Session shall become  
10 effective ~~August 22, 1997.~~ August 29, 1997."

12 **EFFECTIVE DATE**

13 Section 7. (a) Section 13 of S.L. 1997-256, as rewritten by Section 9 of S.L.  
14 1997-347 and Section 10 of S.L. 1997-401, reads as rewritten:

15 "Section 13. This act becomes effective July 1, 1997, except that Sections 5 through  
16 10 of this act become effective June 30, 1997. This act expires ~~August 22, 1997.~~ August  
17 29, 1997."

18 (b) Except as otherwise provided, this act becomes effective August 22, 1997.
