1 A BILL TO BE ENTITLED
2 AN ACT TO LICENSE ATHLETIC TRAINERS.

3 The General Assembly of North Carolina enacts:

4 Section 1. Chapter 90 of the General Statutes is amended by adding a new
5 Article to read:

6 **"ARTICLE 33.**
7 **"ATHLETIC TRAINERS.**

8 **"§ 90-512. Title; purpose.**

9 (a) This Article may be cited as the 'Athletic Trainers Licensing Act'.

10 (b) The practice of athletic trainer services affects the public health, safety, and
11 welfare. Licensure of the practice of athletic trainer services is necessary to ensure
12 minimum standards of competency and to provide the public with safe athletic trainer
13 services. It is the purpose of this Article to provide for the regulation of persons offering
14 athletic trainer services.

15 **"§ 90-513. Definitions.**

16 The following definitions apply in this Article:

17 (1) Athletic trainer. – A person who, under a written protocol with a
18 physician licensed under Article 1 of Chapter 90 of the General Statutes

1 and filed with the North Carolina Medical Board, carries out the
2 practice of care, prevention, and rehabilitation of injuries incurred by
3 athletes, and who, in carrying out these functions, may use physical
4 modalities, including heat, light, sound, cold, electricity, or mechanical
5 devices related to rehabilitation and treatment.

6 (2) Board. – The North Carolina Board of Athletic Trainer Examiners as
7 created by G.S. 90-514.

8 (3) License. – A certificate that evidences approval by the Board that a
9 person has successfully completed the requirements set forth in G.S. 90-
10 518 entitling the person to perform the functions and duties of an
11 athletic trainer.

12 **"§ 90-514. Board of Examiners created.**

13 (a) The North Carolina Board of Athletic Trainer Examiners is created.

14 (b) Composition and Terms. – The Board shall consist of seven members who
15 shall serve staggered terms. Four members shall be athletic trainers certified by the
16 National Athletic Trainers' Association Board of Certification, Inc. One member shall
17 be a licensed orthopedic surgeon, one member shall be a licensed family practice
18 physician or pediatrician, and one member shall represent the public at large.

19 The initial Board members shall be selected on or before August 1, 1997, as follows:

20 (1) The General Assembly, upon the recommendation of the President Pro
21 Tempore of the Senate, shall appoint two certified athletic trainers and
22 an orthopedic surgeon. The certified athletic trainers shall serve for
23 terms of three years, and the orthopedic surgeon shall serve for a term of
24 one year.

25 (2) The General Assembly, upon the recommendation of the Speaker of the
26 House of Representatives, shall appoint two certified athletic trainers
27 and a family practice physician or pediatrician. The certified athletic
28 trainers and the family practice physician or pediatrician shall serve for
29 terms of two years.

30 (3) The Governor shall appoint for a three-year term a public member to the
31 Board.

32 Upon the expiration of the terms of the initial Board members, each member shall be
33 appointed for a term of three years and shall serve until a successor is appointed. No
34 member may serve more than two consecutive full terms.

35 (c) Qualifications. – The athletic trainer members shall hold current licenses and
36 shall reside or be employed in North Carolina. They shall have at least five years'
37 experience as athletic trainers, including the three years immediately preceding
38 appointment to the Board, and shall remain in active practice and in good standing with
39 the Board as a licensee during their terms. The first athletic trainers appointed to the
40 Board pursuant to this section shall be eligible for licensure under G.S. 90-519 and, upon
41 appointment, shall immediately apply for a license.

42 (d) Vacancies. – A vacancy shall be filled in the same manner as the original
43 appointment, except that all unexpired terms of Board members appointed by the General

1 Assembly shall be filled in accordance with G.S. 120-122 and shall be filled within 45
2 days after the vacancy occurs. Appointees to fill vacancies shall serve the remainder of
3 the unexpired term and until their successors have been duly appointed and qualified.

4 (e) Removal. – The Board may remove any of its members for neglect of duty,
5 incompetence, or unprofessional conduct. A member subject to disciplinary proceedings
6 as a licensee shall be disqualified from participating in the official business of the Board
7 until the charges have been resolved.

8 (f) Compensation. – Each member of the Board shall receive per diem and
9 reimbursement for travel and subsistence as provided in G.S. 93B-5.

10 (g) Officers. – The officers of the Board shall be a chair, who shall be a licensed
11 athletic trainer, a vice-chair, and other officers deemed necessary by the Board to carry
12 out the purposes of this Article. All officers shall be elected annually by the Board for
13 one-year terms and shall serve until their successors are elected and qualified.

14 (h) Meetings. – The Board shall hold at least two meetings each year to conduct
15 business and to review the standards and rules for improving athletic training services.
16 The Board shall establish the procedures for calling, holding, and conducting regular and
17 special meetings. A majority of Board members constitutes a quorum.

18 **"§ 90-515. Powers of the Board.**

19 The Board shall have the power and duty to:

- 20 (1) Administer this Article.
- 21 (2) Issue interpretations of this Article.
- 22 (3) Adopt, amend, or repeal rules as may be necessary to carry out the
23 provisions of this Article.
- 24 (4) Employ and fix the compensation of personnel that the Board
25 determines is necessary to carry into effect the provisions of this Article
26 and incur other expenses necessary to effectuate this Article.
- 27 (5) Examine and determine the qualifications and fitness of applicants for
28 licensure, renewal of licensure, and reciprocal licensure.
- 29 (6) Issue, renew, deny, suspend, or revoke licenses and carry out any
30 disciplinary actions authorized by this Article.
- 31 (7) In accordance with G.S. 90-524, set fees for licensure, license renewal,
32 and other services deemed necessary to carry out the purposes of this
33 Article.
- 34 (8) Conduct investigations for the purpose of determining whether
35 violations of this Article or grounds for disciplining licensees exist.
- 36 (9) Maintain a record of all proceedings and make available to licensees and
37 other concerned parties an annual report of all Board action.
- 38 (10) Develop standards and adopt rules for the improvement of athletic
39 training services in the State.
- 40 (11) Adopt a seal containing the name of the Board for use on all licenses
41 and official reports issued by it.

42 **"§ 90-516. Custody and use of funds; contributions.**

1 (a) All fees payable to the Board shall be deposited in the name of the Board in
2 financial institutions designated by the Board as official depositories and shall be used to
3 pay all expenses incurred in carrying out the purposes of this Article.

4 (b) The Board may accept grants, contributions, bequests, and gifts that shall be
5 kept in a separate fund and shall be used by it to enhance the practice of athletic trainers.

6 **"§ 90-517. License required; exemptions from license requirement.**

7 (a) On or after January 1, 1998, no person shall practice or offer to practice as an
8 athletic trainer, perform activities of an athletic trainer, or use any card, title, or
9 abbreviation to indicate that the person is an athletic trainer unless that person is currently
10 licensed as provided by this Article.

11 (b) The prohibition against performing the activities of an athletic trainer does not
12 apply to any of the following persons as long as they do not hold themselves out to the
13 public as athletic trainers:

14 (1) A licensed, registered, or certified professional, such as a nurse, a
15 physical therapist, and a chiropractor.

16 (2) A physician licensed under Article 1 of Chapter 90 of the General
17 Statutes.

18 (3) A person serving as a student-trainer or in a similar position under the
19 supervision of a physician or licensed athletic trainer.

20 (c) The prohibitions in subsection (a) of this section do not apply to an athletic
21 trainer who is employed by, or under contract with, an organization, a corporation, or an
22 educational institution located in another state and who is representing that organization,
23 corporation, or educational institution at an event held in this State.

24 **"§ 90-518. Application for license; qualifications; issuance.**

25 (a) An applicant for a license under this Article shall make a written application to
26 the Board on a form approved by the Board and shall submit to the Board an application
27 fee along with evidence that demonstrates good moral character and graduation from an
28 accredited four-year college or university in a course of study approved by the Board.

29 (b) The applicant shall also pass the examination administered by the National
30 Athletic Trainers' Association Board of Certification, Inc.

31 (c) When the Board determines that an applicant has met all the qualifications for
32 licensure and has submitted the required fee, the Board shall issue a license to the
33 applicant. A license is valid for a period of one year from the date of issuance and may
34 be renewed subject to the requirements of this Article.

35 **"§ 90-519. Athletic trainers previously certified.**

36 The Board shall issue a license to practice as an athletic trainer to a person who
37 applies to the Board on or before August 1, 1998, and furnishes to the Board on a form
38 approved by the Board proof of good moral character, graduation from an accredited
39 four-year college or university in a course of study approved by the Board, and a current
40 certificate from the National Athletic Trainers' Association Board of Certification, Inc.

41 **"§ 90-520. Athletic trainers not certified.**

42 (a) A person who has been actively engaged as an athletic trainer since August 1,
43 1994, and who continues to practice up to the time of application, shall be eligible for

1 licensure without examination by paying the required fee and by demonstrating the
2 following:

- 3 (1) Proof of good moral character.
- 4 (2) Proof of practice in this State since August 1, 1994.
- 5 (3) Proof of graduation from an accredited four-year college or university in
6 a course of study approved by the Board.
- 7 (4) Fulfillment of any other requirements set by the Board.

8 An application made pursuant to this section shall be filed with the Board on or before
9 August 1, 1998.

10 (b) A person is 'actively engaged' as an athletic trainer if the person is a salaried
11 employee of, or has contracted with, an educational institution, an industry, a hospital, a
12 rehabilitation clinic, or a professional athletic organization or another bona fide athletic
13 organization and the person performs the duties of an athletic trainer.

14 **"§ 90-521. Reciprocity with other states.**

15 A license may be issued to a qualified applicant holding an athletic trainer license in
16 another state if that state recognizes the license of this State in the same manner.

17 **"§ 90-522. License renewal.**

18 Every license issued under this Article shall be renewed during the month of January.
19 On or before the date the current license expires, any person who desires to continue
20 practice shall apply for a license renewal and shall submit the required fee. Licenses that
21 are not renewed shall automatically lapse. In accordance with rules adopted by the Board,
22 a license that has lapsed may be reissued within five years from the date it lapsed. A
23 license that has been expired for more than five years may be reissued only in a manner
24 prescribed by the Board.

25 **"§ 90-523. Continuing education.**

26 (a) As a condition of license renewal, a licensee must meet the continuing
27 education requirements set by the Board. The Board shall determine the number of hours
28 and subject matter of continuing education required as a condition of license renewal.
29 The Board shall determine the qualifications of a provider of an educational program that
30 satisfies the continuing education requirement.

31 (b) The Board shall grant approval to a continuing education program or course
32 upon finding that the program or course offers an educational experience designed to
33 enhance the practice of athletic trainer, including the continuing education program of the
34 National Athletic Trainers' Association.

35 (c) If a continuing education program offers to teach licensees to perform
36 advanced skills, the Board may grant approval for the program when it finds that the
37 nature of the procedure taught in the program and the program facilities and faculty are
38 such that a licensee fully completing the program can reasonably be expected to carry out
39 those procedures safely and properly.

40 **"§ 90-524. Expenses and fees.**

41 (a) All salaries, compensation, and expenses incurred or allowed to carry out the
42 purposes of this Article shall be paid by the Board exclusively out of the fees received by
43 the Board as authorized by this Article or funds received from other sources. In no case

1 shall any salary, expense, or other obligation of the Board be charged against the State
2 treasury.

3 (b) The schedule of fees shall not exceed the following:

4 (1) Issuance of a license \$100.00

5 (2) License renewal 50.00

6 (3) Reinstatement of lapsed license 75.00

7 (4) Reasonable charges for duplication services and material.

8 **"§ 90-525. Hiring of athletic trainers by school units.**

9 Local school administrative units may hire persons who are not licensed under this
10 Article. The persons hired may perform the activities of athletic trainers in the scope of
11 their employment but may not claim to be licensed under this Article. The persons hired
12 may not perform the activities of athletic trainers outside the scope of this employment
13 unless they are authorized to do so under G.S. 90-517(b).

14 **"§ 90-526. Disciplinary authority of the Board; administrative proceedings.**

15 (a) Grounds for disciplinary action against a licensee shall include the following:

16 (1) Giving false information or withholding material information from the
17 Board in procuring a license to practice as an athletic trainer.

18 (2) Having been convicted of or pled guilty or no contest to a crime that
19 indicates that the person is unfit or incompetent to practice as an athletic
20 trainer or that indicates that the person has deceived or defrauded the
21 public.

22 (3) Having a mental or physical disability or using a drug to a degree that
23 interferes with the person's fitness to practice as an athletic trainer.

24 (4) Engaging in conduct that endangers the public health.

25 (5) Being unfit or incompetent to practice as an athletic trainer by reason of
26 deliberate or negligent acts or omissions regardless of whether actual
27 injury to a patient is established.

28 (6) Willfully violating any provision of this Article or rules adopted by the
29 Board.

30 (7) Having been convicted of or pled guilty or no contest to an offense
31 under State or federal narcotic or controlled substance laws.

32 (b) In accordance with Article 3A of Chapter 150B of the General Statutes, the
33 Board may require remedial education, issue a letter of reprimand, restrict, revoke, or
34 suspend any license to practice as an athletic trainer in North Carolina or deny any
35 application for licensure if the Board determines that the applicant or licensee has
36 committed any of the above acts or is no longer qualified to practice as an athletic trainer.
37 The Board may reinstate a revoked license or remove licensure restrictions when it finds
38 that the reasons for revocation or restriction no longer exist and that the person can
39 reasonably be expected to practice as an athletic trainer safely and properly.

40 **"§ 90-527. Enjoining illegal practices.**

41 If the Board finds that a person who does not have a license issued under this Article
42 claims to be an athletic trainer or is engaging in practice as an athletic trainer in violation
43 of this Article, the Board may apply in its own name to the Superior Court of Wake

1 County for a temporary restraining order or other injunctive relief to prevent the person
2 from continuing illegal practices. The court may grant injunctions regardless of whether
3 criminal prosecution or other action has been or may be instituted as a result of a
4 violation.

5 **"§ 90-528. Penalties.**

6 A person who does not have a license issued under this Article who either claims to
7 be an athletic trainer or engages in practice as an athletic trainer in violation of this
8 Article is guilty of a Class 1 misdemeanor. Each act of unlawful practice constitutes a
9 distinct and separate offense.

10 **"§ 90-529. Reports; immunity from suit.**

11 A person who has reasonable cause to suspect misconduct or incapacity of a licensee,
12 or who has reasonable cause to suspect that a person is in violation of this Article, shall
13 report the relevant facts to the Board. Upon receipt of a charge, or upon its own
14 initiative, the Board may give notice of an administrative hearing or may, after diligent
15 investigation, dismiss unfounded charges. A person who, in good faith, makes a report
16 pursuant to this section shall be immune from any criminal prosecution or civil liability
17 resulting therefrom.

18 **"§ 90-530. No third-party reimbursement required.**

19 Nothing in this Article shall be construed to require direct third-party reimbursement
20 to persons licensed under this Article."

21 Section 2. This act is effective when it becomes law.
