39 **SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

41 "(b) Distribution of Fees. – The Special Registration Plate Account and the
42 Collegiate and Cultural Attraction Plate Account are established within the Highway
43 Fund. The Division must credit the additional fee imposed for the special registration
44 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the

1 Collegiate and Cultural Attraction Plate Account (CCAPA), and the Natural Heritage
2 Trust Fund (NHTF), which is established under G.S. 113-77.7, as follows:

35 **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:
36 "(b23) Racing Theme. – Before the Division develops or distributes a racing theme
37 plate in this series, it may choose to require 100 prepaid applications for any NASCAR
38 or NASCAR driver's or team's respective plate, or a deposit from any person seeking
39 issuance of a plate of one thousand dollars (\$1,000) per plate. If a deposit is made
40 pursuant to this subsection, the Division shall refund the deposit once an equivalent
41 amount of license plate fees is collected for the plate for which the deposit is made. If an
42 equivalent amount is not collected within four years of the issuance of the first plate, the
43 Division may retain the deposit. The Division may develop any plate in this series
44 without a minimum number of applications or deposit if the person providing the State

1 with the license to use the words, logos, trademarks, or designs associated with the plate
2 produces the plate for the State without a minimum order quantity. The cost of the
3 racing theme special registration plate shall include the costs to produce blank plates for
4 issuance by the Division, as provided in any agreement with the Division authorized by
5 G.S. 20-79.4(b)(35a)."

6 **SECTION 5.** This act is effective when it becomes law.
