19 thereof, be fully secured by surety bonds, or be fully collateralized;  
20 provided further that the rate of return or investment yield may not be  
21 less than that available in the market on United States government or  
22 agency obligations of comparable ~~maturity~~; maturity.

24 (7) Prime quality commercial paper bearing the highest rating of at least  
25 one nationally recognized rating service and not bearing a rating below  
26 the highest by any nationally recognized rating service which rates the

28 (8) Bills of exchange or time drafts drawn on and accepted by a  
29 commercial bank and eligible for use as collateral by member banks in  
30 borrowing from a federal reserve bank, provided that the accepting  
31 bank or its holding company is either (i) incorporated in the State of  
32 North Carolina or (ii) has outstanding publicly held obligations bearing  
33 the highest rating of at least one nationally recognized rating service  
34 and not bearing a rating below the highest by any nationally  
35 recognized rating service which rates the particular obligations.

36 (9) Asset-backed securities (whether considered debt or equity) provided  
37 they bear the highest rating of at least one nationally recognized rating  
38 service and do not bear a rating below the highest rating by any  
39 nationally recognized rating service which rates the particular  
40 securities.

41 (10) Corporate bonds and notes provided they bear the highest rating of at  
42 least one nationally recognized rating service and do not bear a rating

1 below the highest by any nationally recognized rating service which  
2 rates the particular obligation.

3 (d) Unless otherwise provided by law, the interest or income received and  
4 accruing from all deposits or investments of such cash balances shall be paid into the  
5 State's General Fund, except that all interest or income received and accruing on the  
6 monthly balance of the Highway Fund and Highway Trust Fund shall be paid into the  
7 State Highway Fund and Highway Trust Fund. The cash balances of the several funds  
8 may be combined for deposit or investment purposes; and when such combined deposits  
9 or investments are made, the interest or income received and accruing from all deposits  
10 or investments shall be prorated among the funds in conformity with applicable law and  
11 the rules and regulations adopted by the Governor and Council of State.

12 (e) The State Treasurer shall cause to be prepared quarterly statements on or  
13 before the tenth day of ~~January, April, July and October~~ February, May, August, and  
14 November in each year, which shall show the amount of cash on hand, the amount of  
15 money on deposit, the name of each depository, and all investments for which he is in  
16 any way responsible. Each quarterly statement shall be delivered to the ~~Governor and~~  
17 Council of State; Governor, Council of State, President Pro Tempore of the Senate, and  
18 Speaker of the House of Representatives; and a copy shall be posted in the office of the  
19 State Treasurer for the information of the public.

21 (g) ~~If and to the extent the General Assembly shall authorize the sale of all or any~~  
22 ~~part of the stock owned by the State in the North Carolina Railroad Company or the~~

24 ~~separately accounted for and invested as expressly directed by the General Assembly,~~  
25 ~~but in the absence of any express direction as to investment, the proceeds may be~~  
26 ~~invested as authorized by this section."~~

27 **SECTION 3.** G.S. 147-69.2(b) reads as rewritten:

28 "(b) It shall be the duty of the State Treasurer to invest the cash of the funds  
29 enumerated in subsection (a) of this section in excess of the amount required to meet the  
30 current needs and demands on such funds, selecting from among the following:

- 31 (1) Any of the investments authorized by ~~G.S. 147-69.1(e);~~  
32 G.S. 147-69.1(c)(1)-(7).
- 33 (2) General obligations of other states of the United ~~States;~~ States.
- 34 (3) General obligations of cities, counties and special districts in North  
35 ~~Carolina;~~ Carolina.
- 36 (4) Obligations of any company, other organization or legal entity  
37 incorporated or otherwise created or located within or ~~without~~ outside  
38 the United States if ~~such~~ the obligations bear one of the three highest  
39 ratings of at least one nationally recognized rating service and do not  
40 bear a rating below the three highest by any nationally recognized  
41 rating service which rates the particular ~~security;~~ security.

- 9           (7) With respect to Retirement Systems' assets referred to in G.S.  
10          147-69.2(b)(8), (i) insurance contracts ~~which that~~ provide for  
11          participation in individual or pooled separate accounts of insurance  
12          companies, (ii) group trusts, (iii) individual, ~~common~~ common, or  
13          collective trust funds of banks and trust ~~companies and~~ companies, (iv)  
14          real estate investment ~~trusts; trusts,~~ and (v) limited partnerships,  
15          whether described as limited liability partnerships or limited liability  
16          companies; provided the investment manager has assets under  
17          management of at least one hundred million dollars (\$100,000,000);  
18          provided such investment assets are managed primarily for the purpose  
19          of investing in or owning real estate or related debt financing located  
20          ~~in~~ within or outside the United States; and provided that the investment  
21          authorized by this subsection shall not exceed ten percent (10%) of the  
22          ~~book~~ market value of all invested assets of the Retirement  
23          ~~Systems; Systems.~~
- 24          (8) With respect to assets of the Teachers' and State Employees'  
25          Retirement System, the Consolidated Judicial Retirement System, the  
26          Firemen's and Rescue Workers' Pension Fund, the Local  
27          Governmental Employees' Retirement System, ~~and~~ the Legislative  
28          ~~Retirement System~~ System, and the North Carolina National Guard  
29          Pension Fund (hereinafter referred to collectively as the Retirement  
30          Systems), preferred or common stocks issued by any company  
31          incorporated or otherwise created or located within or ~~without~~ outside  
32          the United States, ~~provided:~~ States subject to the conditions set forth in  
33          this subdivision. The assets authorized under this subdivision may be  
34          invested through individual, common, or collective trust funds of  
35          banks, trust companies, and group trust funds of investment advisory  
36          companies provided that the investment manager has assets under  
37          management of at least one hundred million dollars (\$100,000,000).  
38          Further, the assets authorized under this subdivision may be invested  
39          directly if all of the following conditions are met:

41               is registered on a national securities exchange as provided in the  
42               Federal Securities Exchange Act or quoted through the National

7 corporation for the whole of ~~such~~ that period ~~shall~~ have been at  
8 least equal to the amount of ~~such~~ the dividends ~~paid;~~ paid.
- 9 c. ~~That in~~ In applying the dividend and earnings test under this  
10 section to any issuing, assuming, or guaranteeing corporation,  
11 ~~where such corporation shall have~~ if the corporation acquired  
12 its property or any substantial part thereof within a five-year  
13 period immediately preceding the date of investment by  
14 consolidation, merger, or by the purchase of all or a substantial  
15 portion of the property of any other corporation or corporations,  
16 or ~~shall have~~ acquired the assets of any unincorporated business  
17 enterprise by purchase or otherwise, the dividends and net  
18 earnings of the several predecessor or constituent corporations  
19 or enterprises shall be consolidated and adjusted so as to  
20 ascertain whether or not the applicable requirements of this  
21 ~~section subdivision~~ have been complied ~~with;~~ with.
- 22 d. ~~That the~~ The book value of common and preferred stocks  
23 including securities convertible into common stocks shall not  
24 exceed fifty ~~per centum~~ percent (50%) of the book value of all  
25 invested assets of the Retirement ~~Systems;~~ provided, further:  
26 Systems and the following conditions must also be met:
- 27 1. Not more than one and one-half ~~per centum~~ percent (1  
28 1/2%) of the book value of ~~such~~ the assets shall be  
29 invested in the stock of a single ~~corporation,~~ and  
30 ~~provided further;~~ corporation.
- 31 2. The total number of shares in a single corporation shall  
32 not exceed eight ~~per centum~~ percent (8%) of the issued  
33 and outstanding stock of such ~~corporation,~~ and provided  
34 ~~further;~~ corporation.
- 35 3. As used in this subdivision d. and elsewhere in this  
36 section, book value shall mean adjusted cost basis as  
37 shown on the records of the State Treasurer.
- 38 e. Up to five ~~per cent~~ percent (5%) of the limits authorized in  
39 subdivision d. may be invested in the stocks or shares of a  
40 diversified investment company registered under the  
41 "Investment Company Act of 1940" ~~which that~~ has total assets  
42 of at least fifty million dollars (\$50,000,000).

1 f. ~~Individual, common or collective trust funds of banks or trust~~

5 g. That investments may be made in securities convertible into  
6 common stocks issued by any such company, if such securities  
7 bear one of the four highest ratings of at least one nationally  
8 recognized rating service and do not bear a rating below the  
9 four highest by any nationally recognized rating service which  
10 may then rate the particular security.

11 (9) Obligations and securities of The North Carolina Enterprise  
12 Corporation, of the North Carolina Economic Opportunities Fund, or  
13 of a limited partnership in which The North Carolina Enterprise  
14 Corporation or the North Carolina Economic Opportunities Fund is the  
15 only general partner, not to exceed twenty million dollars  
16 (\$20,000,000) from all funds; and a limited partnership interest in a  
17 ~~partnership~~ partnership, or an interest in a limited liability company  
18 whose primary purpose is to invest in venture capital or corporate  
19 buyout transactions, within or outside the United States, not to exceed  
20 thirty million dollars (\$30,000,000) from all funds. These maximum  
21 dollar amounts do not apply to or restrict the reinvestment in  
22 accordance with this subdivision of any income from these  
23 investments.

26 (11) With respect to assets of the Escheat Fund, obligations of the North  
27 Carolina Global TransPark Authority authorized by G.S. 63A-4(a)(22),  
28 not to exceed twenty-five million dollars (\$25,000,000), that have a  
29 final maturity not later than September 1, 2004. The obligations shall  
30 bear interest at the rate set by the State Treasurer. No commitment to  
31 purchase obligations may be made pursuant to this subdivision after  
32 September 1, 1993, and no obligations may be purchased after  
33 September 1, 1994. In the event of a loss to the Escheat Fund by  
34 reason of an investment made pursuant to this subdivision, it is the  
35 intention of the General Assembly to hold the Escheat Fund harmless  
36 from the loss by appropriating to the Escheat Fund funds equivalent to  
37 the loss."

38 **SECTION 4.** G.S. 147-69.3 reads as rewritten:

39 **"§ 147-69.3. Administration of State Treasurer's investment programs.**

40 (a) The State Treasurer shall establish, maintain, administer, manage, and operate  
41 within the Department of State Treasurer one or more investment programs for the  
42 deposit and investment of assets pursuant to the provisions of G.S. 147-69.1 and G.S.  
43 147-69.2.

1 (b) Any official, board, commission, other public authority, local government,  
2 school administrative unit, local ABC board, or community college of the State having  
3 custody of any funds not required by law to be deposited with and invested by the State  
4 Treasurer may deposit all or any portion of ~~such~~ those funds with the State Treasurer for  
5 investment in one of the investment programs established pursuant to this section,  
6 subject to any provisions of law with respect to eligible investments, provided that any  
7 occupational licensing board as defined in G.S. 93B-1 may participate in one of the  
8 investment programs established pursuant to this section regardless of whether or not  
9 the funds were required by law to be deposited with and invested by the State Treasurer.  
10 In the absence of specific statutory provisions to the contrary, any ~~such~~ of those funds  
11 may be invested in accordance with the provisions of G.S. 147-69.2 and 147-69.3. Upon  
12 request from any depositor eligible under this subsection, the State Treasurer may  
13 authorize moneys invested pursuant to this subsection to be withdrawn by warrant on  
14 the State Treasurer.

15 (c) The State Treasurer's investment programs shall be so managed that in the  
16 judgment of the State Treasurer funds may be readily converted into cash when needed.

17 (d) Except as provided by G.S. 147-69.1(d), ~~net income~~ the total return earned on  
18 investments shall ~~be credited~~ accrue pro rata to the fund whose assets are invested  
19 according to ~~such formula as may be~~ the formula prescribed by the State Treasurer with  
20 the approval of the Governor and Council of State.

21 (e) The State Treasurer ~~shall have~~ has full powers as a fiduciary to hold,  
22 purchase, sell, assign, transfer, lend and dispose of any of the securities or investments  
23 in which any of the programs created pursuant to this section have been invested, and  
24 may reinvest the proceeds from the sale of ~~such~~ those securities or investments and any  
25 other investable assets of the program.

26 (f) The cost of administration, management, and operation of investment  
27 programs established pursuant to this section shall be apportioned equitably among the  
28 programs in such manner as may be prescribed by the State Treasurer, such costs to be  
29 paid from each program, and to the extent not otherwise chargeable directly to the  
30 income or assets of the specific investment program or pooled investment vehicle, shall  
31 be deposited with the State Treasurer as a ~~General Fund nontax revenue receipt to the~~  
32 budget of the State Treasurer. ~~The cost of administration, management, and operation of~~  
33 ~~investment programs established pursuant to this section and not directly paid from the~~  
34 ~~income or assets of such program shall be covered by an appropriation to the State~~  
35 ~~Treasurer for this purpose in the Current Operations Appropriations Act.~~

36 (g) The State Treasurer is authorized to retain the services of ~~such~~ independent  
37 appraisers, auditors, actuaries, attorneys, investment counseling firms, statisticians,  
38 custodians, or other persons or firms possessing specialized skills or knowledge ~~as may~~  
39 ~~be~~ necessary for the proper administration of investment programs created pursuant to  
40 this section.

41 (h) The State Treasurer shall prepare, as of the end of each fiscal year, a report on  
42 the financial condition of each investment program created pursuant to this section. A  
43 copy of each report shall be submitted within 30 days following the end of the fiscal

1 year to the official, institution, board, commission or other agency whose funds are  
2 invested, the State Auditor, and the Advisory Budget Commission.

3 (i) The State Treasurer's annual report to the General Assembly shall include a  
4 full and complete statement of all moneys invested by virtue of the provisions of G.S.  
5 147-69.1 and G.S. 147-69.2, the nature and character of investments therein, and the  
6 revenues derived therefrom. ~~The State Treasurer shall also establish annual investment~~  
7 ~~yield targets for all moneys invested by virtue of the provisions of G.S. 147-69.1 and~~  
8 ~~G.S. 147-69.2, and shall include in his annual report a statement of the extent that these~~  
9 ~~targets have been reached.~~

10 (j) Subject to the provisions of ~~G.S. 147-69.1(e)~~, G.S. 147-69.1(d), the State  
11 Treasurer shall adopt ~~such rules and regulations as may be~~ any rules necessary to carry  
12 out the provisions of this section."

13 **SECTION 5.** This act becomes effective July 1, 2001.
