Short Title: Harley Owners' Group License Plate. (Public)

Sponsors: Representatives Weiss; Blust, Cox, Shubert, and Morris.

1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A
3 "HARLEY OWNERS' GROUP" SPECIAL REGISTRATION PLATE.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-79.3(b) reads as rewritten:

6 "(b) Types. – The Division shall issue the following types of special registration
7 plates:

9 (16c) Harley Owners' Group. - Issuable to the registered owner of a motor
10 vehicle in accordance with G.S. 20-81.12. The plate shall be designed
11 in consultation with and be approved by the Harley-Davidson Motor
12 Company, Inc., and shall bear the words and trademark of the "Harley
13 Owners' Group." The Division may not issue the plate authorized by
14 this subdivision unless it receives at least 300 applications for the
15 plate."

16 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

17 "(a) Fees. – Upon request, the Division shall provide and issue free of charge one
18 registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
19 veteran, and an ex-prisoner of war. All other special registration plates, including
20 additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of
21 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or
22 G.S. 20-88 plus an additional fee in the following amount:

SECTION 3. G.S. 20-79.7(b) reads as rewritten:

"(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), and the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, as follows:

11 **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:
12 "(b17) Harley Owners' Group. - The Division shall receive 300 or more
13 applications for a Harley Owners' Group plate before the plate may be developed. The
14 Division shall transfer quarterly the money in the Collegiate and Cultural Attraction
15 Plate Account derived from the sale of Harley Owners' Group plates to the State Board
16 of Community Colleges to support the motorcycle safety instruction program
17 established pursuant to G.S. 115D-72."

18 **SECTION 5.** This act becomes effective July 1, 2001, and expires on June
19 30, 2006.
