1 A JOINT RESOLUTION PROVIDING FOR THE CONFIRMATION OF THE
2 APPOINTMENTS OF JAMES YANCEY KERR, II AND MICHAEL
3 SATTERFIELD WILKINS TO MEMBERSHIP ON THE NORTH CAROLINA
4 UTILITIES COMMISSION AND THE APPOINTMENT OF ROBERT P.
5 GRUBER AS EXECUTIVE DIRECTOR OF THE PUBLIC STAFF OF THE
6 NORTH CAROLINA UTILITIES COMMISSION.

7 Whereas, under the provisions of G.S. 62-10, appointments made by the
8 Governor to membership on the North Carolina Utilities Commission are subject to
9 confirmation by the General Assembly by joint resolution; and

10 Whereas, vacancies will occur on the North Carolina Utilities Commission on
11 June 30, 2001; and

12 Whereas, the Governor has submitted to the presiding officers of the House
13 of Representatives and the Senate, the names of his appointees, James Yancey Kerr, II
14 and Michael Satterfield Wilkins, to serve terms on the North Carolina Utilities
15 Commission, which will begin July 1, 2001, and expire June 30, 2009; and

16 Whereas, under the provisions of G.S. 62-15, the appointment made by the
17 Governor of the Executive Director of the Public Staff of the North Carolina Utilities
18 Commission is subject to confirmation by the General Assembly by joint resolution; and

19 Whereas, a vacancy will occur in the office of Executive Director of the
20 Public Staff of the North Carolina Utilities Commission on June 30, 2001; and

21 Whereas, the Governor has submitted to the presiding officers of the House
22 of Representatives and the Senate, the name of his appointee, Robert P. Gruber, to serve
23 as Executive Director of the Public Staff of the North Carolina Utilities Commission for
24 a term to begin July 1, 2001, and expire June 30, 2007; Now, therefore,

25 Be it resolved by the Senate, the House of Representatives concurring:

26 **SECTION 1.** The appointments of James Yancey Kerr, II and Michael
27 Satterfield Wilkins to the North Carolina Utilities Commission for terms to begin July 1,
28 2001, and expire June 30, 2009, are confirmed.

1 **SECTION 2.** The appointment of Robert P. Gruber as Executive Director of
2 the Public Staff of the North Carolina Utilities Commission for a term to begin July 1,
3 2001, and expire June 30, 2007, is confirmed.

4 **SECTION 3.** This resolution is effective upon ratification.
