	TION 1. The permanent rules of the 2001 Regular Session of the House		
•	ves, with the following amendments, are adopted as the permanent rules		
of the 2002 Ext			
(1)	Rule 1 shall read as follows: "RULE 1. Convening Hour. The House shall convene each legislative day at the hour fixed by the House. In the event the House adjourns on the preceding legislative day without having fixed an hour for reconvening, the House shall convene on the next legislative day at 10:00 A.M."		
(2)	Notwithstanding Rule 26, the Committee on Rules, Calendar, and Operations of the House and the Ethics Committee shall be comprised of the members who were appointed during the regular session and such other members as the Speaker may appoint at the beginning of the Extra Session. The Chairs and Vice-chairs of those committees shall be those who were appointed by the Speaker during the Regular Session.		
(3)	Notwithstanding Rule 27, the standing committees and permanent subcommittees of the House are: <u>Committees</u> a. Rules, Calendar, and Operations of the House (none) b. Ethics (none) All rules of the 2001 Regular Session applicable to standing committees and permanent subcommittees of the House other than the		

may appoint select committees under Rule 26.

1	(4)	Notwithstanding Rule 31(a), all bills and resolutions shall be
2		introduced by submitting same to the Principal Clerk's Office.
3	(5)	Notwithstanding Rules 31 and 31.1:
4		a. The only resolutions that may be introduced or considered in
5		the House are resolutions adjourning the Extra Session sine die.
6		b. All bills shall be excluded from introduction or consideration in
7		the House, other than bills adopting new redistricting plans for
8		the North Carolina House of Representatives and the North
9		Carolina Senate, and legislation providing in 2002 only for
10		scheduling of the primaries and necessary amendments to
11		scheduling for the general election.
12	(6)	Notwithstanding Rule 31.1, all bills or resolutions must be introduced
13	()	not later than 3:00 P.M. on Wednesday, May 15, 2002.
14	(7)	Notwithstanding Rule 32, a resolution adjourning the Extra Session
15	,	sine die may be placed on the calendar without being referred by the
16		Speaker to a committee.
17	(8)	Notwithstanding Rule 41:
18	()	a. The first reading and reference to a standing committee of a
19		House bill shall occur on the legislative day of its introduction
20		The first reading and reference to a standing committee of a
21		Senate bill shall occur on the legislative day of its receipt or
22		messages from the Senate. The Speaker shall give notice at each
23		subsequent reading whether it is the second or third reading.
24		b. Except for a bill governed by Article II, Section 23 of the North
25		Carolina Constitution, a bill may be read more than once on the
26		same day.
27	(9)	Notwithstanding Rule 44(d), a conference report may be placed on the
28	. ,	calendar for the legislative day on which the report is received.
29	(10)	Notwithstanding Rule 59, any member wishing to cosponsor a bill or
30	,	resolution which has been introduced may do so by appearing in the
31		office of the Principal Clerk for such purpose on the day during which
32		such bill or resolution was first read and referred, but only while the
33		bill or resolution is in the possession of the House.
