34 schedule leading to the general election on November 2, 2004. The orders shall include
35 reset dates for absentee balloting that shall as nearly as practical provide the same
36 amount of time for voters and election officials set forth in Article 20 of Chapter 163 of
37 the General Statutes. The State Board shall, as soon as practical, distribute its orders,
38 including a Revised Primary Timetable, to county boards of elections. Adoption of
39 orders under this subsection is not subject to Chapter 150B of the General Statutes.

40 **SECTION 3.(c)** The State Board of Elections shall be governed by the
41 following limitations:

- 42 (1) Any postponement of the candidate filing period or the primary shall
43 apply to all offices in G.S. 163-1 whose primary elections are regularly
44 scheduled on primary day, so that there is one candidate filing period

1 for all those offices and one primary election for all those offices. The
2 postponement shall also apply to any elections to local office held on
3 that date (such as elections for boards of education under G.S.
4 115C-37) and the filing period for those offices.

5 (2) The State Board of Elections does not have the authority to dispense
6 with a second primary. The State Board shall provide for a second
7 primary in its schedule to any candidate entitled to call for a second
8 primary under the provisions of G.S. 163-111.

9 (3) The State Board shall set a filing period no shorter than 10 business
10 days.

11 (4) Before making its decision to postpone a filing period or primary
12 election under this section, the State Board of Elections shall consult
13 with the President Pro Tempore of the Senate, the Speakers of the
14 House of Representatives, and the leaders of both political parties in
15 the House and Senate.

16 **SECTION 3.(d)** If the primary election is postponed under subsection (a) of
17 this section, any local act for election of a board of education elected at the primary
18 which provides that persons elected shall take office in July of the year of the election is
19 modified for the 2004 election only to provide that the persons elected shall take office
20 at the next meeting of the board of education after the certification of the election.

21 **SECTION 3.(e)** For the 2004 primary election only, G.S. 163-112 shall be
22 applied by substituting "10 days" for "30 days" wherever it appears.

23 **SECTION 3.(f)** The provisions of this section apply during the 2004
24 election year only.

25 **SECTION 3.1.** G.S. 163-1 is amended by adding a new subsection to read:

26 "(d) If primaries for the State Senate or State House of Representatives are
27 temporarily moved from the date provided in subsection (b) of this section for any
28 election year, all primaries under this section shall be held on the same day."

29 **SECTION 4.(a)** Chapter 1 of the General Statutes is amended by adding a
30 new Article to read:

31 "Article 26A.

32 "Three-Judge Panel for Redistricting Challenges.

33 **"§ 1-267.1. Three-judge panel for actions challenging plans apportioning or**
34 **redistricting State legislative or congressional districts.**

35 (a) Any action challenging the validity of any act of the General Assembly that
36 apportions or redistricts State legislative or congressional districts shall be filed in the
37 Superior Court of Wake County and shall be heard and determined by a three-judge
38 panel of the Superior Court of Wake County organized as provided by subsection (b) of
39 this section.

40 (b) Whenever any person files in the Superior Court of Wake County any action
41 challenging the validity of any act of the General Assembly that apportioning or redistricts
42 State legislative or congressional districts, a copy of the complaint shall be served upon
43 the senior resident superior court judge of Wake County, who shall be the presiding
44 judge of the three-judge panel required by subsection (a) of this section. Upon receipt of

1 that complaint, the senior resident superior court judge of Wake County shall notify the
2 Chief Justice, who shall appoint two additional resident superior court judges to the
3 three-judge panel of the Superior Court of Wake County to hear and determine the
4 action. Before making those appointments, the Chief Justice shall consult with the North
5 Carolina Conference of Superior Court Judges, who shall provide the Chief Justice with
6 a list of recommended appointments.

7 (c) No order or judgment shall be entered affecting the validity of any act of the
8 General Assembly that apportions or redistricts State legislative or congressional
9 districts except by the three-judge panel of the Superior Court of Wake County
10 organized as provided by subsection (b) of this section. In the event of disagreement
11 among the three resident superior court judges comprising the three-judge panel, then
12 the opinion of the majority shall prevail."

13 **SECTION 4.(b)** Any action challenging the validity of any act of the
14 General Assembly that apportions or redistricts State legislative or congressional
15 districts and pending in a court other than the Superior Court of Wake County on the
16 effective date of this act shall be transferred, with a notice of transfer, by the clerk of
17 superior court of the county in which the action is pending to the clerk of Superior Court
18 of Wake County. The clerk of superior court of the county in which the action is
19 pending shall serve the senior resident superior court judge of Wake County with a copy
20 of the notice of transfer. Upon receipt of the notice of transfer, the senior resident
21 superior court judge of Wake County shall notify the Chief Justice, who shall appoint
22 two additional resident superior court judges to serve with the senior resident superior
23 court judge of Wake County on the three-judge panel of the superior court of Wake
24 County as provided by subsection (a) of this section.

25 **SECTION 5.** Article 1 of Chapter 120 of the General Statutes is amended by
26 adding a new section to read:

27 **"§ 120-2.3. Contents of judgments invalidating apportionment or redistricting**
28 **acts.**

29 Every order or judgment declaring unconstitutional or otherwise invalid, in whole or
30 in part and for any reason, any act of the General Assembly that apportions or redistricts
31 State legislative or congressional districts shall find with specificity all facts supporting
32 that declaration, shall state separately and with specificity the court's conclusions of law
33 on that declaration, and shall, with specific reference to those findings of fact and
34 conclusions of law, identify every defect found by the court, both as to the plan as a
35 whole and as to individual districts."

36 **SECTION 6.** Article 1 of Chapter 120 of the General Statutes is amended by
37 adding a new section to read:

38 **"§ 120-2.4. Opportunity for General Assembly to remedy defects.**

39 If the General Assembly enacts a plan apportioning or redistricting State legislative
40 or congressional districts, in no event may a court impose its own substitute plan unless
41 the court first gives the General Assembly a period of time to remedy any defects
42 identified by the court in its findings of fact and conclusions of law. That period of time
43 shall not be less than two weeks. In the event the General Assembly does not act to
44 remedy any identified defects to its plan within that period of time, the court may

1 impose an interim districting plan for use in the next general election only, but that
2 interim districting plan may differ from the districting plan enacted by the General
3 Assembly only to the extent necessary to remedy any defects identified by the court."

4 **SECTION 7.** Article 1 of Chapter 120 of the General Statutes is amended by
5 adding a new section to read:

6 **"§ 120-2.5. Direct appeal to Supreme Court.**

7 Appeal lies of right directly to the Supreme Court from any final order or judgment
8 of a court declaring unconstitutional or otherwise invalid in whole or in part and for any
9 reason any act of the General Assembly that apportions or redistricts State legislative or
10 congressional districts."

11 **SECTION 8.(a)** Article 7 of Chapter 1 of the General Statutes is amended
12 by adding a new section to read:

13 **"§ 1-81.1. Venue in apportionment or redistricting cases.**

14 (a) Venue in any action concerning any act of the General Assembly
15 apportioning or redistricting State legislative or congressional districts lies exclusively
16 with the Wake County Superior Court.

17 (b) Any action brought concerning an act of the General Assembly apportioning
18 or redistricting the State legislative or congressional districts shall be filed in the
19 Superior Court of Wake County."

20 **SECTION 8.(b)** Any action challenging the validity of any enactment of the
21 General Assembly that apportions or redistricts State legislative or congressional
22 districts and pending in a court other than the Superior Court of Wake County on the
23 effective date of this act shall be transferred, with a notice of transfer, by the clerk of
24 superior court of the county in which the action is pending to the clerk of Superior Court
25 of Wake County. The clerk of superior court of the county in which the action is
26 pending shall serve the senior resident superior court judge of Wake County with a copy
27 of the notice of transfer.

28 **SECTION 9.** G.S. 120-30.9B reads as rewritten:

29 **"§ 120-30.9B. Statewide statutes; State Board of Elections.**

30 (a) The Executive Director of the State Board of Elections shall ~~submit to the~~
31 ~~Attorney General of the United States;~~ seek approval as required by 42 U.S.C. § 1973c
32 all of the following:

- 33 (1) Within 30 days of the time they become laws all acts of the General
34 Assembly that amend, delete, add to, modify or repeal any provision of
35 Chapter 163 of the General Statutes or any other statewide legislation,
36 except relating to Chapter 7A of the General ~~Statutes, Statutes~~ or as
37 provided in subsection (b) of this section, which constitutes a "change
38 affecting voting" under Section 5 of the Voting Rights Act of 1965;
39 and
40 (2) Within 30 days all alterations of precinct boundaries under G.S.
41 163-132.2(c) in counties covered by Section 5 of the Voting Rights
42 Act of 1965.

43 (b) With respect to acts of the General Assembly that amend, delete, add to,
44 modify, or repeal any provision relating to apportioning or redistricting of State

1 legislative or congressional districts, the Attorney General of North Carolina shall seek
2 approval of the plan as required by 42 U.S.C. § 1973c."

3 **SECTION 10.** G.S. 163-132.3(e) reads as rewritten:

4 "(e) During the period beginning October 1, 2002, and ending December 31,
5 ~~2003, 2004,~~ no county board of elections may change any precinct boundary. However,
6 a county that has a precinct line that does not follow a 2000 Census Block Boundary
7 may change that precinct line to conform to the way that precinct is shown on the
8 General Assembly's redistricting database, provided the total population of the area
9 moved from one precinct to another is not greater than ten percent (10%) of the total
10 population of either precinct. A county board of elections proposing a change to a
11 precinct during this period shall submit that change to the Legislative Services Office,
12 which shall examine the proposed change and give its opinion of its compliance with
13 this subsection to the Executive Director of the State Board of Elections. If the proposed
14 change is in compliance with this subsection, the Executive Director shall approve it."

15 **SECTION 11.** G.S. 163-278.41 reads as rewritten:

16 "**§ 163-278.41. Appropriations in general election years and other years.**

17 (a) Following the conclusion of the last primary or nominating convention held
18 by a political party in a general election year in which a presidential election is held, the
19 State ~~chairman-chair~~ of that political party may apply to the State Board of Elections
20 (State Board) for the disbursement of all funds deposited with the State Treasurer on
21 behalf of ~~such-that~~ party in the North Carolina Political Parties Financing Fund
22 (Political Parties Fund) to be administered by the State Board of Elections and in which
23 shall be placed money contributed by taxpayers, as provided in G.S. 105-159.1. If the
24 regular date set for a primary in G.S. 163-1 or nominating convention in G.S. 163-98 is
25 temporarily postponed for one election year, the State party chair may apply for the
26 disbursement after the regular date set in those sections for that party's primary or
27 convention, even though the primary has not occurred under the temporary schedule.
28 Upon receipt of ~~such-that~~ application, the State Board shall forthwith, and every 30 days
29 thereafter, pay over to said chairman all funds currently held by the State Treasurer on
30 behalf of ~~said chairman's-that chair's~~ political party, but provided that all such payments
31 shall cease 30 days after the State Board of Elections has certified all of the results of
32 the general election to the Secretary of State. ~~Additionally and upon~~ Upon receipt of
33 ~~such-that~~ application, the State Board shall pay over to the ~~said chairman-chair~~ all funds
34 currently held by the State Treasurer in the "Presidential Election Year Candidates
35 Fund" of that party, which funds shall be allocated and disbursed during the presidential
36 election year by the same procedure as the funds received from the Political Parties
37 Fund are allocated. Any remaining funds of the political party in the hands of the State
38 Treasurer shall thereafter be held by ~~him-the~~ State Treasurer until eligible for
39 distribution pursuant to this section.

40 (b) Following the conclusion of the last primary or nominating convention held
41 by a political party in a general election year in which there is not a presidential
42 election, the State ~~chairman-chair~~ of the political party may apply to the State Board for
43 the disbursement of all funds deposited on behalf of such party in the Political Parties
44 Fund. If the regular date set for a primary in G.S. 163-1 or nominating convention in

1 G.S. 163-98 is temporarily postponed for one election year, the State party chair may
2 apply for the disbursement after the regular date set in those sections for that party's
3 primary or convention, even though the primary has not occurred under the temporary
4 schedule. Upon receipt of such application, the State Board shall forthwith, and every
5 30 days thereafter, pay over to said chairman all funds currently held by the State
6 Treasurer on behalf of ~~said chairman's~~ that chair's political party provided that all such
7 payments to the ~~said chairman~~ shall cease 30 days after the State Board of Elections has
8 certified all of the results of the general ~~election to the Secretary of State.~~ election. Any
9 remaining funds of the political party in the hands of the State Treasurer shall thereafter
10 be held by ~~him~~ the State Treasurer until eligible for distribution pursuant to this section.

11 (c) In each year in which no general election is held, each State ~~chairman~~ chair of
12 a political party on behalf of which funds have been deposited in the Political Parties
13 Fund may, on or between August 1 and September 1 thereof, apply to the State Board
14 for payment of an amount not to exceed fifty percent (50%) of the then available funds
15 credited to the account of ~~his~~ that party. Upon receipt of such application, the State
16 Board shall pay over to ~~said that State chairman~~ chair an amount not to exceed fifty
17 percent (50%) of the then available funds credited to the account of ~~his~~ that party.
18 Additionally and upon receipt of ~~such~~ that application, the State Board shall direct the
19 State Treasurer to place fifty percent (50%) of ~~the said those~~ available funds in a
20 separate interest bearing account to be known as the "Presidential Election Year
21 Candidates Fund of the (name of the party) Party" to be disbursed in accord with the
22 provisions of subsection (a) above. Any remaining funds of the political party in the
23 hands of the State Treasurer shall thereafter be held by ~~him~~ the State Treasurer until
24 eligible for distribution by the State Board pursuant to this section. Any interest earned
25 on the funds deposited in such Presidential Election Year Campaign Fund shall be
26 credited thereto."

27 **SECTION 12.** The provisions of this act are severable. If any provision of
28 this act is held invalid by a court of competent jurisdiction, the invalidity does not affect
29 any other provisions of this act that can be given effect without the invalid provision.

30 **SECTION 13.** Sections 1 and 2 of this act are effective when it becomes
31 law. The remainder of this act is effective when it becomes law and applies to any case
32 pending on or filed after that date, to any case regardless of when the case was filed, and
33 to any action of a court affecting the validity of an act apportioning or redistricting State
34 legislative or congressional districts.
