A BILL TO BE ENTITLED

AN ACT TO REQUIRE THE REVENUE LAWS STUDY COMMITTEE TO STUDY
SPECIAL PROVISIONS IN THE NORTH CAROLINA TAX CODE.

The General Assembly of North Carolina enacts:

SECTION 1. The Revenue Laws Study Committee may study issues relating to the effects on State revenues of government-enacted tax incentives, exemptions, credits, refunds, and exclusion, including a repeal or modification of any of the following tax provisions:

SECTION 2. Pursuant to section 1(3) of this act, the study includes a proposed rewrite of G.S. 105-130.5 to read:

25 provided for such electricity under this subdivision is forfeited. A taxpayer
26 that forfeits an exemption under this subdivision is liable for all past taxes
27 avoided as a result of the forfeited exemption, computed from the date the
28 taxes would have been due if the exemption had not been allowed, plus
29 interest at the rate established under G.S. 105-241.21. If the forfeiture is
30 triggered due to the lack of a timely investment required by
31 G.S. 105-164.3(8e)d., then interest is computed from the date the taxes
32 would have been due if the exemption had not been allowed. For all other
33 forfeitures, interest is computed from the time as of which the eligible
34 business property or electricity was put to a disqualifying use. The past taxes
35 and interest are due 30 days after the date the exemption is forfeited. A
36 taxpayer that fails to pay the past taxes and interest by the due date is subject
37 to the provisions of G.S. 105-236.

49 **SECTION 5.** The Revenue Laws Study Committee may make an interim report to
50 the 2010 Regular Session of the 2009 General Assembly and shall make its final report to the
51 2011 General Assembly.
