1 A BILL TO BE ENTITLED  
2 AN ACT TO ENSURE THE ACCESSIBILITY OF HANDICAPPED PARKING IN NORTH  
3 CAROLINA BY CHANGING THE HANDICAP PLACARD DESIGN TO REFLECT AN  
4 EXPIRATION DATE VISIBLE FROM AT LEAST TWENTY FEET TO ENSURE  
5 INCREASED ENFORCEMENT AND COLLECTION OF EXPIRED OR REVOKED  
6 PLACARDS AND TO REQUIRE THE DIVISION OF MOTOR VEHICLES TO ISSUE  
7 PLACARD REGISTRATION CARDS.

8 The General Assembly of North Carolina enacts:

9 **SECTION 1.** G.S. 20-37.5(4) reads as rewritten:

10 "(4) "Removable windshield placard" means a two-sided, hooked placard which  
11 includes on each side:

- 12 a. The International Symbol of Access, which is at least three inches in  
13 height, centered on the placard, and is white on a blue shield;  
14 b. An identification number;  
15 c. An expiration date; and date that is visible from at least 20 feet and  
16 gives the month and year of expiration; and  
17 d. The seal or other identification of the issuing authority."

18 **SECTION 2.** G.S. 20-37.6(c) reads as rewritten:

19 "(c) Handicapped Drivers and Passengers; Distinguishing Placards. – A handicapped  
20 person may apply for the issuance of a removable windshield placard or a temporary removable  
21 windshield placard. Upon request, one additional placard may be issued to applicants who do  
22 not have a distinguishing license plate. Any organization which, as determined and certified by  
23 the State Vocational Rehabilitation Agency, regularly transports handicapped persons may also  
24 apply. These organizations may receive one removable windshield placard for each  
25 transporting vehicle. When the removable windshield or temporary removable windshield  
26 placard is properly displayed, all parking rights and privileges extended to vehicles displaying a  
27 distinguishing license plate issued pursuant to subsection (b) shall apply. The removable  
28 windshield placard or the temporary removable windshield placard shall be displayed so that it  
29 may be viewed from the front and rear of the vehicle by hanging it from the front windshield  
30 rearview mirror of a vehicle using a parking space allowed for handicapped persons. When  
31 there is no inside rearview mirror, or when the placard cannot reasonably be hung from the  
32 rearview mirror by the handicapped person, the placard shall be displayed on the driver's side  
33 of the dashboard. A removable windshield placard placed on a motorized wheelchair or similar  
34 vehicle shall be displayed in a clearly visible location. The Division shall establish procedures  
35 for the issuance of the placards and may charge a fee sufficient to pay the actual cost of



1 issuance, but in no event less than five dollars (\$5.00) per placard. The Division shall issue a  
2 placard registration card with each placard issued to an individual. The registration card shall  
3 bear the name of the individual to whom the placard is issued, the individual's address, the  
4 placard number, and an expiration date. The registration card shall be in the vehicle in which  
5 the placard is being used, and the individual to whom the placard is issued shall be the operator  
6 or a passenger in the vehicle in which the placard is displayed."

7 **SECTION 3.** This act becomes effective July 1, 2009.
