**HOUSE BILL 844**

Short Title: Children's Home Society Special Plate. (Public)

A BILL TO BE ENTITLED  
AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE A  
SPECIAL PLATE FOR THE CHILDREN'S HOME SOCIETY OF NORTH CAROLINA  
THAT BEARS THE PHRASE "ADOPTION WORKS."

The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 20-63(b) reads as rewritten:

"(b) Every license plate shall have displayed upon it the registration number assigned to the vehicle for which it is issued, the name of the State of North Carolina, which may be abbreviated, and the year number for which it is issued or the date of expiration. A plate issued for a commercial vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more, must bear the word "commercial," unless the plate is a special registration plate authorized in G.S. 20-79.4 or the commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The plate issued for vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word "weighted".

Except as otherwise provided in this subsection, a registration plate issued by the Division for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight" printed at the top of the plate above all other letters and numerals. The background of the plate shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying slightly upward and to the right. The following special registration plates do not have to be a "First in Flight" plate. The design of the plates that are not "First in Flight" plates must be approved by the Division and the State Highway Patrol for clarity and ease of identification.

12 **SECTION 2.** G.S. 20-79.4(b) is amended by adding a new subdivision to read:

13 **"§ 20-79.4. Special registration plates.**

 15 (b) Types. – The Division shall issue the following types of special registration plates:

 17 (1a) Adoption Works. – This plate is issuable to the registered owner of a motor  
 18 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase  
 19 "Adoption Works" and a logo provided by the Children's Home Society of  
 20 North Carolina.

22 **SECTION 3.** G.S. 20-79.7(a) reads as rewritten:

23 "(a) Fees. – Upon request, the Division shall provide and issue free of charge one  
 24 registration plate to a recipient of a Legion of Valor award, a 100% disabled veteran, and an  
 25 ex-prisoner of war. All other special registration plates, including additional Legion of Valor,  
 26 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle  
 27 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

10           **SECTION 4.** G.S. 20-79.7(b) reads as rewritten:

11           "(b)   Distribution of Fees. – The Special Registration Plate Account and the Collegiate  
12 and Cultural Attraction Plate Account are established within the Highway Fund. The Division  
13 must credit the additional fee imposed for the special registration plates listed in subsection (a)  
14 among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction  
15 Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under  
16 G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under  
17 G.S. 113-44.15, as follows:

2 **SECTION 5.** G.S. 20-81.12 is amended by adding a new subsection to read:

3 "(b73) Adoption Works. – The Division must receive 300 or more applications for the  
4 Adoption Works plate before the plate may be developed. The Division must transfer quarterly  
5 the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of  
6 Adoption Works plates to the Children's Home Society of North Carolina to provide funding to  
7 support the Children's Home Society's mission."

8 **SECTION 6.** This act becomes effective July 1, 2009.
