6 **PART I. INTRODUCTION AND TITLE OF ACT**

7
8 **TITLE OF ACT**

9 **SECTION 1.1.** This act shall be known as "The Current Operations and Capital
10 Improvements Appropriations Act of 2010."

11
12 **INTRODUCTION**

13 **SECTION 1.2.** The appropriations made in this act are for maximum amounts
14 necessary to provide the services and accomplish the purposes described in the budget. Savings
15 shall be effected where the total amounts appropriated are not required to perform these
16 services and accomplish these purposes and, except as allowed by the State Budget Act, or this
17 act, the savings shall revert to the appropriate fund at the end of each fiscal year as provided in
18 G.S. 143C-1-2(b).

23 **SECTION 2.1.** Appropriations from the General Fund of the State for the

1 **SECTION 2.2.(c)** Notwithstanding G.S. 143C-4-2, the State Controller shall not
2 transfer funds to the Savings Reserve Account on June 30, 2010. This subsection becomes
3 effective June 30, 2010.

4 **SECTION 2.2.(d)** Section 2.2(h) of S.L. 2009-451 reads as rewritten:

5 **"SECTION 2.2.(h)** Notwithstanding G.S. 143C-9-3, of the funds credited to the Tobacco
6 Trust, the sum of five million dollars (\$5,000,000) for the 2009-2010 fiscal year and the sum of

43 **SECTION 5.1.(a)** Pursuant to G.S. 18C-164, the revenue used to support
 44 appropriations made in this act is transferred from the State Lottery Fund in the amount of four
 45 hundred forty-one million three hundred forty-seven thousand five hundred dollars
 46 (\$441,347,500) for the 2010-2011 fiscal year.

47 **SECTION 5.1.(b)** Notwithstanding G.S. 18C-164, the appropriations made from
 48 the Education Lottery Fund pursuant to G.S. 18C-164(d) for the 2010-2011 fiscal year are as
 49 follows:

4 **SECTION 5.1.(c)** Notwithstanding G.S. 18C-164(f) or any other provision of law,
5 excess lottery receipts realized in the 2009-2010 fiscal year in the amount of thirty-one million
6 eight hundred eighty-one thousand forty-six dollars (\$31,881,046) shall be transferred to the
7 Public School Building Capital Fund and allocated on the basis of average daily membership
8 (ADM) to those local school administrative units that did not qualify for funding in the
9 2009-2010 fiscal year pursuant to G.S. 115C-546.2(d)(2). Notwithstanding G.S. 18C-164(f) or
10 any other provision of law, the balance of the excess lottery revenues realized in the 2009-2010
11 fiscal year shall be used for scholarships for needy students.

12 **SECTION 5.1.(d)** Section 5.2.(d) of S.L. 2009-451, as enacted by Section 3N of
13 S.L. 2009-575, is repealed.

14 **SECTION 5.1.(e)** Notwithstanding G.S. 18C-164(c), G.S. 115C-546.2(d), or any
15 other provision of law, funds appropriated in this section to the Public School Building Capital
16 Fund for the 2010-2011 fiscal year shall be allocated to counties on the basis of average daily
17 membership (ADM). Counties may authorize local school administrative units to use all or part
18 of these funds for classroom teachers.

19 These funds shall not be included in the computation of "average per pupil
20 allocation for average daily membership" or "per pupil local current expense appropriation"
21 under G.S. 115C-238.29H.

22 **SECTION 5.1.(f)** Notwithstanding G.S. 18C-164(c), Article 35A of Chapter 115C
23 of the General Statutes, or any other provision of law, of the funds appropriated in this section
24 for Scholarships for Needy Students, the sum of twenty-six million six hundred sixty-one
25 thousand forty-six dollars (\$26,661,046) shall be administered in accordance with the policy
26 adopted by the Board of Governors of The University of North Carolina.

27 **SECTION 5.1.(g)** Subsections (c) and (d) of this section become effective June 30,
28 2010.

29

7 APPROPRIATION OF CASH BALANCES

8 **SECTION 5.3.** Section 5.4 of S.L. 2009-451 reads as rewritten:

9 **"SECTION 5.4.(a)** State funds, as defined in G.S. 143C-1-1(d)(25), are appropriated ~~and~~
 10 ~~authorized~~ as provided in G.S. 143C-1-2 for the 2009-2011 fiscal biennium as follows:

- 11 (1) For all budget codes listed in the Base Budget and Performance
 12 Management Information sections of "North Carolina State Budget,
 13 Recommended Operating Budget 2009-2011, Volumes 1 through 6," and in
 14 the Budget Support Document, cash balances and receipts are appropriated
 15 up to the amounts specified in Volumes 1 through 6, as adjusted by the
 16 General Assembly, for the 2009-2010 fiscal year and the 2010-2011 fiscal
 17 year. Funds may be expended only for the programs, purposes, objects, and
 18 line items specified in Volumes 1 through 6, or otherwise authorized by the
 19 General Assembly. Expansion budget funds listed in those documents are
 20 appropriated only as otherwise provided in this act.
- 21 (2) For all budget codes that are not listed in "North Carolina State Budget,
 22 Recommended Operating Budget 2009-2011, Volumes 1 through 6," or in
 23 the Budget Support Document, cash balances and receipts are appropriated
 24 for each year of the 2009-2011 fiscal biennium up to the level of actual
 25 expenditures for the ~~2008-2009-2009-2010~~ fiscal year, unless otherwise
 26 provided by law. Funds may be expended only for the programs, purposes,
 27 objects, and line items authorized for the ~~2008-2009-2009-2010~~ fiscal year.
- 28 (3) Notwithstanding subdivisions (1) and (2) of this subsection, any receipts that
 29 are required to be used to pay debt service requirements for various
 30 outstanding bond issues and certificates of participation are appropriated up
 31 to the actual amounts received for the 2009-2010 fiscal year and the
 32 2010-2011 fiscal year and shall be used only to pay debt service
 33 requirements.
- 34 (4) Notwithstanding subdivisions (1) and (2) of this subsection, cash balances
 35 and receipts of funds that meet the definition issued by the Governmental
 36 Accounting Standards Board of a trust or agency fund are appropriated for
 37 and in the amounts required to meet the legal requirements of the trust
 38 agreement for the 2009-2010 fiscal year and the 2010-2011 fiscal year.

39 **"SECTION 5.4.(b)** Receipts collected in a fiscal year in excess of the amounts authorized
 40 by this section shall remain unexpended and unencumbered until appropriated by the General
 41 Assembly in a subsequent fiscal year, unless the expenditure of overrealized receipts in the
 42 fiscal year in which the receipts were collected is authorized by the State Budget Act.

43 Overrealized receipts are appropriated up to the amounts necessary to implement this
 44 subsection.

45 In addition to the consultation and reporting requirements set out in G.S. 143C-6-4, the
 46 Office of State Budget and Management shall report to the Joint Legislative Commission on
 47 Governmental Operations and to the Fiscal Research Division within 30 days after the end of
 48 each quarter on any overrealized receipts approved for expenditure under this subsection by the
 49 Director of the Budget. The report shall include the source of the receipt, the amount
 50 overrealized, the amount authorized for expenditure, and the rationale for expenditure.

1 "SECTION 5.4.(c) Notwithstanding subsections (a) and (b) of this section, there is
2 appropriated from the Reserve for Reimbursements to Local Governments and Shared Tax
3 Revenues for each fiscal year an amount equal to the amount of the distributions required by
4 law to be made from that reserve for that fiscal year."
5

6 OTHER RECEIPTS FROM PENDING GRANT AWARDS

7 SECTION 5.4. Section 5.6 of S.L. 2009-451 reads as rewritten:

8 "SECTION 5.6. Notwithstanding G.S. 143C-6-4, State agencies may, with approval of the
9 Director of the Budget and after consultation with the Joint Legislative Committee on
10 Governmental Operations, spend funds received from grants awarded subsequent to the
11 enactment of this act. The Office of State Budget and Management shall work with the
12 recipient State agencies to budget grant awards according to the annual program needs and
13 within the parameters of the respective granting entities. Depending on the nature of the award,
14 additional State personnel may be employed on a time-limited basis. The Office of State
15 Budget and Management shall consult with the Joint Legislative Commission on Governmental
16 Operations prior to expending any funds received from grant awards. Funds received from such
17 grants are hereby appropriated and shall be incorporated into the ~~certified~~-authorized budget of
18 the recipient State agency."
19

20 PART VI. GENERAL PROVISIONS

21 EXPENDITURE OF FUNDS IN RESERVES LIMITED

22 SECTION 6.1. All funds appropriated by this act into reserves may be expended
23 only for the purposes for which the reserves were established.
24
25

26 BUDGET CODE CONSOLIDATIONS

27 SECTION 6.2. Notwithstanding G.S. 143C-6-4, the Office of State Budget and
28 Management may adjust the enacted budget by making transfers among purposes or programs
29 for the purpose of consolidating budget and fund codes or eliminating inactive budget and fund
30 codes. The Office of State Budget and Management shall change the authorized budget to
31 reflect these adjustments.
32

33 BUDGET REALIGNMENT

34 SECTION 6.3. Notwithstanding G.S. 143C-6-4(b), the Office of State Budget and
35 Management, in consultation with the Office of the State Controller and the Fiscal Research
36 Division, may adjust the enacted budget by making transfers among purposes or programs for
37 the sole purpose of correctly aligning authorized positions and associated operating costs with
38 the appropriate purposes or programs as defined in G.S. 143C-1-1(d)(23). The Office of State
39 Budget and Management shall change the certified budget to reflect these adjustments only
40 after reporting the proposed adjustments to the Joint Legislative Commission on Governmental
41 Operations and the Fiscal Research Division. Under no circumstances shall total General Fund
42 expenditures for a State department exceed the amount appropriated to that department from
43 the General Fund for the fiscal year.
44

45 BUDGET ADJUSTMENTS AUTHORIZED

46 SECTION 6.4.(a) Notwithstanding G.S. 143C-6-4(a) or any other provision of
47 law, the maximum amount expended at the budget code level from funds appropriated in
48 Section 2.1 of S.L. 2009-451, as amended, shall not exceed by more than three percent (3%)
49 the amount appropriated for that budget code in Section 2.1 of S.L. 2009-451, as amended.
50

51 SECTION 6.4.(b) This section applies to the 2010-2011 fiscal year only.

ESTABLISHING OR INCREASING FEES PURSUANT TO THIS ACT

SECTION 6.5.(a) Notwithstanding G.S. 12-3.1, an agency is not required to consult with the Joint Legislative Commission on Governmental Operations prior to establishing or increasing a fee as authorized or anticipated in this act.

SECTION 6.5.(b) Notwithstanding G.S. 150B-21.1A(a), an agency may adopt an emergency rule in accordance with G.S. 150B-21.1A to establish or increase a fee as authorized by this act if the adoption of a rule would otherwise be required under Article 2A of Chapter 150B of the General Statutes.

LEGISLATIVE BUDGET PRIORITIES

SECTION 6.6. The General Assembly finds North Carolina's citizens and businesses are suffering from the effects of a significant State, national, and international financial crisis and that this financial crisis has resulted in large reductions in revenues available to fund the State's budget for the upcoming year and in large increases in demand for State services. The General Assembly further finds that, in spite of the reduced revenues, the State must act decisively to create jobs, encourage economic activity to keep our families working, provide job training and higher education opportunities to the citizens of the State, and protect core government services such as health care for the most vulnerable populations and public safety for the citizens of the State; therefore, the General Assembly provides funding for and support of the following initiatives:

- (1) Retention of classroom teachers.
- (2) Tax credits for small businesses.
- (3) Small Business Assistance Fund.
- (4) Preservation of access to health care for vulnerable populations.
- (5) Financial aid to needy college and community college students.
- (6) Full funding community college enrollment growth to be used to hire additional faculty and student support staff.
- (7) Small Business Centers at community colleges.
- (8) Business Recruitment.
- (9) One North Carolina Small Business.
- (10) One North Carolina Fund.
- (11) Job Maintenance and Capital Development Fund.
- (12) Health science and engineering programs at the community college and university levels.
- (13) Energy Research Grants.
- (14) Regional Economic Development Commissions.
- (15) Home Grown Jobs.

- (23) Minority Support Center.
- (24) Tourism Marketing.
- (25) In-Source NC.
- (26) Lab-to-Market Commercialization Funds.
- (27) Capital projects.

AMEND ARRA FUNDS

1 **SECTION 6.7.** Section 6.6C.(b) of Session Law 2009-451 reads as rewritten:

2 **"SECTION 6.6C.(b)** Appropriation of ARRA Funds. – Funds received from ARRA grants
3 and receipts not specified in this act are hereby appropriated in the amounts provided in the
4 notification of award from the federal government or any entity acting on behalf of the federal
5 government to administer federal ARRA funds. ~~Prior to allocation of funds not expressly~~
6 ~~delineated in this act, the OSBM and affected state agencies shall consult with report to the~~
7 Joint Legislative Commission on Governmental Operations. Operations on ARRA grants
8 received that are not expressly delineated in this act."
9

10 **INFORMATION TECHNOLOGY OPERATIONS**

11 **SECTION 6.8.** Section 6.7 of S.L. 2009-451 reads as rewritten:

12 **"SECTION 6.7.(a)** Office of Information Technology Services Budget. – Notwithstanding
13 G.S. 147-33.88, the Office of Information Technology Services shall develop an annual budget
14 for review and approval by the Office of State Budget and Management in accordance with a
15 schedule prescribed by the Director of the Office of State Budget and Management. The
16 approved Office of Information Technology Services budget shall be included in the
17 Governor's budget recommendations to the General Assembly.

18 The Office of State Budget and Management shall ensure that State agencies have an
19 opportunity to adjust their budgets based on any rate changes proposed by the Office of
20 Information Technology Services.

21 **"SECTION 6.7.(b)** Enterprise Projects. – The State Chief Information Officer shall
22 consult the respective State agency chief information officers to identify specific State agency
23 requirements prior to the initiation of any enterprise project. State agency requirements shall be
24 incorporated into any enterprise agreement signed by the State Chief Information Officer.
25 Enterprise projects shall not exceed the participating State agencies' ability to financially
26 support the contracts.

27 The State Chief Information Officer shall not enter into any information technology
28 contracts without obtaining written agreements from participating State agencies regarding
29 apportionment of funding. State agencies agreeing to participate in a contract shall:

- 30 (1) Ensure that sufficient funds are budgeted to support their agreed shares of
31 enterprise agreements throughout the life of the contract.
- 32 (2) Transfer the agreed-upon funds to the Office of Information Technology
33 Services in sufficient time for the Office of Information Technology
34 Services to meet contract requirements.
- 35 (3) Ensure that enterprise project costs are allocated to participating agencies in
36 an equitable manner.

37 **"SECTION 6.7.(c)** Notwithstanding the cash management provisions of G.S. 147-86.11,
38 the Office of Information Technology Services may procure information technology goods and
39 services for periods of up to a total of three years where the terms of the procurement contract
40 require payment of all, or a portion, of the contract purchase price at the beginning of the
41 agreement. All of the following conditions shall be met before payment for these agreements
42 may be disbursed:

- 43 (1) Any advance payment complies with the Office of Information Technology
44 Services budget.
- 45 (2) The State Controller receives conclusive evidence that the proposed
46 agreement would be more cost-effective than a multiyear agreement that
47 complies with G.S. 147-86.11.
- 48 (3) The procurement complies in all other aspects with applicable statutes and
49 rules.
- 50 (4) The proposed agreement contains contract terms that protect the financial
51 interests of the State against contractor nonperformance or insolvency

1 through the creation of escrow accounts for funds, source codes, or both, or
2 by any other reasonable means that have legally binding effect.

3 The Office of State Budget and Management shall ensure the savings from any authorized
4 agreement shall be included in the Office of Information Technology Services calculation of
5 rates before the Office of State Budget and Management annually approves the proposed rates.
6 The Office of Information Technology Services shall report to the Office of State Budget and
7 Management on any State agency budget impacts resulting from multiyear contracts.

8 The Office of Information Technology Services shall submit a quarterly written report of
9 any authorizations granted under this subsection to the Joint Legislative Oversight Committee
10 on Information Technology and to the Fiscal Research Division.

11 **"SECTION 6.7.(d)** State agencies developing and implementing information technology
12 projects shall use the State infrastructure to host their projects. The State Chief Information
13 Officer may grant an exception if the State agency can demonstrate any of the following:

- 14 (1) Using an outside contractor would be more cost-effective for the State.
- 15 (2) The Office of Information Technology Services does not have the technical
16 capabilities required to host the application.
- 17 (3) Valid security requirements preclude the use of State infrastructure, and a
18 contractor can provide a more secure environment.

19 **"SECTION 6.7.(e)** Service level agreements developed with supported State agencies
20 shall include metrics for ITS, as well as the supported agencies. When ITS or an agency fails to
21 meet metrics established by the SLA, a report will be provided to the Office of State Budget
22 and Management and the Fiscal Research Division of the General Assembly within 10 days
23 that details the shortfall and provides a corrective action plan with a time line.

24 **"SECTION 6.7.(f)** The Office of Information Technology Procurement shall assist State
25 agencies in identifying the least expensive source for the purchase of IT goods and services and
26 shall ensure that agencies receive every available discount when purchasing IT goods and
27 services.

28 **"SECTION 6.7.(g)** The State CIO shall ensure that the agency bills from ITS for
29 information technology goods and services are easily understood and fully transparent."

30 31 **COORDINATION OF INFORMATION TECHNOLOGY REQUIREMENTS AND** 32 **GEOGRAPHICAL INFORMATION SYSTEM EFFORTS**

33 **SECTION 6.9.(a)** The State Chief Information Officer (SCIO), through the
34 Enterprise Program Management Office (EPMO), shall adopt measures to avoid the duplication
35 of information technology capabilities and resources across State agencies. When multiple
36 State agencies require the same or a substantially similar information technology capability, the
37 SCIO shall designate one State agency as the lead to coordinate support and to manage that
38 capability for all State agencies requiring the capability, with the SCIO maintaining oversight
39 of the effort. Further, the EPMO shall:

- 40 (1) Review all ongoing and future information technology projects to determine
41 whether the capabilities required for each project, or the specific
42 requirements comprising a component within a project, already exist in a
43 planned, ongoing, or completed information technology project developed
44 by another State agency.
- 45 (2) When State agencies request approval for new projects determine if the
46 information technology project has transferable applicability to current or
47 future capabilities required by another State agency.
- 48 (3) Upon identifying an existing information technology capability needed by a
49 State agency, assist that agency in determining how best to access existing
50 projects.

- 1 (4) Identify all current instances of duplication and work with the affected State
2 agencies to develop and implement a plan to integrate their efforts. These
3 plans shall be reported to the Joint Legislative Oversight Committee on
4 Information Technology and to the Fiscal Research Division by January 1,
5 2011.

6 **SECTION 6.9.(b)** All State agencies shall coordinate any Geographic Information
7 System (GIS) initiatives through the Center for Geographic Information and Analysis (CGIA)
8 to ensure that they are not duplicating an existing function. The CGIA shall monitor and
9 approve all new GIS-related information technology projects and expansion budget requests.
10 By January 1, 2011, the CGIA shall make a written report to the Joint Legislative Oversight
11 Committee on Information Technology and to the Fiscal Research Division on the results of
12 these efforts.

13
14 **CRIMINAL JUSTICE LAW ENFORCEMENT AUTOMATED DATA SERVICES**
15 **(CJLEADS)**

16 **SECTION 6.10.(a)** The Office of the State Controller, in cooperation with the
17 State Chief Information Officer, shall:

- 18 (1) Continue the implementation of the Criminal Justice Data Integration Pilot
19 Program, which is now known as the Criminal Justice Law Enforcement
20 Automated Data Services (CJLEADS), in Wake County; and
21 (2) Begin the transfer of the hosting of CJLEADS to the Department of Justice.

22 The Office of the State Controller shall not expand CJLEADS beyond Wake County.

23 **SECTION 6.10.(b)** Effective October 1, 2010, CJLEADS is transferred from the
24 Office of State Controller to the Department of Justice. This transfer shall have all of the
25 elements of a Type I transfer, as defined in G.S. 143A-6.

26 **SECTION 6.10.(c)** The Department of Justice shall administer CJLEADS with the
27 assistance of a Leadership Council consisting of:

- 28 (1) The Attorney General;
29 (2) The Director of Administrative Office of the Courts;
30 (3) The Secretary of the Department of Correction;
31 (4) The Secretary of Crime Control and Public Safety;
32 (5) The Secretary of the Department of Juvenile Justice and Delinquency
33 Prevention;
34 (6) The Commissioner of Motor Vehicles, Department of Transportation;
35 (7) The President of The North Carolina Association of Chiefs of Police;
36 (8) The Executive Director of the North Carolina Sheriffs' Association, Inc.;
37 (9) A representative of the Federal Bureau of Investigation who shall be a
38 nonvoting member; and
39 (10) The State Controller.

40 **SECTION 6.10.(d)** The transfer of the hosting of CJLEADS to the Department of
41 Justice shall be completed by July 1, 2011.

42 **SECTION 6.10.(e)** Funds appropriated for CJLEADS shall be used only for
43 project requirements of CJLEADS and not for other BEACON data integration requirements.
44

45 **ITS NETWORK INTEGRATION**

46 **SECTION 6.11.** Section 6.13.(c) of S.L. 2009-451 as amended by Section 3A(b) of
47 S.L. 2009-575 reads as rewritten:

48 "SECTION 6.13.(c) Following completion of the feasibility study by the Office of
49 Information and Technology Services and the Office of State Budget and Management, and if
50 the Program Evaluation Division and the Fiscal Research Division can verify that the
51 efficiencies and savings identified in the study are valid, accurate, and substantial enough to

1 justify increased coordination, then the Office of Information Technology Services and MCNC
2 shall develop a plan to identify areas in which it may be feasible to coordinate their operations.
3 The coordination plan shall include at least the following:

- 4 (1) Definition of requirements to achieve statewide integration.
- 5 (2) Detailed information on the allocation of responsibility for each requirement
6 and component.
- 7 (3) An estimate of the associated costs with each requirement or component,
8 including what the costs to each agency would be without coordination.
- 9 (4) Priorities for integration.
- 10 (5) A schedule for implementation.
- 11 (6) Detailed cost information for the development and integration of a single
12 network.
- 13 (7) A governance structure for management and oversight of the network.
- 14 (8) A means for resolution of any issues identified during the feasibility study.

15 The coordination plan shall be completed by ~~February 28, 2010, December 1, 2010,~~ and
16 shall be presented to the Joint Legislative Commission on Governmental Operations and the
17 Joint Legislative Oversight Committee on Information Technology."
18

19 INFORMATION TECHNOLOGY CONTRACTED PERSONNEL

20 **SECTION 6.12.** Section 6.18 of S.L. 2009-451 reads as rewritten:

21 "**SECTION 6.18.(a)** Beginning July 1, 2009, and notwithstanding any provision of law to
22 the contrary:

- 23 (1) No contract for information technology personal services, or providing
24 personnel to perform information technology functions, may be established
25 or renewed ~~for any term longer than 12 months unless otherwise specifically~~
26 ~~required by a contract in effect on June 30, 2009, without the express written~~
27 approval of the Statewide Information Technology Procurement Office.
- 28 (2) Before any State agency, department, or institution may renew a contract
29 position for information technology personnel the State agency must report
30 to the Statewide Information Technology Procurement Office (SITPO),
31 Office of State Budget and Management (OSBM), to the Office of State
32 Personnel (OSP), to the Office of Information Technology Services (ITS),
33 and to the Fiscal Research Division (FRD) of the Legislative Services Office
34 on the justification for the contract. The report shall explain:
 - 35 a. The proposed duration of the contract position. If the contract term is
36 for more than 12 months, why recruitment for an in-house State
37 employee position is not feasible.
 - 38 b. Whether the contract position requires unique skills for which the
39 State has a short-term need.
 - 40 c. Whether the contract position is required by a specific information
41 technology project and if the position will be terminated upon
42 completion of the project.
 - 43 d. The specific work products and completion time lines for the contract
44 position.
- 45 (3) Contract positions subject to this subsection shall be reviewed and approved
46 by the Statewide Information Technology Procurement Office and shall be
47 entered in the project portfolio management tool.
- 48 (4) Once approved, contract positions will be reviewed by the Office of State
49 Personnel to determine what the market rate is for the type of contractor
50 required, as well as to determine the comparable cost for a State employee.
51 Agencies may not exceed the market rate determined by OSP.

- 1 (5) After OSP provides cost data, OSBM must approve funding for the position.
2 (6) Whenever a State agency, department, or institution determines that only
3 a contractor can fill a position and the position is required to perform an
4 ongoing function within the agency, the head of the State agency must
5 develop and implement a plan to hire or train a qualified State employee to
6 fill that position within 12 months. Within 60 days of hiring the contractor,
7 this plan shall be forwarded to the Office of State Budget and Management,
8 to the Office of State Personnel, to the Office of Information Technology
9 Services, to the Joint Legislative Oversight Committee on Information
10 Technology, and to the Fiscal Research Division of the Legislative Services
11 Office.
12 (7) Any contract position requiring information technology skills is subject to
13 this provision. OSBM may immediately terminate the funding for any
14 information technology position that is filled without following defined
15 procedures.
16 (8) All information technology personnel contracts shall be competitive and
17 shall be subject to competition each time they expire. Exceptions must be
18 approved by ITS, OSP, and OSBM and can only be approved once for a
19 particular individual. Approved exceptions must be immediately reported to
20 the Joint Legislative Oversight Committee on Information Technology and
21 to the Fiscal Research Division of the Legislative Services Office.

22 **"SECTION 6.18.(b)** By October 1, 2009, and monthly thereafter, each State agency,
23 department, and institution employing information technology personal services contractors, or
24 personnel to perform information technology functions, shall provide a detailed report on those
25 contracts to the Office of State Budget and Management, to the Office of State Personnel, to the
26 Office of Information Technology Services, to the Joint Legislative Oversight Committee on
27 Information Technology, and to the Fiscal Research Division of the Legislative Services
28 Office. Each State agency's report shall include at least the following:

- 29 (1) For each contracted information technology position:
30 a. The title of the position, a brief synopsis of the essential functions of
31 the position, and how long the position has existed.
32 b. The name of the individual filling the position and the vendor
33 company, if any, that regularly employs that individual.
34 c. The type, start date, and the termination date of the contract.
35 d. The length of time that the individual filling the contracted position
36 has been employed as a contractor.
37 e. The contracted position salary or hourly rate, the number of hours per
38 year, and the total annualized cost of the contracted position.
39 f. The salary and benefits cost for a State employee performing the
40 same function.
41 g. The purchase order number for the position.
42 h. Whether the position can be converted to a State employee position.
43 This determination shall be made by the SITPO.
44 i. When the agency anticipates converting the position to a State
45 employee.
46 (2) The total annual cost for information technology contractors and the total
47 annual salary and benefits cost for filling the contract positions with State
48 employees.
49 (3) A determination of whether the information technology functions performed
50 by contractors can be performed by State employees, which shall be
51 validated by the Statewide Information Technology Procurement Office.

- 1 (4) All information required by this subsection related to information
2 technology contractors regardless of the contracting source.
- 3 (5) A detailed explanation for any differences between the agency report and the
4 Information Technology Expenditures Report annually published by the
5 Office of the State Controller.

6 "**SECTION 6.18.(c)** This section does not apply to The University of North Carolina and
7 its constituent institutions."

8

9 **CONTINUING PILOT PROGRAM TO ALLOW PUBLIC-PRIVATE PARTNERSHIPS**
10 **TO MEET DEPARTMENT OF REVENUE TECHNOLOGY NEEDS**

11 **SECTION 6.13.** Section 6.20 of S.L. 2009-451 reads as rewritten:

12 "**SECTION 6.20.(a)** To speed the implementation of the Tax Information Management
13 System (TIMS) and the additional components of the Planning and Design Project (PDP)
14 ~~during the 2009-2011 fiscal biennium, through June 30, 2015,~~ the Secretary of the Department
15 of Revenue may enter into public-private arrangements where (i) the funding of projects under
16 the arrangement comes from revenue generated by the project and (ii) the project is related to
17 the implementation of TIMS and additional components of the PDP. As used in this section, the
18 "additional components of the PDP" are Enterprise Data Warehouse, Management Reporting
19 and Decision Analytics, Customer Relationship Management, Enterprise Case Management,
20 and E-Services.

21 Work under a public-private arrangement may be contracted by requests for proposals,
22 modifications to existing contracts, and purchases using existing contract vehicles.

23 The Secretary of Revenue shall establish a measurement process to determine the increased
24 revenue attributable to the public-private arrangements. To accomplish this, the Secretary shall
25 consult subject matter experts outside the Department of Revenue, both within State
26 government and from private industry. The measurement process shall include:

- 27 (1) Calculation of a revenue baseline against which the increased revenue
28 attributable to the project is measured;
- 29 (2) Periodic evaluation to determine if the baseline needs to be modified based
30 on significant measurable changes in the economic environment; and
- 31 (3) Monthly calculation of increased revenue attributable to contracts executed
32 under this program.

33 Of funds generated from collections above the baseline established by subdivision (1) of
34 this subsection, in both the General and Highway Funds, up to forty-one million dollars
35 (\$41,000,000) may be authorized by the Office of State Budget and Management (i) for the
36 purchases related to the implementation of TIMS and the additional components of the PDP,
37 including payment for services from non-State entities and (ii) toward internal State costs
38 related to the implementation of TIMS and PDP components. The total of any funds expended
39 ~~during the 2009-2011 biennium~~ for implementation of TIMS and the additional PDP
40 components shall not exceed the sum of forty-one million dollars (\$41,000,000).

41 If the Department of Revenue finds that it cannot generate additional benefits totaling
42 forty-one million dollars (\$41,000,000) ~~in the 2009-2011 biennium, through June 30, 2015,~~ the
43 Department shall immediately notify the Chairs of the House of Representatives and Senate
44 Appropriations Committees and Fiscal Research Division, identify any obligations to vendors,
45 identify options for meeting obligations to vendors, and provide costs associated with each
46 option. The Department shall ensure that this notification is made in sufficient time to allow the
47 General Assembly to properly evaluate the options presented.

48 "**SECTION 6.20.(b)** Notwithstanding G.S. 114-2.3, the Department of Revenue shall
49 engage the services of private counsel with the pertinent information technology and computer
50 law expertise to review requests for proposals, and to negotiate and review contracts associated
51 with TIMS and the additional components of the Planning and Design Project (PDP)

1 (Enterprise Data Warehouse, Management Reporting and Decision Analytics, Customer
2 Relationship Management, Enterprise Case Management, and E-Services).

3 "SECTION 6.20.(c) There is established within the Department of Revenue the Oversight
4 Committee for reviewing and approving the benefits measurement methodology and
5 calculation process. The Oversight Committee shall review and approve all contracts executed
6 under this section. This shall include (i) details of each public-private contract, (ii) the benefits
7 from each contract, and (iii) a comprehensive forecast of the benefits of using public-private
8 agreements to implement TIMS and the additional PDP components, including the
9 measurement process established for the Secretary of Revenue. The Oversight Committee shall
10 approve all of the fund transfers for this project.

11 The members of the Committee shall include the following:

- 12 (1) The State Budget Director;
- 13 (2) The Secretary of the Department of Revenue;
- 14 (3) The State Chief Information Officer;
- 15 (4) Two persons appointed by the Governor;
- 16 (5) One member of the general public having expertise in information
17 technology appointed by the General Assembly upon the recommendation of
18 the Speaker of the House of Representatives; and
- 19 (6) One member of the general public having expertise in economic and revenue
20 forecasting appointed by the General Assembly upon recommendation of the
21 President Pro Tempore of the Senate.

22 The State Budget Director shall serve as chair of the Committee. The Committee shall set
23 its meeting schedule and adopt its rules of operation by majority vote. A majority of the
24 members constitutes a quorum. Vacancies shall be filled by the appointing authority.
25 Administrative support staff shall be provided by the Department of Revenue. Members of the
26 Committee shall receive reimbursements for subsistence and travel expenses as provided by
27 Chapter 138 of the General Statutes. The Committee shall terminate on ~~June 30, 2011~~ June 30,
28 2015.

29 "SECTION 6.20.(d) Beginning October 1, 2009 and quarterly thereafter, the Department
30 of Revenue shall submit reports to the Chairs of the House of Representatives and Senate
31 Committees on Appropriation, to the Joint Legislative Oversight Committee on Information
32 Technology, and to the Fiscal Research Division of the Legislative Services Office. The report
33 shall include (i) details of each public-private contract, (ii) the benefits from each contract, (iii)
34 a comprehensive forecast of the benefits of using public-private agreements to implement
35 TIMS and the additional PDP components, including cost savings and the acceleration of the
36 project timeline, (iv) and any issues associated with the operation of the public-private
37 partnership. Within 60 days of implementing the public-private partnership, the Department of
38 Revenue shall provide to the Chairs of the House of Representatives and Senate Appropriations
39 Committees, and Fiscal Research Division, a schedule for vendor payments that identifies
40 sources and amounts of funding anticipated as a result of the project's implementation.

41 "SECTION 6.20.(e) In addition to the oversight provided by the Oversight Committee
42 established in subsection (c) of this section, the TIMS project shall be subject to existing
43 Information Technology project oversight legislation, including, but not limited to,
44 G.S. 147-33.72C and G.S. 147-33.72E."
45

46 FUNDING FOR DATA INTEGRATION ENTERPRISE LICENSING AGREEMENTS

47 SECTION 6.14.(a) If the cost of data integration enterprise licensing agreements
48 for the 2010-2011 fiscal year is in excess of two million dollars (\$2,000,000), the Office of
49 Information Technology Services shall recover the excess cost through cost allocation to
50 participating agencies.

1 **SECTION 6.14.(b)** The State Chief Information Officer shall develop a plan for
2 the equitable distribution of all costs for executive agency data integration enterprise licensing
3 agreements to the participating agencies. By October 1, 2010, the State Chief Information
4 Officer shall present this plan to the Joint Legislative Oversight Committee on Information
5 Technology and shall provide a copy to Fiscal Research Division.

6 **SECTION 6.14.(c)** Beginning with the 2011-2012 fiscal year, all costs for
7 executive agency data integration enterprise licensing agreements shall be allocated to the
8 participating agencies.

9 10 **NETWORK SECURITY ASSESSMENTS**

11 **SECTION 6.15.(a)** G.S. 147-33.111 reads as rewritten:

12 **"§ 147-33.111. State CIO approval of security standards and security assessments.**

13 (a) Notwithstanding G.S. 143-48.3 or any other provision of law, and except as
14 otherwise provided by this section, all information technology security purchased using State
15 funds, or for use by a State agency or in a State facility, shall be subject to approval by the State
16 Chief Information Officer in accordance with security standards adopted under this Article.

17 (a1) The State Chief Information Officer shall conduct assessments of network
18 vulnerability, including network penetration or any similar procedure. The State Chief
19 Information Officer may contract with another party or parties to perform the assessments.
20 Detailed reports of the security issues identified shall be kept confidential as provided in
21 G.S. 132-6.1(c).

22 (b) If the legislative branch, the judicial branch, The University of North Carolina and
23 its constituent institutions, local school administrative units as defined by G.S. 115C-5, or the
24 North Carolina Community Colleges System develop their own security standards, taking into
25 consideration the mission and functions of that entity, that are comparable to or exceed those
26 set by the State Chief Information Officer under this section, then these entities may elect to be
27 governed by their own respective security standards, and approval of the State Chief
28 Information Officer shall not be required before the purchase of information technology
29 security. The State Chief Information Officer shall consult with the legislative branch, the
30 judicial branch, The University of North Carolina and its constituent institutions, local school
31 administrative units, and the North Carolina Community Colleges System in reviewing the
32 security standards adopted by those entities.

33 (c) Before a State agency may enter into any contract with another party for an
34 assessment of network ~~vulnerability, including network penetration or any similar procedure,~~
35 vulnerability, the State agency shall notify the State Chief Information Officer and obtain
36 approval of the request. ~~The State Chief Information Officer shall refer the request to the State~~
37 ~~Auditor for a determination of whether the Auditor's office can perform the assessment and~~
38 ~~testing. If the State Auditor determines that the Auditor's office can perform the assessment and~~
39 ~~testing, then the State Chief Information Officer shall authorize the assessment and testing by~~
40 ~~the Auditor. If the State Auditor determines that the Auditor's office cannot perform the~~
41 ~~assessment and testing, then with the approval of the State Chief Information Officer and State~~
42 ~~Auditor, the State agency may enter into a contract with another party for the assessment and~~
43 ~~testing.~~ after approval of the State Chief Information Officer, the State agency shall issue public reports
44 on the general results of the reviews. The contractor shall provide the State agency with
45 detailed reports of the security issues identified that shall not be disclosed as provided in
46 G.S. 132-6.1(c). The State agency shall provide the State Chief Information Officer ~~and the~~
47 ~~State Auditor~~ with copies of the detailed reports that shall not be disclosed as provided in
48 G.S. 132-6.1(c).
49

1 (d) Nothing in this section shall be construed to preclude the Office of the State Auditor
2 from assessing the security practices of State information technology systems as part of that
3 Office's duties and responsibilities."

4 **SECTION 6.15.(b)** G.S. 147-64.6(c)(18) is repealed.

5
6 **INMATE MEDICAL COST CONTAINMENT**

7 **SECTION 6.16.(a)** Providers and facilities that deliver medically necessary
8 services to inmates in the Department's custody of the Department of Correction shall charge
9 the Department using the same schedule of charges used for other patients, and the Department
10 may reimburse those providers and facilities at up to seventy percent (70%) of the amount
11 charged. The requirements of this subsection shall apply to all medical and facility services
12 provided outside the correctional facility, including hospitalizations, professional services,
13 medical supplies, and other medications provided to any inmate confined in a correctional
14 facility.

15 **SECTION 6.16.(b)** The Department of Correction shall make every effort to
16 contain inmate medical costs by making use of its own hospital and health care facilities to
17 provide health care services to inmates. To the extent that the Department of Correction must
18 utilize other facilities and services to provide health care services to inmates, the Department
19 shall make use of hospitals with available capacity or other health care facilities in a region to
20 accomplish that goal. The Department shall work to ensure that care usage is distributed
21 equitably among all hospitals or other appropriate health care facilities, with no one health care
22 facility being required to admit more than five percent (5%) of all patients requiring
23 hospitalization or hospital services, unless doing so would jeopardize the health of an inmate or
24 unless otherwise agreed to by contract. The Department shall also give preference to those
25 hospitals in the same county or an adjoining county to the correctional facility where an inmate
26 requiring hospitalization is incarcerated.

27 **SECTION 6.16.(c)** The Department of Correction shall consult with the Division
28 of Medical Assistance in the Department of Health and Human Services to develop protocols
29 for prisoners who would be eligible for Medicaid if they were not incarcerated to access
30 Medicaid while in custody or under extended limits of confinement. The Department shall seek
31 reimbursement from Medicaid for those health care costs incurred by the Department in those
32 instances when an inmate's Medicaid eligibility has been temporarily reinstated due to a
33 hospitalization.

34 **SECTION 6.16.(d)** The Department of Correction, in consultation with the Office
35 of State Budget and Management, shall study the impact on inmate medical costs resulting
36 from the measures set forth in subsections (a), (b), and (c) of this section. The Department shall
37 present its findings by March 1, 2011, to the Chairs of the House of Representatives and Senate
38 Appropriations Subcommittees on Justice and Public Safety and to the Joint Legislative
39 Corrections, Crime Control, and Juvenile Justice Oversight Committee.

40 **SECTION 6.16.(e)** If the findings of the Department of Correction demonstrate
41 that the Department has been unable to achieve the savings in inmate medical costs called for in
42 the 2010-2011 budget, the Office of State Budget and Management may require that any
43 hospital that provides health care services to Medicaid and Medicare patients shall also provide
44 services to any inmate confined in a correctional facility at the rates applicable under
45 subsection (a) of this section.

46 **SECTION 6.16.(f)** The Department of Correction shall make every effort to
47 explore other cost containment methods not expressly outlined in this section. These methods
48 may include the following:

- 49 (1) Contracting with a private third party to manage and provide all inmate
50 medical services;

- 1 (2) Partnering with the federal government to allow for treatment of State
2 inmates in federal correctional hospitals; and
3 (3) Purchasing a fixed number of beds at a hospital.

4 **SECTION 6.16.(g)** The Department of Correction shall report to the Joint
5 Legislative Corrections, Crime Control, and Juvenile Justice Oversight Committee no later than
6 October 1, 2010, on

- 7 (1) The Department's progress with the RFP process initiated pursuant to
8 Section 19.20(b) of S.L. 2009-451, as rewritten by Section 15A of S.L.
9 2009-575, to contract for claims processing, medical management services,
10 and the development and management of a medical professional and facility
11 provider network.

- 12 (2) The anticipated effects on medical care provided to inmates as a result of the
13 new hospital at Central Prison and the updated facilities at the North
14 Carolina Correctional Institute for Women, as well as any other new medical
15 services capacity within the Department. Specifically, the Department shall
16 report on:

- 17 a. The types and volumes of services that the new and updated facilities
18 will provide that previously would have been provided by
19 community providers; and
20 b. The projected types and volumes of services that will still be referred
21 to community providers.

22 The report shall also address changes in statewide inmate custody that are
23 needed to maximize the utilization of the new facilities and the Department's
24 ability to contract with community providers with the available capacity
25 throughout the State.

26 **SECTION 6.16.(h)** The Department of Correction shall report to the Joint
27 Legislative Commission on Governmental Operations no later than October 1, 2010, and
28 quarterly thereafter on:

- 29 (1) The volume of services provided by community medical providers that can
30 be scheduled in advance and, of that volume, the percentage of those
31 services that are provided by contracted providers; and
32 (2) The volume of services provided by community medical providers that
33 cannot be scheduled in advance and, of that volume, the percentage of those
34 services that are provided by contracted providers.

35 **SECTION 6.16.(i)** Section 19.20(a) of S.L. 2009-451, as amended by Section 15A
36 of S.L. 2009-575, is repealed.

37 38 **PART VII. PUBLIC SCHOOLS**

39 40 **FUNDS FOR CHILDREN WITH DISABILITIES**

41 **SECTION 7.1.** The State Board of Education shall allocate additional funds for
42 children with disabilities on the basis of three thousand five hundred ninety-eight dollars and
43 fifty-five cents (\$3,598.55) per child. Each local school administrative unit shall receive funds
44 for the lesser of (i) all children who are identified as children with disabilities or (ii) twelve and
45 five-tenths percent (12.5%) of the 2010-2011 allocated average daily membership in the local
46 school administrative unit. The dollar amounts allocated under this section for children with
47 disabilities shall also adjust in accordance with legislative salary increments, retirement rate
48 adjustments, and health benefit adjustments for personnel who serve children with disabilities.

49 50 **FUNDS FOR ACADEMICALLY GIFTED CHILDREN**

1 **SECTION 7.2.** The State Board of Education shall allocate additional funds for
2 academically or intellectually gifted children on the basis of one thousand one hundred
3 ninety-two dollars and ninety cents (\$1,192.90) per child. A local school administrative unit
4 shall receive funds for a maximum of four percent (4%) of its 2010-2011 allocated average
5 daily membership, regardless of the number of children identified as academically or
6 intellectually gifted in the unit. The dollar amounts allocated under this section for
7 academically or intellectually gifted children shall also adjust in accordance with legislative
8 salary increments, retirement rate adjustments, and health benefit adjustments for personnel
9 who serve academically or intellectually gifted children.

10 11 **STATE FISCAL STABILIZATION FUND APPROPRIATION**

12 **SECTION 7.3.** In order to ensure compliance with the requirements of Title XIV
13 of the American Recovery and Reinvestment Act of 2009 and notwithstanding any other
14 provision of law, the Office of State Budget and Management shall adjust the State Fiscal
15 Stabilization Fund appropriation amounts, including any associated budget reductions, between
16 the State Public School Fund and The University of North Carolina budget to align with the
17 requirements of the North Carolina State Fiscal Stabilization Fund application as amended for
18 2010-2011.

19 20 **NORTH CAROLINA VIRTUAL PUBLIC SCHOOLS ALLOTMENT FORMULA**

21 **SECTION 7.4.(a)** The State Board of Education shall implement an allotment
22 formula for the North Carolina Virtual Public Schools (NCVPS) beginning with the 2010-2011
23 school year. In accordance with Section 7.16 of S.L. 2006-66, the allotment formula shall
24 create a sustainable source of funding that increases commensurate with student enrollment and
25 recognizes "the extent to which projected enrollment in e-learning courses affects funding
26 required for other allotments that are based on ADM."

27 **SECTION 7.4.(b)** The State Board shall use only funds provided through the
28 North Carolina Virtual Public Schools Allotment Formula to fund NCVPS.

29 **SECTION 7.4.(c)** The Department of Public Instruction shall take the following
30 steps to implement the North Carolina Virtual Public Schools Allotment Formula:

- 31 (1) Project the unduplicated NCVPS enrollment for each local school
32 administrative unit and for each grade level.
- 33 (2) Divide the projected unduplicated NCVPS enrollment for each unit by six in
34 order to calculate its ADM-equivalent student enrollment in NCVPS.
- 35 (3) Reduce the unit's ADM allotments by seventy-five percent (75%) of its
36 ADM-equivalent student enrollment in NCVPS.
- 37 (4) Transfer a dollar amount equal to seventy-five percent (75%) of the unit's
38 ADM-equivalent student enrollment to NCVPS.

39 NCVPS shall use the funds transferred to it to provide the NCVPS program at no
40 cost to all high school students in North Carolina who are enrolled in North Carolina's public
41 schools, Department of Defense schools, and schools operated by the Bureau of Indian Affairs.

42 **SECTION 7.4.(d)** NCVPS shall provide only high school courses.

43 **SECTION 7.4.(e)** The Director of NCVPS shall continue to ensure that course
44 quality standards are established and met and that all e-learning opportunities offered by
45 State-funded entities to public school students are consolidated under the North Carolina
46 Virtual Public School program, eliminating course duplication.

47 48 **MORE AT FOUR PROGRAM**

49 **SECTION 7.5.(a)** The Department of Public Instruction shall continue the
50 implementation of the More at Four prekindergarten program for four-year-olds who are at risk
51 for school failure in all counties. The State prekindergarten program shall serve children who

1 reach the age of four on or before August 31 of that school year and who meet eligibility
2 criteria that indicate a child's risk for school failure. Prekindergarten classrooms shall be
3 operated in public schools, Head Start programs, and licensed child care facilities that choose to
4 participate under procedures defined by the Office of Early Learning within the Department of
5 Public Instruction. All such classrooms shall be subject to the supervision of the Office of Early
6 Learning and shall be operated in accordance with standards adopted by the State Board of
7 Education.

8 **SECTION 7.5.(b)** The Office of Early Learning shall specify program standards
9 and requirements addressing:

- 10 (1) Early learning standards and curricula;
- 11 (2) Teacher education and specialized training;
- 12 (3) Teacher in-service training and professional development;
- 13 (4) Maximum class size;
- 14 (5) Staff-child ratio;
- 15 (6) Screenings, referrals, and support services;
- 16 (7) Meals; and
- 17 (8) Monitoring of sites to demonstrate adherence to State programs standards.

18 **SECTION 7.5.(c)** The State Board of Education shall submit an annual report no
19 later than March 15 of each year to the Joint Legislative Commission on Governmental
20 Operations, the Joint Legislative Education Oversight Committee, the Senate Appropriations
21 Committee on Education, the House of Representatives Appropriations Subcommittee on
22 Education, the Office of State Budget and Management, and the Fiscal Research Division. The
23 report shall include the following:

- 24 (1) The number of children participating in State prekindergarten.
- 25 (2) The number of children participating in State prekindergarten who have
26 never been served in other early education programs, such as child care,
27 public or private preschool, Head Start, Early Head Start, or early
28 intervention programs.
- 29 (3) The expected State prekindergarten expenditures for the programs and the
30 source of the local contributions.
- 31 (4) The results of an annual evaluation of the program.

32 **SECTION 7.5.(d)** The Office of Early Learning shall establish income eligibility
33 requirements for the program not to exceed seventy-five percent (75%) of the State median
34 income. Up to twenty percent (20%) of children enrolled may have family incomes in excess of
35 seventy-five percent (75%) of median income if they have other designated risk factors.
36 Furthermore, any age-eligible child of (i) an active duty member of the armed forces of the
37 United States, including the North Carolina National Guard, State military forces, or a reserve
38 component of the armed forces who is ordered to active duty by the proper authority within the
39 last 18 months or expected to be ordered within the next 18 months or (ii) a member of the
40 armed forces of the United States, including the North Carolina National Guard, State military
41 forces, or a reserve component of the armed forces, who was injured or killed while serving on
42 active duty, shall be eligible for the program.

43 **SECTION 7.5.(e)** The More at Four program funding shall not supplant any
44 funding for classrooms serving four-year-olds as of the 2005-2006 fiscal year. Support of
45 existing four-year-old classrooms with More at Four program funding shall be permitted when
46 current funding is eliminated, reduced, or redirected as required to meet other specified federal
47 or State mandates.

48 **SECTION 7.5.(f)** The Office of Early Learning shall develop a new More at Four
49 funding model to be implemented in the 2010-2011 fiscal year. The per-child funding rates
50 shall be based on participating provider cost structures and shall require a contribution of local
51 resources to support the full cost of providing high quality prekindergarten. The Office of Early

1 Learning shall implement an administrative cap on More at Four program funding and shall
2 establish parameters for allowable administrative costs.

3 **SECTION 7.5.(g)** The Office of Early Learning shall contract with an independent
4 research organization not affiliated with the Department of Health and Human Services, the
5 Department of Public Instruction, the Office of the Governor, or any entity currently funded by
6 or affiliated with the Department of Health and Human Services, the Department of Public
7 Instruction, or the Office of the Governor to produce an annual report to include longitudinal
8 review of the More at Four program and academic, behavioral, and other child-specific
9 outcomes. The review shall include a quasi-experimental research design of a representative
10 sample of children who complete the More at Four program every year and shall report on their
11 sustained progress until the end of grade 9. The review shall also study a representative sample
12 of children who do not enter the More at Four program but who are of the same grade level and
13 demographic as those who complete the program, and their sustained progress shall also be
14 reviewed until the end of grade 9. The review shall be presented to the Joint Legislative
15 Oversight Committee on Education by January 31 of every year.

16 17 **LEADERSHIP ACADEMY**

18 **SECTION 7.6.** Of the funds appropriated in this act to the Department of Public
19 Instruction for the 2010-2011 fiscal year, up to two hundred thousand dollars (\$200,000) may
20 be used to support a Leadership Academy that provides professional development to
21 superintendents enabling them to train principals to address critical areas such as student
22 achievement and teacher recruitment and retention.

23 24 **DEPARTMENT OF PUBLIC INSTRUCTION**

25 **SECTION 7.7.(a)** The Department of Public Instruction is not required to
26 eliminate receipt-supported positions for the 2010-2011 fiscal year.

27 **SECTION 7.7.(b)** The Department of Public Instruction shall review expenditures
28 of federal funds for personnel and contracts at the State level. Unless the expenditure is a
29 condition of receiving the funds, the Department shall reallocate the funds to local school
30 administrative units whenever possible.

31 The Department shall report on the reallocation of these funds to local school
32 administrative units, to the Office of the Governor, the chairs of the House of Representatives
33 Committee on Appropriations and the House of Representatives Appropriations Subcommittee
34 on Education, the chairs of the Senate Committee on Appropriations/Base Budget and the
35 Senate Appropriations Committee on Education/Higher Education, and the Office of State
36 Budget and Management no later than January 15, 2011.

37 38 **CAREER AND COLLEGE – READY, SET, GO!**

39 **SECTION 7.8.(a)** The State Board of Education shall work with all member
40 institutions of the Education Cabinet and the Joint Governing Boards to focus funding and
41 program priorities to ensure that all North Carolina students graduate prepared to successfully
42 pursue a career or further education. Each Education Cabinet Institution shall prioritize the
43 Governor's Ready, Set, Go! initiative and ensure that all students PK-20:

- 44 (1) Are prepared to be successful in school and can successfully progress
45 through PK-20 education. This includes, but is not limited to:
- 46 a. Establishment of the Governor's Child Advocacy Council to increase
47 ways for all children to come to school healthy and ready to learn;
 - 48 b. Investment in early child development programs like Smart Start and
49 More at Four;
 - 50 c. Investment in smaller class sizes in K-3;

- 1 d. Implementation of student diagnostics in grades K-3 and 5 to ensure
2 that all students at a minimum possess grade-level reading, writing,
3 and math skills;
- 4 e. Implementation of student diagnostics for career and college
5 readiness in grades 8 and 11 so students graduate prepared for work,
6 college, or technical training; and
- 7 f. Implementation of the Student Learning Conditions Survey for
8 grades 7, 9, and 11 that is aligned with the Teacher Working
9 Conditions Survey.
- 10 (2) Receive clear standards and high expectations, and benefit from the best
11 teachers and principals that can most effectively help students reach those
12 standards. This includes, but is not limited to:
- 13 a. Adoption of the State-led National Common Standards, including
14 Career and College Ready Skills and assessments that prepare
15 students for the global economy;
- 16 b. Evaluation of Teacher Preparation programs to identify best practices
17 and programs that produce effective teachers;
- 18 c. Increased access to virtual learning opportunities for students and
19 teachers like those provided through the NC Virtual Public School;
- 20 d. Increased access to Science, Technology, Engineering and
21 Mathematics (STEM) opportunities;
- 22 e. Development of leadership academies that recruit and prepare
23 effective principals;
- 24 f. Development of a PK-20 data system to provide comprehensive
25 information on students;
- 26 g. Reduction and eventual elimination of low-performing status in
27 North Carolina schools; and
- 28 h. Job-imbedded professional development for teachers and principals.
- 29 (3) Fully understand and complete the prerequisites for the career, certification,
30 or degree of choice that promotes workforce success. This includes, but is
31 not limited to:
- 32 a. Development of academic boot camps for high school students who
33 need additional support in reading, composition, and math;
- 34 b. Consolidation of high school transition courses to provide high
35 school students with more college level or career and technical
36 courses;
- 37 c. Increased access to virtual college level and specific career and
38 technical courses for high school students;
- 39 d. Alignment between high school and college curricula so that all
40 students are prepared for higher education work; and
- 41 e. Implementation of NCSuccess, a program designed to increase the
42 number of certificates and associate or bachelor's degrees in higher
43 education.

44 **SECTION 7.8.(b)** The Education Cabinet shall report by January 15, 2011, to the
45 Office of the Governor, the Joint Governing Boards, and the Joint Education Oversight
46 Committee on its progress toward reaching the Governor's goal that every North Carolina
47 student will graduate ready to be successful in a career, a 2- or 4-year college, or technical
48 training.

49
50 **SCHOOL CONNECTIVITY INITIATIVE**

1 **SECTION 7.9.** Section 7.12.(a) of S.L. 2009-451, as rewritten by Section 3E of
2 S.L. 2009-575, is repealed.

3 4 **SCHOOL CALENDAR PILOT PROGRAM**

5 **SECTION 7.10.** Section 7.40 of S.L. 2009-451 reads as rewritten:

6 **"SECTION 7.40.** The State Board of Education shall establish a school calendar pilot
7 program in the Wilkes County Schools. The purpose of the pilot program is to determine
8 whether and to what extent a local school administrative unit can save money during this
9 extreme fiscal crisis by consolidating the school calendar.

10 Notwithstanding G.S. 115C-84.2(a)(1), the school calendar for the 2009-2010 ~~calendar~~
11 ~~year~~ and the 2010-2011 calendar years for the Wilkes County Schools shall include a minimum
12 of 180 days or 1,000 hours of instruction covering at least nine calendar months.
13 Notwithstanding G.S. 115C-84.2(d), the opening date for students shall not be before August
14 24.

15 If the Wilkes County Board of Education adds instructional hours to previously scheduled
16 days under this section, the local school administrative unit is deemed to have a minimum of
17 180 days of instruction and teachers employed for a 10-month term are deemed to have been
18 employed for the days being made up and shall be compensated as if they had worked the days
19 being made up.

20 The State Board of Education shall report to the Joint Legislative Education Oversight
21 Committee by March 15, ~~2010~~, 2011, on the administration of the pilot program, cost-savings
22 realized by it, and its impact on student achievement."

23 24 **NATIONAL BOARD FOR PROFESSIONAL TEACHING STANDARDS (NBPTS)** 25 **FUNDS**

26 **SECTION 7.11.(a)** G.S. 115C-296.2(d1) reads as rewritten:

27 "(d1) Repayment of the Application Fee. – A teacher shall repay the application fee to the
28 State Education Assistance Authority within three years. The State Education Assistance
29 Authority may forgive the loan upon the death or permanent disability of the teacher.

30 All funds appropriated to, or otherwise received by, the Authority to provide loans to
31 teachers pursuant to this section, all funds received as repayment of loans, and all interest
32 earned on these funds shall be placed in a trust fund. This fund shall be used only for loans
33 made pursuant to this section and administrative costs of the Authority."

34 **SECTION 7.11.(b)** The State Board of Education shall transfer funds in the
35 amount of three million two hundred seventy-four thousand five hundred dollars (\$3,274,500)
36 from the State Public School Fund to the State Education Assistance Authority for the
37 2010-2011 fiscal year for NBPTS loans. It is the intent of the General Assembly that these
38 funds are included in the certified budget for the State Education Assistance Authority for the
39 2011-2012 fiscal year and subsequent fiscal years.

40 41 **DRIVER EDUCATION**

42 **SECTION 7.12.** The Highway Safety Research Center Institute of the University
43 of North Carolina at Chapel Hill shall work in collaboration with the Department of Public
44 Instruction and the Governor's Highway Safety Commission to create a standard curriculum to
45 be used for the Driver Education Program in the Department of Public Instruction. The
46 curriculum shall be ready for use in the school year beginning in the fall of 2011 and shall be
47 used for all driver education programs funded with State funds.

48 **PROTECTION OF THE CLASSROOM WHILE MAXIMIZING FLEXIBILITY**

49 **SECTION 7.13.(a)** Section 7.8 of S.L. 2009-451 reads as rewritten:

50 **"SECTION 7.8.(a)** The State Board of Education is authorized to adopt emergency rules
51 in accordance with G.S. 150B-21.1A to grant maximum flexibility to local school

1 administrative units regarding the expenditure of State funds. These rules shall not be subject to
2 the limitations on transfers of funds between funding allotment categories set out in
3 G.S. 115C-105.25. These rules:

- 4 (1) Shall authorize the transfer of textbook funds to other allotments to manage
5 funding cuts; and
- 6 (2) Shall not permit the transfer of funds from school-based positions to the
7 central office.

8 "**SECTION 7.8.(b)** ~~For fiscal years 2009-2010 and 2010-2011, For the 2010-2011 fiscal~~
9 ~~year, local school administrative units shall make every effort to reduce spending whenever and~~
10 ~~wherever such budget reductions are appropriate with the goal of to protecting protect direct~~
11 ~~classroom-services services, and services for students at risk and children with special needs.~~
12 Local school administrative units shall implement administrative and other operating
13 efficiencies ~~prior to and minimize~~ the dismissal of classroom-based ~~personnel-personnel~~. Local
14 school administrative units shall maximize federal ~~by maximizing~~ funds received from the
15 including American Recovery and Reinvestment Act of 2009 (ARRA), P.L. 111-5; Keep Our
16 Educators Working Act or any other federal act that provides funding that can be expended on
17 positions; Individuals with Disabilities Act (IDEA); Title I; and Title II funds. Local school
18 administrative units are encouraged to designate all Title I-eligible schools and must maximize
19 attrition prior to the dismissal of classroom-based personnel. Notwithstanding G.S. 115C-301
20 or any other law, local school administrative units shall have the maximum flexibility to use
21 allotted teacher positions to maximize student achievement in grades 4-12. Allocation of
22 teachers and class size requirements in grades K-3 shall remain unchanged.

23 "**SECTION 7.8.(c)** Within 14 days of the date this act becomes law, the State Board of
24 Education shall notify each local school administrative unit and charter school of the amount
25 the unit must reduce from the State General Fund appropriations. The State Board shall
26 determine the amount of the reduction for each unit on the basis of average daily membership.

27 "**SECTION 7.8.(d)** Each unit shall report to the State Board of Education, the Office of
28 State Budget and Management, and the Department of Public Instruction on the flexibility
29 budget reductions it has identified for the unit, including an explanation of how administrative
30 efficiencies, federal funds, and attrition have been maximized prior to the dismissal of
31 classroom-based personnel, within 30 days of the date this act becomes law."

32 **SECTION 7.13.(b)** For fiscal year 2010-2011, local boards of education may also
33 implement furloughs in accordance with Section 29.1 of this act to manage funding amounts.
34

35 PROBATIONARY TEACHERS

36 **SECTION 7.14.(a)** G.S. 115C-325(c)(5) reads as rewritten:

- 37 "(5) Consecutive Years of Service. – If a probationary teacher in a full-time
38 permanent position does not work for at least 120 workdays in a school year
39 because the teacher is on sick leave, disability leave, or both, that school
40 year shall not be deemed to constitute (i) a consecutive year of service for
41 the teacher or (ii) a break in the continuity in consecutive years of service for
42 the teacher.

43 If a probationary teacher in a full-time permanent position resigns or is
44 not renewed because of a reduction in force and is subsequently rehired by
45 the same school system within three years, there shall be deemed to be no
46 break in the continuity in consecutive years of service for such teacher up to
47 a maximum of three consecutive years towards career status. If, at the time
48 the teacher resigns or is not renewed because of a reduction in force, the
49 teacher had been employed by a school system for four consecutive years
50 pursuant to G.S. 115C-325(c)(1), or one year pursuant to
51 G.S. 115C-325(c)(2), and the board subsequently rehires such teacher within

1 three years, the board may grant career status immediately upon
2 reemploying the teacher, or vote on the teacher's career status pursuant to
3 G.S. 115C-325(c)(1) or (c)(2) after one additional year of employment."

4 **SECTION 7.14.(b)** This act is effective when it becomes law and applies to
5 probationary teacher employed by a local school administrative unit in a full-time permanent
6 position for the 2010-2011 school year.

8 **LEARN AND EARN ONLINE**

9 **SECTION 7.15.** Section 7.10(j) of S.L. 2009-451 reads as rewritten:

10 **"SECTION 7.10.(j)** For the 2009-2011 biennium, high school students attending a
11 nonpublic school may enroll in any Learn and Earn Online ~~course with space available that has~~
12 ~~been offered to but not filled by any eligible public school student.~~ course. Notwithstanding
13 subsection (h) of this section, nonpublic school students shall be responsible for supplying their
14 own textbooks and other instructional materials."

16 **PART VIII COMMUNITY COLLEGES**

18 **CARRYFORWARD OF COLLEGE INFORMATION SYSTEM FUNDS**

19 **SECTION 8.1.(a)** Of the funds appropriated to the Community Colleges System
20 Office for the 2009-2011 fiscal biennium for the College Information System, up to one million
21 two hundred fifty thousand dollars (\$1,250,000) shall not revert at the end of each fiscal year
22 but shall remain available until expended. These funds may only be used to purchase periodic
23 system upgrades.

24 **SECTION 8.1.(b)** This section becomes effective June 30, 2010.

26 **STATE AID BUDGET FLEXIBILITY**

27 **SECTION 8.2.** G.S. 115D-31 is amended by adding a new subsection to read:

28 "(b1) A local community college may use all State funds allocated to it, except for
29 Literacy funds and Customized Training funds, for any authorized purpose that is consistent
30 with the college's Institutional Effectiveness Plan. Each local community college shall include
31 in its Institutional Effectiveness Plan a section on how funding flexibility allows the college to
32 meet the demands of the local community and to maintain a presence in all previously funded
33 categorical programs."

35 **TUITION FOR PRISON INMATES**

36 **SECTION 8.3.(a)** Funds are appropriated to the Department of Correction in
37 Section 2.1 of this act to provide courses for inmates in State prisons. These funds shall be
38 used only for courses that are known to reduce recidivism.

39 Courses provided in federal prisons or local jails shall be offered on a
40 self-supporting basis.

41 **SECTION 8.3.(b)** The Department of Correction and the Community Colleges
42 System Office shall report to the 2011 General Assembly on:

43 (1) The implementation of the new funding structure and requirements.

44 (2) Strategies for implementing their recommendations to:

45 a. Enhance measurable goals, objectives, and outcomes.

46 b. Enhance and standardize data collection.

47 c. Strengthen the continuum of programming from entry to exit, based
48 on assessment of skills and needs.

49 d. Give individuals the opportunity to use specific skills through work
50 assignments that meet system needs.

51 e. Tailor programs to specific inmate needs.

- 1 f. Increase Cognitive Behavioral Interventions (CBI) courses.
 2 g. Develop an offender-specific human resources development course.
 3 h. Explore additional funding sources.
 4 i. Explore federal grant for wiring courses.
 5 (3) Strategies for reasonably limiting the number of courses an individual takes
 6 while in prison.

7 **SECTION 8.3.(c)** The Office of State Budget and Management shall transfer
 8 sufficient funds from the Department of Correction to the Community Colleges System Office
 9 to pay for inmates' tuition for the Fall 2010 semester.

10 TUITION WAIVERS

11 **SECTION 8.4.(a)** G.S. 115D-5(b) reads as rewritten:

12 "(b) In order to make instruction as accessible as possible to all citizens, the teaching of
 13 curricular courses and of noncurricular extension courses at convenient locations away from
 14 institution campuses as well as on campuses is authorized and shall be encouraged. A pro rata
 15 portion of the established regular tuition rate charged a full-time student shall be charged a
 16 part-time student taking any curriculum course. In lieu of any tuition charge, the State Board of
 17 Community Colleges shall establish a uniform registration fee, or a schedule of uniform
 18 registration fees, to be charged students enrolling in extension courses for which instruction is
 19 financed primarily from State funds; ~~provided, however, that the funds.~~ The State Board of
 20 Community Colleges may provide by general and uniform regulations for waiver of tuition and
 21 registration fees for persons for:

- 22 (1) Persons not enrolled in elementary or secondary schools taking courses
 23 leading to a high school diploma or equivalent ~~certificate, for training~~
 24 ~~certificate;~~
 25 (2) Training courses for (i) volunteer firemen, (ii) local fire department
 26 personnel, (iii) volunteer rescue and lifesaving department personnel, (iv)
 27 local rescue and lifesaving department personnel, (v) Radio Emergency
 28 Associated Citizens Team (REACT) members when the REACT team is
 29 under contract to a county as an emergency response agency, ~~local~~ (vi)
 30 municipal, county, State, or federal law-enforcement officers, provided that
 31 the permanent duty station of the officers is within North Carolina, patients
 32 in State alcoholic rehabilitation centers, (vii) all full-time custodial
 33 employees of the Department of Correction, and (viii) employees of the
 34 Department's Division of Community Corrections and employees of the
 35 Department of Juvenile Justice and Delinquency Prevention required to be
 36 certified under Chapter 17C of the General Statutes and the rules of the
 37 Criminal Justice and Training Standards Commission, Commission;
 38 (3) Patients in State alcoholic rehabilitation centers; trainees
 39 (4) Trainees enrolled in courses conducted under the ~~New and Expanding~~
 40 ~~Industry Program, clients~~ Customized Training Program;
 41 (5) Clients of sheltered ~~workshops, clients~~ workshops;
 42 (6) Clients of adult developmental activity ~~programs, students~~ programs;
 43 (7) Students in Health and Human Services Development ~~Programs,~~
 44 ~~juveniles~~ Programs;
 45 (8) Juveniles of any age committed to the Department of Juvenile Justice and
 46 Delinquency Prevention by a court of competent ~~jurisdiction,~~
 47 ~~members~~ jurisdiction;
 48 (9) Members of the North Carolina State Defense Militia as defined in
 49 G.S. 127A-5 and as administered under Article 5 of Chapter 127A of the
 50 General Statutes, ~~and elementary~~ Statutes;
 51

- 1 (10) Elementary and secondary school employees enrolled in courses in first aid
2 or cardiopulmonary resuscitation (CPR). ~~Provided further, tuition shall be~~
3 ~~waived for up (CPR);~~
4 (11) Up to six hours of credit instruction and 96 contact hours one course of
5 noncredit instruction per academic semester for senior citizens age 65 or
6 older who are qualified as legal residents of North Carolina. ~~Provided~~
7 ~~further, tuition shall also be waived for all Carolina;~~
8 (12) All courses taken by high school students at community colleges, including
9 students in early college and middle college high school programs, in
10 accordance with G.S. 115D-20(4) and this ~~section.~~ section; and
11 (13) Human resources development courses for any individual who (i) is
12 unemployed; (ii) has received notification of a pending layoff; (iii) is
13 working and is eligible for the Federal Earned Income Tax Credit (FEITC);
14 or (iv) is working and earning wages at or below two hundred percent
15 (200%) of the federal poverty guidelines."

16 **SECTION 8.4.(b)** The Community Colleges System Office shall report to the 2011
17 General Assembly on the number and cost of courses taken by State law enforcement officers
18 and of courses taken by local law enforcement officers.

19 **SECTION 8.4.(c)** The Community Colleges System Office shall make a
20 comprehensive study of the currently authorized tuition waivers and shall report to the 2011
21 General Assembly on waivers that should be modified or abolished because they are not being
22 used or for other reasons.

23

24 **COMMUNITY COLLEGE FINANCIAL AID LOANS**

25 **SECTION 8.5.(a)** The State Board of Community Colleges shall permanently
26 realign its funding formula by increasing the amount allocated in the funding formula for
27 students' services by fifty million dollars (\$50,000,000) and by reducing the amount in the
28 funding formula for curriculum and continuing education instruction by a commensurate
29 amount. The revised formula shall ensure that community colleges have the adequate funds
30 and resources necessary to administer and provide financial aid services to students.

31 **SECTION 8.5.(b)** G.S. 115D-40.1 reads as rewritten:

32 **"§ 115D-40.1. Financial Assistance for Community College Students.**

33 (a) Need-Based Assistance Program. – It is the intent of the General Assembly that the
34 Community College System make these financial aid funds available to the neediest students
35 who are not eligible for other financial aid programs that fully cover the required educational
36 expenses of these students. The State Board may use some of these funds as short-term loans to
37 students who anticipate receiving the federal HOPE or Lifetime Learning Tax Credits.

38 (b) Targeted Assistance. – Notwithstanding subsection (a) of this section, the State
39 Board may allocate no more than ten percent (10%) of the funds appropriated for Financial
40 Assistance for Community College Students to:

- 41 (1) Students who do not qualify for need-based assistance but who enroll in
42 low-enrollment programs that prepare students for high-demand
43 occupations, and
44 (2) Students with disabilities who have been referred by the Division of
45 Vocational Rehabilitation and are enrolled in a community college.

46 (c) Administration of Program. – The State Board shall adopt rules and policies for the
47 disbursement of the financial assistance provided in subsections (a) and (b) of this section.
48 Degree, diploma, and certificate students must complete a Free Application for Federal Student
49 Aid (FAFSA) to be eligible for financial assistance. The State Board may contract with the
50 State Education Assistance Authority for administration of these financial assistance funds.

1 These funds shall not revert at the end of each fiscal year but shall remain available until
2 expended for need-based financial assistance. The

3 ~~The State Board shall ensure that at least one counselor is available at each college to~~
4 ~~inform students about federal programs and funds available to assist community college~~
5 ~~students including, but not limited to, Pell Grants and HOPE and Lifetime Learning Tax~~
6 ~~Credits and to actively encourage students to utilize these federal programs and funds. The~~
7 ~~interest earned on the funds provided in subsections (a) and (b) of this section may be used to~~
8 ~~support the costs of administering the Community College Grant Program.~~

9 (d) Participation in Federal Loan Programs. – All community colleges shall participate
10 in the William D. Ford Federal Direct Loan Program. The State Board shall ensure that at least
11 one counselor is available at each college to inform students about federal programs and funds
12 available to assist community college students, including, but not limited to, Pell Grants, HOPE
13 and Lifetime Learning Tax Credits, and the William D. Ford Federal Direct Loan Program, and
14 to actively encourage students to utilize these federal programs and funds."

15 **SECTION 8.5.(c)** Subsection (b) of this section becomes effective July 1, 2011.
16 The remainder of this section becomes effective July 1, 2010.

17 18 **TUITION REFUNDS**

19 **SECTION 8.6.(a)** A refund of community college tuition shall not be made except
20 under the following circumstances:

- 21 (1) A one hundred percent (100%) refund shall be made if the student officially
22 withdraws prior to the first day of class of the academic semester or term as
23 noted in the college calendar. Also, a student is eligible for a 100 percent
24 refund if the class in which the student is officially registered is cancelled
25 due to insufficient enrollment.
- 26 (2) A seventy-five percent (75%) refund shall be made if the student officially
27 withdraws from the class prior to or on the official ten percent (10%) point
28 of the semester.
- 29 (3) For classes beginning at times other than the first week (seven calendar
30 days) of a semester a one hundred percent (100%) refund shall be made if
31 the student officially withdraws from the class prior to the first class
32 meeting. A seventy-five percent (75%) refund shall be made if the student
33 officially withdraws from the class prior to or on the ten percent (10%) point
34 of the class.
- 35 (4) A one hundred percent (100%) refund shall be made if the student officially
36 withdraws from a contact hour class prior to the first day of class of the
37 academic semester or term or if the college cancels the class. A seventy-five
38 percent (75%) shall be made if the student officially withdraws from a
39 contact hour class on or before the tenth calendar day of the class.

40 **SECTION 8.6.(b)** To comply with applicable federal regulations regarding
41 refunds, federal regulations supersede the provisions of this section.

42 **SECTION 8.6.(c)** Where a student, having paid the required tuition for a semester,
43 dies during that semester (prior to or on the last day of examinations of the college the student
44 was attending), all tuition and fees for that semester may be refunded to the estate of the
45 deceased.

46 **SECTION 8.6.(d)** Community colleges shall adopt local refund policies for classes
47 for which they collect receipts which are not required to be deposited into the State Treasury
48 account.

49 50 **MANAGEMENT FLEXIBILITY REDUCTION/COMMUNITY COLLEGES**

51 **SECTION 8.7.** Section 8.24 of S.L. 2009-451 reads as rewritten:

1 "SECTION 8.24. The management flexibility reduction for the North Carolina Community
2 College System shall be allocated by the State Board of Community Colleges in a manner that
3 accounts for the unique needs of each college and provides for the equitable distribution of
4 funds to the institutions consistent with G.S. 115D-5(a). Before taking reductions to
5 instructional budgets, the community colleges shall consider reducing budgets for senior and
6 middle management personnel and for programs that have both low-enrollment and
7 low-postgraduate success. Colleges shall minimize the impact on student support services and
8 on the retraining of dislocated workers. Colleges shall not reduce funding for the Small
9 Business Centers. The community colleges shall also review their institutional funds to
10 determine whether there are monies available in those funds that can be used to assist with
11 operating costs before taking reductions in instructional budgets."
12

13 PART IX. UNIVERSITIES

14 15 REPEAL ESCHEAT FUND APPROPRIATION FOR MILLENNIUM TEACHING 16 SCHOLARSHIP LOAN PROGRAM

17 SECTION 9.1. Section 9.1.(c) of S.L. 2009-451 is repealed.
18

19 STUDY FINANCIAL AID CONSOLIDATION

20 SECTION 9.2.(a) The State Education Assistance Authority, The University of
21 North Carolina, the North Carolina Community College System, and the Fiscal Research
22 Division of the General Assembly shall establish a work group to study jointly the
23 simplification and consolidation of State-funded financial aid for students. North Carolina
24 Independent Colleges and Universities, Inc., shall also be included as a joint member of the
25 work group if it chooses to participate in the study. The State Education Assistance Authority
26 shall be the lead agency for the work group and study.

27 SECTION 9.2.(b) The purpose of the study is to develop recommendations and
28 options for simplifying and consolidating the delivery of, administration of, and access to
29 State-funded financial aid for students. In conducting the study, the work group shall consider
30 the State's current student financial aid programs and how to consolidate those programs into
31 two categories of State-funded student aid programs: one program that consolidates the State's
32 major need-based programs and one program that consolidates many of the State's scholarship
33 and forgivable loan programs currently available to students who plan to earn degrees and
34 pursue careers in certain professional areas. More specifically the work group shall do the
35 following:

- 36 (1) Design a unified need-based financial aid program that combines at a
37 minimum the following three programs into a single need-based financial aid
38 program: The University of North Carolina Need-Based Grant program, the
39 North Carolina Community College Grant program, and the North Carolina
40 Education Lottery Scholarship program established under Article 35A of
41 Chapter 115C of the General Statutes. Currently each of these programs has
42 its own award criteria, formulas, target populations, and funding sources
43 (Escheat Fund, General Fund, and Lottery Funds). As part of its study, the
44 work group shall determine what the appropriate parameters may be for such
45 a unified program by using models that take into account income, expected
46 family contribution, college expenses, type of college attended, and any
47 other factors the work group deems relevant. In designing the program, the
48 work group shall address the issue of proportionality of funding and shall
49 take into account all of the following in its consideration of that issue: the
50 proportionality of funding that currently exists among The University of
51 North Carolina, the North Carolina Community College System, and the

1 North Carolina private colleges and universities; funding sources;
2 accounting for student enrollment change; monetary differences between
3 certain categories of students and whether based on those monetary
4 differences student financial aid should be based on cost of attendance or
5 tuition and fees. The work group may also consider whether it is appropriate
6 to redefine "need" for purposes of student financial aid and to develop a
7 common formula for the distribution of financial aid and the consequences
8 of any proposed modifications if the decision is made to redefine "need" and
9 develop a common formula. The program shall be designed to: (i) distribute
10 funds in a manner that is consistent with legislative intent, but more easily
11 understood by potential students, and (ii) retain the ability to track lottery
12 funds.

- 13 (2) Design a "forgivable loans for service" program that combines at a minimum
14 the following existing programs into one consolidated program that focuses
15 on loans for services: the Nurse Educators of Tomorrow; Nurse Scholars
16 Program; Nurse Education Scholarship Loan Program; Board of Governors
17 Medical Scholarship Loans; Board of Governors Dental Scholarship Loans;
18 Health, Science and Mathematics Student Loan Program; Prospective
19 Teacher Scholarship Loan Program; and the Teacher Assistant Scholarship
20 Program. This single consolidated program shall initially focus on two high
21 area needs: teaching and health professions (including nursing, allied health
22 and medical, dental, and pharmacy careers). In designing this program, the
23 work group may consider the current allocation of funds among the various
24 scholarship and forgivable loan programs, whether it would be appropriate
25 to allow the reallocation and award of funds not distributed as forgivable
26 loans in a specific service area to be awarded as forgivable loans in a
27 different service area, and, if so, what procedure and methodology would be
28 appropriate to trigger the reallocation of funds and provide for the
29 distribution of those funds as awards in a different service area.

30 **SECTION 9.2.(c)** In addition to the considerations set out in subsection (b) of this
31 section, the work group shall also consider all of the following:

- 32 (1) The time period required to phase out student loans from any of the
33 programs affected by the program consolidation.
34 (2) How federal funding may affect student financial aid services.
35 (3) How to deal with current recipients of funds from programs affected by the
36 consolidation.
37 (4) How to deal with recipients who are paying back loans made through
38 programs affected by the consolidation.
39 (5) Whether the State Education Assistance Authority should be authorized to
40 extend the repayment period for forgivable loans in hardship circumstances
41 when a good faith effort has been made to repay the loan in a timely manner,
42 and if so, what the appropriate procedure may be for making that
43 determination and extending the repayment period.
44 (6) Whether there are, and if so how to address, any significant abuses of the
45 financial aid system, particularly by persons who intentionally apply for and
46 receive financial aid but who intend to drop out of school after securing
47 financial aid funds.
48 (7) Any other issues the work group deems relevant to this study.

49 **SECTION 9.2.(d)** The work group shall present its proposed program designs and
50 report its findings and recommendations to the Joint Select Committee on State Funded Student
51 Financial Aid by October 1, 2010. In its report the work group shall also identify options that

1 may vary from the proposed program designs but that are alternatives that the work group
2 determines may also be workable and consistent with the legislative intent of this study. The
3 work group shall also include in the report any legislative changes that may be needed to
4 implement the program designs and work group recommendations.

6 **COORDINATE THE REPORT DUE DATES FOR VARIOUS TEACHER EDUCATION**
7 **REPORTS**

8 **SECTION 9.3.(a)** G.S. 116-11 is amended by adding a new subdivision to read:

9 "(12d) The Board of Governors shall provide a comprehensive annual report on
10 teacher education efforts at The University of North Carolina. The report
11 shall include information about teacher education and recruitment, 2+2
12 initiatives, distance education programs focused on teacher education, and
13 professional development programs for teachers and school administrators.
14 The teacher education report shall be due on April 15 of each year to the
15 Joint Legislative Education Oversight Committee and the State Board of
16 Education."

17 **SECTION 9.3.(b)** G.S. 116-74.21(c) reads as rewritten:

18 "(c) The Board of Governors shall study the issue of supply and demand of school
19 administrators to determine the number of school administrators to be trained in the programs
20 in each year of the biennium and report the results of this study to the Joint Legislative
21 Education Oversight Committee no later than ~~March 1~~April 15 annually."

22 **SECTION 9.3.(c)** Section 9.7(c) of S.L. 2008-107 reads as rewritten:

23 "**SECTION 9.7.(c)** The University of North Carolina and Community Colleges System
24 Office shall report by ~~September 1, 2008, April 15, 2011,~~ and annually thereafter, to the Joint
25 Legislative Education Oversight ~~Commission, Committee,~~ the State Board of Education, the
26 Office of State Budget and Management, and the Fiscal Research Division of the General
27 Assembly on the implementation of the UNC-NCCCS 2+2 E-Learning Initiative. This report
28 shall include:

- 29 (1) The courses and programs within the 2+2 E-Learning Initiative;
- 30 (2) The total number of prospective teachers that have taken or are taking part in
31 this initiative to date broken down by the current academic period and each
32 of the previous academic periods since the program's inception;
- 33 (3) The total number of teachers currently in the State's classrooms, by local
34 school administrative unit, who have taken part in this initiative;
- 35 (4) The change in the number of teachers available to schools since the
36 program's inception;
- 37 (5) The qualitative data from students, teachers, local school administrative unit
38 personnel, university personnel, and community college personnel as to the
39 impact of this initiative on our State's teaching pool; and
- 40 (6) An explanation of the expenditures and collaborative programs between the
41 North Carolina Community College System and The University of North
42 Carolina, including recommendations for improvement."

43 **SECTION 9.3.(d)** Section 9.3(c) of S.L. 2005-276 reads as rewritten:

44 "**SECTION 9.3.(c)** These results shall be reported by ~~September 1, 2006, April 15, 2011,~~
45 and annually thereafter to the State Board of Education, the Board of Governors of The
46 University of North Carolina, the State Board of Community Colleges, the Education Cabinet,
47 the Joint Legislative Education Oversight ~~Commission, Committee,~~ and the Office of State
48 Budget and Management."

49 **SECTION 9.3.(e)** Section 9.9 of S.L. 2002-126 reads as rewritten:

50 "**SECTION 9.9.** The Board of Governors of The University of North Carolina may allow
51 Elizabeth City State University, the University of North Carolina at Pembroke, and Western

1 Carolina University each to allocate up to one hundred seventy-eight thousand three hundred
2 eighty dollars (\$178,380) of the funds allocated to them for focused enrollment growth for a
3 maximum of 20 Prospective Teacher Scholars. These funds may be used to recruit new
4 nonresident students to enter into agreements to: (i) pursue a full-time course of study that will
5 lead to teacher certification in North Carolina and (ii) teach in a North Carolina public school
6 or a school operated by the United States government in North Carolina for one year for each
7 year that they receive this benefit. The Board of Governors shall establish guidelines and
8 regulations for this pilot program, including methodology for determining its success in
9 increasing the supply of qualified teachers for North Carolina public schools. The Board shall
10 report its guidelines and regulations to guide these pilot programs to the Joint Legislative
11 Education Oversight Committee by ~~November 15, 2002.~~ April 15, 2011. The Board shall report
12 annually to the Committee on the progress of the pilot programs and their costs."
13

14 **ELIMINATE BIENNIAL DISTANCE EDUCATION REPORTS**

15 **SECTION 9.4.** Section 11.7 of S.L. 1998-212 reads as rewritten:

16 "Section 11.7. This act provides funding to The University of North Carolina Board of
17 Governors for degree-related courses provided away from the campus sites of the constituent
18 institutions of The University of North Carolina. The intent of this commitment is to provide
19 expanded opportunities for higher education to more North Carolina residents, including
20 nontraditional students, and to increase the number of North Carolina residents who earn
21 post-secondary degrees.

22 These funds shall be used for the provision of off-campus higher education programs,
23 including the costs for the development or adaptation of programs for this purpose, and the
24 funds may be used for the costs of providing space and services at the off-campus sites.

25 Prior to approving funding for off-campus programs in nursing, the Board shall consult
26 with the central office of the Area Health Education Centers (AHEC) to obtain information
27 about regional needs and priorities and to coordinate funding with AHEC efforts in nursing
28 education.

29 The Board of Governors shall track these funds separately in order to provide data on the
30 costs of providing these programs, including the different costs for various methods of delivery
31 of educational programs. The Board of Governors shall provide for evaluation of these
32 off-campus programs, including comparisons to the costs and quality of on-campus delivery of
33 similar programs, as well as the impact on access to higher education and the educational
34 attainment levels of North Carolina residents. ~~The Board shall provide a preliminary report to
35 the General Assembly by May 1, 2000, and subsequent evaluations, including

11 ~~appropriation remaining after all reductions, prior to and included in the act, are incorporated.~~
12 The Roanoke Island Commission may use these funds to purchase equipment and to contract

23 Carolina, General Administration shall compile a comprehensive list of the programs within
24 The University System whose primary objective is to provide community outreach in the form
25 of either (i) teacher professional development programs to strengthen the quality of science or
26 mathematics instruction in the public schools; or (ii) K-12 student enrichment programs in the
27 areas of science, technology, engineering, or mathematics. The University of North Carolina
28 General Administration shall submit the list of STEM programs compiled pursuant to this
29 subsection to the Office of State Budget and Management and the Fiscal Research Division by
30 February 15, 2011.

31 At a minimum, all of the following programs shall be included in the list:

- 32 (1) Pre-College and Teacher Professional Development programs administered
33 through the North Carolina Mathematics and Science Education Network
34 (NC-MSEN).
- 35 (2) Summer Ventures Program.
- 36 (3) North Carolina Central University Center for Science, Math and Technology
37 Education.
- 38 (4) Fayetteville State University CHEER Summer Bridges.
- 39 (5) NCSTEM Community Collaborative.

40 SECTION 9.7.(b) The University of North Carolina General Administration shall
41 conduct a review of each of the programs identified pursuant to subsection (a) of this section
42 and shall report the results to the Office of State Budget and Management and the Fiscal
43 Research Division no later than September 30, 2011, to assist with future funding decisions.
44 The report shall contain the following information for each program:

- 45 (1) A description of the program mission, goals, and objectives.

42 economic life. The demonstration project shall commence operations as soon as practicable,
43 and, in any event, no later than December 31, 2011.

44 Any contract entered into between The University and a third party pursuant to this section
45 shall ensure that The University is provided appropriate access to the demonstration turbines
46 and necessary support facilities for research purposes. The actual number and placement of the
47 wind turbines and necessary support facilities shall be determined by the coastal sounds wind
48 energy study in coordination with participating entities. The Director of the Budget shall ensure
49 that any available federal funds are secured by the State to construct the demonstration turbines
50 and necessary support facilities. The University may negotiate and execute any rights-of-way,
51 easements, leases, and any other agreements necessary to construct, establish, and operate the

1 demonstration turbines and supporting facilities, notwithstanding any other provisions of law
2 governing such negotiation and execution of any rights-of-way, easements, leases, or other
3 required agreements required for the facilities authorized under this section.

5 **"SECTION 9.14.(c)** The North Carolina Utilities Commission is directed to facilitate and
6 expedite wind energy pilot projects developed pursuant to this act that come within its
7 jurisdiction to the extent allowed by law and consistent with State statute. A wind turbine
8 constructed pursuant to this section shall be exempt from the requirements of G.S. 62-110.1.
9 For such wind turbines owned by a public utility, upon an application by the public utility
10 seeking a rider to recover the costs of such project, the Utilities Commission shall establish an
11 annual rider for the public utility to recover the just and reasonable costs, including the utility's
12 cost of debt and equity, of such project upon completion. Should the project development and
13 construction of the demonstration wind turbines be unreasonably delayed beyond the date set
14 forth in subsection (a) of this section for reasons outside the control of the public utility, all just
15 and reasonable costs incurred by the public utility during project development and construction
16 shall nonetheless be recoverable through an annual rider under this subsection, provided that
17 the public utility shall bear the burden of proving by a preponderance of the evidence that the
18 reasons for the delay were beyond its control and its execution of the project was reasonable
19 and prudent. Should the demonstration wind turbines be abandoned prior to completion, the
20 capital costs and AFUDC related to the project shall nonetheless be recoverable under this
21 Article, provided that the utility shall bear the burden of proving by a preponderance of the
22 evidence that the decision to abandon construction of the project was prudent.

24 25 **COASTAL WAVE ENERGY RESEARCH AND PROTOTYPE PROJECT**

26 **SECTION 9.10.(a)** In order to provide opportunities for research into tidal, wave,
27 and other ocean-based sources of alternative energy, the University of North Carolina Coastal
28 Studies Institute shall form a consortium with the Colleges of Engineering at North Carolina
29 State University, North Carolina Agricultural and Technical State University, and the
30 University of North Carolina at Charlotte to design and construct a prototype generator to
31 capture energy of ocean waves. The generator shall be attached to or staged from an existing
32 State-owned structure located in the ocean waters of the State and shall be used to support
33 marine or ocean-based research collaborations involving public and private universities.

34 **SECTION 9.10.(b)** With respect to the demonstration wave energy facility and
35 necessary support facilities authorized by subsection (a) of this section, the facilities authorized
36 under this act shall be constructed in accordance with the provisions of general law applicable
37 to the construction of State facilities, except that the State Property Office shall expedite and
38 grant all easements and use agreements required for construction of the facilities without
39 payment of any fee, royalty, or other cost. Notwithstanding any other provision of law,
40 construction of the facilities authorized by this section shall be exempt from the following
41 statutes and rules implementing those statutes: G.S. 143-48 through 143-64, 143-128, 143-129,
42 143-132, 113A-1 through 113A-10, 113A-50 through 113A-66, and 113A-116 through
43 113A-128. With respect to any other environmental permits required for construction of the
44 facilities, the Department of Environment and Natural Resources is directed to expedite
45 permitting of the project to the extent allowed by law and shall waive any application fees that
46 would be otherwise applicable to applications for permits required for the facilities and, where
47 possible under applicable law, issue all permits within 40 days of receipt of a complete
48 application.

9 1, 1998, by virtue of their previous membership on the board of
10 directors of the University of North Carolina Hospitals at Chapel
11 Hill, shall not be eligible, for a period of one year following
12 expiration of their term, to be reappointed to the board of directors of
13 the University of North Carolina Health Care System. Any vacancy
14 in an unexpired term shall be filled by an appointment made by the

16 nomination of the board of directors, for the balance of the term

30 policies of the Board of ~~Governors.~~ Governors or, to the extent the board's

32 the policies of the University of North Carolina at Chapel Hill. The board
33 may authorize any component of the University of North Carolina Health
34 Care System, including the University of North Carolina Hospitals at Chapel
35 Hill, to contract in its individual capacity, subject to such policies and

32 SECTION 9.12. G.S. 116-29.1 reads as rewritten:

UNC MANAGEMENT FLEXIBILITY REDUCTION

SECTION 9.13.(a) Section 9.19 of S.L. 2009-451 reads as rewritten:

"SECTION 9.19. The management flexibility reduction for The University of North Carolina shall not be allocated by the Board of Governors to the constituent institutions and affiliated entities using an across-the-board method but in a manner that recognizes the importance of the academic mission and differences among The University of North Carolina entities. Before taking reductions in instructional budgets, the Board of Governors and the campuses of the constituent institutions shall consider reducing budgets for senior and middle management personnel, centers and institutes, low enrollment degree programs, speaker series, and nonacademic activities. The Board of Governors and the campuses of the constituent institutions also shall review the institutional trust funds and the special funds held by or on behalf of ~~the~~The University of North Carolina and its constituent institutions to determine whether there are monies available in those funds that can be used to assist with operating costs before taking reductions in instructional budgets. In addition, the campuses of the constituent institutions also shall require their faculty to have a teaching workload equal to the national average in their Carnegie classification. Budget reductions shall not be considered in funding available for need-based financial aid.

Notwithstanding any other provision of law, for the 2010-2011 fiscal year only, the constituent institutions may, with the approval of the President of The University of North Carolina, increase tuition by up to seven hundred fifty dollars (\$750.00) per academic year. This increase shall be in addition to other increases authorized for the fiscal year. These funds shall be used only to offset the institutions' management flexibility reductions."

SECTION 9.13.(b) Section 9.23 of S.L. 2009-451 is repealed.

INSTITUTE FOR OUTDOOR DRAMA

SECTION 9.14.(a) The Institute for Outdoor Drama shall be transferred from the University of North Carolina at Chapel Hill to East Carolina University.

SECTION 9.14.(b) Of the funds appropriated to the Department of Commerce, Division of Tourism, Film, and Sports Development, the sum of one hundred fifty thousand dollars (\$150,000) shall be transferred to the Board of Governors of The University of North Carolina for the Institute for Outdoor Drama at East Carolina University.

RECRUITMENT OF PHARMACY STUDENTS

SECTION 9.15.(a) The University of North Carolina at Chapel Hill shall collaborate with the University of North Carolina at Asheville and Elizabeth City State University regarding the recruitment of students of pharmacy. The universities shall develop and institute a plan in which potential pharmacy students are informed of the pharmacy programs at each of the public universities in an effort to recruit those students to State schools.

SECTION 9.15.(b) The Board of Governors shall make funds in the amount of forty-four thousand dollars (\$44,000) available to Elizabeth State University for the 2010-2011 fiscal year for the recruitment and academic support of pharmacy students.

SECTION 10.1. The Department of Health and Human Services, Division of Child Development, shall implement an Electronic Benefits Transfer system for child care subsidy. 30 Department of Health and Human Services the sum of three million one hundred sixty-eight
31 thousand two hundred fifty dollars (\$3,168,250) for the 2009-2010 fiscal year. These funds
32 shall be used to support the child welfare postsecondary support program for the educational
33 needs of foster youth aging out of the foster care system and special needs children adopted
34 from foster care after age 12 by providing assistance with the "cost of attendance" as that term
35 is defined in 20 U.S.C. § 10871l. The Department shall collaborate with the State Education
36 Assistance Authority to develop policies and procedures for the distribution of these funds.

41 Funds appropriated by this subsection shall be allocated by the State Education Assistance
42 Authority.

43 The purpose for which funds are appropriated under this section is in addition to other
44 purposes for which Escheat Fund income is distributed under G.S. 116B-7 and shall not be
45 construed to otherwise affect the distribution of funds under G.S. 116B-7.

46 "**SECTION 10.50.(a1)** Of the funds appropriated from the General Fund to the
47 Department of Health and Human Services, the sum of ~~three million one hundred sixty eight~~
48 ~~thousand two hundred fifty dollars (\$3,168,250)~~ one million five hundred eighty-four thousand
49 one hundred twenty-five dollars (\$1,584,125) for the 2010-2011 fiscal year shall be used to
50 support the child welfare postsecondary support program for the educational needs of foster
51 youth aging out of the foster care system and special needs children adopted from foster care

1 after age 12 by providing assistance with the "cost of attendance" as that term is defined in 20
2 U.S.C. § 10871l.

3 Funds appropriated by this subsection shall be allocated by the State Education Assistance
4 Authority.

5 **"SECTION 10.50.(b)** Of the funds appropriated from the General Fund to the Department
6 of Health and Human Services the sum of fifty thousand dollars (\$50,000) for the 2009-2010
7 fiscal year and the sum of fifty thousand dollars (\$50,000) for the 2010-2011 fiscal year shall
8 be allocated to the North Carolina State Education Assistance Authority (SEAA). The SEAA
9 shall use these funds only to perform administrative functions necessary to manage and
10 distribute scholarship funds under the child welfare postsecondary support program.

34 by this section are: Beaufort, Caldwell, Catawba, Lenoir, Lincoln, Macon, and Wilson.

35 **"SECTION 10.51.(c)** Counties that submitted the letter of intent to remain as an Electing
36 County or to be redesignated as an Electing County and the accompanying county plan for
37 fiscal years 2009 through 2011, pursuant to G.S. 108A-27(e), shall operate under the Electing
38 County budget requirements effective July 1, 2009. For programmatic purposes, all counties
39 referred to in this subsection ~~shall~~may remain under their current county designation through
40 September 30, ~~2009-2012~~.

41 **"SECTION 10.51.(d)** For the ~~2009-2010~~2010-2011 fiscal year, Electing Counties shall be
42 held harmless to their Work First Family Assistance allocations for the 2008-2009 fiscal year,
43 provided that remaining funds allocated for Work First Family Assistance and Work First
44 Diversion Assistance are sufficient for payments made by the Department on behalf of
45 Standard Counties pursuant to G.S. 108A-27.11(b).

46 **"SECTION 10.51.(e)** In the event that Departmental projections of Work First Family
47 Assistance and Work First Diversion Assistance for the ~~2009-2010~~2010-2011 fiscal year
48 indicate that remaining funds are insufficient for Work First Family Assistance and Work First
49 Diversion Assistance payments to be made on behalf of Standard Counties, the Department is

14 House of Representatives Appropriations Subcommittee on Health and Human Services, and
15 the Fiscal Research Division by ~~December 1, 2010~~February 1, 2011."

17 **ELIMINATION OF THE OFFICE OF EDUCATION SERVICES/TRANSFER**
18 **RESIDENTIAL AND PRESCHOOLS TO THE DEPARTMENT OF PUBLIC**
19 **INSTRUCTION**

20 **SECTION 10.21.(a)** The Office of Education Services (OES) within the
21 Department of Health and Human Services is hereby dissolved and the Central Office,
22 Resource Support, Governor Morehead School Outreach, Deaf/Blind, and Exceptional Children
23 Support programs within OES are eliminated.

24 **SECTION 10.21.(b)** In accordance with G.S. 143A-6, the North Carolina School
25 for the Deaf, the Eastern North Carolina School for the Deaf, the Governor Morehead School
26 for the Blind, the Governor Morehead Preschool, Early Intervention Services – Preschool, and
27 Family Resource Center programs operated within the Office of Education Services are
28 transferred to the Department of Public Instruction, Exceptional Children Division, by Type I
29 transfer. In addition, the School Administrator position, #60089692, and School
30 Speech-Language Pathologist position, #60039336, shall be transferred to the Department of
31 Public Instruction, Exceptional Children Division, to continue to provide technical assistance to
32 Local Education Agencies and support collaborative efforts with the following:

- 33 (1) North Carolina Central University, Visual Impairment Training Program.
- 34 (2) East Carolina University, Teacher Support Program for Students with
35 Deaf-Blindness.
- 36 (3) East Carolina University, Project E.A.R.
- 37 (4) Department of Health and Human Services, Division of Public Health, Early
38 Intervention Services.
- 39 (5) Beginnings for Parents of Children Who Are Deaf or Hard of Hearing.
- 40 (6) University of North Carolina Center for the Acquisition of Spoken Language
41 through Listening Enrichment (CASTLE).

42 **SECTION 10.21.(c)** The Office of State Budget and Management, the Department
43 of Health and Human Services, and the Department of Public Instruction shall effect this Type I
44 transfer no later than July 1, 2010.

45 **SECTION 10.21.(d)** Upon transfer, the Director of the Exceptional Children
46 Division shall assume the functions of the Superintendent of the Local Education Agency
47 comprised of the North Carolina School for the Deaf, the Eastern North Carolina School for the
48 Deaf, and the Governor Morehead School for the Blind. The Department shall establish an
49 Assistant Director position to augment management of residential school and itinerant
50 preschool programs.

1 **SECTION 10.21.(e)** The Department of Public Instruction shall reinstate the
2 residential and instructional schedules for the Governor Morehead School for the Blind,
3 Eastern North Carolina School for the Deaf, and North Carolina School for the Deaf in effect
4 before February 8, 2010. Residential students shall have the opportunity to arrive at their

10 **SECTION 10.22.(a)** Section 10.58.(d) of S.L. 2009-451 reads as rewritten:

11 **"SECTION 10.58.(d) Services and Payment Bases.** – The Department shall spend funds
12 appropriated for Medicaid services in accordance with the following schedule of services and
13 payment bases. All services and payments are subject to the language at the end of this
14 subsection. Unless otherwise provided, services and payment bases will be as prescribed in the
15 State Plan as established by the Department of Health and Human Services and may be
16 changed with the approval of the Director of the Budget.

17 ...

18 (28) **Drugs. – Reimbursements.** Reimbursements shall be available for
19 prescription drugs as allowed by federal regulations plus a professional
20 services fee per month, excluding refills for the same drug or generic
21 equivalent during the same month. Payments for drugs are subject to the
22 provisions of this subdivision or in accordance with the State Plan adopted
23 by the Department of Health and Human Services, consistent with federal
24 reimbursement regulations. Payment of the professional services fee shall be
25 made in accordance with the State Plan adopted by the Department of Health
26 and Human Services, consistent with federal reimbursement regulations. The
27 professional services fee shall be five dollars and sixty cents (\$5.60) per
28 prescription for generic drugs and four dollars (\$4.00) per prescription for
29 brand-name drugs. Adjustments to the professional services fee shall be
30 established by the General Assembly. In addition to the professional services
31 fee, the Department may pay an enhanced fee for pharmacy services.

32 **Limitations on quantity.** – The Department of Health and Human
33 Services may establish authorizations, limitations, and reviews for specific
34 drugs, drug classes, brands, or quantities in order to manage effectively the
35 Medicaid pharmacy program, ~~except that the Department shall not impose~~
36 ~~limitations on brand name medications for which there is a generic~~
37 ~~equivalent in cases where the prescriber has determined, at the time the drug~~
38 ~~is prescribed, that the brand name drug is medically necessary and has~~
39 ~~written on the prescription order the phrase "medically necessary." program.~~
40 The Department may impose prior authorization requirements on
41 brand-name drugs in instances where the phrase "medically necessary" is
42 written on the prescription.

43 **Dispensing of generic drugs.** – Notwithstanding G.S. 90-85.27 through
44 G.S. 90-85.31, or any other law to the contrary, under the Medical
45 Assistance Program (Title XIX of the Social Security Act), and except as
46 otherwise provided in this subsection for drugs listed in the narrow
47 therapeutic index, a prescription order for a drug designated by a trade or
48 brand name shall be considered to be an order for the drug by its established
49 or generic name, except when the prescriber has determined, at the time the
50 drug is prescribed, that the brand-name drug is medically necessary and has
51 written on the prescription order the phrase "medically necessary." An initial

1 prescription order for a drug listed in the narrow therapeutic drug index that
2 does not contain the phrase "medically necessary" shall be considered an
3 order for the drug by its established or generic name, except that a pharmacy
4 shall not substitute a generic or established name prescription drug for
5 subsequent brand or trade name prescription orders of the same prescription
6 drug without explicit oral or written approval of the prescriber given at the
7 time the order is filled. Generic drugs shall be dispensed at a lower cost to
8 the Medical Assistance Program rather than trade or brand-name drugs.
9 Notwithstanding this subdivision to the contrary, the Secretary of Health and
10 Human Services may prevent substitution of a generic equivalent drug,
11 including a generic equivalent that is on the State maximum allowable cost
12 list, when the net cost to the State of the brand-name drug, after
13 consideration of all rebates, is less than the cost of the generic equivalent. As
14 used in this subsection, "brand name" means the proprietary name the
15 manufacturer places upon a drug product or on its container, label, or
16 wrapping at the time of packaging; and "established name" has the same
17 meaning as in section 502(e)(3) of the Federal Food, Drug, and Cosmetic
18 Act, as amended, 21 U.S.C. § 352(e)(3).

19 Prior authorization. – The Department of Health and Human Services
20 shall not impose prior authorization requirements or other restrictions under
21 the State Medical Assistance Program on medications prescribed for
22 Medicaid recipients for the treatment of (i) mental illness, including, but not
23 limited to, medications for schizophrenia, bipolar disorder, major depressive
24 disorder or ~~(ii) HIV/AIDS, except that the Department of Health and Human~~
25 ~~Services shall continually review utilization of medications under the State~~
26 ~~Medical Assistance Program prescribed for Medicaid recipients for the~~
27 ~~treatment of mental illness, including, but not limited to, medications for~~
28 ~~schizophrenia, bipolar disorder, or major depressive disorder. The~~
29 ~~Department may, however, with respect to drugs to treat mental illnesses,~~
30 ~~develop guidelines and measures to ensure appropriate usage of these~~
31 ~~medications, including FDA approved indications and dosage levels. (ii)~~
32 HIV/AIDS. Medications prescribed for the treatment of mental illness shall
33 be included on the Preferred Drug List (PDL). The Department of Health
34 and Human Services, Division of Medical Assistance, may initiate prior
35 authorization for the prescribing of drugs specified for the treatment of
36 mental illness for the purpose of identifying providers who fail to prescribe
37 those drugs in accordance with indications and dosage levels approved by
38 the federal Food and Drug Administration or in accordance with best
39 practices. The Department may also require retrospective clinical
40 justification for the use of multiple psychotropic drugs for a Medicaid
41 patient. For individuals 18 years of age and under who are prescribed three
42 or more psychotropic medications, the Department shall implement clinical
43 edits that target inefficient, ineffective, or potentially harmful prescribing
44 patterns. When such patterns are identified, the Medical Director for the
45 Division of Medical Assistance and the Chief of Clinical Policy for the
46 Division of Mental Health, Developmental Disabilities, and Substance
47 Abuse Services shall require a peer-to-peer consultation with the target
48 prescribers. Alternatives discussed during the peer-to-peer consultations
49 shall be based upon:

- 50 a. Evidence-based criteria available regarding efficacy or safety of the
51 covered treatments; and

b. Policy approval by a majority vote of the North Carolina Physicians Advisory Group (NCPAG).
 The target prescriber has final decision-making authority to determine which prescription drug to prescribe or refill.

...
 (30) Experimental or trial procedures. – Coverage is limited to procedures that are recognized or approved by a nationally recognized professional specialty organization.

(31) Medicaid as secondary payer claims. – The Department shall apply Medicaid medical policy to recipients who have primary insurance other than Medicare, Medicare Advantage, and Medicaid. The Department shall pay an amount up to the actual coinsurance or deductible or both, in accordance with the State Plan, as approved by the Department of Health and Human Services. The Department may disregard application of this policy in cases where application of the policy would adversely affect patient care."

SECTION 10.22.(b) Section 10.58.(e) of S.L. reads as rewritten:

"SECTION 10.58.(e) Provider Performance Bonds and Visits. –

(1) Subject to the provisions of this subdivision, the Department may require Medicaid-enrolled providers to purchase a performance bond in an amount not to exceed one hundred thousand dollars (\$100,000) naming as beneficiary the Department of Health and Human Services, Division of Medical Assistance, or provide to the Department a validly executed letter of credit or other financial instrument issued by a financial institution or agency honoring a demand for payment in an equivalent amount. The Department may require the purchase of a performance bond or the submission of an executed letter of credit or financial instrument as a condition of initial enrollment, reenrollment, or reinstatement if:

- a. The provider fails to demonstrate financial viability,
- b. The Department determines there is significant potential for fraud and abuse,
- c. The Department otherwise finds it is in the best interest of the Medicaid program to do so.

The Department shall specify the circumstances under which a performance bond or executed letter of credit will be required.

(1a) The Department may waive or limit the requirements of this paragraph for individual Medicaid-enrolled providers or for one or more classes of Medicaid-enrolled providers based on the following:

- a. The provider's or provider class's dollar amount of monthly billings to Medicaid.
- b. The length of time an individual provider has been licensed, endorsed, certified, or accredited in this State to provide services.
- c. The length of time an individual provider has been enrolled to provide Medicaid services in this State.
- d. The provider's demonstrated ability to ensure adequate record keeping, staffing, and services.
- e. The need to ensure adequate access to care.

In waiving or limiting requirements of this paragraph, the Department shall take into consideration the potential fiscal impact of the waiver or limitation on the State Medicaid Program. The Department shall provide to the affected provider written notice of the findings upon which its action is based and

1 shall include the performance bond requirements and the conditions under
2 which a waiver or limitation apply. The Department may adopt temporary
3 rules in accordance with G.S. 150B-21.1 as necessary to implement this
4 provision.

- 5 (2) Reimbursement is available for up to 30 visits per recipient per fiscal year
6 for the following professional services: ~~hospital-outpatient providers,~~
7 physicians, nurse practitioners, nurse midwives, clinics, health departments,
8 optometrists, chiropractors, and podiatrists. The Department of Health and
9 Human Services shall adopt medical policies in accordance with
10 G.S. 108A-54.2 to distribute the allowable number of visits for each service
11 or each group of services consistent with federal law. In addition, the
12 Department shall establish a threshold of some number of visits for these
13 services. The Department shall ensure that primary care providers or the
14 appropriate CCNC network are notified when a patient is nearing the
15 established threshold to facilitate care coordination and intervention as
16 needed.

17 Prenatal services, all EPSDT children, emergency room visits, and
18 mental health visits subject to independent utilization review are exempt
19 from the visit limitations contained in this subdivision. Subject to
20 appropriate medical review, the Department may authorize exceptions when
21 additional care is medically necessary. Routine or maintenance visits above
22 the established visit limit will not be covered unless necessary to actively
23 manage a life threatening disorder or as an alternative to more costly care
24 options."
25

26 SPECIALTY DRUG PROVIDER NETWORK

27 **SECTION 10.23.** The Department of Health and Human Services shall create a
28 specialty drug provider network that requires best practices, prevents overutilization, and
29 allows for drug reimbursement rate negotiations for hemophilia, hepatitis C, and intravenous
30 immunoglobulin (IVIG) drugs.
31

32 STATEWIDE EXPANSION OF CAPITATED 1915(B)/(C) BEHAVIORAL HEALTH 33 WAIVERS

34 **SECTION 10.24.** The Division of Medical Assistance and the Division of Mental
35 Health, Developmental Disabilities, and Substance Abuse Services may expand the capitated
36 1915(b)/(c) waivers which have been operating in the Piedmont Behavioral Healthcare Local
37 Management Entity (LME) catchment area as a demonstration program since April 2005. The
38 Divisions shall add additional LMEs to the waiver program as they demonstrate readiness to
39 participate through a request for proposal process. The waiver program shall include all
40 Medicaid-covered mental health, developmental disabilities, and substance abuse services.
41 Expansion of the waiver to additional LMEs shall be contingent upon approval by the Centers
42 for Medicare and Medicaid Services.
43

44 STUDY MEDICAID PROVIDER RATES

45 **SECTION 10.25.(a)** The Department of Health and Human Services, Division of
46 Medical Assistance, shall initiate a study or contract out for a study of reimbursement rates for
47 Medicaid providers and program benefits. The study shall include the following information:

- 48 (1) A comparison of Medicaid reimbursement rates in North Carolina with
49 reimbursement rates in surrounding states and with rates in two additional
50 states; and

- 1 (2) A comparison of Medicaid program benefits in North Carolina with program
2 benefits provided in surrounding states and with rates in two additional
3 states. Selected provider rates shall be studied for the initial report.

4 **SECTION 10.25.(b)** The Department shall report its initial findings to the
5 Governor, the Senate Appropriations Committee on Health and Human Services, the House of
6 Representatives Appropriations Subcommittee on Health and Human Services, and the Fiscal
7 Research Division by April 1, 2011.

8 **SECTION 10.25.(c)** Funds appropriated to the Department of Health and Human
9 Services may be used to complete this study.

10 11 **MEDICAID FRAUD PREVENTION**

12 **SECTION 10.26.(a)** The Department of Health and Human Services (Department)
13 is authorized to create a fraud prevention program that uses information, lawfully obtained,
14 from State and private databases to develop a fraud risk analysis of Medicaid providers and
15 recipients. This analysis would be used to prevent fraud before it takes place and to achieve
16 cost avoidance savings. While it is the intent that this initiative allow broad new access to
17 information and databases across State government, the plan shall comply with all necessary
18 security measures and restrictions to ensure that access to any specific information held
19 confidential under federal and State law shall be limited to authorized persons.

20 **SECTION 10.26.(b)** The information obtained by the Department pursuant to
21 subsection (a) of this section shall be privileged and confidential, is not a public record
22 pursuant to G.S. 132-1, and may only be used for investigative or evidentiary purposes related
23 to violations of State or federal law and regulatory activities. The Department shall release data
24 collected pursuant to this section to the following persons only:

- 25 (1) An individual who requests the individual's own Medicaid recipient
26 information.
27 (2) A provider who requests the provider's Medicaid provider information.
28 (3) Special agents of the North Carolina State Bureau of Investigation who are
29 assigned to the Medicaid Fraud Investigations Unit. The SBI shall notify the
30 Office of the Attorney General of North Carolina of each request for
31 inspection of records maintained by the Department.
32 (4) To a court pursuant to a lawful court order in a criminal action.

33 The Department may provide data to public or private entities for statistical,
34 research, or educational purposes only after removing information that could be used to identify
35 individual recipients or providers of Medicaid services.

36 **SECTION 10.26.(c)** Notwithstanding any other provision of law to the contrary,
37 the Department may modify or extend existing contracts to achieve Medicaid fraud prevention
38 savings in a timely manner, subject to review and approval by the Secretary of the Department
39 of Administration. The requirements of G.S. 143-59 apply to contracts entered into, modified,
40 or extended pursuant to this section.

41 **SECTION 10.26.(d)** The Department shall report on the activities conducted under
42 this section, including actions taken relating to compliance with G.S. 143-59 and any contract
43 modifications or extensions that are approved pursuant to this section to the House of
44 Representatives Appropriations Subcommittee on Health and Human Services, the Senate
45 Appropriations Committee on Health and Human Services, the Office of State Budget and
46 Management, and the Fiscal Research Division on or before April 1, 2011.

47 **SECTION 10.26.(e)** The authority granted to the Department under this section
48 expires one year following the effective date of this section. The Department shall destroy all
49 records and information obtained pursuant to this section after five years. Any records or
50 information turned over to the State Bureau of Investigation or a court of competent jurisdiction
51 shall not be subject to the destruction requirements of this subsection.

STUDY HIV MEDICAID WAIVER

SECTION 10.27. By November 1, 2010, the Department of Health and Human Services, Divisions of Medical Assistance and Public Health, shall jointly study and report to the Senate Appropriations Committee on Health and Human Services, the House of Representatives Appropriations Subcommittee on Health and Human Services, and the Fiscal Research Division on the financial and programmatic feasibility of reducing the waiting list for the AIDS Drug Assistance Program (ADAP) by expanding eligibility for Medicaid to HIV-positive individuals with incomes at or below one hundred thirty-three percent (133%) of the federal poverty level. The study shall include an assessment of the cost-effectiveness of using State dollars to expand Medicaid eligibility to this population as compared to using State dollars for ADAP. The study may also consider any planning and coordination benefits the State may derive from expanding Medicaid eligibility to HIV-positive individuals, in preparation for the expansion of Medicaid eligibility in calendar year 2014 to all individuals with incomes at or below one hundred thirty-three percent (133%) of the federal poverty level. If, as a result of the study, the Divisions of Medical Assistance and Public Health conclude that expanding Medicaid eligibility to HIV-positive individuals with incomes at or below one hundred thirty-three percent (133%) of the federal poverty level is a cost-effective means for the State to eliminate its ADAP waiting list, then the Division of Medical Assistance shall apply to the Centers for Medicare and Medicaid Services (CMS) for an appropriate waiver to implement this expansion in Medicaid eligibility. If approved by CMS, the Division shall not implement the waiver except as authorized by an act of the General Assembly appropriating funds for this purpose.

ELIMINATE REIMBURSEMENT OF "NEVER EVENTS"

SECTION 10.28. The Department of Health and Human Services, Division of Medical Assistance, shall modify its Medicaid State Plan, as detailed by the Centers for Medicare and Medicaid Services in its July 31, 2008, letter to State Medicaid Directors, to ensure that inpatient hospital reimbursement is not provided for Hospital-Acquired Conditions (HACs) that are identified as nonpayable by Medicare. The State Plan Amendment addressing this "Never Event" modification shall apply to all Medicaid reimbursement provisions in section 4.19A of the North Carolina Medicaid State Plan governing inpatient hospital reimbursement, including Medicaid supplemental or enhanced payments and Medicaid disproportionate share hospital payments.

- 1 (2) Whose endorsement has been withdrawn or whose application for
2 endorsement has been denied by a local management entity.

3 **SECTION 10.29.(b)** Section 10.15A(e2) of S.L. 2008-107, as amended by Section

5 "**SECTION 10.15A.(e2)** The appeals process for providers of community support provider
6 appeals process services or PCS shall be developed and implemented as follows:

 11 hearing on the merits has not been commenced prior to that date. The

7 **SECTION 10.32.** Section 10.66.(c) of S.L. 2009-451 reads as rewritten:

8 "**SECTION 10.66.(c)** The Department, in consultation with the PAG, shall adopt and
9 publish policies and procedures relating to the preferred drug list, including:

- 10 (1) Guidelines for the presentation and review of drugs for inclusion on the
11 preferred drug list,
- 12 (2) The manner and frequency of audits of the preferred drug list for
13 appropriateness of patient care and cost-effectiveness,
- 14 (3) An appeals process for the resolution of disputes, and
- 15 (4) Such other policies and procedures as the Department deems necessary and
16 appropriate.

17 The Department and the pharmaceutical and therapeutics committee shall consider all
18 therapeutic classes of prescription drugs for inclusion on the preferred drug list, ~~except~~

21 The Department shall maintain an updated preferred drug list in electronic format and shall
22 make the list available to the public on the Department's Internet Web site.

23 The Department shall: (i) enter into a multistate purchasing pool; (ii) negotiate directly with
24 manufacturers or labelers; (iii) contract with a pharmacy benefit manager for negotiated
25 discounts or rebates for all prescription drugs under the medical assistance program; or (iv)
26 effectuate any combination of these options in order to achieve the lowest available price for
27 such drugs under such program.

28 The Department may negotiate supplemental rebates from manufacturers that are in
29 addition to those required by Title XIX of the federal Social Security Act. The committee shall
30 consider a product for inclusion on the preferred drug list if the manufacturer provides a
31 supplemental rebate. The Department may procure a sole source contract with an outside entity
32 or contractor to conduct negotiations for supplemental rebates."

34 **MEDICAID PREFERRED DRUG LIST (PDL) REVIEW PANEL**

35 **SECTION 10.33.(a)** The Secretary of the Department of Health and Human
36 Services shall establish a Preferred Drug List (PDL) Policy Review Panel within 60 days after
37 the effective date of this section. The purpose of the PDL Policy Review Panel is to review the
38 Medicaid PDL recommendations from the Department of Health and Human Services, Division
39 of Medical Assistance, and the Physician Advisory Group (PAG) Pharmacy and Therapeutics
40 (P&T) Committee.

41 **SECTION 10.33.(b)** The Secretary shall appoint the following individuals to the
42 review panel:

- 43 (1) The Director of Pharmacy for the Division of Medical Assistance.
- 44 (2) A representative from the PAG P&T Committee.
- 45 (3) A representative from the Old North State Medical Society.
- 46 (4) A representative from the North Carolina Association of Pharmacists.
- 47 (5) A representative from Community Care of North Carolina.
- 48 (6) A representative from the North Carolina Psychiatric Association.
- 49 (7) A representative from the North Carolina Pediatric Society.
- 50 (8) A representative from the North Carolina Academy of Family Physicians.

- 1 (9) A representative from the North Carolina Chapter of the American College
2 of Physicians.

3 Individuals appointed to the Review Panel, except for the Division's Director of
4 Pharmacy, shall only serve a two-year term.

5 **SECTION 10.33.(c)** Within 30 days after the Department, in consultation with the
6 PAG P&T Committee, publishes a proposed policy or procedure related to the Medicaid PDL,
7 the Review Panel shall hold an open meeting to review the recommended policy or procedure
8 along with any written public comments received as a result of the posting. The Review Panel
9 shall provide an opportunity for public comment at the meeting. After the conclusion of the
10 meeting, the Review Panel shall submit policy recommendations about the proposed Medicaid
11 PDL policy or procedure to the Department.

13 **LOCK NARCOTIC PRESCRIPTIONS INTO SINGLE PHARMACY/PROVIDER**

14 **SECTION 10.34.** The Department of Health and Human Services, Division of
15 Medical Assistance, shall lock narcotic prescription medications provided to Medicaid
16 enrollees into a single pharmacy and provider, as follows:

29 **SECTION 10.35.** Section 10.68A.(a) of S.L. 2009-451, as amended by Section 5A
30 of S.L. 2009-575, reads as rewritten:

31 **"SECTION 10.68A.(a)** For the purpose of enabling the Department of Health and Human
32 Services, Division of Medical Assistance, to achieve the budget reductions enacted in this act
33 for the Medicaid program, the Department may take the following actions, notwithstanding any
34 other provision of this act or other State law or rule to the contrary and subject to the
35 requirements of subsection (e) of this section:

- 36 (1) Electronic transactions. –
37 a. Within 60 days of notification of its procedures via the DMA Web
38 site, Medicaid providers shall follow the Department's established

40 September 1, 2009, the Department shall cease routine provider

42 b. Effective September 1, 2009, all Medicaid providers shall file claims
43 electronically to the fiscal agent. Nonelectronic claims submission
44 may be required when it is in the best interest of the Department.
45 c. Effective September 1, 2009, enrolled Medicaid providers shall
46 submit Preadmission Screening and Annual Resident Reviews
47 (PASARR) through the Department's Web-based tool or through a
48 vendor with interface capability to submit data into the Web-based
49 PASARR.
50 (2) Clinical coverage. – The Department of Health and Human Services,
51 Division of Medical Assistance, shall amend applicable clinical policies and

1 submit applicable State Plan amendments to CMS to implement the budget
2 reductions authorized in the following clinical coverage areas in this act:

- 3 a. Consolidate and reduce Targeted Case Management and case
4 management functions bundled within other Medicaid services.
5 b. Take appropriate action to lower the cost of HIV case management,
6 including tightening service hours and limiting administrative costs.
7 The Department shall maintain HIV case management as a
8 stand-alone service outside of departmental efforts to consolidate
9 case management services.
10 c. Eliminate coverage of therapeutic camps. The Department shall
11 report on or before October 1, 2009, on the plan to transition children
12 out of mental health residential therapeutic camps. The Department
13 shall submit the report to the Joint Legislative Oversight Committee
14 on Mental Health, Developmental Disabilities, and Substance Abuse
15 Services.

16 ~~(3) Medicaid Personal Care Service provision.—Upon the enactment of this act,

35 ~~f. If sufficient reduction in cost is not achieved with the revised policy,
36 the Secretary shall direct the Division of Medical Assistance to
37 further modify the policy to achieve targeted cost savings.~~

38 ~~Recipients currently receiving PCS services shall be reviewed under the
39 above criteria, and those recipients not meeting the new criteria shall be
40 terminated from the service within 30 days of the review. The Department
41 shall review usage of personal care services in adult care homes to determine
42 if overuse is occurring and shall report its findings to the House of
43 Representatives Appropriations Subcommittee on Health and Human
44 Services, the Senate Appropriations Committee on Health and Human
45 Services, and the Fiscal Research Division on or before December 1, 2009.~~

46 (3) Medicaid Personal Care Service provision. – The Department of Health and
47 Human Services, Division of Medical Assistance, shall reform the Personal
48 Care Services (PCS) and Personal Care Services-Plus (PCS-Plus) programs
49 provided under the State Medicaid plan as follows:

- 1 a. Terminate all services provided under these two PCS programs and
2 implement two new PCS programs, PCS-C and PCS-ADE, effective
3 January 1, 2011, or whenever approval is received from CMS.
- 4 b. Determine the most effective and efficient means for Medicaid to
5 manage the cost, quality, and utilization of personal care services
6 through one of the available funding options, including revised
7 Medicaid plan optional services, a §1915(c) home and
8 community-based services (HCBS) waiver, or through a §1915(i)
9 option that allows states to establish home- and community-based
10 services that can target specific populations.
- 11 c. Submit applications or State plan amendments to CMS as required to
12 obtain approval for two PCS programs, as follows:
- 13 1. PCS for Children (PCS-C) – To assist families to meet their
14 needs for personal care assistance for children, including
15 individuals under the age of 21 receiving comprehensive and
16 preventative child health services through the Early and

- 11 g. Effective 60 days from the enactment of this act, the paraprofessional
12 level of community support shall be eliminated, and from this date
13 the Department shall not use any Medicaid or State funds to pay for

16 shall be accompanied with a discharge plan. Submission of the
17 discharge plan will be a required document for a request to be
18 considered complete. Failure to submit the discharge plan will result

20 the service must occur within 90 days after the submission of the

28 requirements of their Medicaid provider agreement or State-funded

- 31 k. Failure to comply with notification, recipient transition planning, or
32 record maintenance shall result in suspension of further payment
33 until such failure is corrected. In addition, failure to comply shall
34 result in denial of enrollment as a provider for any Medicaid or
35 State-funded service. A provider (including its officers, directors,
36 agents, or managing employees or individuals or entities having a
37 direct or indirect ownership interest or control interest of five percent
38 (5%) or more as set forth in Title XI of the Social Security Act) that
39 fails to comply with the required record retention may be subject to
40 sanctions, including exclusion from further participation in the
41 Medicaid program, as set forth in Title XI.
- 42 (6) Community Support Team. – Authorization for a Community Support Team
43 shall be based upon medical necessity as defined by the Department and
44 shall not exceed 18 hours per week. The Division of Medical Assistance
45 shall do an immediate rate study of the Community Support Team to bring
46 the average cost of service per recipient in line with Assertive Community
47 Treatment Team (ACTT) services. The Division shall also revise provider
48 qualifications and tighten the service definition to contain costs in this line
49 item. Not later than December 1, 2009, the Division of Medical Assistance
50 shall report its findings on the rate study and any actions it has taken to
51 conform with this subdivision to the Joint Legislative Oversight Committee

- 17 (8) Reduce Medicaid rates. – Subject to the prior approval of the Office of State

47 Plan, as follows:
- 48 a. Restructure the current PDN Program to provide services that are:
49 1. Provided only to qualified recipients under the age of 21;
50 2. Authorized by the recipient's primary care or attending
51 physician;

- 1 3. Limited to 16 hours of service per day, unless additional
 2 services are required to correct or ameliorate defects and
 3 physical and mental illnesses and conditions as defined in 42
 4 U.S.C. § 1396d(r)(5);
 5 4. Approved based on an initial assessment and continuing need
 6 reassessments performed by an Independent Assessment
 7 Entity (IAE) that does not provide PDN services and
 8 authorized in amounts that are medically necessary based on
 9 the recipient's medical condition, amount of family assistance
 10 available, and other relevant conditions and circumstances, as
 11 defined by the Medicaid Clinical Coverage Policy for this
 12 service.
 13 5. Provided in accordance with a plan of care approved by DMA
 14 or its designee.
 15 b. Develop and submit to CMS a § 1915(c) Home and
 16 Community-Based Services Waiver for individuals dependent on
 17 technology to substitute for a vital body function.
 18 c. Once approved by CMS and upon approval of the Medicaid Clinical
 19 Coverage Policy, transition all qualified recipients age 21 and older
 20 currently receiving PDN to waiver services provided under the
 21 Technology Dependent Waiver."
 22

23 **IMPLEMENT INDEPENDENT ASSESSMENTS ON MENTAL HEALTH SERVICES**

24 **SECTION 10.36.(a)** The Department of Health and Human Services, Division of
 25 Medical Assistance, shall require that, prior to the delivery of enhanced mental health services
 26 in the Medicaid program, an independent assessment be conducted that meets all of the
 27 following criteria:

- 28 (1) An initial assessment or a continuing need reassessment is performed by an
 29 Independent Assessment Entity (IAE) that is not the provider of the services
 30 in question.
 31 (2) The IAE authorizes the type and amount of service to be provided based on
 32 the specific health condition and needs of the intended recipient of the
 33 service.

34 **SECTION 10.36.(b)** The Department of Health and Human Services, Division of
 35 Medical Assistance, shall provide a report of savings generated and other findings relating to
 36 the implementation of this section to the Senate Appropriations Committee on Health and
 37 Human Services, the House of Representatives Appropriations Subcommittee on Health and
 38 Human Services, and the Fiscal Research Division on or before April 1, 2011.

40 **DHSR ADULT CARE HOME ADMINISTRATOR/MEDICATION AIDE FEES**

15 **GENERAL PROVISIONS**

16 **SECTION 10.37.(b)** Information to Be Included in Block Grant Plans. – The
17 Department of Health and Human Services shall submit a separate plan for each Block Grant
18 received and administered by the Department, and each plan shall include the following:

- 19 (1) A delineation of the proposed allocations by program or activity, including
20 State and federal match requirements.
21 (2) A delineation of the proposed State and local administrative expenditures.
22 (3) An identification of all new positions to be established through the Block
23 Grant, including permanent, temporary, and time-limited positions.
24 (4) A comparison of the proposed allocations by program or activity with two
25 prior years' program and activity budgets and two prior years' actual program
26 or activity expenditures.
27 (5) A projection of current year expenditures by program or activity.
28 (6) A projection of federal Block Grant funds available, including unspent
29 federal funds from the current and prior fiscal years.

30 **SECTION 10.37.(c)** Changes in Federal Fund Availability. – If the Congress of the
31 United States increases the federal fund availability for any of the Block Grants or contingency
32 funds and other grants related to existing block grants administered by the Department of
33 Health and Human Services from the amounts appropriated in this section, the Department
34 shall allocate the increase proportionally across the program and activity appropriations
35 identified for that Block Grant in this section. In allocating an increase in federal fund
36 availability, the Office of State Budget and Management shall not approve funding for new
37 programs or activities not appropriated in this section.

38 If the Congress of the United States decreases the federal fund availability for any of
39 the Block Grants or contingency funds and other grants related to existing block grants
40 administered by the Department of Health and Human Services from the amounts appropriated
41 in this section, the Department shall reduce State administration by at least the percentage of
42 the reduction in federal funds. After determining the State administration, the remaining
43 reductions shall be allocated proportionately across the program and activity appropriations
44 identified for that Block Grant in this section. The Office of State Budget and Management
45 shall report on these changes.

46 Prior to allocating the change in federal fund availability, the proposed allocation
47 must be approved by the Office of State Budget and Management. If the Department adjusts the
48 allocation of any Block Grant due to changes in federal fund availability, then a report shall be
49 made to the Joint Legislative Commission on Governmental Operations, the House of
50 Representatives Appropriations Subcommittee on Health and Human Services, the Senate
51 Appropriations Committee on Health and Human Services, and the Fiscal Research Division.

1 **SECTION 10.37.(d)** Appropriations from federal Block Grant funds are made for
2 the fiscal year ending June 30, 2011, according to the schedule enacted for State fiscal year
3 2010-2011 or until a new schedule is enacted by the General Assembly.

4 **SECTION 10.37.(e)** All changes to the budgeted allocations to the Block Grants or
5 contingency funds and other grants related to existing block grants administered by the
6 Department of Health and Human Services that are not specifically addressed in this section
7 shall be approved by the Office of State Budget and Management, and the Office of State
8 Budget and Management shall consult with the Joint Legislative Commission on Governmental
9 Operations for review prior to implementing the changes. The report shall include an itemized
10 listing of affected programs, including associated changes in budgeted allocations. All changes
11 to the budgeted allocations to the Block Grants shall be reported immediately to the House of
12 Representatives Appropriations Subcommittee on Health and Human Services, the Senate
13 Appropriations Committee on Health and Human Services, and the Fiscal Research Division.
14 This subsection does not apply to Block Grant changes caused by legislative salary increases
15 and benefit adjustments.

16 17 **TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) FUNDS**

18 **SECTION 10.37.(f)** The sum of one million ninety-three thousand one hundred
19 seventy-six dollars (\$1,093,176) appropriated in this section in TANF funds to the Department
20 of Health and Human Services, Division of Social Services, for the 2010-2011 fiscal year shall
21 be used to support administration of TANF-funded programs.

22 **SECTION 10.37.(g)** The sum of two million two hundred thousand dollars
23 (\$2,200,000) appropriated under this section in TANF funds to the Department of Health and
24 Human Services, Division of Social Services, for the 2010-2011 fiscal year shall be used to
25 provide domestic violence services to Work First recipients. These funds shall be used to
26 provide domestic violence counseling, support, and other direct services to clients. These funds
27 shall not be used to establish new domestic violence shelters or to facilitate lobbying efforts.
28 The Division of Social Services may use up to seventy-five thousand dollars (\$75,000) in
29 TANF funds to support one administrative position within the Division of Social Services to
30 implement this subsection.

31 Each county department of social services and the local domestic violence shelter
32 program serving the county shall develop jointly a plan for utilizing these funds. The plan shall
33 include the services to be provided and the manner in which the services shall be delivered. The
34 county plan shall be signed by the county social services director or the director's designee and
35 the domestic violence program director or the director's designee and submitted to the Division
36 of Social Services by December 1, 2010. The Division of Social Services, in consultation with
37 the Council for Women, shall review the county plans and shall provide consultation and
38 technical assistance to the departments of social services and local domestic violence shelter
39 programs, if needed.

40 The Division of Social Services shall allocate these funds to county departments of
41 social services according to the following formula: (i) each county shall receive a base
42 allocation of five thousand dollars (\$5,000); and (ii) each county shall receive an allocation of
43 the remaining funds based on the county's proportion of the statewide total of the Work First
44 caseload as of July 1, 2010, and the county's proportion of the statewide total of the individuals
45 receiving domestic violence services from programs funded by the Council for Women as of
46 July 1, 2010. The Division of Social Services may reallocate unspent funds to counties that
47 submit a written request for additional funds.

48 **SECTION 10.37.(h)** The sum of one million six hundred thirty-nine thousand
49 seven hundred fourteen dollars (\$1,639,714) appropriated in this section in TANF funds to the
50 Department of Health and Human Services, Division of Social Services, for the 2010-2011
51 fiscal year shall be used to expand after-school programs and services for at-risk children. The

1 Department shall develop and implement a grant program to award grants to community-based
2 programs that demonstrate the ability to reach children at risk of teen pregnancy, school
3 dropout, and gang participation. The Department shall award grants to community-based
4 organizations that demonstrate the ability to develop and implement linkages with local
5 departments of social services, area mental health programs, schools, and other human services
6 programs in order to provide support services and assistance to the child and family. These
7 funds may be used to fund one position within the Division of Social Services to coordinate
8 at-risk after-school programs and shall not be used for other State administration.

9 **SECTION 10.37.(i)** The sum of fourteen million four hundred fifty-two thousand
10 three hundred ninety-one dollars (\$14,452,391) appropriated in this section to the Department
11 of Health and Human Services, Division of Social Services, in TANF funds for the 2010-2011
12 fiscal year for child welfare improvements shall be allocated to the county departments of
13 social services for hiring or contracting staff to investigate and provide services in Child
14 Protective Services cases; to provide foster care and support services; to recruit, train, license,
15 and support prospective foster and adoptive families; and to provide interstate and postadoption
16 services for eligible families.

17 **SECTION 10.37.(j)** The sum of three million dollars (\$3,000,000) appropriated in
18 this section in TANF funds to the Department of Health and Human Services, Special Children
19 Adoption Fund, for the 2010-2011 fiscal year shall be used in accordance with G.S. 108A-50.2,
20 as enacted in Section 10.48 of S.L. 2009-451. The Division of Social Services, in consultation
21 with the North Carolina Association of County Directors of Social Services and representatives
22 of licensed private adoption agencies, shall develop guidelines for the awarding of funds to
23 licensed public and private adoption agencies upon the adoption of children described in
24 G.S. 108A-50 and in foster care. Payments received from the Special Children Adoption Fund
25 by participating agencies shall be used exclusively to enhance the adoption services program.
26 No local match shall be required as a condition for receipt of these funds.

27 **SECTION 10.37.(k)** The sum of four hundred thousand dollars (\$400,000)
28 appropriated in this section to the Department of Health and Human Services, Division of
29 Social Services, in TANF funds for the 2010-2011 fiscal year shall be used to expand
30 after-school programs for at-risk children attending middle school. The Department shall
31 develop and implement a grant program to award funds to community-based programs
32 demonstrating the capacity to reach children at risk of teen pregnancy, school dropout, and
33 gang participation. These funds shall not be used for training or administration at the State
34 level. All funds shall be distributed to community-based programs, focusing on those
35 communities where similar programs do not exist in middle schools.

36 **SECTION 10.37.(l)** In implementing the use of TANF funds, the Department of
37 Health and Human Services shall review policies, programs, and initiatives to ensure that they
38 support men in their role as fathers and strengthen fathers' involvement in their children's lives.
39 The Department shall encourage county departments of social services to ensure their Work
40 First programs emphasize responsible fatherhood and increased participation by noncustodial
41 fathers.

42 **SECTION 10.37.(m)** The sum of four hundred forty thousand dollars (\$440,000)
43 appropriated in this section to the Department in TANF funds for the 2010-2011 fiscal year
44 shall be transferred to Connect, Inc. Connect, Inc., shall report on the number of people served
45 and the services received as a result of the receipt of funds. The report shall contain expenditure
46 data, including the amount of funds used for administration and direct training. The report shall
47 also include the number of people who have been employed as a direct result of services
48 provided by Connect, Inc., including the length of employment in the new position. The
49 Department of Health and Human Services shall evaluate the program and ensure that services
50 provided are not duplicative of local employment security commissions in the nine counties
51 served by Connect, Inc. The evaluation report shall be submitted to the House of

1 Representatives Appropriations Subcommittee on Health and Human Services, the Senate
2 Appropriations Committee on Health and Human Services, and the Fiscal Research Division no
3 later than May 1, 2011.

4 **SECTION 10.37.(n)** The sum of two million five hundred thousand dollars
5 (\$2,500,000) appropriated in this section to the Department in TANF funds for Boys and Girls
6 Clubs for the 2010-2011 fiscal year shall be used to make grants for approved programs. The
7 Department of Health and Human Services, in accordance with federal regulations for the use
8 of TANF funds, shall administer a grant program to award funds to the Boys and Girls Clubs
9 across the State in order to implement programs that improve the motivation, performance, and
10 self-esteem of youths and to implement other initiatives that would be expected to reduce gang
11 participation, school dropout, and teen pregnancy rates. The Department shall encourage and
12 facilitate collaboration between the Boys and Girls Clubs and Support Our Students,
13 Communities in Schools, and similar programs to submit joint applications for the funds if
14 appropriate.

15 **SECTION 10.37.(o)** The sum of one million one hundred twenty-nine thousand
16 one hundred fifteen dollars (\$1,129,115) appropriated in this section to the Department of
17 Health and Human Services in TANF funds for the 2010-2011 fiscal year shall be used to
18 continue support for the Child Welfare Collaborative.

19 **SECTION 10.37.(p)** The sum of three hundred sixty thousand dollars (\$360,000)
20 appropriated to the Department of Health and Human Services, Division of Social Services,
21 under this section in TANF funds for the 2010-2011 fiscal year shall be used to continue
22 support for the Citizens Schools Program, a three-year urban/rural dropout prevention pilot
23 program in the Durham and Vance County public school systems.

24 **SECTION 10.37.(q)** The sum of seventeen million dollars (\$17,000,000)
25 appropriated in this section to the Department of Health and Human Services in TANF funds
26 for the 2010-2011 fiscal year for community services shall be used to support TANF-eligible
27 programs. The Department, upon review and approval of the Office of State Budget and
28 Management, shall implement an equivalent reduction of General Fund appropriations and
29 shall transfer the appropriations to support community services.

30 31 **TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) EMERGENCY** 32 **CONTINGENCY FUNDS**

33 **SECTION 10.37.(r)** The sum of twenty million dollars (\$20,000,000) appropriated
34 under this section from TANF Emergency Contingency funds to the Department of Health and
35 Human Services, Division of Social Services, for the 2010-2011 fiscal year shall be used for
36 subsidized child care services. Payment for subsidized child care services provided with TANF
37 Emergency Contingency funds shall comply with all regulations and policies issued by the
38 Division of Child Development for the subsidized child care program.

39 **SECTION 10.37.(s)** The sum of forty-six million three hundred ninety-two
40 thousand five hundred forty-four dollars (\$46,392,544) appropriated under this section from
41 TANF Emergency Contingency funds to the Department of Health and Human Services,
42 Division of Social Services, for the 2010-2011 fiscal year shall be used to support assistance
43 payments provided under the Work First Family Assistance program.

44 45 **SOCIAL SERVICES BLOCK GRANT**

46 **SECTION 10.37.(t)** Social Services Block Grant funds appropriated to the North
47 Carolina Inter-Agency Council for coordinating homeless programs, child medical evaluations,
48 and community services provided by Children's Advocacy Centers are exempt from the
49 provisions of 10A NCAC 71R .0201(3).

50 **SECTION 10.37.(u)** The sum of one million seven hundred fifty thousand dollars
51 (\$1,750,000) appropriated in this section in the Social Services Block Grant to the Department

1 of Health and Human Services, Division of Social Services, for the 2010-2011 fiscal year shall
2 be used to support various child welfare training projects as follows:

- 3 (1) Provide a regional training center in southeastern North Carolina.
- 4 (2) Provide training for residential child caring facilities.
- 5 (3) Provide for various other child welfare training initiatives.

6 **SECTION 10.37.(v)** The sum of nine hundred forty-three thousand two dollars
7 (\$943,002) appropriated in this section to the Department of Health and Human Services in the
8 Social Services Block Grant for the 2010-2011 fiscal year shall be used to support maternity
9 home services.

10 **SECTION 10.37.(w)** The sum of one million nine hundred ninety-seven thousand
11 six hundred nineteen dollars (\$1,997,619) appropriated in this section in the Social Services
12 Block Grant for child caring agencies for the 2010-2011 fiscal year shall be allocated in support
13 of State foster home children.

14 **SECTION 10.37.(x)** The Department of Health and Human Services is authorized,
15 subject to the approval of the Office of State Budget and Management, to transfer Social
16 Services Block Grant funding allocated for departmental administration between divisions that
17 have received administrative allocations from the Social Services Block Grant.

18 **SECTION 10.37.(y)** Social Services Block Grant funds appropriated for the
19 Special Children's Adoption Incentive Fund will require a fifty percent (50%) local match.

20 **SECTION 10.37.(z)** The sum of three hundred seventy-five thousand dollars
21 (\$375,000) appropriated in this section in the Social Services Block Grant for the 2010-2011
22 fiscal year shall be allocated to the Division of Social Services to support community services
23 provided by Children's Advocacy Centers on behalf of children who are victims of child abuse.

24 **SECTION 10.37.(aa)** The sum of four hundred twenty-two thousand three dollars
25 (\$422,003) appropriated in this section in the Social Services Block Grant to the Department of
26 Health and Human Services, Division of Social Services, for the 2010-2011 fiscal year shall be
27 used to continue a Mental Health Services Program for children.

28 **LOW-INCOME HOME ENERGY ASSISTANCE BLOCK GRANT**

29 **SECTION 10.37.(bb)** Additional emergency contingency funds received may be
30 allocated for Energy Assistance Payments or Crisis Intervention Payments without prior
31 consultation with the Joint Legislative Commission on Governmental Operations. Additional
32 funds received shall be reported to the Joint Legislative Commission on Governmental
33 Operations and the Fiscal Research Division upon notification of the award. The Department of
34 Health and Human Services shall not allocate funds for any activities, including increasing
35 administration, other than assistance payments, without prior consultation with the Joint
36 Legislative Commission on Governmental Operations.

37 **CHILD CARE AND DEVELOPMENT FUND BLOCK GRANT**

38 **SECTION 10.37.(cc)** Payment for subsidized child care services provided with
39 federal TANF funds shall comply with all regulations and policies issued by the Division of
40 Child Development for the subsidized child care program.

41 **SECTION 10.37.(dd)** If funds appropriated through the Child Care and
42 Development Fund Block Grant for any program cannot be obligated or spent in that program
43 within the obligation or liquidation periods allowed by the federal grants, the Department may
44 move funds to child care subsidies, unless otherwise prohibited by federal requirements of the
45 grant, in order to use the federal funds fully.

46 **SECTION 10.37.(ee)** If American Recovery and Reinvestment Act of 2009 funds
47 appropriated through the Child Care and Development Fund Block Grant for any program
48 cannot be obligated or spent in that program within the obligation or liquidation periods
49 allowed by the federal grants, the Department may move funds to child care subsidies, unless
50
51

1 otherwise prohibited by federal requirements of the grant, in order to use the federal funds
2 fully.

4 **SUBSTANCE ABUSE PREVENTION AND TREATMENT BLOCK GRANT**

5 **SECTION 10.37.(ff)** The sum of two hundred fifty thousand dollars (\$250,000)
6 appropriated in this section in the Substance Abuse Prevention and Treatment Block Grant to
7 the Department of Health and Human Services, Division of Mental Health, Developmental
8 Disabilities, and Substance Abuse Services, for the 2010-2011 fiscal year for the North
9 Carolina Institute of Medicine (NCIOM) shall be used to study the following:

- 10 (1) The availability of Medicaid and State-funded mental health, developmental
11 disabilities, and substance abuse services to active duty, reserve, and veteran
12 members of the military and National Guard. The study should discuss the
13 current availability of services, the extent of use, and any gaps in services.
- 14 (2) Issues related to cost, quality, and access to appropriate and affordable
15 health care for all North Carolinians. The North Carolina Institute of
16 Medicine (NCIOM) may use funds appropriated for the 2007-2009 fiscal
17 biennium to continue the work of its Health Access Study Group to study
18 these issues. The Health Access Study Group may include in its study the
19 matters contained in Sections 31.1, 31.2, and 31.3 of S.L. 2008-181 and also
20 may monitor federal health-related legislation to determine how the
21 legislation would impact costs, quality, and access to health care.
- 22 (3) Short-term and long-term strategies to address issues within adult care
23 homes that provide residence to persons who are frail and elderly and to
24 persons suffering from mental illness.

25 The Institute shall make an interim report to the Governor's Office, the Joint
26 Legislative Health Care Oversight Committee, and the Joint Legislative Oversight Committee
27 on Mental Health, Developmental Disabilities, and Substance Abuse Services no later than
28 January 15, 2010, which may include recommendations and proposed legislation, and shall
29 issue its final report with findings, recommendations, and suggested legislation to the 2011
30 General Assembly upon its convening. In the event members of the General Assembly serve on
31 the NCIOM Health Access Study Group, they shall receive per diem, subsistence, and travel
32 allowances in accordance with G.S. 120-3.1. The Health Access Study Group may include in
33 its study the matters contained in Sections 31.1, 31.2, and 31.3 of S.L. 2008-181 and also may
34 monitor federal health-related legislation to determine how the legislation would impact costs,
35 quality, and access to health care.

37 **MATERNAL AND CHILD HEALTH BLOCK GRANT**

38 **SECTION 10.37.(gg)** If federal funds are received under the Maternal and Child
39 Health Block Grant for abstinence education, pursuant to section 912 of Public Law 104-193
40 (42 U.S.C. § 710), for the 2010-2011 fiscal year, then those funds shall be transferred to the
41 State Board of Education to be administered by the Department of Public Instruction. The
42 Department of Public Instruction shall use the funds to establish an abstinence until marriage
43 education program and shall delegate to one or more persons the responsibility of
44 implementing the program and G.S. 115C-81(e1)(4) and (4a). The Department of Public
45 Instruction shall carefully and strictly follow federal guidelines in implementing and
46 administering the abstinence education grant funds.

47 **SECTION 10.37.(hh)** The Department of Health and Human Services shall ensure
48 that there will be follow-up testing in the Newborn Screening Program.

50 **PART XI. DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES**

1 **FEE INCREASES FOR PESTICIDE DEALERS, PESTICIDE APPLICATORS, AND**
2 **PEST CONTROL CONSULTANTS**

3 **SECTION 11.1.(a)** G.S. 143-440 reads as rewritten:

4 **"§ 143-440. Restricted use pesticides regulated.**

5 (a) The Board may, by regulation after a public hearing, adopt and from time to time
6 revise a list of restricted use pesticides for the State or for designated areas within the State.
7 The Board may designate any pesticide or device as a "restricted use pesticide" upon the
8 grounds that, in the judgment of the Board (either because of its persistence, its toxicity, or
9 otherwise) it is so hazardous or injurious to persons, pollinating insects, animals, crops,
10 wildlife, lands, or the environment, other than the pests it is intended to prevent, destroy,
11 control, or mitigate that additional restriction on its sale, purpose, use or possession are
12 required.

13 (b) The Board may include in any such restricted use regulation the time and conditions
14 of sale, distribution, or use of such restricted use pesticides, may prohibit the use of any
15 restricted use pesticide for designated purposes or at designated times; may require the
16 purchaser or user to certify that restricted use pesticides will be used only as labeled or as
17 further restricted by regulation; may require the certification and recertification of private
18 applicators and, charge a fee of up to ten dollars (\$10.00), with the fee set at a level to make the
19 certification/recertification program self-supporting, and, after opportunity for a hearing, may
20 suspend, revoke or modify the certification for violation of any provision of this Article, or any
21 rule or regulation adopted thereunder; and may, if it deems it necessary to carry out the
22 provisions of this Part, require that any or all restricted use pesticides shall be purchased,
23 possessed, or used only under permit of the Board and under its direct supervision in certain
24 areas and/or under certain conditions or in certain quantities or concentrations except that any
25 person licensed to sell such pesticides may purchase and possess such pesticides without a
26 permit. The Board may require all persons issued such permits to maintain records as to the use
27 of the restricted use pesticides. The Board may authorize the use of restricted use pesticides by
28 persons licensed under the North Carolina Structural Pest Control Act without a permit. A
29 nonrefundable fee of ten dollars (\$10.00) shall be charged for each examination required by
30 this section. This examination fee is in addition to the certification or recertification fee, and
31 any other fee authorized pursuant to any other provision of Article 4C of Chapter 106 of the
32 General Statutes.

33 (c) A fee of fifty dollars (\$50.00) shall be charged for examination of individuals
34 seeking to be designated as Worker Protection Designated Trainers, in accordance with
35 provisions of the Federal Worker Protection Standard set forth in 40 C.F.R. Part 170, and
36 subsequent amendments to those regulations."

37 **SECTION 11.1.(b)** G.S. 143-448(b) reads as rewritten:

38 **"§ 143-448. Licensing of pesticide dealers; fees.**

39 ...
40 (b) Applications for a pesticide dealer license shall be in the form and shall contain the
41 information prescribed by the Board. Each application shall be accompanied by a
42 non-refundable fee of ~~fifty dollars (\$50.00)~~ seventy-five dollars (\$75.00). All licenses issued
43 under this Part shall expire on December 31 of the year for which they are issued.

44"

45 **SECTION 11.1.(c)** G.S. 143-449(b) reads as rewritten:

46 **"§ 143-449. Qualifications for pesticide dealer license; examinations.**

47 ...
48 (b) Each applicant shall satisfy the Board as to his responsibility in carrying on the
49 business of a pesticide dealer. Each applicant for an original license must demonstrate upon
50 written, or written and oral, examination to be prescribed by the Board his knowledge of
51 pesticides, their usefulness and their hazards; his competence as a pesticide dealer; and his

1 knowledge of the laws and regulations governing the use and sale of pesticides. A
2 nonrefundable fee of fifty dollars (\$50.00) shall be charged for each examination required by
3 this section. This examination fee is in addition to any fee authorized pursuant to any other
4 provision of Article 4C of Chapter 106 of the General Statutes.

5"

6 **SECTION 11.1.(d)** G.S. 143-452(b) reads as rewritten:

7 **"§ 143-452. Licensing of pesticide applicators; fees.**

8 ...

9 (b) Applications for pesticide applicator license shall be in the form and shall contain
10 the information prescribed by the Board. Each application shall be accompanied by a
11 non-refundable fee of ~~fifty dollars (\$50.00)~~ seventy-five dollars (\$75.00) for each pesticide
12 applicator's license. In addition, an annual inspection fee of twenty-five dollars (\$25.00) shall
13 be submitted for each aircraft to be licensed. Should any aircraft fail to pass inspection, making
14 it necessary for a second inspection to be made, the Board shall require an additional
15 twenty-five-dollar (\$25.00) inspection fee. In addition to the required inspection, unannounced
16 inspections may be made without charge to determine if equipment is properly calibrated and
17 maintained in conformance with the laws and regulations. All aircraft licensed to apply
18 pesticides shall be identified by a license plate or decal furnished by the Board at no cost to the
19 licensee, which plate or decal shall be affixed on the aircraft in a location and manner
20 prescribed by the Board. No applicator inspection or license fee, original or renewal, shall be
21 charged to State agencies or local governments or their employees. Inspections of ground
22 pesticide application equipment may be made. Any such equipment determined to be faulty or
23 unsafe shall not be used for the purpose of applying a pesticide(s) until such time as proper
24 repairs and/or alterations are made."

25 **SECTION 11.1.(e)** G.S. 143-453 reads as rewritten:

26 **"§ 143-453. Qualifications for pesticide applicator's license; examinations.**

27 (a) An applicant for a license must present satisfactory evidence to the Board
28 concerning his qualifications for a pesticide applicator license. The contractor and each pilot
29 involved in aerial application of pesticides shall be licensed.

30 Those qualifications, in the case of a pilot, shall include at least 125 hours and one year's
31 flying experience as a pilot in the field of aerial pesticide application. A pilot lacking 125 hours
32 and one year's experience as a pilot in the field of aerial pesticide application shall be licensed
33 as an apprentice aerial pesticide applicator pilot. All aerial applications of pesticides by a
34 licensed apprentice shall be conducted under the direct supervision of a licensed pesticide
35 applicator pilot. The supervising pilot, while directly supervising an apprentice, shall operate
36 out of the same airstrip as the apprentice and shall be available periodically throughout each
37 day to provide advice and assistance to the apprentice. A nonrefundable fee of fifty dollars
38 (\$50.00) shall be charged for the examination required by this subsection. Such examination
39 fee shall be charged in addition to the fees authorized pursuant to subsection (b) of this section
40 or any other provision of Article 4C of Chapter 106 of the General Statutes.

41 (b) Each applicant shall satisfy the Board as to his knowledge of the laws and
42 regulations governing the use and application of pesticides in the classifications he has applied
43 for (manually or with various equipment that he may have applied for a license to operate), and
44 as to his responsibility in carrying on the business of a pesticide applicator. Each applicant for
45 an original license must demonstrate upon written, or written and oral, examination to be
46 prescribed by the Board his knowledge of pesticides, their usefulness and their hazards; his
47 competence as a pesticide applicator; and his knowledge of the laws and regulations governing
48 the use and application of pesticides in the classification for which he has applied. A
49 nonrefundable fee of fifty dollars (\$50.00) shall be charged for the core examination, and an
50 additional twenty dollars (\$20.00) shall be charged for each additional specific classification
51 licensure. Such examination fees shall be charged in addition to the fees authorized pursuant to

1 subsection (a) of this section or any other provision of Article 4C of Chapter 106 of the General
2 Statutes.

3"

4 **SECTION 11.1.(f)** G.S. 143-455 reads as rewritten:

5 **"§ 143-455. Pest control consultant license.**

6 (a) No person shall perform services as a pest control consultant without first procuring
7 from the Board a license. Applications for a consultant license shall be in the form and shall
8 contain the information prescribed by the Board. The application for a license shall be
9 accompanied by a non-refundable annual fee of ~~fifty dollars (\$50.00)~~seventy-five dollars
10 (\$75.00).

11 (b) An applicant for a consultant license must present satisfactory evidence to the Board
12 concerning his qualifications for such license. The Board may classify consultant licenses into
13 one or more classifications or subclassifications based upon types of consulting services
14 performed or to be performed. Such classifications and subclassifications may reflect the crops
15 involved in the consulting service, the discipline or training of consultant, the discretion or lack
16 of discretion involved in the consulting service, and the site or location of the service. Each
17 classification and subclassification may be subject to separate testing procedures and
18 requirements, and may be subject to its own minimum standards of training in specialized
19 subject matter from a recognized college or university, or equivalent specialized consulting
20 experience or training. A nonrefundable fee of fifty dollars (\$50.00) shall be charged for the
21 consultant examination, and an additional twenty dollars (\$20.00) shall be charged for each
22 additional specific classification licensure permitted by this subsection. Such examination fee
23 shall be charged in addition to the fees authorized pursuant to subsection (a) of this section or
24 any other provision of Article 4C of Chapter 106 of the General Statutes. Qualifications for
25 licensing may be less stringent if the licensee is restricted to making recommendations
26 contained in publications recognized by the Board as appropriate for a specific consulting
27 classification or subclassification.

28"

30 **STRUCTURAL PEST CONTROL ACT FEE INCREASES**

31 **SECTION 11.2.(a)** G.S. 106-65.27 reads as rewritten:

32 **"§ 106-65.27. Examinations of applicants; fee; license not transferable.**

33 (a) Certified Applicator. – All applicants for a certified applicator's identification card
34 shall demonstrate practical knowledge of the principles and practices of pest control and safe
35 use of pesticides. Competency shall be determined on the basis of written examinations to be
36 provided and administered by the Committee and, as appropriate, performance testing. Testing
37 shall be based upon examples of problems and situations appropriate to the particular phase or
38 subphase of structural pest control for which application is made and shall include, where
39 relevant, the following areas of competency:

- 40 (1) Label and labeling comprehension.
- 41 (2) Safety factors associated with pesticides – toxicity, precautions, first aid,
42 proper handling, etc.
- 43 (3) Influence of and on the environment.
- 44 (4) Pests – identification, biology, and habits.
- 45 (5) Pesticides – types, formulations, compatibility, hazards, etc.
- 46 (6) Equipment – types and uses.
- 47 (7) Application techniques.
- 48 (8) Laws and regulations.

49 An applicant for a certified applicator's identification card shall submit an examination fee
50 of ~~ten dollars (\$10.00)~~twenty-five dollars (\$25.00) for each phase or subphase of structural pest
51 control in which the applicant chooses to be examined. An examination for more than one

1 phase or subphase may be taken at the same time at any regularly scheduled examination.
2 Frequency of such examinations shall be at the discretion of the Committee, provided that a
3 minimum of two examinations be given annually. The examination will cover each phase or
4 subphase of structural pest control for which application is being made.

5 (b) License. – Each applicant for an original license must demonstrate upon written
6 examination, to be provided and administered by the Committee, his competency as a structural
7 pest control operator for the phase or subphase in which he is applying for a license. Frequency
8 of such examinations shall be at the discretion of the Committee, provided that a minimum of
9 two examinations shall be given annually. The examination will cover each phase or subphase
10 of structural pest control for which application is being made. All applicants for a license shall
11 register with the Division on a prescribed form. A license examination fee of ~~twenty-five~~
12 ~~dollars (\$25.00)~~ fifty dollars (\$50.00) shall be charged for each phase or subphase of structural
13 pest control in which the applicant chooses to be examined. An examination for more than one
14 phase or subphase of structural pest control may be taken at the same time.

15"

16 **SECTION 11.2.(b)** G.S. 106-65.31 reads as rewritten:

17 **"§ 106-65.31. Annual certified applicator card and license fee; registration of servicemen,**
18 **salesmen, solicitors, and estimators; identification cards.**

19 (a) Certified Applicator's Identification Card. – The fee for issuance or renewal of a
20 certified applicator's identification card shall be ~~thirty dollars (\$30.00)~~ fifty dollars (\$50.00).
21 Within 75 days after the employment of a certified applicator, the licensee shall apply to the
22 Division for the issuance of a certified applicator's identification card. A certified applicator's
23 identification card shall expire on June 30 of each year and shall be renewed annually. All
24 certified applicators who fail or neglect to renew their card on or before June 30 but make
25 application before January 1 of the following year may have their card renewed without having
26 to be reexamined unless the applicant is scheduled for periodic reexamination under regulations
27 adopted pursuant to G.S. 106-65.27(d)(3). All applicants submitting applications for the
28 renewal of their cards after June 30 shall not use or supervise the use of restricted use pesticides
29 until a new card has been issued.

30 Any certified applicator whose employment is terminated with a licensee or agent prior to
31 the end of any license year may at any time prior to the end of the license year be reissued a
32 certified applicator's identification card for the remainder of the license year as an employee of
33 another licensee or agency or as an individual for a fee of five dollars (\$5.00). The licensee
34 shall notify the Division of the termination or change in status of any certified applicator.

35 Any certified applicator whose identification card is lost or destroyed or changed in any
36 way may be reissued a new card for the remainder of the license year for a fee of five dollars
37 (\$5.00).

38 (b) License. – The fee for the issuance or renewal of a license for any one phase of
39 structural pest control shall be ~~one hundred fifty dollars (\$150.00)~~ two hundred dollars
40 (\$200.00). Each additional phase shall be ~~sixty-five dollars (\$65.00)~~ seventy-five dollars
41 (\$75.00). The fee for each subphase shall be fifteen dollars (\$15.00). Licenses shall expire on
42 June 30 of each year and shall be renewed annually. All licensees who fail or neglect to renew
43 their license on or before June 30, but who make application before January 1 of the following
44 year, may have their license renewed without having to be reexamined, unless the applicant is
45 scheduled for periodic reexamination under regulations adopted pursuant to
46 G.S. 106-65.27(d)(3). No structural pest control work may be performed until the license has
47 been renewed or until a new license has been issued.

48 Any licensee whose employment is terminated by his employer or any licensee who is
49 transferred to another company or location other than the company or location shown on his
50 license certificate, may at any time, have his license reissued for the remainder of the license
51 year for a fee of ten dollars (\$10.00).

1 Any licensee whose license is lost or destroyed may secure a duplicate license for a fee of
2 ten dollars (\$10.00).

3 (b1) Registration. – Within 75 days after the hiring of an employee who is either an
4 estimator, salesman, serviceman, or solicitor, the licensee shall apply to the Division for the
5 issuance of an identification card for such employee. The application must be accompanied by
6 a fee of ~~twenty-five dollars (\$25.00)~~ forty dollars (\$40.00) for each card. The card shall be
7 issued in the name of the employee and shall bear the name of the employing licensee, the
8 employer's license number and phases, the name and address of the employer's business, and
9 such other information as the Committee may specify. The identification card shall be carried
10 by the employee on his person at all times while performing any phase of structural pest control
11 work. The card must be displayed upon demand by the Commissioner, the Committee, the
12 Division, or any representative thereof, or the person for whom any phase of structural pest
13 control work is being performed. A registered technician's identification card must be renewed
14 annually on or before June 30 by payment of a renewal fee of twenty-five dollars (\$25.00). If a
15 card is lost or destroyed the licensee may secure a duplicate for a fee of five dollars (\$5.00). The
16 licensee shall notify the Division of the termination or change in status of any registered
17 technician. All identification cards expire when a license expires.

18 When a license is reissued, the licensee shall be responsible for registering and securing
19 identification cards for all existing employees who engage in structural pest control within 10
20 days of the reissuance of the license.

21 A certified applicator who is not an employee of a licensed individual shall register the
22 names of all employees under his supervision who are engaged in the performance of structural
23 pest control with the Division and shall purchase a registered technician's identification card for
24 each such employee.

25"

26 27 **CONSOLIDATE GRADE "A" MILK PROGRAM INTO DAIRY PROGRAM AND** 28 **STUDY FEE STRUCTURE**

29 **SECTION 11.3.(a)** All functions, powers, duties, and obligations previously vested
30 in the Grade "A" Milk Sanitation Program within the Division of Environmental Health of the
31 Department of Environment and Natural Resources are transferred to and vested in the Food
32 and Drug Protection Division of the Department of Agriculture and Consumer Services by a
33 Type I transfer, as defined in G.S. 143A-6.

34 **SECTION 11.3.(b)** The Department of Agriculture and Consumer Services shall
35 study the development of a schedule of fees for the Grade "A" Milk Sanitation Program

- 43 (4) The Small Business Ombudsman.

45 "(h) **Recycling Plan Required.** – Each applicant for an on-premises malt beverage
46 permit, on-premises unfortified wine permit, on-premises fortified wine permit, or a mixed
47 beverages permit shall prepare and submit with the application a plan for the collection and
48 recycling of all recyclable beverage containers of all beverages to be sold at retail on the
49 premises. A permittee who is not able to find a recycler for its beverage containers may apply
50 to the Alcoholic Beverage Control Commission for a one-year stay of the requirement to

19 (a) The General Assembly finds that the rapid growth of the urban and suburban areas
20 of North Carolina and the economic challenges facing many of the State's urban cores, rural
21 areas, and smaller communities create a significant need for the strategic use of resources to
22 plan and accommodate healthy and equitable development without compromising natural
23 systems and the needs of future generations of North Carolinians.

24 (b) The General Assembly finds that the following principles describe sustainable
25 development for North Carolina's communities:

26 (1) Better transportation choices. – Offering safe, reliable, and economical
27 motorized and nonmotorized transportation options to decrease household
28 transportation costs, reduce dependence on foreign oil, improve air quality,
29 reduce greenhouse gas emissions, and promote public health.

30 (2) Equitable, affordable housing. – Encouraging the provision to North
31 Carolina citizens of all ages, incomes, races, and ethnicities expanded
32 location-, water-, and energy-efficient housing choices that increase
33 mobility, decrease the impact on existing water and energy infrastructure,
34 and lower the combined cost of housing and transportation.

35 (3) Enhanced economic competitiveness. – Expanding business access to
36 markets and improving North Carolina's economic competitiveness through
37 reliable and timely access to employment centers, educational opportunities,
38 services, and other basic needs by workers.

39 (4) Support of existing communities. – Targeting public funds toward existing
40 communities that are using strategies such as transit-oriented, mixed-use
41 development, and land recycling to increase community revitalization,
42 enhance the efficiency and cost-effectiveness of public works investments,

44 (5) Coordination and leverage of State policies and investment. – Aligning State

8 to G.S. 130A-310.12(b). The penalty shall not exceed one hundred dollars (\$100.00) for a first
9 violation; two hundred dollars (\$200.00) for a second violation within any 12-month period;
10 and five hundred dollars (\$500.00) for each additional violation within any 12-month period for
11 any violation of Part 2G of Article 9 of this Chapter or of any rule adopted pursuant to
12 G.S. 130A-309.06(a)(15). If a person fails to pay a civil penalty within 60 days after the final
13 agency decision or court order has been served on the violator, the Secretary of Environment
14 and Natural Resources shall request the Attorney General to institute a civil action in the
15 superior court of any county in which the violator resides or has his or its principal place of
16 business to recover the amount of the assessment. Such civil actions must be filed within three
17 years of the date the final agency decision or court order was served on the violator.

19 20 **INCREASE HAZARDOUS WASTE FEES**

21 **SECTION 13.8.** G.S. 130A-294.1(f) reads as rewritten:

22 "(f) A person who generates 100 kilograms or more of hazardous waste in any calendar
23 month during the year beginning 1 July and ending 30 June but less than 1000 kilograms of
24 hazardous waste in each calendar month during that year shall pay an annual fee of one

42 **SECTION 13.10.(a)** G.S. 130A-309.121 reads as rewritten:

43 **"§ 130A-309.121. Definitions.**

44 As used in this Part, the following definitions apply:

- 45 (1) Plastic bag. – A carryout bag composed primarily of thermoplastic synthetic
46 polymeric material, which is provided by a store to a customer at the point of
47 sale and incidental to the purchase of other goods.
- 48 (2) Prepared foods retailer. – A retailer primarily engaged in the business of
49 selling prepared foods, as that term is defined in G.S. 105-164.3, to
50 consumers.

- 1 (2a) Recycled content. – Content that is either postconsumer, postindustrial, or a
 2 mix of postconsumer and postindustrial.
- 3 (3) Recycled paper bag. – A paper bag that meets all of the following
 4 requirements:
- 5 a. The bag is manufactured from one hundred percent (100%) recycled
 6 content, content, including postconsumer content, postindustrial
 7 content, or a mix of postconsumer and postindustrial content.
- 8 b. The bag displays the words "made from recycled material" and
 9 "recyclable."
- 10 (4) ~~Retail Chain. – Five or more stores located within the State that are engaged~~
 11 ~~in the same general field of business and (i) conduct business under the same~~
 12 ~~business name or (ii) operate under common ownership or management or~~
 13 ~~pursuant to a franchise agreement with the same franchisor.~~
- 14 (5) Retailer. – A person who offers goods for sale in this State to consumers and
 15 who provides a single-use plastic bag to the consumer to carry or transport
 16 the goods for free or for a nominal charge. ~~goods and (i) has more than 5,000~~
 17 ~~square feet of retail or wholesale space or (ii) is one of a retail chain.~~
- 18 (6) Reusable bag. – ~~A durable plastic bag with handles that is~~ A bag with
 19 handles that is specifically designed and manufactured for multiple reuse and
 20 is made of one of the following materials: at least 2.25 mils thick
- 21 a. Nonwoven polypropylene or other plastic material with a minimum
 22 weight of 80 grams per square meter, and is specifically designed and
 23 ~~manufactured for multiple reuse or a bag made of~~
- 24 b. ~~cloth~~ Cloth or other machine washable ~~fabric with handles.~~ fabric."

25 **SECTION 13.10.(b)** From funds available to the Department of Environment and
 26 Natural Resources, the Division of Waste Management and the Division of Environmental
 27 Assistance and Outreach shall monitor plastic bag use reduction resulting from the
 28 implementation of Part 2G of Article 9 of Chapter 130A of the General Statutes and shall report
 29 to the Environmental Review Commission on or before January 15, 2012, on the impacts the
 30 ban enacted by that Part has had on plastic bag litter in coastal waterways adjacent to areas
 31 where that Part applies.

32 **SECTION 13.10.(c)** Subsection (a) of this section becomes effective January 1,
 33 2011.

 35 **PARKS AND RECREATION TRUST FUND/AUTHORITY TO CONSIDER**
 36 **OPERATING EXPENSES**

37 **SECTION 13.11.** G.S. 113-44.15 reads as rewritten:

38 "**§ 113-44.15. Parks and Recreation Trust Fund.**

39 (a) Fund Created. – There is established a Parks and Recreation Trust Fund in the State
 40 Treasurer's Office. The Trust Fund shall be a nonreverting special revenue fund consisting of
 41 gifts and grants to the Trust Fund, monies credited to the Trust Fund pursuant to
 42 G.S. 105-228.30(b), and other monies appropriated to the Trust Fund by the General Assembly.
 43 Investment earnings credited to the assets of the Fund shall become part of the Fund.

44 (b) Use. – Funds in the Trust Fund are annually appropriated to the North Carolina
 45 Parks and Recreation Authority and, unless otherwise specified by the General Assembly or the
 46 terms or conditions of a gift or grant, shall be allocated and used as follows:

- 47 (1) Sixty-five percent (65%) for the State Parks System for capital projects,
 48 repairs and renovations of park facilities, and land acquisition, and to retire
 49 debt incurred for these purposes under Article 9 of Chapter 142 of the
 50 General Statutes.

1 (2) Thirty percent (30%) to provide matching funds to local governmental units
2 or public authorities as defined in G.S. 159-7 on a dollar-for-dollar basis for
3 local park and recreation purposes. The appraised value of land that is
4 donated to a local government unit or public authority may be applied to the
5 matching requirement of this subdivision. These funds shall be allocated by
6 the North Carolina Parks and Recreation Authority based on criteria
7 patterned after the Open Project Selection Process established for the Land
8 and Water Conservation Fund administered by the National Park Service of
9 the United States Department of the Interior.

10 (3) Five percent (5%) for the Coastal and Estuarine Water Beach Access
11 Program.

12 (b1) Geographic Distribution. – In allocating funds in the Trust Fund under this section,
13 the North Carolina Parks and Recreation Authority shall make geographic distribution across
14 the State to the extent practicable.

15 (b2) Administrative Expenses. – Of the funds appropriated to the North Carolina Parks
16 and Recreation Authority from the Trust Fund each year, no more than three percent (3%) may
17 be used by the Department for operating expenses associated with managing capital
18 improvements projects, acquiring land, and administration of local grants programs.

19 (b3) Operating Expenses for State Parks System Allocations. – In allocating funds in the
20 Trust Fund under subdivision (1) of subsection (b) of this section, the North Carolina Parks and
21 Recreation Authority shall consider the operating expenses associated with each capital project,
22 repair and renovation project, and each land acquisition. In considering the operating expenses,
23 the North Carolina Parks and Recreation Authority shall determine both:

24 (1) The minimal anticipated operating expenses, which are determined by the
25 minimum staff and other operating expenses needed to maintain the project.

26 (2) The optimal anticipated operating budget, which is determined by the level
27 of staff and other operating expenses required to achieve a more satisfactory
28 level of operation under the project.

29 (c) Reports. – The North Carolina Parks and Recreation Authority shall report no later
30 than October 1 of each year to the Joint Legislative Commission on Governmental Operations,
31 the House and Senate Appropriations Subcommittees on Natural and Economic Resources, the
32 Fiscal Research Division, and the Environmental Review Commission on allocations from the
33 Trust Fund from the prior fiscal year. For funds allocated from the Trust Fund under
34 subdivision (b1) of this section, this report shall include the operating expenses determined
35 under subdivisions (1) and (2) of subsection (b3) of this section.

36 ..."

37 38 **RECLASSIFY SEVEN VACANT POSITIONS IN THE DIVISION OF PARKS AND** 39 **RECREATION**

40 **SECTION 13.12.** The Division of Parks and Recreation of the Department of
41 Environment and Natural Resources shall reclassify seven vacant positions within the Division
42 and shall fill these reclassified positions in a timely manner in order to provide support for new
43 or expanding parks within the State Parks System, as defined in G.S. 113-44.9.

44 45 **STATE PARKS SYSTEM PLAN**

46 **SECTION 13.13.** G.S. 113-44.11 is amended by adding a new subsection to read:

47 "(d) No later than October 1 of each year, the Department shall submit electronically the
48 State Parks System Plan to the Environmental Review Commission, the Senate and the House
49 of Representatives Appropriations Subcommittees on Natural and Economic Resources, and
50 the Fiscal Research Division. Concurrently, the Department shall submit a summary of each
51 change to the Plan that was made during the previous fiscal year."

NO NEW FEES FOR PARKING IN STATE PARKS

SECTION 13.14. Notwithstanding any provision to the contrary, the funds appropriated to the Department of Environment and Natural Resources for State Parks for the 2010-2011 fiscal year shall not be reduced or replaced with fees for parking at State Parks, unless these fees were charged prior to the 2010-2011 fiscal year. No fees shall be charged and no fees shall be collected for parking in a State Park during the 2010-2011 fiscal year, unless these fees were charged prior to the 2010-2011 fiscal year.

AUTHORITY FOR THE DEPARTMENT OF REVENUE TO SHARE INFORMATION WITH DENR

SECTION 13.15. G.S. 105-259(b) is amended by adding a new subdivision to read:

"(b) Disclosure Prohibited. – An officer, an employee, or an agent of the State who has access to tax information in the course of service to or employment by the State may not disclose the information to any other person except as provided in this subsection. Standards used or to be used for the selection of returns for examination and data used or to be used for determining the standards may not be disclosed for any purpose. All other tax information may be disclosed only if the disclosure is made for one of the following purposes:

...

(40) To furnish the Division of Forest Resources of the Department of Environment and Natural Resources pertinent contact and financial information concerning companies that are involved in the primary processing of timber products so that the Secretary of Environment and Natural Resources is able to comply with G.S. 113A-193 under the Primary Forest Product Assessment Act."

DIVISION OF MARINE FISHERIES AND DIVISION OF FOREST RESOURCES AIRCRAFT MAINTENANCE

SECTION 13.16.(a) The Division of Marine Fisheries of the Department of Environment and Natural Resources shall use mechanics employed by the Division of Forest Resources of the Department of Environment and Natural Resources for the purpose of performing aircraft maintenance for all aircraft of the Division of Marine Fisheries except for a particular instance when this would be impracticable.

SECTION 13.16.(b) The Division of Forest Resources of the Department of Environment and Natural Resources shall perform aircraft maintenance using its mechanics for all aircraft of the Division of Marine Fisheries, except for a particular instance when this would be impracticable. The Division of Forest Resources shall develop a process to establish priorities for the aviation maintenance needs of all the aircraft in both the Division of Forest Resources and the Division of Marine Fisheries.

PURCHASE OF COMPUTER SOFTWARE BY DENR FOR DENR AIRCRAFT FLIGHTS AND MAINTENANCE RECORDKEEPING

SECTION 13.17. The Department of Environment and Natural Resources shall purchase computer software to be used to establish and maintain a record of the flights and the maintenance of aircraft of the Department of Environment and Natural Resources. For the purchase under this section, the Department of Environment and Natural Resources shall use funds realized from the sale of aircraft by the divisions within the department that operate aircraft. The Department of Environment and Natural Resources shall work with the Division of Marine Fisheries, the Division of Forest Resources, and the Aviation Division of the Department of Transportation to develop the specifications for this software system and to

1 evaluate the best product available to accomplish the purpose set forth in this section. The
2 Department should evaluate all available options, including the purchase of a commercially
3 available system and the purchase of a license to use a software system that is currently used by
4 another State agency. The purchase under this section is subject to all State laws and rules
5 regarding the procurement of distributed information technology assets, as defined in
6 G.S. 147-33.81.

8 **REPORT ON DENR AVIATION ACTIVITIES**

9 **SECTION 13.18.(a)** No later than October 1, 2010, the Department of
10 Environment and Natural Resources shall submit a report to the Joint Legislative Commission
11 on Governmental Operations, the House of Representatives and Senate Appropriations
12 Subcommittees on Natural and Economic Resources, and the Fiscal Research Division. The
13 report shall:

- 14 (1) Describe the uses of the State aircraft fleet within the control of either the
15 Division of Forest Resources of the Department of Environment and Natural
16 Resources or the Division of Marine Fisheries of the Department of
17 Environment and Natural Resources; and
- 18 (2) Describe the progress of the Department of Environment and Natural
19 Resources in implementing the eight management practices that were
20 recommended by the Program Evaluation Division of the General Assembly
21 in its report entitled "Selling 25 Underutilized Aircraft May Yield Up to \$8.1
22 Million and Save \$1.5 Million Annually" (Report 2010-04), based upon its
23 study of the State's aircraft fleets, as authorized by Section 14.6 of S.L.
24 2009-451.

25 **SECTION 13.18.(b)** The Department of Environment and Natural Resources shall
26 include in its report under subsection (a) of this section a summary of the Conklin & de Decker
27 report that is due to be submitted to the Division of Forest Resources in August 2010, including
28 any recommendations included in the Conklin & de Decker report and a description of the
29 Department's plan to implement the Conklin & de Decker report recommendations.

31 **FISHERY RESOURCE GRANT FUNDS TO BE USED FOR AT-SEA OBSERVER 32 PROGRAM**

33 **SECTION 13.19.(a)** Of the funds appropriated to the Department of Environment
34 and Natural Resources for the Fishery Resource Grant Program for the 2010-2011 fiscal year,
35 the sum of three hundred thousand dollars (\$300,000) shall be used by the Division of Marine
36 Fisheries to develop and establish the At-Sea Observer Program. Establishing and funding the
37 At-Sea Observer Program is necessary to meet federal requirements to monitor gill net fisheries
38 statewide and record sea turtle and other endangered and threatened species interactions.

39 **SECTION 13.19.(b)** The funds allocated under subsection (a) of this section shall
40 be used to establish and support three Marine Fisheries Technician II positions to provide
41 at-sea-observer coverage. In establishing the positions under this section, it is the intent of the
42 General Assembly to enable gill net fishing to continue in North Carolina and to enhance the
43 ability of the Division of Marine Fisheries to collect and analyze data necessary to determine
44 the health of fish stock, such as measures of spawning stock biomass, mortality, recruitment,
45 and sustainable harvest levels. Actions recommended in Fishery Management Plans, which are
46 developed in accordance with G.S. 113-182.1 to ensure the long-term viability of the State's
47 commercially and recreationally significant species or fisheries, rely upon these data.

49 **GRASSROOTS SCIENCE PROGRAM**

50 **SECTION 13.20.** Section 13.7.(a) of S.L. 2009-451 reads as rewritten:

"SECTION 13.7.(a) Of the funds appropriated in this act to the Department of Environment and Natural Resources for the Grassroots Science Program, the sum of three million four hundred eleven thousand seven hundred thirteen dollars (\$3,411,713) for the 2009-2010 fiscal year and the sum of ~~three million four hundred eleven thousand seven hundred thirteen dollars (\$3,411,713)~~three million two hundred forty-one thousand one hundred twenty-seven dollars (\$3,241,127) for the 2010-2011 fiscal year is allocated as grants-in-aid for each fiscal year as follows:

"**SECTION 14.1.** Of the funds appropriated in this act to the One North Carolina Fund for the ~~2009-2010~~2010-2011 fiscal year, the Department of Commerce may use up to three hundred thousand dollars (\$300,000) to cover its expenses in administering the One North Carolina Fund and other economic development incentive grant programs during the ~~2009-2010~~2010-2011 fiscal year."

SECTION 14.2.(a) Appropriations from federal block grant funds are made for the fiscal year ending June 30, 2011, according to the following schedule:

SECTION 14.2.(b) Decreases in Federal Fund Availability. – If federal funds are reduced below the amounts specified above after the effective date of this act, then every program in each of these federal block grants shall be reduced by the same percentage as the reduction in federal funds.

SECTION 14.2.(c) Increases in Federal Fund Availability for Community Development Block Grant. – Any block grant funds appropriated by the Congress of the United States in addition to the funds specified in this section shall be expended as follows: each program category under the Community Development Block Grant shall be increased by the same percentage as the increase in federal funds.

SECTION 14.2.(d) Limitations on Community Development Block Grant Funds. – Of the funds appropriated in this section for the Community Development Block Grant, the following shall be allocated in each category for each program year: up to one million dollars (\$1,000,000) may be used for State Administration; up to sixteen million five hundred thousand dollars (\$16,500,000) may be used for Scattered Site Housing; up to seven million two hundred ten thousand dollars (\$7,210,000) may be used for Economic Development; up to three million dollars (\$3,000,000) may be used for Small Business/Entrepreneurship; not less than eight million two hundred forty thousand dollars (\$8,240,000) shall be used for NC Catalyst; up to

1 four hundred fifty thousand dollars (\$450,000) may be used for State Technical Assistance; up
2 to eight million dollars (\$8,000,000) may be used for Infrastructure; six hundred thousand
3 dollars (\$600,000) may be used for Capacity Building. If federal block grant funds are reduced
4 or increased by the Congress of the United States after the effective date of this act, then these
5 reductions or increases shall be allocated in accordance with subsection (b) or (c) of this
6 section, as applicable.

7 **SECTION 14.2.(e)** Increase Capacity for Nonprofit Organizations. – Assistance to
8 nonprofit organizations to increase their capacity to carry out CDBG-eligible activities in
9 partnership with units of local government is an eligible activity under any program category in
10 accordance with federal regulations. Capacity building grants may be made from funds
11 available within program categories, program income, or unobligated funds.

12 **SECTION 14.2.(f)** The Department of Commerce shall consult with the Joint
13 Legislative Commission on Governmental Operations prior to reallocating Community
14 Development Block Grant Funds. Notwithstanding the provisions of this subsection, whenever
15 the Director of the Budget finds that:

16 (1) A reallocation is required because of an emergency that poses an imminent
17 threat to public health or public safety, the Director of the Budget may
18 authorize the reallocation without consulting the Commission. The
19 Department of Commerce shall report to the Commission on the reallocation
20 no later than 30 days after it was authorized and shall identify in the report
21 the emergency, the type of action taken, and how it was related to the
22 emergency.

23 (2) The State will lose federal block grant funds or receive less federal block
24 grant funds in the next fiscal year unless a reallocation is made. The
25 Department of Commerce shall provide a written report to the Commission
26 on the proposed reallocation and shall identify the reason that failure to take
27 action will result in the loss of federal funds. If the Commission does not
28 hear the issue within 30 days of receipt of the report, the Department may
29 take the action without consulting the Commission.

30 **SECTION 14.2.(g)** By September 1, 2010, the Division of Community Assistance,
31 Department of Commerce, shall report to the Joint Legislative Commission on Governmental
32 Operations and the Fiscal Research Division on the use of Community Development Block
33 Grant Funds appropriated in the prior fiscal year.

34 35 **STATE AGENCIES AND INSTITUTIONS/GREATER ENERGY EFFICIENCY** 36 **REPORTING AND COMPLIANCE**

37 **SECTION 14.3.** G.S. 143-64.12 reads as rewritten:

38 "**§ 143-64.12. Authority and duties of the Department; State agencies and State**
39 **institutions of higher learning.**

40 (a) The Department of Commerce through the State Energy Office shall develop a
41 comprehensive program to manage energy, water, and other utility use for State agencies and
42 State institutions of higher learning and shall update this program annually. Each State agency
43 and State institution of higher learning shall develop and implement a management plan that is
44 consistent with the State's comprehensive program under this subsection to manage energy,
45 water, and other utility ~~use~~, and that addresses any findings or recommendations resulting
46 from the energy audit required by subsection (b1) of this section. The energy consumption per

(b) The application and fee required by subsection (e) of this section shall be addressed presented to the clerk of the court of the county in which such divorced person resides or where the divorce was granted, and shall set forth the full name of the former spouse of the applicant, the name of the county and state in which the divorce was granted, and the term or session of court at which such divorce was granted, and shall be signed by the woman in her full maiden name, or by the man in his full premarriage surname. The clerks of court of the several counties of the State shall record and index such applications in such manner as shall be required by the Administrative Office of the Courts.

1 (c) If an applicant, since the divorce, has adopted one of the surnames listed in
2 subsection (a) or (a1) of this section, the applicant's use and adoption of that name is validated.

27 Fund; (iv) the Department of Justice."

31 PROVIDE FEE SCHEDULE REQUIREMENTS FOR LAW ENFORCEMENT 32 SUPPORT SERVICES

33 SECTION 17.1.(a) The General Assembly finds that a centralized evidence and
34 DNA storage facility will provide local law enforcement agencies and clerks of court with a
35 lower cost storage alternative, reducing or eliminating the need for local entities to provide
36 their own storage and streamlining the evidence storage process.

37 SECTION 17.1.(b) G.S. 143B-475.2 is repealed.

38 SECTION 17.1.(c) Part 7 of Article 11 of Chapter 143B of the General Statutes is
39 amended by adding a new section to read:

41 Fees shall be established and collected by the Department for all program services provided
42 by the Law Enforcement Support Services Division, except for Department of Defense
43 property being transferred pursuant to the National Defense Authorization Act of 1997. The

26 of State Budget and Management and the Governor's Crime Commission shall consult with the
27 Department of Juvenile Justice and Delinquency Prevention regarding the criteria for awarding
28 federal funds. The Office of State Budget and Management, the Governor's Crime
29 Commission, and the Department of Juvenile Justice and Delinquency Prevention shall report
30 to the Appropriations Committees of the Senate and House of Representatives and the Joint
31 Legislative Commission on Governmental Operations prior to allocation of the federal funds.
32 The report shall identify the amount of funds to be received for the 2010-2011 fiscal year, the
33 amount of funds anticipated for the 2010-2011 fiscal year, and the allocation of funds by
34 program and purpose.

38 **SECTION 18.2.** Section 18.4 of S.L. 2009-451 is repealed.

42 **FEDERAL GRANT MATCHING FUNDS**

43 **SECTION 19.1.** Section 19.9 of S.L. 2009-451 reads as rewritten:

44 "**SECTION 19.9.** Notwithstanding the provisions of G.S. 143C-6-9, the Department of
45 Correction may use up to the sum of one million two hundred thousand dollars (\$1,200,000)
46 during the 2009-2010 fiscal year and up to the sum of one million two hundred thousand
47 dollars (\$1,200,000) during the 2010-2011 fiscal year from funds available to the Department
48 to provide the State match needed in order to receive federal grant funds. Prior to using funds
49 for this purpose, the Department shall report to the Chairs of the House of Representatives and
50 Senate Appropriations Subcommittees on Justice and Public Safety and the Joint Legislative
51 Commission on Governmental Operations on the grants to be matched using these funds."

PLAN FOR A PILOT PROGRAM ON PRIVATIZATION OF PROBATION SERVICES

SECTION 19.2. The Department of Correction, Division of Community Corrections, shall develop a plan for implementing a pilot program on the privatization of probation services. The plan shall include a determination of what resources and policy changes are necessary to conduct a pilot program for fee-based supervision of low-risk or community-level offenders by private entities.

No pilot program shall be implemented without the prior approval of the General Assembly. The Division shall report its plan to the Joint Legislative Corrections, Crime Control, and Juvenile Justice Oversight Committee and the Fiscal Research Division by March 1, 2011.

The court may require that the fee be paid in advance or in a lump sum or sums, and a probation officer may require payment by such methods if he is authorized by subsection (g) to determine the payment schedule. Supervision fees must be paid to the clerk of court for the county in which the judgment was entered or the deferred prosecution agreement was filed. Fees collected under this subsection shall be transmitted to the State for deposit into the State's General Fund."

"(f) Required Supervision Fee. – The Commission shall require as a condition of post-release supervision that the supervisee pay a supervision fee of ~~thirty dollars (\$30.00)~~forty dollars (\$40.00) per month. The fee shall be paid to the clerk of superior court of the county in which the supervisee was convicted. In no event shall a supervisee be required to pay more than one supervision fee per month."

SECTION 19.3.(c) G.S. 15A-1374(c) reads as rewritten:

INCREASE FEE FOR COMMUNITY SERVICE PROGRAM

18 (a1) For each fiscal year, the State Superintendent of Public Instruction shall calculate a
19 per student allocation for the driver education program by dividing the total funds allocated for
20 the program by the estimated number of qualified students throughout the State, as described in
21 subsection (a) of this section. The Superintendent shall distribute funds to local school
22 administrative units by giving each local school administrative unit an amount equal to the per
23 student allocation multiplied by the estimated number of qualified students within that local
24 school administrative unit's district, including students enrolled in both public and private
25 schools. If, at the end of the fiscal year, fewer than the expected number of students have
26 participated in the driver education program in a local school administrative unit, then the local
27 school administrative unit shall revert the per student allocation for each student that was
28 estimated to be eligible to participate but did not actually participate in the driver education
29 program.

30 ...

31 (c) All expenses incurred by the State in carrying out the provisions of this section shall
32 be paid out of the Highway Fund. At the end of each fiscal year, the Department of Public
33 Instruction shall collect and revert any unused funds allocated for this program back to the
34 Highway Fund.

36 37 **PART XXIX. SALARIES AND BENEFITS**

38 39 **FURLOUGHS AUTHORIZED/PUBLIC SCHOOLS**

40 **SECTION 29.1.(a)** The General Assembly finds that:

- 41 (1) North Carolina's citizens and businesses are suffering from the effects of a
42 significant State financial crisis.
- 43 (2) The financial crisis has resulted in large reductions in revenues projected to
44 be available to fund the State's budget for the 2010-2011 fiscal year.
- 45 (3) Each local school administrative unit is required to reduce its budget and
46 should attempt to protect employees when possible.
- 47 (4) The implementation of furloughs may be necessary to balance local school
48 administrative unit budgets for the 2010-2011 fiscal year.

49 **SECTION 29.1.(b)** In accordance with Section 7.13 of this act, local boards of
50 education may implement furloughs of State-funded public school employees to offset the LEA
51 funding flexibility adjustment.

1 **SECTION 29.1.(c)** The following definitions apply in this section:

2 (1) Furlough. – A temporary period of leave from employment without pay that
3 (i) is ordered by a local board of education and (ii) is not in connection with
4 a demotion or other disciplinary action.

5 (2) Public school employee. – Any person employed by a local school
6 administrative unit. The term includes public officers.

7 **SECTION 29.1.(d)** The provisions of Section 26.14E.(b) and (c) of S.L. 2009-451
8 apply to public school employees furloughed pursuant to the section.

9 **SECTION 29.1.(e)** Local school administrative units shall cooperate with the
10 Department of Public Instruction in the implementation of a furlough, if required.

11 **SECTION 29.1.(f)** As soon as practicable, and no more than 30 calendar days from
12 the effective date of this section, the State Board of Education shall adopt rules for the
13 implementation of this section in accordance with G.S. 150B-21.1A, except that
14 notwithstanding G.S. 150B-21.1A(d), those emergency rules may remain in effect until the
15 expiration of this section. These rules shall be applied by local boards of education in
16 designating the times public school employees may be subject to furlough. These rules shall
17 provide, at a minimum, that:

18 (1) Employees who work only on instructional days shall not be subject to
19 furlough.

20 (2) Employees who earn an annual base rate of thirty thousand dollars (\$30,000)
21 or less shall not be subject to furlough.

22 (3) A furlough for other employees shall be for the same number of days for all
23 such employees and shall be for a maximum of two days;

24 (4) No teacher shall be subject to a furlough on an instructional day or a
25 protected work day.

26 (5) A local board of education shall have a public hearing and shall disclose the
27 local school administrative unit's finances before the local board implements
28 a furlough.

29 (6) The local school administrative unit shall cut all bonus pay before it imposes
30 a furlough.

31 (7) A local school administrative unit may spread the salary or wage reduction
32 for furloughed employees over the contract period in order to lessen the
33 impact on the employees.

34 (8) All savings realized as a result of a furlough shall be used to offset the LEA
35 funding flexibility adjustment.

36 (9) A county in which a local school administrative unit implements a furlough
37 pursuant to this section shall not supplant existing local current expense
38 funds for schools.

39 (10) Each local board of education shall report to the State Board of Education on
40 the details of any furlough implemented by the local school administrative
41 unit and certify that the furlough complied with the provisions of this section
42 and the rules adopted by the State Board.

43 **SECTION 29.1.(g)** The provisions of Section 26.14E.(e) of S.L. 2009-451 apply to
44 furloughs under this section.

45 **SECTION 29.1.(h)** A furlough as implemented by this section does not constitute
46 a demotion pursuant to Part 3 of Article 22 of Chapter 115C of the General Statutes or under
47 any other personnel law or policy.

48 **SECTION 29.1.(i)** Notwithstanding G.S. 115C-273, 115C-285(b), 115C-302.1(h),
49 and 115C-316(b), or any other provision of law, public school employees who are not paid out
50 of State funds shall receive the same reduction in pay applicable to State-paid employees in the
51 event a furlough is enacted by a local school administrative unit.

1 **SECTION 29.1.(j)** This section is effective when it becomes law and expires June
2 30, 2011.

3
4 **TEACHER SALARY SCHEDULES**

5 **SECTION 29.2.(a)** The following monthly salary schedules shall apply for the
6 2010-2011 fiscal year to certified personnel of the public schools who are classified as teachers.
7 The schedule contains 34 steps, with each step corresponding to one year of teaching
8 experience. Public school employees paid according to this salary schedule and receiving
9 NBPTS certification or obtaining a master's degree shall not be prohibited from receiving the
10 appropriate increase in salary. Provided, however, teachers employed during the 2009-2010
11 school year who did not work the required number of months to acquire an additional year of
12 experience shall not receive a decrease in salary as otherwise would be required by the salary
13 schedule below.

SECTION 29.2.(b) Annual longevity payments for teachers shall be at the rate of one and one-half percent (1.5%) of base salary for 10 to 14 years of State service, two and twenty-five hundredths percent (2.25%) of base salary for 15 to 19 years of State service, three and twenty-five hundredths percent (3.25%) of base salary for 20 to 24 years of State service, and four and one-half percent (4.5%) of base salary for 25 or more years of State service. The longevity payment shall be paid in a lump sum once a year.

SECTION 29.2.(c) Certified public schoolteachers with certification based on academic preparation at the six-year degree level shall receive a salary supplement of one hundred twenty-six dollars (\$126.00) per month in addition to the compensation provided for certified personnel of the public schools who are classified as "M" teachers. Certified public schoolteachers with certification based on academic preparation at the doctoral degree level shall receive a salary supplement of two hundred fifty-three dollars (\$253.00) per month in

1 addition to the compensation provided for certified personnel of the public schools who are
 2 classified as "M" teachers.

3 **SECTION 29.2.(d)** The first step of the salary schedule for school psychologists
 4 shall be equivalent to Step 5, corresponding to five years of experience, on the salary schedule
 5 established in this section for certified personnel of the public schools who are classified as
 6 "M" teachers. Certified psychologists shall be placed on the salary schedule at an appropriate
 7 step based on their years of experience. Certified psychologists shall receive longevity
 8 payments based on years of State service in the same manner as teachers.

9 Certified psychologists with certification based on academic preparation at the
 10 six-year degree level shall receive a salary supplement of one hundred twenty-six dollars
 11 (\$126.00) per month in addition to the compensation provided for certified psychologists.
 12 Certified psychologists with certification based on academic preparation at the doctoral degree
 13 level shall receive a salary supplement of two hundred fifty-three dollars (\$253.00) per month
 14 in addition to the compensation provided for certified psychologists.

15 **SECTION 29.2.(e)** Speech pathologists who are certified as speech pathologists at
 16 the master's degree level and audiologists who are certified as audiologists at the master's
 17 degree level and who are employed in the public schools as speech and language specialists and
 18 audiologists shall be paid on the school psychologist salary schedule.

19 Speech pathologists and audiologists with certification based on academic
 20 preparation at the six-year degree level shall receive a salary supplement of one hundred
 21 twenty-six dollars (\$126.00) per month in addition to the compensation provided for speech
 22 pathologists and audiologists. Speech pathologists and audiologists with certification based on
 23 academic preparation at the doctoral degree level shall receive a salary supplement of two
 24 hundred fifty-three dollars (\$253.00) per month in addition to the compensation provided for
 25 speech pathologists and audiologists.

26 **SECTION 29.2.(f)** Certified school nurses who are employed in the public schools
 27 as nurses shall be paid on the "M" salary schedule.

28 **SECTION 29.2.(g)** As used in this section, the term "teacher" shall also include
 29 instructional support personnel.
 30

31 **SCHOOL-BASED ADMINISTRATOR SALARY SCHEDULE**

32 **SECTION 29.3.(a)** The following base salary schedule for school-based
 33 administrators shall apply only to principals and assistant principals. This base salary schedule
 34 shall apply for the 2010-2011 fiscal year, commencing July 1, 2010. Provided, however,
 35 school-based administrators (i) employed during the 2009-2010 school year who did not work
 36 the required number of months to acquire an additional year of experience and (ii) employed
 37 during the 2010-2011 school year in the same classification shall not receive a decrease in
 38 salary as otherwise would be required by the salary schedule below.

SECTION 29.3.(b) The appropriate classification for placement of principals and assistant principals on the salary schedule, except for principals in alternative schools and in cooperative innovative high schools, shall be determined in accordance with the following schedule:

The beginning classification for principals in alternative schools and in cooperative innovative high school programs shall be the Principal III level. Principals in alternative schools who supervise 33 or more teachers shall be classified according to the number of teachers supervised.

SECTION 29.3.(c) A principal shall be placed on the step on the salary schedule that reflects total number of years of experience as a certificated employee of the public schools and an additional step for every three years of experience as a principal. Provided, however, a principal who acquires an additional step for the 2009-2010 or 2010-2011 fiscal years shall not receive a corresponding increase in salary during the 2009-2011 fiscal biennium. A principal or assistant principal shall also continue to receive any additional State-funded percentage increases earned for the 1997-1998, 1998-1999, and 1999-2000 school years for improvement in student performance or maintaining a safe and orderly school.

SECTION 29.3.(d) Principals and assistant principals with certification based on academic preparation at the six-year degree level a salary supplement of one hundred twenty-six dollars (\$126.00) per month and at the doctoral degree level shall be paid a salary supplement of two hundred fifty-three dollars (\$253.00) per month.

SECTION 29.3.(e) Longevity pay for principals and assistant principals shall be as provided for State employees under the State Personnel Act.

SECTION 29.3.(f) If a principal is reassigned to a higher job classification because the principal is transferred to a school within a local school administrative unit with a larger number of State-allotted teachers, the principal shall be placed on the salary schedule as if the principal had served the principal's entire career as a principal at the higher job classification.

1 If a principal is reassigned to a lower job classification because the principal is
2 transferred to a school within a local school administrative unit with a smaller number of
3 State-allotted teachers, the principal shall be placed on the salary schedule as if the principal
4 had served the principal's entire career as a principal at the lower job classification.

5 This subsection applies to all transfers on or after the effective date of this section,
6 except transfers in school systems that have been created, or will be created, by merging two or
7 more school systems. Transfers in these merged systems are exempt from the provisions of this
8 subsection for one calendar year following the date of the merger.

9 **SECTION 29.3.(g)** Participants in an approved full-time master's in school
10 administration program shall receive up to a 10-month stipend at the beginning salary of an
11 assistant principal during the internship period of the master's program. For the 2006-2007
12 fiscal year and subsequent fiscal years, the stipend shall not exceed the difference between the
13 beginning salary of an assistant principal plus the cost of tuition, fees, and books and any
14 fellowship funds received by the intern as a full-time student, including awards of the Principal
15 Fellows Program. The Principal Fellows Program or the school of education where the intern
16 participates in a full-time master's in school administration program shall supply the
17 Department of Public Instruction with certification of eligible full-time interns.

18 **SECTION 29.3.(h)** During the 2010-2011 fiscal year, the placement on the salary
19 schedule of an administrator with a one-year provisional assistant principal's certificate shall be
20 at the entry-level salary for an assistant principal or the appropriate step on the teacher salary
21 schedule, whichever is higher.

24 **SECTION 29.4.(a)** Findings. – The General Assembly finds that:

- 27 (2) The financial crisis has resulted in large reductions in revenues projected to
28 be available to fund the State's budget for the 2010-2011 fiscal year.
- 29 (3) The University of North Carolina and its constituent institutions are required
30 to reduce their budgets and should attempt to protect university employees
31 when possible.
- 32 (4) The implementation of furloughs may be necessary to balance The
33 University of North Carolina's and its constituent institutions' budgets for the
34 2010-2011 fiscal year.

35 **SECTION 29.4.(b)** The President of The University of North Carolina may
36 implement furloughs of university employees or delegate furlough authority to a chancellor of a
37 constituent institution to offset the UNC Management Flexibility Reduction.

38 **SECTION 29.4.(c)** Definitions. – The following definitions apply in this section:

- 39 (1) Furlough. – A temporary period of leave from employment without pay that
40 (i) is ordered by the President of The University of North Carolina or a
41 chancellor when delegated and (ii) is not in connection with a demotion or
42 other disciplinary action.
- 43 (2) University employee. – Any permanent full-time, permanent part-time, or
44 time-limited employee of The University of North Carolina, including
45 employees exempt from the State Personnel Act under G.S. 126-5(c),
46 126-5(c1), 126-5(c7), and 126-5(c8). The term includes public officers.

47 **SECTION 29.4.(d)** Compensation and Benefits. – The provisions of Section
48 26.14E.(b) and (c) of S.L. 2009-451 apply to university employees furloughed pursuant to the
49 section.

1 **SECTION 29.4.(e)** Cooperation with The University of North Carolina – General
2 Administration. – Constituent institutions shall cooperate with UNC General Administration in
3 the implementation of furloughs, if required.

4 **SECTION 29.4.(f)** As soon as practicable, and no more than 30 calendar days from
5 the effective date of this section, the Board of Governors of The University of North Carolina
6 shall adopt policies for the implementation of this section to remain in effect until the
7 expiration of this section. These policies shall be applied by the President and the constituent
8 institutions in implementing a furlough of university employees. These policies shall provide,
9 at a minimum, that:

- 10 (1) The President may establish a salary threshold below which university
11 employees shall not be subject to furlough. In no event may any full-time
12 university employee, prorated for any part-time employee, earning an annual
13 base rate of thirty thousand dollars (\$30,000) or less be subject to furlough.
- 14 (2) The scheduling of any furlough period shall be at the discretion of the
15 President or the chancellor of the constituent institution when delegated.
- 16 (3) Paid leave shall not be used to offset all or any portion of a furlough.
- 17 (4) If a holiday falls during the mandatory furlough period, the university
18 employee must be paid for the holiday.
- 19 (5) All savings realized as a result of a furlough shall be used to offset the
20 Management Flexibility Reduction for The University of North Carolina..

21 **SECTION 29.4.(g)** Reporting Requirements. – The provisions of Section
22 26.14E.(e) of S.L. 2009-451 apply to furloughs under this section.

23 **SECTION 29.4.(h)** Upon delegation of furlough authority to a chancellor, the
24 constituent institution shall develop a furlough plan to be approved by the President consistent
25 with the policies adopted by the UNC Board of Governors. Access to approved furlough plans
26 shall be provided to all affected employees.

27 **SECTION 29.4.(i)** Effective Date. – This section is effective when it becomes law
28 and expires June 30, 2011.

30 **MONITOR COMPLIANCE WITH FREEZE ON MOST SALARY INCREASES**

31 **SECTION 29.5.(a)** The Office of State Budget and Management and the Office of
32 State Personnel shall monitor jointly the compliance of the following units of government with
33 the provisions of Section 26.1A of S.L. 2009-451, and beginning September 1, 2010, shall
34 submit quarterly reports of their monitoring activities to the President Pro Tempore of the
35 Senate, the Speaker of the House of Representatives, and the Fiscal Research Division: (i) State
36 agencies, departments, and institutions, including authorities, boards, and commissions; (ii) the
37 judicial branch; and (iii) The University of North Carolina and its constituent institutions.

38 The quarterly reports required by this section shall include the following
39 information:

- 40 (1) For agencies reporting through the BEACON HR/Payroll system, (i) a
41 breakdown by action type (including promotion, reallocation, career
42 progression, salary adjustment, and any similar actions increasing employee
43 pay) of the number and annual amount of those increases and (ii) a
44 breakdown by action reason (including in-range higher level, acting pay,
45 trainee adjustment, and other similar action reasons) of the number and

SALARY-RELATED CONTRIBUTIONS/EMPLOYER

SECTION 29.6. Section 6(c) of S.L. 2009-16, as amended by Section 26.20(b) of S.L. 2009-451, reads as rewritten:

The rate for State Law Enforcement Officers includes five percent (5%) for Supplemental Retirement Income."

This addition does not apply to a net operating loss deduction of an eligible small business as defined under section 172(b)(1)(H) of the Code.

(8) For taxable years 2011 through 2013, a taxpayer who made an addition under subdivision (7) of this subsection may deduct one-third of the taxpayer's net operating loss absorbed on the taxpayer's 2003, 2004, 2005, and 2006 federal returns under section 172(b)(1)(H) or section 810(b)(4) of the Code."

SECTION 31.1.(c) This section is effective when it becomes law.

CAP TAX RATE ON INCOME FROM FAMILY-OWNED AND OTHER SMALL BUSINESS

48 authorized by law. The term does not include court costs or fees assessed in

SECTION 31.8.(b) G.S. 147-86.22 reads as rewritten:

"§ 147-86.22. Statewide accounts receivable program.

(a) Program. – The State Controller shall implement a statewide accounts receivable program. As part of this program, the State Controller shall do all of the following:

(1) Monitor the State's accounts receivable collection efforts.

(2) Coordinate information, systems, and procedures between State agencies to maximize the collection of past-due accounts receivable.

(3) Adopt policies and procedures for the management and collection of accounts receivable by State agencies.

(4) Establish procedures for writing off accounts receivable ~~and for determining when to end efforts to collect accounts receivable after they have been written off.~~ receivable.

(b) Electronic Payment. – Notwithstanding the provisions of G.S. 147-86.20 and G.S. 147-86.21, this subsection applies to debts owed a community college, a local school administrative unit, an area mental health, developmental disabilities, and substance abuse authority, and the Administrative Office of the Courts, and to debts payable to or through the office of a clerk of superior court or a magistrate, as well as to debts owed to other State agencies as defined in G.S. 147-86.20.

The State Controller shall establish policies that allow accounts receivable to be payable under certain conditions by electronic payment. These policies shall be established with the concurrence of the State Treasurer. In addition, any policies that apply to debts payable to or through the office of a clerk of superior court or a magistrate shall be established with the concurrence of the Administrative Officer of the Courts. The Administrative Officer of the Courts may also establish policies otherwise authorized by law that apply to these debts as long as those policies are not inconsistent with the Controller's policies.

A condition of payment by electronic payment is receipt by the appropriate State agency of the full amount of the account receivable owed to the State agency. A debtor who pays by electronic payment may be required to pay any fee or charge associated with the use of electronic payment. Fees associated with processing electronic payments may be paid out of the General Fund and Highway Fund if the payment of the fee by the State is economically beneficial to the State and the payment of the fee by the State has been approved by the State Controller and State Treasurer.

The State Controller and State Treasurer shall consult with the Joint Legislative Commission on Governmental Operations before establishing policies that allow accounts receivable to be payable by electronic payment and before authorizing fees associated with electronic payment to be paid out of the General Fund and Highway Fund. A State agency must also consult with the Joint Legislative Commission on Governmental Operations before implementing any program to accept payment under the policies established pursuant to this subsection.

A payment of an account receivable that is made by electronic payment and is not honored by the issuer of the card or the financial institution offering electronic funds transfer does not relieve the debtor of the obligation to pay the account receivable.

(c) Collection Techniques. – The State Controller, in conjunction with the Office of the Attorney General, shall establish policies and procedures to govern techniques for collection of accounts receivable. These techniques may include use of credit reporting bureaus, judicial remedies authorized by law, and administrative setoff by a reduction of ~~an individual's~~ a tax refund pursuant to the Setoff Debt Collection Act, Chapter 105A of the General Statutes, or a reduction of another payment, other than payroll, due from the State to a person to reduce or eliminate an account receivable that the person owes the State.

1 No later than January 1, 1999, ~~the~~The State Controller shall negotiate a contract with a third
 2 party to perform an audit and collection process of inadvertent overpayments by State agencies
 3 to vendors as a result of pricing errors, neglected rebates and discounts, miscalculated freight
 4 charges, unclaimed refunds, erroneously paid excise taxes, and related errors. The third party
 5 shall be compensated only from funds recovered as a result of the audit. Savings realized in
 6 excess of costs shall be transferred from the agency to the Office of State Budget and
 7 Management and placed in a special reserve account for future direction by the General
 8 Assembly. Any disputed savings shall be settled by the State Controller. This paragraph does
 9 not apply to the purchase of medical services by State agencies or payments used to reimburse
 10 or otherwise pay for health care services."

11 **SECTION 31.8.(c)** G.S. 147-86.25 reads as rewritten:

13 The State Controller shall implement a statewide setoff debt collection program to provide

 29 ~~Statutes shall be conducted under Articles 3 and 4 of Chapter 150B of the General Statutes."~~

30 **SECTION 31.8.(d)** G.S. 105A-2 reads as rewritten:

1 **SECTION 31.8.(f)** G.S. 105A-14(a) reads as rewritten:

2 "(a) Simultaneously with the transmittal of the net proceeds collected to a claimant
3 agency, the Department must provide the agency with an accounting of the setoffs for which
4 payment is being made. The accounting must whenever ~~possible~~,possible include the full
5 names of the debtors, the debtors' social security ~~numbers~~,numbers or federal identification
6 numbers, the gross proceeds collected per setoff, the net proceeds collected per setoff, and the
7 collection assistance fee added to the debt and collected per setoff."

22 **SECTION 31.8.(h)** G.S. 105-242(b) reads as rewritten:

23 "~~Garnishment and Attachment.~~Attachment and Garnishment. – Intangible property
24 that belongs to a taxpayer, is owed to a taxpayer, or has been transferred by a taxpayer under
25 circumstances that would permit it to be levied upon if it were tangible property is subject to
26 attachment and garnishment in payment of a tax that is due from the taxpayer and is collectible
27 under G.S. 105-241.22. Intangible personal property includes bank deposits, rent, salaries,
28 wages, property held in the Escheat Fund, and any other property incapable of manual levy or
29 delivery. AG.S. 105-242.1 sets out the procedure for attachment and garnishment of intangible
30 property.

31 A person who is in possession of intangible property that is subject to attachment and
32 garnishment is the garnishee and is liable for the amount the taxpayer owes. The liability
33 applies only to the amount of the taxpayer's property in the garnishee's possession, reduced by
34 any amount the taxpayer owes the garnishee.~~G.S. 105-242.1 sets out the procedure for~~
35 ~~attachment and garnishment of intangible property.~~

36 The Secretary may submit to a financial institution, as defined in G.S. 53B-2, information
37 that identifies a taxpayer who owes a tax debt that is collectible under G.S. 105-241.22 and the
38 amount of the debt. The Secretary may submit the information on a quarterly basis or, with the
39 agreement of the financial institution, on a more frequent basis. A financial institution that
40 receives the information must determine the amount, if any, of intangible property it holds that
41 belongs to the taxpayer and is subject to attachment and garnishment and must inform the
42 Secretary of its determination. The Secretary must reimburse a financial institution for its costs
43 in providing the information, not to exceed the amount payable to the financial institution under
44 G.S. 110-139 for providing information for use in locating a noncustodial parent.

45 No more than ten percent (10%) of a taxpayer's wages or salary is subject to attachment and
46 garnishment. The wages or salary of an employee of the United States, the State, or a political
47 subdivision of the State are subject to attachment and garnishment."

48 **SECTION 31.8.(i)** G.S. 105-242.1 reads as rewritten:

49 "**§ 105-242.1. Procedure for attachment and garnishment.**

50 (a) Notice. – G.S. 105-242 specifies when intangible property is subject to attachment
51 and garnishment. Before the Department attaches and garnishes intangible property in payment

1 of a tax, the Department must send the garnishee a notice of garnishment. The notice must be

 14 garnishment to a garnishee, the Department and the garnishee must have an agreement that
 15 establishes the protocol for transmitting the notice and provides the information required under
 16 subdivisions (4) and (5) of subsection (a) of this section. An electronic notice must contain the
 17 information required under subdivisions (1), (2), and (3) of subsection (a) of this section.

18 (b) Action. – ~~Within 30 days after receiving a notice of garnishment, a~~ A garnishee must
 19 comply with ~~the a~~ notice of garnishment or file a written response to the ~~notice.~~ notice within
 20 the time set in this subsection. A garnishee that is a financial institution must comply or file a
 21 response within 20 days after receiving a notice of garnishment. All other garnishees must
 22 comply or file a response within 30 days after receiving a notice of garnishment. A written
 23 response must explain why the garnishee is not subject to garnishment and attachment. ~~Upon~~

24 Upon receipt of the a written response, the Department must contact the garnishee and
 25 schedule a conference to discuss the response or inform the garnishee of the Department's
 26 position concerning the response. If the Department does not agree with the garnishee on the
 27 garnishee's liability, the Department may proceed to enforce the garnishee's liability for the tax
 28 by sending the garnishee a notice of proposed assessment in accordance with G.S. 105-241.9.

29 (c) Release. – ~~When the Department releases a garnishee from liability, the Department~~
 30 ~~must send the garnishee a letter of release. The letter must identify the taxpayer to whom the~~
 31 ~~release applies and contain the identifying information about the taxpayer that is required under~~
 32 ~~subsection (a) on a notice of garnishment.~~ A notice of garnishment sent to a financial institution
 33 is released when the financial institution complies with the notice. A notice of garnishment sent
 34 to all other garnishees is released when the Department sends the garnishee a notice of release.
 35 A notice of release must state the name and social security number or federal identification
 36 number of the taxpayer to whom the release applies.

37 (d) Financial Institution. – As used in this section, the term 'financial institution' has the
 38 same meaning as in G.S. 53B-2."

39 **SECTION 31.8.(j)** G.S. 53B-4(2) reads as rewritten:

40 "**§ 53B-4. Access to financial records.**

41 Notwithstanding any other provision of law, no government authority may have access to a
 42 customer's financial record held by a financial institution unless the financial record is
 43 described with reasonable specificity and access is sought pursuant to any of the following:

- 45 (2) Authorization under ~~G.S. 105-251~~ G.S. 105-242 or G.S. 105-258."

46 **SECTION 31.8.(k)** Subsection (h) of this section becomes effective January 1,
 47 2011. The remainder of this section is effective when it becomes law.

49 **REDUCE FRANCHISE TAX BURDEN ON CONSTRUCTION COMPANIES**

50 **SECTION 31.9.(a)** Section 2 of S.L. 2009-422 reads as rewritten:

1 "SECTION 2. This act is effective retroactively for taxable years beginning on or after
2 January 1, 2010.~~January 1, 2007.~~"

3 **SECTION 31.9.(b)** A taxpayer that paid franchise tax in taxable years 2007, 2008,
4 or 2009 and that included billings in excess of costs in its capital base may apply to the
5 Department of Revenue for a refund of any excess tax paid to the extent the refund is the result
6 of the change in the law enacted by this section. A request for a refund must be made on or
7 before January 1, 2011. A request for refund received after that date is barred.

8 **SECTION 31.9.(c)** This section is effective when it becomes law.
9

10 FAIR TAX PENALTIES

11 **SECTION 31.10.(a)** G.S. 105-236(a)(4) reads as rewritten:

12 "(4) Failure to Pay Tax When Due. – In the case of failure to pay any tax when
13 due, without intent to evade the tax, the Secretary shall assess a penalty
14 equal to ten percent (10%) of the tax, subject to a minimum of five dollars
15 (\$5.00). This penalty does not apply in any of the following circumstances:

16 a. When the amount of tax shown as due on an amended return is paid
17 when the return is filed.

18 b. When the Secretary proposes an assessment for tax due but not
19 shown on a return and the tax due is paid within 45 days after the
20 later of the following:

21 1. The date of the notice of proposed assessment of the ~~tax~~ tax,
22 if the taxpayer does not file a timely request for a
23 Departmental review of the proposed assessment.

24 2. The date the proposed assessment becomes collectible under
25 G.S. 105-241.22, if the taxpayer files a timely request for a
26 Departmental review of the proposed assessment.

27 c. When a taxpayer files a consolidated return under G.S. 105-130.6
28 at the request of the Secretary and the tax due is paid within 45 days
29 after the later of the following:

30 1. The date the consolidated return is filed, if the taxpayer does
31 not file a timely request for a Departmental review of the tax.

32 2. The date the Departmental review of the tax ends as a result
33 of the occurrence of one of the actions listed in
34 G.S. 105-241.22(3) through (6), if the taxpayer files a timely
35 request for a Departmental review."

36 **SECTION 31.10.(b)** G.S. 105-236(a)(5) is amended by adding a new
37 sub-subdivision to read:

38 "(5) Negligence. –

40 f. Consolidated return. – The amount of tax shown as due on a
41 consolidated return requested by the Secretary under G.S. 105-130.6

43 **SECTION 31.10.(c)** This section is effective when it becomes law and applies to
44 penalties that are assessed and unpaid as of the effective date, penalties that are paid as of the
45 effective date but are based on a tax that is the subject of an administrative or judicial action
46 that is pending on the effective date, and penalties and taxes assessed on or after that date.

48 CREDIT FOR CONSTRUCTING A RENEWABLE ENERGY PROPERTY FACILITY

49 **SECTION 31.11.(a)** Article 3B of Chapter 105 of the General Statutes is amended
50 by adding a new section to read:

51 **§ 105-129.16I. Credit for constructing a renewable energy property facility.**

1 (a) Credit. – A taxpayer that constructs and places in service in this State a commercial
2 facility for the manufacture of renewable energy property is allowed a credit equal to
3 twenty-five percent (25%) of the cost to the taxpayer of constructing and equipping the facility.
4 The entire credit may not be taken for the taxable year in which the facility is placed in service
5 but must be taken in seven equal annual installments beginning with the taxable year in which
6 the facility is placed in service. If, in one of the years in which the installment of a credit
7 accrues, the facility with respect to which the credit was claimed is disposed of or taken out of
8 service, the credit expires and the taxpayer may not take any remaining installment of the
9 credit. The taxpayer may, however, take the portion of an installment that accrued in a previous
10 year and was carried forward to the extent permitted under G.S. 105-129.17. A taxpayer that
11 claims any other credit allowed under this Chapter with respect to construction of a facility may
12 not take the credit allowed in this section with respect to the same facility.

13 (b) Sunset. – This section is repealed effective for a renewable energy property facility
14 placed in service on or after January 1, 2014."

15 **SECTION 31.11.(b)** This section becomes effective for taxable years beginning on
16 or after January 1, 2011.

18 **PART XXXII. MISCELLANEOUS PROVISIONS**

20 **STATE BUDGET ACT APPLIES**

21 **SECTION 32.1.** The provisions of the State Budget Act, Chapter 143C of the
22 General Statutes, are reenacted and shall remain in full force and effect and are incorporated in
23 this act by reference.

24 **COMMITTEE REPORT**

25 **SECTION 32.2.(a)** The Senate Appropriations Committee Report On The
26 Continuation, Expansion and Capital Budgets for Senate Bill 897, dated May 16, 2010, which
27 was distributed in the Senate and the House of Representatives and used to explain this act,
28 shall indicate action by the General Assembly on this act and shall therefore be used to construe
29 this act, as provided in the State Budget Act, Chapter 143C of the General Statutes, as
30 appropriate, and for these purposes shall be considered a part of this act and as such shall be
31 printed as a part of the Session Laws.

32 **SECTION 32.2.(b)** The budget enacted by the General Assembly is for the
33 maintenance of the various departments, institutions, and other spending agencies of the State
34 for the 2010-2011 budget as provided in G.S. 143C-3-5. This budget includes the
35 appropriations of State funds as defined in G.S. 143C-1-1(d)(25).

36 The Director of the Budget submitted recommended adjustments to the budget to
37 the General Assembly in April 2010 in the documents "The North Carolina State Budget,
38 Recommended Operating Budget with Performance Management Information 2010-2011" for
39 the 2010-2011 fiscal year for the various departments, institutions, and other spending agencies
40 of the State. The adjustments to these documents made by the General Assembly are set out in
41 the Committee Report.,

42 **SECTION 32.2.(c)** The budget enacted by the General Assembly shall also be
43 interpreted in accordance with G.S. 143C-5-5, the special provisions in this act, and other
44 appropriate legislation.

45 In the event that there is a conflict between the line-item budget certified by the
46 Director of the Budget and the budget enacted by the General Assembly, the budget enacted by
47 the General Assembly shall prevail.

49 **MOST TEXT APPLIES ONLY TO THE 2010-2011 FISCAL YEAR**

50 **SECTION 32.3.** Except for statutory changes or other provisions that clearly
51 indicate an intention to have effects beyond the 2010-2011 fiscal year, the textual provisions of

1 this act apply only to funds appropriated for, and activities occurring during, the 2010-2011
2 fiscal year.

3
4 **EFFECT OF HEADINGS**

5 **SECTION 32.4.** The headings to the parts and sections of this act are a
6 convenience to the reader and are for reference only. The headings do not expand, limit, or
7 define the text of this act, except for effective dates referring to a part.

8
9 **APPROPRIATIONS LIMITATIONS AND DIRECTIONS APPLY**

10 **SECTION 32.5.(a)** Except where expressly repealed or amended by this act, the
11 provisions of S.L. 2009-451 and S.L. 2009-575 remain in effect.

12 **SECTION 32.5.(b)** Notwithstanding any modifications by this act in the amounts
13 appropriated, except where expressly repealed or amended, the limitations and directions for
14 the 2010-2011 fiscal year in S.L. 2009-451 and S.L. 2009-575 that applied to appropriations to
15 particular agencies or for particular purposes apply to the newly enacted appropriations and
16 budget reductions of this act for those same particular purposes.

17
18 **SEVERABILITY CLAUSE**

19 **SECTION 32.6.** If any section or provision of this act is declared unconstitutional
20 or invalid by the courts, it does not affect the validity of this act as a whole or any part other
21 than the part so declared to be unconstitutional or invalid.

22
23 **EFFECTIVE DATE**

24 **SECTION 32.7.** Except as otherwise provided, this act becomes effective July 1,
25 2010.
