A BILL TO BE ENTITLED

AN ACT TO MAKE APPROPRIATIONS AND ADJUSTMENTS FOR THE 2011-2013 FISCAL BIENNIUM TO THE STATE HEALTH PLAN FOR TEACHERS AND STATE EMPLOYEES; AND TO TRANSFER THE STATE HEALTH PLAN FOR TEACHERS AND STATE EMPLOYEES TO THE OFFICE OF STATE TREASURER.

The General Assembly of North Carolina enacts:

**PART I. APPROPRIATIONS AND CONTRIBUTIONS FOR 2011-2013 FISCAL BIENNIUM**

**APPROPRIATIONS FROM GENERAL FUND AND HIGHWAY FUND**

**SECTION 1.1.(a)** General Fund Appropriation. – Notwithstanding G.S. 143C-5-2, there is appropriated from the General Fund to the Reserve for the State Health Plan in the Office of State Budget and Management the sum of eight million sixty-one thousand seven hundred ninety-eight dollars (\$8,061,798) for the 2011-2012 fiscal year and the sum of one hundred one million seven hundred eighty-two thousand six hundred seventy dollars (\$101,782,670) for the 2012-2013 fiscal year. These funds shall be used to cover health care and administrative costs to the Plan in the 2011-2013 fiscal biennium.

**SECTION 1.1.(b)** Highway Fund Appropriation. – Notwithstanding G.S. 143C-5-2, there is appropriated from the Highway Fund to the Reserve for the State Health Plan in the Office of State Budget and Management the sum of three hundred seventy-six thousand two hundred seventeen dollars (\$376,217) for the 2011-2012 fiscal year and the sum of four million seven hundred forty-nine thousand eight hundred fifty-eight dollars (\$4,749,858) for the 2012-2013 fiscal year. These funds shall be used to cover health care and administrative costs to the Plan in the 2011-2013 fiscal biennium.

**SECTION 1.1.(c)** All other agency funds required to fund the premium increase enacted in this act, other than funds appropriated in subsections (a) and (b) of this section, are appropriated for the 2011-2013 fiscal biennium.

**PREMIUM ADJUSTMENTS**

**SECTION 1.2.(a)** Partially Contributory Coverage. – Employee and retiree monthly premium rates for partially contributory coverage under G.S. 135-45.2(a1), as enacted by Section 1.6 of this act, and established in accordance with G.S. 135-44.6, as enacted by this act, shall be as follows for the 2011-2012 and 2012-2013 fiscal years:

8           **SECTION 1.2.(b)** Contributory Coverage. – Premium rates for contributory  
9 coverage established in accordance with G.S. 135-44.6 shall be increased by five and  
10 two-tenths percent (5.2%) for contributory coverage for the 2011-2012 fiscal year and shall be  
11 increased by an additional five and two-tenths percent (5.2%) over the premium rate for  
12 contributory coverage for the 2012-2013 fiscal year.

#### 14 **DEDUCTIBLE, COINSURANCE, AND CO-PAYMENT ADJUSTMENTS**

15           **SECTION 1.3.(a)** Effective July 1, 2011, the Executive Administrator shall make  
16 the following changes to deductibles, coinsurance maximums, and co-payments under the  
17 Basic and Standard PPO Plans:

18           (1) Basic Plan (70/30):

- 19           a. Increase the in-network annual deductible to nine hundred  
20 thirty-three dollars (\$933.00) for member-only coverage and to one  
21 thousand eight hundred sixty-six dollars (\$1,866) for the  
22 out-of-network annual deductible for member-only coverage. The  
23 aggregate maximum annual deductible for employee-child and  
24 employee-family coverage shall be three times the member-only  
25 annual deductibles.
- 26           b. Increase the in-network coinsurance maximum to three thousand  
27 seven hundred ninety-three dollars (\$3,793) for member-only  
28 coverage and to seven thousand five hundred eighty-six dollars  
29 (\$7,586) for member-only out-of-network maximum coinsurance.  
30 The aggregate maximum coinsurance for employee-child and  
31 employee-family coverage shall be three times the member-only  
32 coinsurance maximums.
- 33           c. Increase the in-network urgent care co-payment to eighty-seven  
34 dollars (\$87.00) per covered individual.
- 35           d. Increase the in-network primary care co-payment to thirty-five  
36 dollars (\$35.00) per covered individual.
- 37           e. Increase the in-network specialist co-payment to eighty-one dollars  
38 (\$81.00) per covered individual, except that for mental health and  
39 substance abuse services, chiropractic services, and physical therapy,  
40 occupational therapy, and speech therapy services, the in-network  
41 specialist co-payment shall be sixty-four dollars (\$64.00) per covered  
42 individual.
- 43           f. Increase the in-network and out-of-network inpatient co-payment to  
44 two hundred ninety-one dollars (\$291.00) per covered individual.
- 45           g. Increase the in-network and out-of-network emergency room  
46 co-payment to two hundred ninety-one dollars (\$291.00) per covered  
47 individual.
- 48           h. Increase prescription drug co-payments as required under  
49 G.S. 135-45.6(b)(1) as amended by this section.

- 1 i. Except as otherwise provided in this act, co-payments and  
 2 coinsurance for coverage not otherwise listed in this subdivision shall  
 3 remain as applicable in the 2010-2011 benefit year.
- 4 (2) Standard Plan (80/20):
- 5 a. Increase the in-network annual deductible to seven hundred dollars  
 6 (\$700.00) for member-only coverage and to one thousand four  
 7 hundred dollars (\$1,400) for the member-only out-of-network annual  
 8 deductible. The aggregate maximum annual deductible for  
 9 employee-child and employee-family coverage shall be three times  
 10 the member-only annual deductibles.
- 11 b. Increase the in-network coinsurance maximum to three thousand two  
 12 hundred ten dollars (\$3,210) for member-only coverage and to six  
 13 thousand four hundred twenty dollars (\$6,420) for member-only  
 14 out-of-network maximum coinsurance. The aggregate maximum  
 15 coinsurance for employee-child and employee-family coverage shall  
 16 be three times the member-only coinsurance maximums.
- 17 c. Increase the in-network urgent care co-payment to eighty-seven  
 18 dollars (\$87.00) per covered individual.
- 19 d. Increase the in-network primary care co-payment to thirty dollars  
 20 (\$30.00) per covered individual.
- 21 e. Increase the in-network specialist co-payment to seventy dollars  
 22 (\$70.00) per covered individual, except that for mental health and  
 23 substance abuse services, chiropractic services, and physical therapy,  
 24 occupational therapy, and speech therapy services, the in-network  
 25 specialist co-payment shall be fifty-two dollars (\$52.00) per covered  
 26 individual.
- 27 f. Increase the in-network and out-of-network inpatient co-payment to  
 28 two hundred thirty-three dollars (\$233.00) per covered individual.
- 29 g. Increase the in-network and out-of-network emergency room  
 30 co-payment to two hundred thirty-three dollars (\$233.00) per covered  
 31 individual.
- 32 h. Increase prescription drug co-pays as required under  
 33 G.S. 135-45.6(b)(1) as amended by this act.
- 34 i. Except as otherwise provided in this act, co-payments and  
 35 coinsurance for coverage not otherwise listed in this subdivision shall  
 36 remain as applicable in the 2010-2011 benefit year.

37 **SECTION 1.3.(b)** G.S. 135-45.6(b)(1) reads as rewritten:

38 "(1) The Plan will pay allowable charges for each outpatient prescription drug  
 39 less a copayment to be paid by each covered individual equal to the  
 40 following amounts: pharmacy charges up to ten dollars (\$10.00) for each  
 41 generic prescription, ~~thirty-five dollars (\$35.00)~~ forty dollars (\$40.00) for  
 42 each preferred branded prescription without a generic equivalent, and  
 43 ~~fifty-five dollars (\$55.00)~~ sixty-four dollars (\$64.00) for each nonpreferred  
 44 branded prescription. For each branded prescription drug with a generic  
 45 equivalent drug, the member shall pay the generic co-payment plus the  
 46 difference between the Plan's gross allowed cost for the generic prescription  
 47 and the Plan's cost for the branded prescription drug."  
 48

49 **LIMITATION ON AUTHORITY TO CHANGE BENEFITS**

50 **SECTION 1.4.** G.S. 135-45(g) reads as rewritten:

1 "(g) The Executive Administrator and Board of Trustees shall not change the Plan's  
2 comprehensive health benefit coverage, co-payments, deductibles, out-of-pocket expenditures,  
3 and lifetime maximums in effect on ~~July 1, 2009, July 1, 2011,~~ that would result in a net  
4 increased cost to the Plan or in a reduction in benefits to Plan members unless and until the  
5 proposed changes are directed to be made in an act of the General Assembly."  
6

7 **REPEAL COMPREHENSIVE WELLNESS INITIATIVE**

8 **SECTION 1.5.** Section 2(b) of S.L. 2009-16, as amended by S.L. 2009-571, is  
9 repealed.  
10

11 **IMPLEMENT MONTHLY CONTRIBUTION BY EMPLOYEES AND CERTAIN**  
12 **RETIREEES**

13 **SECTION 1.6.(a)** G.S. 135-45(b) reads as rewritten:

14 "(b) Individuals eligible for coverage under G.S. 135-45.2 on a ~~fully or partially~~  
15 partially, one-half, or fully contributory basis are eligible to participate in any plan authorized  
16 under this section."  
17

18 **SECTION 1.6.(b)** G.S. 135-45.2 reads as rewritten:

19 **"§ 135-45.2. Eligibility.**

20 (a) Noncontributory Coverage. – The following persons are eligible for coverage under  
21 the Plan, on a noncontributory basis, subject to the provisions of G.S. 135-45.4:

22 (1) ~~All permanent full-time employees of an employing unit who meet the~~  
23 ~~following conditions:~~

24 a. ~~Paid from general or special State funds, or~~

25 b. ~~Paid from non State funds and in a group for which his or her~~  
26 ~~employing unit has agreed to provide coverage.~~

36 Enforcement Officers' Retirement System prior to January 1, 1985. Except  
37 as otherwise provided in this subdivision, on and after January 1, 1988, a  
38 retiring employee or retiree must have completed at least five years of  
39 contributory retirement service with an employing unit prior to retirement  
40 from any State-supported retirement system in order to be eligible for group  
41 benefits under this Part as a retired employee or retiree. For employees first  
42 hired on and after October 1, 2006, and members of the General Assembly  
43 first taking office on and after February 1, 2007, future coverage as retired  
44 employees and retired members of the General Assembly is subject to a  
45 requirement that the future retiree have 20 or more years of retirement  
46 service credit in order to be covered by the provisions of this subdivision.

47 (4) Surviving spouses of:

48 a. Deceased retired employees, provided the death of the former plan  
49 member occurred prior to October 1, 1986; and

50 b. Deceased teachers, State employees, and members of the General  
Assembly who are receiving a survivor's alternate benefit under any

2 former plan member occurred prior to October 1, 1986.
- 3 ~~(5) Employees of the General Assembly, not otherwise covered by this section,  
4 as determined by the Legislative Services Commission, except for legislative  
5 interns and pages.~~
- 6 ~~(6) Members of the General Assembly.~~
- 7 ~~(7) Notwithstanding the provisions of subsection (e) of this section, employees  
8 on official leave of absence while completing a full time program in school  
9 administration in an approved program as a Principal Fellow in accordance  
10 with Article 5C of Chapter 116 of the General Statutes.~~
- 11 ~~(8) Notwithstanding the provisions of G.S. 135-45.12 employees formerly  
12 covered by the provisions of this section, other than retired employees, who  
13 have been employed for 12 or more months by an employing unit, or who  
14 have completed a contract term of employment of 10 or 11 months and  
15 whose employing unit is a local school administrative unit, and whose jobs  
16 are eliminated because of a reduction, in total or in part, in the funds used to  
17 support the job or its responsibilities, provided the employees were covered  
18 by the Plan at the time of separation from service resulting from a job  
19 elimination. Employees covered by this subsection shall be covered for a  
20 period of up to 12 months following a separation from service because of a  
21 job elimination. An employee formerly covered by the provisions of this  
22 section shall not be eligible for coverage under this subdivision if the  
23 employee is provided health benefit coverage on a non-contributory basis by  
24 a subsequent employer.~~
- 25 ~~(9) Any member enrolled pursuant to subdivision (1) or (2) of this subsection  
26 who is on approved leave of absence with pay or receiving workers'

- 28 ~~(10) Employees on approved Family and Medical Leave.~~
- 29 (a1) Partially Contributory Coverage. – The following persons are eligible for coverage  
30 under the Plan, on a partially contributory basis, subject to the provisions of G.S. 135-45.4:
- 31 (1) All permanent full-time employees of an employing unit who meet either of  
32 the following conditions:
- 33 a. Paid from general or special State funds.
- 34 b. Paid from non-State funds and in a group for which his or her  
35 employing unit has agreed to provide coverage.
- 36 Employees of State agencies, departments, institutions, boards, and  
37 commissions not otherwise covered by the Plan who are employed in  
38 permanent job positions on a recurring basis and who work 30 or more hours  
39 per week for nine or more months per calendar year are covered by the  
40 provisions of this subdivision.
- 41 (2) Permanent hourly employees who work at least one-half of the workdays of  
42 each pay period.
- 43 (3) Retired teachers, State employees, members of the General Assembly, and  
44 retired State law enforcement officers who retired under the Law  
45 Enforcement Officers' Retirement System prior to January 1, 1985. Except  
46 as otherwise provided in this subdivision, on and after January 1, 1988, a

35 described in G.S. 115C-326.5. If these employees elect to participate in the  
36 Plan, the employing unit shall pay fifty percent (50%) of the Plan's total

39 unit.
- 40 (2) ~~Subject to the provisions of G.S. 135-45.4, employees~~ Employees and

42 retirement service credit provided the employees were first hired on or after  
43 October 1, 2006, and the members first took office on or after February 1,  
44 2007. For such future retirees, the State shall pay fifty percent (50%) of the  
45 Plan's total ~~noncontributory employer~~ employer premiums. Individual retirees shall  
46 pay the balance of the total ~~noncontributory~~ premiums not paid by the State.
- 47 (c) ~~Fully Contributory.~~ Contributory Coverage. – The following ~~person~~ persons shall be  
48 eligible for coverage under the Plan, on a fully contributory basis, subject to the provisions of  
49 G.S. 135-45.4:
- 50 (1) Former members of the General Assembly who enroll before October 1,  
51 1986.

- 1 (2) For enrollments after September 30, 1986, former members of the General  
2 Assembly if covered under the Plan at termination of membership in the  
3 General Assembly. To be eligible for coverage as a former member of the  
4 General Assembly, application must be made within 30 days of the end of  
5 the term of office. Only members of the General Assembly covered by the  
6 Plan at the end of the term of office are eligible. If application is not made  
7 within the specified time period, the member forfeits eligibility.
- 8 (3) Surviving spouses of deceased former members of the General Assembly  
9 who enroll before October 1, 1986.
- 10 (4) Employees of the General Assembly, not otherwise covered by this section,  
11 as determined by the Legislative Services Commission, except for legislative  
12 interns and pages.
- 13 (5) For enrollments after September 30, 1986, surviving spouses of deceased  
14 former members of the General Assembly, if covered under the Plan at the  
15 time of death of the former member of the General Assembly.
- 16 (6) All permanent part-time employees (designated as half-time or more) of an  
17 employing unit who ~~meets~~ meet the conditions outlined in ~~subdivision~~  
18 ~~(a)(1)a. above,~~ sub-subdivision (a1)(1)a. of this section and who are not  
19 covered by the provisions of ~~G.S. 135-45.2(a)(1).~~ subdivision (a1)(1) of this  
20 section.
- 21 (7) The spouses and eligible dependent children of enrolled teachers, State  
22 employees, retirees, former members of the General Assembly, former  
23 employees covered by the provisions of ~~G.S. 135-45.2(a)(8),~~ former  
24 subdivision (a)(8) or subdivision (a1)(7) of this section, Disability Income  
25 Plan beneficiaries, enrolled continuation members, and members of the  
26 General Assembly. Spouses of surviving dependents are not eligible, nor are  
27 dependent children if they were not covered at the time of the member's  
28 death. Surviving spouses may cover their dependent children provided the  
29 children were enrolled at the time of the member's death or enroll within 90  
30 days of the member's death.
- 31 (8) Blind persons licensed by the State to operate vending facilities under  
32 contract with the Department of Health and Human Services, Division of  
33 Services for the Blind and its successors, who are:
- 34 a. Operating such a vending facility;
- 35 b. Former operators of such a vending facility whose service as an  
36 operator would have made these operators eligible for an early or  
37 service retirement allowance under Article 1 of this Chapter had they  
38 been members of the Retirement System; and
- 39 c. Former operators of such a vending facility who attain five or more  
40 years of service as operators and who become eligible for and receive  
41 a disability benefit under the Social Security Act upon cessation of  
42 service as an operator.
- 43 Spouses, dependent children, surviving spouses, and surviving dependent  
44 children of such members are not eligible for coverage.
- 45 (9) Surviving spouses of deceased retirees and surviving spouses of deceased  
46 teachers, State employees, and members of the General Assembly provided  
47 the death of the former Plan member occurred after September 30, 1986, and  
48 the surviving spouse was covered under the Plan at the time of death.
- 49 (10) Any eligible dependent child of the deceased retiree, teacher, State  
50 employee, member of the General Assembly, former member of the General  
51 Assembly, or Disability Income Plan beneficiary, provided the child was

covered at the time of death of the retiree, teacher, State employee, member of the General Assembly, former member of the General Assembly, or Disability Income Plan beneficiary, (or was in posse at the time and is covered at birth under this Part), or was covered under the Plan on September 30, 1986. An eligible surviving dependent child can remain covered until ~~age 19, or age 26 if a full-time student,~~ or indefinitely if certified as incapacitated under ~~G.S. 135-45.1(5)b.~~ G.S. 135-45.2(d).

- (11) Retired teachers, State employees, and members of the General Assembly with less than 10 years of retirement service credit, provided the teachers and State employees were first hired on or after October 1, 2006, and the members first took office on or after February 1, 2007.
- (12) Notwithstanding the provisions of G.S. 135-45.12 former employees covered by the provisions of ~~G.S. 135-45.2~~ this section and their spouses and eligible dependent children who were covered by the Plan at the time of the former employees' separation from service pursuant to ~~G.S. 135-45.2,~~ this section, following expiration of the former employees' coverage provided by ~~G.S. 135-45.2,~~ this section. Election of coverage under this subdivision shall be made within 90 days after the termination of coverage provided under ~~G.S. 135-45.2,~~ this section.
- (13) Firefighters, rescue squad workers, and members of the National Guard, their eligible spouses, and eligible dependent children.

## ALLOW COVERAGE FOR CHILDREN UP TO 26 YEARS OLD, IN COMPLIANCE WITH FEDERAL AFFORDABLE CARE ACT

SECTION 1.7.(a) G.S. 135-45.1(10) reads as rewritten:

"(10) Dependent child. – Subject to the eligibility requirements of G.S. 135-45.2(d), any of the following:

- a. A ~~natural,~~ natural or legally adopted, or foster adopted child or children of the employee and or spouse, unmarried, up to the first of the month following his or her 19th the child's 26th birthday, whether or not the child is living with the employee, as long as the employee is legally responsible for such child's maintenance and support.  
employee.
- b. A foster child or children of the employee up to the first month following the child's 19th birthday, whether or not the child is living with the employee, as long as the employee is legally responsible for the child's maintenance and support.
- c. ~~Dependent child also includes a~~ A child for which an employee is a court-appointed guardian, as long as the employee is legally responsible for the child's maintenance and support.
- d. ~~Dependent child also includes a~~ A stepchild of the member who primarily resides with a member who is married to the stepchild's natural parent. To be eligible, the stepchild must have his or her primary residence with the member.
- e. ~~Dependent child shall also include any~~ Any child under age 19 who has reached his or her 18th birthday, provided the employee was legally responsible for such the child's maintenance and support on his or her 18th birthday. ~~Dependent~~

Dependent children of firefighters, rescue squad workers, and members of the National Guard are subject to the same terms and conditions as are other



1 dependent children covered by this subdivision. ~~Eligibility of dependent~~  
2 ~~children is subject to the requirements of G.S. 135-45.2(d). The Plan may~~  
3 ~~require documentation from the member confirming a child's eligibility to be~~  
4 ~~covered as the member's dependent."~~

5 **SECTION 1.7.(b)** G.S. 135-45.2(d) reads as rewritten:

6 "(d) A foster child is covered as a dependent child (i) if living in a regular parent-child  
7 relationship with the expectation that the employee will continue to rear the child into  
8 adulthood, (ii) if at the time of enrollment, or at the time a foster child relationship is  
9 established, whichever occurs first, the employee applies for coverage for such child and

## 34 **SALARY-RELATED CONTRIBUTIONS**

35 **SECTION 1.8.(a)** Effective for the 2011-2013 fiscal biennium, required employer

46 workers' compensation, severance pay, separation allowances, and applicable disability income  
47 benefits.

46 member. The Plan has a lien, for not more than the value of claims paid related to the liability  
47 of the third party, on any damages subsequently recovered against the liable third party. If the

- 31 (c) One-Half Contributory Coverage. – The following persons are eligible for coverage  
32 under the Plan, on a one-half contributory basis, subject to the provisions of ~~G.S. 135-45.4~~;

- 34 (1) A school employee in a job-sharing position as described in  
35 G.S. 115C-326.5. If these employees elect to participate in the Plan, the

- 18 (7) The spouses and eligible dependent children of enrolled teachers, State  
19 employees, retirees, former members of the General Assembly, former  
20 employees covered by the provisions of ~~former subdivision (a)(8)~~ or  
21 subdivision ~~(a1)(7)~~ (b)(7) of this section, Disability Income Plan  
22 beneficiaries, enrolled continuation members, and members of the General  
23 Assembly. Spouses of surviving dependents are not eligible, nor are  
24 dependent children if they were not covered at the time of the member's  
25 death. Surviving spouses may cover their dependent children provided the  
26 children were enrolled at the time of the member's death or enroll within 90

16 Medicare-eligible spouse of an employee shall also cease the last day of the  
17 month in which Medicare is selected to be the primary payer of medical  
18 benefits for the Medicare-eligible spouse. Such members are eligible to  
19 apply for conversion coverage.
- 20 (8) The last day of the month in which a covered individual is found to be  
21 ineligible for coverage.
- 22 (b) Coverage under this Plan as a dependent child ceases when the child ceases to be a  
23 dependent child as defined by ~~G.S. 135-45.1~~ G.S. 135-48.1 except, coverage may continue  
24 under this Plan for a period of not more than 36 months after loss of dependent status on a fully  
25 contributory basis provided the dependent child was covered under the Plan at the time of loss  
26 of dependent status.
- 27 (c) Coverage under the Plan as a surviving dependent child whether covered as a  
28 dependent of a surviving spouse, or as an individual member (no living parent), ceases when  
29 the child ceases to be a dependent child as defined by ~~G.S. 135-45.1~~, G.S. 135-48.1, except  
30 coverage may continue under the Plan on a fully contributory basis for a period of not more  
31 than 36 months after loss of dependent status.
- 32 (d) Termination of employment shall mean termination for any reason, including layoff  
33 and leave of absence, except as provided in subdivisions (a)(1) and (2) of this section, but shall  
34 not, for purposes of this Plan, include retirement upon which the employee is granted an  
35 immediate service or disability pension under and pursuant to a State-supported Retirement  
36 System.
- 37 (1) In the event of termination for any reason other than death, coverage under  
38 the Plan for an employee and his or her eligible spouse or dependent  
39 children, provided the eligible spouse or dependent children were covered  
40 under the Plan at termination of employment may be continued for a period  
41 of not more than 18 months following termination of employment on a fully  
42 contributory basis. Employees who were covered under the Plan at  
43 termination of employment may be continued for a period of not more than  
44 18 months or 29 months if determined to be disabled under the Social  
45 Security Act, Title II, OASDI or Title XVI, SSI.
- 46 (2) In the event of approved leave of absence without pay, other than for active  
47 duty in the armed forces of the United States, coverage under this Plan for an  
48 employee and his or her dependents may be continued during the period of  
49 such leave of absence by the employee's paying one hundred percent (100%)  
50 of the cost.

- 1 (3) If employment is terminated in the second half of a calendar month and the  
2 covered individual has made the required contribution for any coverage in  
3 the following month, that coverage will be continued to the end of the  
4 calendar month following the month in which employment was terminated.
- 5 (4) Employees paid for less than 12 months in a year, who are terminated at the  
6 end of the work year and who have made contributions for the non-work  
7 months, will continue to be covered to the end of the period for which they  
8 have made contributions, with the understanding that if they are not  
9 employed by another State-covered employer under this Plan at the  
10 beginning of the next work year, the employee will refund to the  
11 ex-employer the amount of the employer's cost paid for them during the  
12 non-paycheck months.
- 13 (5) Any employee receiving benefits pursuant to Article 6 of this Chapter when  
14 the employee has less than five years of retirement membership service, or  
15 an employee on leave of absence without pay due to illness or injury for up  
16 to 12 months, is entitled to continued coverage under the Plan for the  
17 employee and any eligible dependents by the employee's paying one hundred  
18 percent (100%) of the cost.
- 19 (e) A legally divorced spouse and any eligible dependent children of a covered  
20 employee or retired employee may continue coverage under this Plan for a period of not more  
21 than 36 months following the first of the month after a divorce becomes final on a fully  
22 contributory basis, provided the former spouse and any eligible dependent children were  
23 covered under the Plan at the time a divorce became final.
- 24 (f) A legally separated spouse of a covered employee or retired employee may continue  
25 coverage under this Plan for a period not to exceed 36 months from the separation date on a  
26 fully contributory basis, provided the separated spouse was covered under the Plan at the time  
27 of separation and provided the covered employee's or retired employee's actions result in the  
28 loss of coverage for the separated spouse. Eligible dependent children may also continue  
29 coverage if covered under the Plan at time of separation, provided the employee's or retired  
30 employee's actions result in the loss of coverage for the dependent children.
- 31 (g) Whenever this section gives a right to continuation coverage, such coverage must be  
32 elected within the time allowed by applicable federal law.
- 33 (h) Continuation coverage under this Plan shall not be continued past the occurrence of  
34 any one of the following events:
- 35 (1) The termination of the Plan.
- 36 (2) Failure of a Plan member to pay monthly in advance any required premiums.
- 37 (3) A person becomes a covered employee or a dependent of a covered  
38 employee under any group health plan and that group health plan has no  
39 restrictions or limitations on benefits.
- 40 (4) A person becomes eligible for Medicare benefits on or after the effective  
41 date of the continuation coverage.
- 42 (5) The person was determined to be no longer disabled, provided the 18-month  
43 coverage was extended to 29 months due to having been determined to be  
44 disabled under the Social Security Act, Title II, OASDI or Title XVI, SSI.
- 45 (6) The person reaches the maximum applicable continuation period of 18, 29,  
46 or 36 months.
- 47 (i) Notice requirements concerning continuation coverage shall be developed by the  
48 ~~Executive Administrator and Board of Trustees. Plan.~~
- 49 (j) The spouse and any eligible dependent children of a covered employee may  
50 continue coverage under the Plan on a fully contributory basis for a period not to exceed 36  
51 months from the date the employee becomes eligible for Medicare benefits which results in a

1 loss of coverage under the Plan, provided that the spouse and eligible dependent children were  
2 covered under the Plan at the time the employee became eligible for Medicare benefits which  
3 results in a loss of coverage under the Plan.

4 "**§ 135-48.45. Conversion.**

5 (a) Upon a cessation of group coverage under the Plan and/or eligibility for group  
6 coverage under the Plan, an employee or dependent shall be entitled to a conversion to  
7 nongroup coverage without the necessity of a physical examination. Such conversion coverage  
8 shall include hospitalization, surgical, and medical benefits as contained in the major medical  
9 and alternative plan conversion provisions of Article 53 of Chapter 58 of the General Statutes.  
10 The ~~Executive Administrator and Board of Trustees~~ State Treasurer in ~~their~~ his or her sole  
11 discretion shall approve the conversion coverage, which shall be administered by the Claims  
12 Processor through an insurance contract arranged by the Claims Processor, or administered as

14 eligible employee or dependent must apply for conversion coverage within 30 days after  
15 termination of group eligibility.

18 contributory basis. The ~~Executive Administrator and Board of Trustees~~ State Treasurer shall

20 before taking action under this subsection.

21 "Part 5. Coverage Mandates and Exclusions; Other Mandates

22 "**§ 135-48.50. Coverage mandates.**

23 The Plan shall provide coverage subject to the following coverage mandates:

- 24 (1) Reserved.
- 25 (2) Immunizations. – The Plan shall pay one hundred percent (100%) of  
26 allowable medical charges for immunizations for the prevention of  
27 contagious diseases as generally accepted medical practices would dictate  
28 when directed by a credentialed provider as determined by the claims  
29 processor.
- 30 (3) Insulin. – Prescription benefits shall be provided for insulin even though a  
31 prescription is not required.
- 32 (4) Mental health parity. – Benefits for the treatment of mental illness and  
33 chemical dependency are covered by the Plan and shall be subject to the  
34 same deductibles, durational limits, and coinsurance factors as are benefits  
35 for physical illness generally. Nothing in this subdivision, however, shall  
36 prohibit the Plan from requiring the most cost-effective treatment setting to  
37 be utilized by a person undergoing necessary care and treatment for  
38 chemical dependency.
- 39 (5) Reserved.
- 40 (6) Permissive coverage extension. – If a covered service becomes excluded  
41 from coverage under the Plan, the Executive Administrator and Claims  
42 Processor may, in the event of exceptional situations creating undue  
43 hardships or adverse medical conditions, allow persons enrolled in the Plan  
44 to remain covered by the Plan's previous coverage for up to three months  
45 after the effective date of the change in coverage, provided the persons so  
46 enrolled had been undergoing a continuous plan of specific treatment  
47 initiated within three months prior to the effective date of the change in  
48 coverage.
- 49 (7) Reconstructive surgery. – Charges for cosmetic surgery or treatment  
50 required for correction of damage caused by accidental injury sustained by  
51 the covered individual while coverage under this plan is in force on his or

1 her account or to correct congenital deformities or anomalies shall not be  
2 excluded if they otherwise qualify as covered medical expenses.  
3 Reconstructive breast surgery following mastectomy, as those terms are  
4 defined in G.S. 58-51-62, shall be covered.

5 **"§ 135-48.51. Coverage and operational mandates related to Chapter 58 of the General**  
6 **Statutes.**

7 The following provisions of Chapter 58 of the General Statutes apply to the State Health  
8 Plan:

- 9 (1) G.S. 58-3-191, Managed care reporting and disclosure requirements.
- 10 (2) G.S. 58-3-221, Access to nonformulary and restricted access prescription  
11 drugs.
- 12 (3) G.S. 58-3-223, Managed care access to specialist care.
- 13 (4) G.S. 58-3-225, Prompt claim payments under health benefit plans.
- 14 (5) G.S. 58-3-235, Selection of specialist as primary care provider.
- 15 (6) G.S. 58-3-240, Direct access to pediatrician for minors.
- 16 (7) G.S. 58-3-245, Provider directories.
- 17 (8) G.S. 58-3-250, Payment obligations for covered services.
- 18 (9) G.S. 58-3-265, Payment obligations for covered services.
- 19 (10) G.S. 58-3-280, Coverage for the diagnosis and treatment of lymphedema.
- 20 (11) G.S. 58-3-285, Coverage for hearing aids.
- 21 (12) G.S. 58-50-30, Right to choose services of optometrist, podiatrist, licensed  
22 clinical social worker, certified substance abuse professional, licensed  
23 professional counselor, dentist, chiropractor, psychologist, pharmacist,  
24 certified fee-based practicing pastoral counselor, advanced practice nurse,  
25 licensed marriage and family therapist, or physician assistant
- 26 (13) G.S. 58-67-88, Continuity of care.

27 **"§ 135-48.52. General limitations and exclusions.**

28 The Plan shall not provide coverage for or pay any benefits for any of the following:

- 29 (1) Charges to the extent paid, or which the individual is entitled to have paid, or  
30 to obtain without cost, in accordance with any government laws or  
31 regulations except Medicare. If a charge is made to any such person which  
32 he or she is legally required to pay, any benefits under this Plan will be  
33 computed in accordance with its provisions, taking into account only such  
34 charge. "Any government" includes the federal, State, provincial, or local  
35 government, or any political subdivision thereof, of the United States,  
36 Canada, or any other country.
- 37 (2) Charges for services rendered in connection with any occupational injury or  
38 disease arising out of and in the course of employment with any employer, if  
39 (i) the employer furnishes, pays for or provides reimbursement for such  
40 charges, or (ii) the employer makes a settlement payment for such charges,  
41 or (iii) the person incurring such charges waives or fails to assert his or her  
42 rights respecting such charges.
- 43 (3) Charges for any services rendered as a result of injury or sickness due to an  
44 act of war, declared or undeclared, which act shall have occurred after the  
45 effective date of a person's coverage under the Plan.
- 46 (4) Charges for any services with respect to which there is no legal obligation to  
47 pay. For the purposes of this item, any charge which exceeds the charge that  
48 would have been made if a person were not covered under this Plan shall, to  
49 the extent of such excess, be treated as a charge for which there is no legal  
50 obligation to pay; and any charge made by any person for anything which is  
51 normally or customarily furnished by such person without payment from the



1                    recipient or user thereof shall also be treated as a charge for which there is  
2                    no legal obligation to pay.

3                    (5)            Charges during a continuous hospital confinement which commenced prior  
4                    to the effective date of the person's coverage under this Plan.

5                    (6)            Charges for services unless a claim is filed within 18 months from the date  
6                    of service.

7                    (7)            Charges for sexual dysfunction or hair growth drugs or for nonmedically  
8                    necessary drugs used for cosmetic purposes.

9                    **"§ 135-48.53. Reserved for future codification purposes.**

10                   **"§ 135-48.54. Optional participation for charter schools operated by private nonprofit**  
11                   **corporations.**

12                   (a)            The board of directors of each charter school operated by a private nonprofit  
13                   corporation shall elect whether to become a participating employer in the Plan in accordance  
14                   with this Article. This election shall be in writing, shall be made no later than 30 days after ~~this~~  
15                   ~~section becomes law, October 28, 1998,~~ and shall be filed with the ~~Executive Administrator~~  
16                   ~~and Board of Trustees, Plan~~ and with the State Board of Education. For each charter school  
17                   employee who is employed on or before the date the board makes the election, membership in  
18                   the Plan is effective as of the date the board makes the election. For each charter school  
19                   employee who is employed after the date the board makes the election, membership in the Plan  
20                   is effective as of the date of that employee's entry into eligible service. This subsection applies  
21                   only to charter schools that received State Board of Education approval under

26                   with this Article. This election shall be in writing and filed with the ~~Executive Administrator,~~  
27                   ~~the Board of Trustees, Plan~~ and the State Board of Education. This election is effective for each  
28                   charter school employee as of the date of that employee's entry into eligible service. This  
29                   subsection applies to charter schools that receive State Board of Education approval under  
30                   G.S. 115C-238.29D after 1998.

31                   (c)            A board's election to become a participating employer in the Plan under this section  
32                   is irrevocable and shall require all eligible employees of the charter school to participate.

33                   (d)            If a charter school's board of directors does not elect to become a participating  
34                   employer in the Plan under this section, that school's employees and the dependents of those  
35                   employees are not eligible for any benefits under the Plan on account of employment with a  
36                   charter school.

37                   (e)            The board of directors of each charter school shall notify each of its employees as to  
38                   whether the board elected to become a participating employer in the Plan under this section.  
39                   This notification shall be in writing and shall be provided within 30 days of the board's election  
40                   or at the time an initial offer for employment is made, whichever occurs last. If the board did  
41                   not elect to become a participating employer in the Plan, the notice shall include a statement  
42                   that the employee shall have no legal recourse against the board or the State for any possible  
43                   benefit under the Plan. The employee shall provide written acknowledgment of the employee's  
44                   receipt of the notification under this subsection.

45                   **"§ 135-48.55. Interest charged to charter schools on late premiums.**

46                   The total amount of premiums due the Plan from charter schools as employing units,  
47                   including amounts withheld from the compensation of Plan members, that is not remitted to the  
48                   Plan by the fifteenth day of the month following the due date of remittance shall be assessed  
49                   interest of one and one-half percent (1 1/2%) of the amount due the Plan, per month or fraction  
50                   thereof, beginning with the sixteenth day of the month following the due date of the remittance.  
51                   The interest authorized by this section shall be assessed until the premium payment plus the

1 accrued interest amount is remitted to the Plan. The remittance of premium payments under this  
2 section shall be presumed to have been made if the remittance is postmarked in the United  
3 States mail on a date not later than the fifteenth day of the month following the due date of the

5 **"§ 135-48.56. Education of covered active and retired employees.**

6 It is the intent of the General Assembly that active employees and retired employees  
7 covered under the Plan and its successor Plan shall have several opportunities in each fiscal  
8 year to attend presentations conducted by Plan management staff providing detailed  
9 information about benefits, limitations, premiums, co-payments, and other pertinent Plan  
10 matters. To this end, the Plan's management staff shall conduct multiple presentations each year  
11 to Plan members and association groups representing active and retired employees across all  
12 geographic regions of the State. Regional meetings shall be held in locations that afford  
13 reasonably convenient access to Plan members. The presentations shall be designed not only to  
14 present information about the Plan but also to hear and respond to Plan members' questions and  
15 concerns.

16 **"§ 135-48.57. Payments for county or city ambulance service.**

17 Allowable payments for services provided by a county or city ambulance service shall be  
18 paid directly or shall be co-payable to the county or city ambulance service provider. As used  
19 in this subsection, "county or city ambulance service" means ambulance services provided by a  
20 county or county-franchised ambulance service supplemented by county funds, or a  
21 municipally owned and operated ambulance service or by an ambulance service supplemented  
22 by municipal funds.

23 **"§ 135-48.58. Premiums for firefighters, rescue squad workers, and members of National  
24 Guard.**

25 In setting premiums for firefighters, rescue squad workers, and members of the National  
26 Guard, and their eligible dependents, the ~~Executive Administrator and Board of Trustees~~ Plan  
27 shall establish rates separate from those affecting other members of the Plan. These separate  
28 premium rates shall include rate factors for incurred but unreported claim costs, for the effects  
29 of adverse selection from voluntary participation in the Plan, and for any other actuarially  
30 determined measures needed to protect the financial integrity of the Plan for the benefit of its  
31 served employees, retired employees, and their eligible dependents.

32 "Part 6. Long-term Care Benefits.

33 **"§ 135-48.60. Undertaking.**

34 (a) The State of North Carolina undertakes to make available an optional program of  
35 long-term care benefits for the benefit of its qualified employees, retired employees and their  
36 dependents which will pay benefits in accordance with the terms hereof. Retired employees of  
37 the Local Governmental Employees' Retirement System pursuant to Article 3 of Chapter 128 of  
38 the General Statutes and their dependents are also eligible to be qualified for the benefits  
39 provided by this Part.

40 (b) The long-term care benefits provided by this Part shall be made available through  
41 the State Health Plan for Teachers and State Employees pursuant to ~~Article~~ Articles 2 and 3A  
42 3B of this Chapter (hereinafter called the "Plan") and administered by the ~~Plan's Executive~~  
43 ~~Administrator and Board of Trustees.~~ State Treasurer. In administering the benefits provided by  
44 this Part, the ~~Executive Administrator and Board of Trustees~~ State Treasurer shall have the  
45 same type of powers and duties that are provided under ~~Part 3~~ the other Parts of this Article for  
46 hospital and medical benefits. The benefits provided by this Part may be offered by the Plan on  
47 a self-insured basis, in which case a third-party claims processor shall be chosen through  
48 competitive bids, or through a contract of insurance, in which case a carrier licensed to do  
49 business in North Carolina shall be selected on a competitive bid basis in accordance with State  
50 law.

1 (c) The benefits authorized by this Part are available only to qualified employees and  
2 retired employees who voluntarily elect to provide such benefits for themselves and their  
3 qualified dependents. Payroll deductions shall be available from employee salary and disability  
4 benefit payments and from retired employee retirement benefit payments for fully contributory  
5 premium amounts.

6 (d) ~~The Executive Administrator and Board of Trustees of the Plan~~ State Treasurer shall  
7 insure insofar as possible that the long-term care benefits provided by this Part shall be  
8 tax-qualified under federal law.

9 **"§ 135-48.61. Long-term care benefits.**

10 (a) Definitions. – The following definitions apply in this section:

11 (1) Adult care facility. – A facility which (i) is operated under State law to  
12 provide group care for the aged and disabled in a setting away from their  
13 residence on a less than 24-hour basis when such aged or disabled would  
14 otherwise be in need of full-time personal care away from their residence; or  
15 (ii) meets the requirements for certification under Chapter 131D of the  
16 General Statutes.

17 (2) Assisted living facility. – A facility which (i) is operated under State law to  
18 provide residential care for the aged or disabled whose principal need is a  
19 home which provides personal care appropriate to their age or disability; or  
20 (ii) meets the requirements for licensure under Chapter 131D of the General  
21 Statutes.

22 (3) Home care agency. – A residential care agency which is (i) operated under  
23 State law and which is qualified as a home health care agency under  
24 Medicare; or (ii) an agency meeting the requirements for licensure as a home  
25 care agency under Chapter 131E of the General Statutes.

26 (4) Nursing home. – A facility or a part of a facility which is (i) operated under  
27 State law and which is qualified as a skilled nursing or intermediate nursing  
28 facility under Medicare; or is (ii) a facility meeting the requirements for  
29 licensure under Chapter 131E of the General Statutes.

30 (b) Long-term care benefits provided by this Part are subject to elimination periods,  
31 coinsurance provisions, and other limitations separate and apart from those provided for in ~~Part~~  
32 3 the other Parts of this Article. No limitation on out-of-pocket expenses are provided for the  
33 benefits covered by this section. Long-term care benefits are as follows:

34 (1) Nursing Home Benefits. – The Plan will pay a fixed amount of the  
35 reasonable and customary daily charges allowed for nursing facilities  
36 providing skilled nursing care and intermediate nursing care up to a  
37 maximum amount per day for each day after a fixed number of consecutive  
38 days for each nursing home stay. Such daily charges shall be inclusive of  
39 semiprivate room and board; skilled and semiskilled nursing services;  
40 routine laboratory tests and examinations; physical, occupational, and speech  
41 therapy; respiratory and other gas therapy; and drugs, injections, biologicals,  
42 fluids, solutions, dietary aids and supplements, and other routine medical  
43 supplies and equipment. Readmission to a nursing home within 180 days,  
44 exclusive of hospital stays, for the same or related cause or causes shall be  
45 considered a single nursing home stay for the purposes of this section.  
46 Benefits payable under this subdivision are contingent upon compliance with  
47 the following conditions and will, in no instance, be paid under this section  
48 without compliance with each of the following conditions:

49 a. Confinement to a nursing home is medically appropriate due to an  
50 illness, disease, or injury upon recommendation of an admitting

1 physician other than a proprietor, employee, or agent of the nursing  
2 home;

3 b. Confinement to a nursing home is for any overnight stay for which a  
4 charge for a day's stay is due and payable; and

5 c. Prior to confinement, the admitting physician secures approval  
6 certification from the Plan for confinement.

7 ~~As used in this section, a nursing home is a facility or a part of a facility which is (i) operated~~  
8 ~~under State law and which is qualified as a skilled nursing or intermediate nursing facility~~  
9 ~~under Medicare; or is (ii) a facility meeting the requirements for licensure under Chapter 131E~~  
10 ~~of the General Statutes.~~

11 (2) Custodial Benefits. – The Plan will pay a fixed percentage of the fixed  
12 amount of reasonable and customary daily charges allowed by the Plan in  
13 subdivision (1) of this section for assisted living facilities, for adult day care  
14 facilities, and for home care agencies up to a maximum amount per day for  
15 each day after a fixed number of consecutive days that such custodial care is  
16 provided. Benefits payable under this subdivision are contingent upon  
17 compliance with the following conditions and will, in no instance, be paid  
18 under this subdivision without compliance with each of the following  
19 conditions:

20 a. Use of such custodial benefits is medically appropriate in a treatment  
21 plan established and certified initially and at least once every six  
22 months by an attending physician or other allied health professionals  
23 other than a proprietor, employee, or agent of one or more of the  
24 aforementioned facilities and agencies;

25 b. Confinement to a nursing home would be medically appropriate  
26 without custodial care proposed to be rendered by one or more of the

47 (4) The Executive Administrator and Board of Trustees of the Plan shall  
48 establish the payment percentages, maximum daily payment rates, benefit  
49 periods, elimination periods, and maximum lifetime benefits payable for  
50 each covered individual for the nursing home and custodial benefits  
51 provided by this section. The Executive Administrator and Board of Trustees

- 1 shall provide for inflationary increases in the maximum daily payment rates  
2 and the maximum lifetime benefits payable for each covered individual.
- 3 (5) The ~~Executive Administrator and Board of Trustees of the~~ Plan shall provide  
4 a bed reservation benefit whenever Plan members are hospitalized during a  
5 stay in a nursing home or an assisted living facility.
- 6 (6) The ~~Executive Administrator and Board of Trustees of the~~ Plan shall provide  
7 for a waiver of premiums involving minimum lengths of stay in a nursing  
8 home or an assisted living facility. In addition, the Executive Administrator  
9 and Board of Trustees shall allow coverage to be reinstated upon failure to  
10 pay premiums, provided certain grace periods are not exceeded and  
11 retroactive premium payments are made.
- 12 (7) Limitations and Exclusions to Long-Term Care Benefits. – The benefits  
13 provided by this section are for the purpose of meeting the requirements for  
14 assistance from the loss of functional capacity associated with a chronic  
15 illness, disease, or disabling injury for extended periods of time; and are, in  
16 no way, intended to duplicate the benefits provided for acute and other  
17 medical care provided by Medicare or Part 3 of this Article. A loss of  
18 functional capacity can occur from: (i) an illness, disease, or disabling injury  
19 resulting in a physical incapacity to perform the activities of daily living; or  
20 (ii) an irreversible organic mental impairment resulting in a mental  
21 incapacity. Activities of daily living consist of routine functions involving  
22 personal care and mobility.

23 **"§ 135-48.62. Conversion.**

24 Upon cessation of group coverage under this Part, an employee, retired employee, or  
25 dependent shall be entitled to a conversion to a nongroup plan of long-term care benefits. The  
26 Executive Administrator and Board of Trustees of the Plan shall determine how the conversion  
27 rights authorized by this Part shall be administered."  
28

29 **STATEMENT OF LEGISLATIVE INTENT REGARDING REPEAL OF LANGUAGE**

30 **SECTION 2.11.** In repealing a specific, detailed provision of Article 3A of Chapter  
31 135 of the General Statutes and not placing that detailed provision into Article 3B of Chapter  
32 135 of the General Statutes, it is not necessarily the intent of the General Assembly to prohibit  
33 the State Treasurer or the State Health Plan from having that authority.  
34

35 **CARRYOVER OF RULES AND POLICIES**

36 **SECTION 2.12.** Rules and policies adopted by the Executive Administrator and  
37 the Board of Trustees prior to the effective date of this section shall continue to be in effect  
38 unless the rule or policy directly conflicts with a provision of Article 3B of Chapter 135 of the  
39 General Statutes or until the State Treasurer changes the rule or policy.  
40

41 **EFFECTIVE DATE FOR PART II**

42 **SECTION 2.13.** Except as otherwise provided, Part II of this act becomes effective  
43 January 1, 2012.

46 **EFFECT OF HEADINGS**

47 **SECTION 3.1.** The headings to the parts and sections of this act are a convenience  
48 to the reader and are for reference only. The headings do not expand, limit, or define the text of  
49 this act, except for effective dates referring to a part.
