1 A BILL TO BE ENTITLED  
2 AN ACT TO MAKE VARIOUS AMENDMENTS TO THE ELECTION ADMINISTRATION  
3 LAWS, CAMPAIGN FINANCE LAWS, AND OTHER CONFORMING CHANGES.

4 The General Assembly of North Carolina enacts:

5  
6 **PART I. ELECTION ADMINISTRATION CHANGES.**

7 **SECTION 1.** Article 1 of Chapter 163 of the General Statutes is amended by  
8 adding a new section to read:

9 **"§ 163-3. Special elections.**

10 Special elections shall be called as permitted by law and conducted in accordance with  
11 G.S. 163-287."

12 **SECTION 2.** G.S. 163-19 reads as rewritten:

13 **"§ 163-19. State Board of Elections; appointment; term of office; vacancies; oath of office.**

14 (a) All of the terms of office of the present members of the State Board of Elections  
15 shall expire on May 1, 1969, or when their successors in office are appointed and qualified.

16 The State Board of Elections shall consist of five registered voters whose terms of office  
17 shall begin on May 1, 1969, and shall continue for four years, and until their successors are  
18 appointed and qualified. The Governor shall appoint the members of this Board and likewise  
19 shall appoint their successors every four years at the expiration of each four-year term. Not  
20 more than three members of the Board shall be members of the same political party. The  
21 Governor shall appoint the members from a list of nominees submitted to him by the State  
22 party chairman of each of the two political parties having the highest number of registered  
23 affiliates as reflected by the latest registration statistics published by the State Board of  
24 Elections. Each party chairman shall submit a list of five nominees who are affiliated with that  
25 political party.

26 Any vacancy occurring in the Board shall be filled by the Governor, and the person so  
27 appointed shall fill the unexpired term. The Governor shall fill the vacancy from a list of three  
28 nominees submitted to him by the State party chairman of the political party that nominated the  
29 vacating member as provided by the preceding paragraph. The three nominees must be  
30 affiliated with that political party.

31 (b) At the first meeting held after new appointments are made, the members of the State  
32 Board of Elections shall take the following oath:

33 "I, \_\_\_\_\_, do solemnly swear (or affirm) that I will support the Constitution  
34 of the United States; that I will be faithful and bear true allegiance to the State of North



1 Carolina, and to the constitutional powers and authorities which are or may be  
2 established for the government thereof; that I will endeavor to support, maintain and  
3 defend the Constitution of said State, and that I will well and truly execute the duties of  
4 the office of member of the State Board of Elections according to the best of my  
5 knowledge and ability, according to law, so help me, God."

6 (c) After taking the prescribed oath, the Board shall organize by electing one of its  
7 members chairman and another secretary. The term of office of the chairman is two years and  
8 begins on May 1 of each odd-numbered year. No person may be elected as chairman for more  
9 than two terms. In the case of a vacancy, a new chairman shall be elected to serve the  
10 remainder of the unexpired term.

11 (d) No person shall be eligible to serve as a member of the State Board of Elections  
12 who holds any elective or appointive office under the government of the United States, or of  
13 the State of North Carolina or any political subdivision thereof. No person who holds any office  
14 in a political party, or organization, or who is a candidate for nomination or election to any  
15 office, or who is a campaign manager or treasurer of any candidate in a primary or election  
16 shall be eligible to serve as a member of the State Board of Elections."

17 **SECTION 3.** G.S. 163-59 reads as rewritten:

18 **"§ 163-59. Right to participate or vote in party primary.**

19 No person shall be entitled to vote or otherwise participate in the primary election of any  
20 political party unless that person complies with all of the following:

- 21 (1) Is a registered voter.
- 22 (2) Has declared and has had recorded on the registration book or record the fact  
23 that the voter affiliates with the political party in whose primary the voter  
24 proposes to vote or participate.
- 25 (3) Is in good faith a member of that party.

26 Notwithstanding the previous paragraph, any unaffiliated voter who is authorized under  
27 G.S. 163-119 may also vote in the primary if the voter is otherwise eligible to vote in that  
28 primary except for subdivisions (2) and (3) of the previous paragraph.

29 Any person who will become qualified by age to register and vote in the general election  
30 for which the primary is held, even though not so qualified by the date of the primary, shall be  
31 entitled to register for the primary and general election prior to the primary and then to vote in  
32 the primary after being registered. Such person may register not earlier than 60 days nor later  
33 than the last day for making application to register under G.S. 163-82.6(c) prior to the primary.  
34 In addition, persons who will become qualified by age to register and vote in the general  
35 election for which the primary is held, who do not register during the special period may  
36 register to vote after such period as if they were qualified on the basis of age, but until they are  
37 qualified by age to vote, they may vote only in primary elections. ~~Such a person also may~~  
38 ~~register and vote in the primary and general election pursuant to G.S. 163-82.6A(f)."~~

39 **SECTION 4.** G.S. 163-82.6 reads as rewritten:

40 **"§ 163-82.6. Acceptance of application forms.**

41 (a) How the Form May Be Submitted. – The county board of elections shall accept any  
42 form described in G.S. 163-82.3 if the applicant submits the form by mail, facsimile  
43 transmission, transmission of a scanned document, or in person. The applicant may delegate the  
44 submission of the form to another person. Any person who communicates to an applicant  
45 acceptance of that delegation shall deliver that form so that it is received by the appropriate  
46 county board of elections in time to satisfy the registration deadline in subdivision (1) or (2) of  
47 subsection (c) of this section for the next election. It shall be a Class 2 misdemeanor for any  
48 person to communicate to the applicant acceptance of that delegation and then fail to make a  
49 good faith effort to deliver the form so that it is received by the county board of elections in  
50 time to satisfy the registration deadline in subdivision (1) or (2) of subsection (c) of this section  
51 for the next election. It shall be an affirmative defense to a charge of failing to make a good

1 faith effort to deliver a delegated form by the registration deadline that the delegatee informed  
2 the applicant that the form would not likely be delivered in time for the applicant to vote in the  
3 next election. ~~It shall be a Class 2 misdemeanor for any person to sell or attempt to sell a~~  
4 ~~completed voter registration form or to condition its delivery upon payment.~~

5 (a1) Misdemeanors. – It shall be a Class 2 misdemeanor for any person to do any of the  
6 following:

- 7 (1) To communicate to the applicant acceptance of the delegation described in  
8 subsection (a) of this section and then fail to make a good faith effort to  
9 deliver the form so that it is received by the county board of elections in time  
10 to satisfy the registration deadline in subdivision (1) or (2) of subsection (c)  
11 of this section for the next election. It shall be an affirmative defense to a  
12 charge of failing to make a good faith effort to deliver a delegated form by  
13 the registration deadline that the delegatee informed the applicant that the  
14 form would not likely be delivered in time for the applicant to vote in the  
15 next election.
- 16 (2) To sell or attempt to sell a completed voter registration form or to condition  
17 its delivery upon ~~payment~~ payment, including payment on a per voter  
18 registration application completed basis.
- 19 (3) To change a person's information on a voter registration form prior to its  
20 delivery to a county board of elections.
- 21 (4) To coerce a person into marking a party affiliation other than the party  
22 affiliation the person desires.
- 23 (5) To offer a person a voter registration form that has a party affiliation  
24 premarked unless the person receiving the form has requested the  
25 premarking.
- 26 (6) To pay another person to register voters, or assist or encourage voters to fill  
27 out voter registration forms, on the basis of per voter registration application  
28 completed.
- 29 (7) To accept payment for registering voters, or assisting or encouraging voters  
30 to fill out voter registration forms, on the basis of per voter registration  
31 application completed.

32 (b) Signature. – The form shall be valid only if signed by the applicant. An  
33 electronically captured image of the signature of a voter on an electronic voter registration form  
34 offered by a State agency shall be considered a valid signature for all purposes for which a  
35 signature on a paper voter registration form is used.

36 (c) Registration Deadlines for a Primary or Election. – In order to be valid for a primary  
37 or election, ~~except as provided in G.S. 163-82.6A,~~ the form:

- 38 (1) If submitted by mail, must be postmarked at least 25 days before the primary  
39 or election, except that any mailed application on which the postmark is  
40 missing or unclear is validly submitted if received in the mail not later than  
41 20 days before the primary or election,
- 42 (2) If submitted in person, by facsimile transmission, or by transmission of a  
43 scanned document, must be received by the county board of elections by a  
44 time established by that board, but no earlier than 5:00 P.M., on the  
45 twenty-fifth day before the primary or election,
- 46 (3) If submitted through a delegatee who violates the duty set forth in subsection  
47 (a) of this section, must be signed by the applicant and given to the delegatee  
48 not later than 25 days before the primary or election, except as provided in  
49 subsection (d) of this section.

1 (c1) If the application is submitted by facsimile transmission or transmission of a  
2 scanned document, a permanent copy of the completed, signed form shall be delivered to the  
3 county board no later than 20 days before the election.

4 ~~(d) Instances When Person May Register and Vote on Primary or Election Day.—If a~~  
5 ~~person has become qualified to register and vote between the twenty-fifth day before a primary~~  
6 ~~or election and primary or election day, then that person may apply to register on primary or~~  
7 ~~election day by submitting an application form described in G.S. 163-82.3(a) or (b) to:~~

8 (1) A member of the county board of elections;

9 (2) The county director of elections; or

10 (3) The chief judge or a judge of the precinct in which the person is eligible to  
11 vote;

12 and, if the application is approved, that person may vote the same day. The official in  
13 subdivisions (1) through (3) of this subsection to whom the application is submitted shall  
14 decide whether the applicant is eligible to vote. The applicant shall present to the official  
15 written or documentary evidence that the applicant is the person he represents himself to be.  
16 The official, if in doubt as to the right of the applicant to register, may require other evidence  
17 satisfactory to that official as to the applicant's qualifications. If the official determines that the  
18 person is eligible, the person shall be permitted to vote in the primary or election and the  
19 county board shall add the person's name to the list of registered voters. If the official denies  
20 the application, the person shall be permitted to vote a challenged ballot under the provisions of  
21 G.S. 163-88.1, and may appeal the denial to the full county board of elections. The State Board  
22 of Elections shall promulgate rules for the county boards of elections to follow in hearing  
23 appeals for denial of primary or election day applications to register. No person shall be  
24 permitted to register on the day of a second primary unless he shall have become qualified to  
25 register and vote between the date of the first primary and the date of the succeeding second  
26 primary.

27 (e) For purposes of subsection (d) of this section, persons who "become qualified to  
28 register and vote" during a time period:

29 (1) Include those who during that time period are naturalized as citizens of the  
30 United States or who are restored to citizenship after a conviction of a  
31 felony; but

32 (2) Do not include persons who reach the age of 18 during that time period, if  
33 those persons were eligible to register while 17 years old during an earlier  
34 period.

35 (f) The county board of elections shall forward by electronic means any application  
36 submitted for the purpose of preregistration to the State Board of Elections. No later than 60  
37 days prior to the first election in which the applicant will be legally entitled to vote, the State  
38 Board of Elections shall notify the appropriate county board of elections to verify the  
39 qualifications and address of the applicant in accordance with G.S. 163-82.7."

40 **SECTION 5.** G.S. 163-82.6A is repealed.

41 **SECTION 6.** G.S. 163-82.25 is repealed.

42 **SECTION 7.** G.S. 163-98 reads as rewritten:

43 **"§ 163-98. General election participation by new political party.**

44 (a) In the first general election following the date on which a new political party  
45 qualifies under the provisions of G.S. 163-96, it shall be entitled to have the names of its  
46 candidates for national, State, congressional, and local offices printed on the official ballots  
47 upon paying a filing fee equal to that provided for candidates for the office in G.S. 163-107 or  
48 upon complying with the alternative available to candidates for the office in G.S. 163-107.1.

49 (b) For the first general election following the date on which it qualifies under  
50 G.S. 163-96, a new political party shall select its candidates by party convention. Following  
51 adjournment of the nominating convention, but not later than the first day of July prior to the

1 general election, the president of the convention shall certify to the State Board of Elections the  
 2 names of persons chosen in the convention as the new party's candidates in the ensuing general  
 3 election. Any candidate nominated by a new party shall be affiliated with the party at the time  
 4 of certification to the State Board of Elections. The requirement of affiliation with the party  
 5 will be met if the candidate submits at or before the time of certification as a candidate an  
 6 application to change party affiliation to that party. The State Board of Elections shall print  
 7 names thus certified on the appropriate ballots as the nominees of the new party. The State  
 8 Board of Elections shall send to each county board of elections the list of any new party  
 9 candidates so that the county board can add those names to the appropriate ballot.

10 (c) When any candidate is nominated under this section, the board of elections with  
 11 jurisdiction over the election shall issue a notification to the candidate stating the following:

12 (1) The organizational report required under G.S. 163-278.9(a)(1) shall be filed  
 13 with the Board no later than the tenth day following the day the candidate  
 14 files notice of candidacy or the tenth day following the organization of the  
 15 political committee, whichever occurs first. If the organizational report is not  
 16 filed within the required time frame, a civil late penalty of two hundred fifty  
 17 dollars (\$250.00) per day for each day the filing is late shall be assessed  
 18 against the candidate.

19 (2) Every treasurer of a political committee shall participate in treasurer training  
 20 required under G.S. 163-278.7(f)."

21 **SECTION 8.** G.S. 163-106 reads as rewritten:

22 **"§ 163-106. Notices of candidacy; pledge; with whom filed; date for filing; withdrawal.**

23 (a) Notice and Pledge. – No one shall be voted for in a primary election without having  
 24 filed a notice of candidacy with the appropriate board of elections, State or county, as required  
 25 by this section. To this end every candidate for selection as the nominee of a political party  
 26 shall file with and place in the possession of the board of elections specified in subsection (c) of  
 27 this section, a notice and pledge in the following form:

 registration records of the precinct in which I reside as an affiliate of the

I pledge that if I am defeated in the primary, I will not run for the same  
 office as a write-in candidate in the next general election.

Each candidate shall sign the notice of candidacy in the presence of the chairman or secretary  
 of the board of elections, State or county, with which the candidate files. In the alternative, a  
 candidate may have the candidate's signature on the notice of candidacy acknowledged and  
 certified to by an officer authorized to take acknowledgments and administer oaths, in which  
 case the candidate may mail or deliver by commercial courier service the candidate's notice of  
 candidacy to the appropriate board of elections.

In signing the notice of candidacy the candidate shall use only that candidate's legal name  
 and may use any nickname by which ~~he~~that candidate is commonly known. A candidate may  
 also, in lieu of that candidate's legal first name and legal middle initial or middle name (if any)  
 sign a nickname, provided that the candidate appends to the notice of candidacy an affidavit

1 that the candidate has been commonly known by that nickname for at least five years prior to  
2 the date of making the affidavit. The candidate shall also include with the affidavit the way that  
3 candidate's name (as permitted by law) should be listed on the ballot if another candidate with  
4 the same last name files a notice of candidacy for that office.

5 A notice of candidacy signed by an agent or any person other than the candidate shall be  
6 invalid.

7 Prior to the date on which candidates may commence filing, the State Board of Elections  
8 shall print and furnish, at State expense, to each county board of elections a sufficient number  
9 of the notice of candidacy forms prescribed by this subsection for use by candidates required to  
10 file with county boards of elections.

11 (a1) Disclosure of Felony Conviction. – At the same time the candidate files notice of  
12 candidacy under this section, the candidate shall file with the same office a statement  
13 answering the following question: "Have you ever been convicted of a felony?" The State  
14 Board of Elections shall adapt the notice of candidacy form to include the statement required  
15 by this subsection. The form shall make clear that a felony conviction need not be disclosed if  
16 the conviction was dismissed as a result of reversal on appeal or resulted in a pardon of  
17 innocence or expungement. The form shall require a candidate who answers "yes" to the  
18 question to provide the name of the offense, the date of conviction, the date of the restoration of  
19 citizenship rights, and the county and state of conviction. The form shall require the candidate  
20 to swear or affirm that the statements on the form are true, correct, and complete to the best of  
21 the candidate's knowledge or belief. The form shall be available as a public record in the office  
22 of the board of elections where the candidate files notice of candidacy and shall contain an  
23 explanation that a prior felony conviction does not preclude holding elective office if the  
24 candidate's rights of citizenship have been restored. This subsection shall also apply to  
25 individuals who become candidates for election by the people under G.S. 163-114, 163-122,  
26 163-123, 163-98, 115C-37, 130A-50, Article 24 of Chapter 163 of the General Statutes, or any  
27 other statute or local act. Those individuals shall complete the question at the time the  
28 documents are filed initiating their candidacy. The State Board of Elections shall adapt those  
29 documents to include the statement required by this subsection. If an individual does not  
30 complete the statement required by this subsection, the board of elections accepting the filing  
31 shall notify the individual of the omission, and the individual shall have 48 hours after notice to  
32 complete the statement. If the individual does not complete the statement at the time of filing or  
33 within 48 hours after the notice, the individual's filing is not complete, the individual's name  
34 shall not appear on the ballot as a candidate, and votes for the individual shall not be counted. It  
35 is a Class I felony to complete the form knowing that information as to felony conviction or  
36 restoration of citizenship is untrue. This subsection shall not apply to candidates required by  
37 G.S. 138A-22(d) to file Statements of Economic Interest.

38 (b) Eligibility to File. – No person shall be permitted to file as a candidate in a primary  
39 if, at the time ~~he~~that person offers to file notice of candidacy, ~~he~~that person is registered on  
40 the appropriate registration book or record as an affiliate of a political party other than that in  
41 whose primary ~~he~~the person is attempting to file. No person who has changed ~~his~~-political  
42 party affiliation or who has changed from unaffiliated status to party affiliation as permitted in  
43 G.S. 163-82.17, shall be permitted to file as a candidate in the primary of the party to which ~~he~~  
44 that person changed unless ~~he~~that person has been affiliated with the political party in which ~~he~~  
45 that person seeks to be a candidate for at least 90 days prior to the filing date for the office for  
46 which ~~he~~that person desires to file ~~his~~a notice of candidacy.

47 A person registered as "unaffiliated" shall be ineligible to file as a candidate in a party  
48 primary election.

49 (c) Time for Filing Notice of Candidacy. – Candidates seeking party primary  
50 nominations for the following offices shall file their notice of candidacy with the State Board of

1 Elections no earlier than 12:00 noon on the second Monday in February and no later than 12:00  
2 noon on the last business day in February preceding the primary:

3 Governor

4 Lieutenant Governor

5 All State executive officers

6 Justices of the Supreme Court, Judges of the Court of Appeals

7 Judges of the superior courts

8 Judges of the district courts

9 United States Senators

10 Members of the House of Representatives of the United States

11 District attorneys

12 Candidates seeking party primary nominations for the following offices shall file their  
13 notice of candidacy with the county board of elections no earlier than 12:00 noon on the second  
14 Monday in February and no later than 12:00 noon on the last business day in February  
15 preceding the primary:

16 State Senators

17 Members of the State House of Representatives

18 All county offices.

19 (d) Notice of Candidacy for Certain Offices to Indicate Vacancy. – In any primary in  
20 which there are two or more vacancies for associate justices for the Supreme Court, two or  
21 more vacancies for the Court of Appeals, two or more vacancies for district court judge, or two  
22 vacancies for United States Senator from North Carolina, each candidate shall, at the time of  
23 filing notice of candidacy, file with the State Board of Elections a written statement designating  
24 the vacancy to which ~~he~~ that candidate seeks nomination. Votes cast for a candidate shall be  
25 effective only for ~~his~~ his nomination to the vacancy for which ~~he~~ that candidate has given notice of  
26 candidacy as provided in this subsection.

27 (e) Withdrawal of Notice of Candidacy. – Any person who has filed notice of  
28 candidacy for an office shall have the right to withdraw it at any time prior to the date on which  
29 the right to file for that office expires under the terms of subsection (c) of this section. If a  
30 candidate does not withdraw before the filing deadline, except as provided in G.S. 163-112, ~~his~~  
31 that candidate's name shall be printed on the primary ballot, any votes for ~~him~~ that candidate  
32 shall be counted, and ~~he~~ that candidate shall not be refunded ~~his~~ the filing fee.

33 (f) Candidates required to file their notice of candidacy with the State Board of  
34 Elections under subsection (c) of this section shall file along with their notice a certificate  
35 signed by the chairman of the board of elections or the director of elections of the county in  
36 which they are registered to vote, stating that the person is registered to vote in that county,  
37 stating the party with which the person is affiliated, and that the person has not changed ~~his~~  
38 his affiliation from another party or from unaffiliated within three months prior to the filing  
39 deadline under subsection (c) of this section. In issuing such certificate, the chairman or  
40 director shall check the registration records of the county to verify such information. During the  
41 period commencing 36 hours immediately preceding the filing deadline the State Board of  
42 Elections shall accept, on a conditional basis, the notice of candidacy of a candidate who has  
43 failed to secure the verification ordered herein subject to receipt of verification no later than  
44 three days following the filing deadline. The State Board of Elections shall prescribe the form  
45 for such certificate, and distribute it to each county board of elections no later than the last  
46 Monday in December of each odd-numbered year.

47 (g) When any candidate files a notice of candidacy with a board of elections under  
48 subsection (c) of this section or under G.S. 163-291(2), the board of elections shall,  
49 immediately upon receipt of the notice of candidacy, inspect the registration records of the  
50 county, and cancel the notice of candidacy of any person who does not meet the constitutional  
51 or statutory qualifications for the office, including residency.

1 The board shall give notice of cancellation to any candidate whose notice of candidacy has  
 2 been cancelled under this subsection by mail or by having the notice served on ~~him~~the  
 3 candidate by the sheriff, and to any other candidate filing for the same office. A candidate who  
 4 has been adversely affected by a cancellation or another candidate for the same office affected  
 5 by a substantiation under this subsection may request a hearing on the cancellation. If the  
 6 candidate requests a hearing, the hearing shall be conducted in accordance with Article 11B of  
 7 Chapter 163 of the General Statutes.

8 (h) No person may file a notice of candidacy for more than one office described in  
 9 subsection (c) of this section for any one election. If a person has filed a notice of candidacy  
 10 with a board of elections under this section for one office, then a notice of candidacy may not  
 11 later be filed for any other office under this section when the election is on the same date unless  
 12 the notice of candidacy for the first office is withdrawn under subsection (e) of this section;  
 13 provided that this subsection shall not apply unless the deadline for filing notices of candidacy  
 14 for both offices is the same. Notwithstanding this subsection, a person may file a notice of  
 15 candidacy for a full term as United States Senator, and also file a notice of candidacy for the  
 16 remainder of the unexpired term of that same seat in an election held under G.S. 163-12, and  
 17 may file a notice of candidacy for a full term as a member of the United States House of  
 18 Representatives, and also file a notice of candidacy for the remainder of the unexpired term in  
 19 an election held under G.S. 163-13.

20 (i) Repealed by Session Laws 2001-403, s. 3, effective January 1, 2002.

21 (j) When any candidate files a notice of candidacy, the board of elections with  
 22 jurisdiction over the election shall issue a notification to the candidate stating the following:

23 (1) The organizational report required under G.S. 163-278.9(a)(1) shall be filed  
 24 with the Board no later than the tenth day following the day the candidate  
 25 files notice of candidacy or the tenth day following the organization of the  
 26 political committee, whichever occurs first. If the organizational report is not  
 27 filed within the required time frame, a civil late penalty of two hundred fifty  
 28 dollars (\$250.00) per day for each day the filing is late shall be assessed  
 29 against the candidate.

30 (2) Every treasurer of a political committee shall participate in treasurer training  
 31 required under G.S. 163-278.7(f)."

32 **SECTION 9.** G.S. 163-107(a) reads as rewritten:

33 "(a) Fee Schedule. – At the time of filing a notice of candidacy, each candidate shall pay  
 34 to the board of elections with which ~~he~~that candidate files under the provisions of  
 35 G.S. 163-106 a filing fee for the office ~~he seeks~~sought in the amount specified in the following  
 36 tabulation:

25 (a) Order of Precedence Generally. – Candidate ballot items shall be arranged on the

46 shall appear on a county's official ballots in any primary ballot item shall be determined by the  
47 county board of elections using a process designed by the State Board of Elections for random  
48 selection.

49 (d) Order of Party Candidates on General Election Official Ballot. – Candidates in any  
50 ballot item on a general election official ballot shall appear in the following order:

- 1 (1) Nominees of political parties that reflect ~~at least five percent (5%)~~the two  
2 highest percentages of statewide voter registration, according to the most  
3 recent statistical report published by the State Board of Elections, in  
4 alphabetical order by party and in alphabetical order within the party.
- 5 (2) Nominees of other political parties, in alphabetical order by party and in

- 7 (3) Unaffiliated candidates, in alphabetical order.

8 (d1) Rotation of Parties on General Election Official Ballot. – The order of the political

11 ~~(e) Straight Party Voting. – Each official ballot shall be arranged so that the voter may~~

4 **"§ 163-216.4. Certification of electors.**

5 (a) Before the date fixed for the meeting of the electors, the Governor shall send by  
6 registered mail to the Archivist of the United States either three duplicate original certificates or  
7 one original certificate and two authenticated copies of the Certificates of Ascertainment under  
8 the great seal of the State setting forth the names of the persons chosen as presidential electors  
9 for this State and the number of votes cast for each. These Certificates of Ascertainment should  
10 be sent as soon as possible after the election, but must be received before the Electoral College  
11 meeting. At the same time the Governor shall deliver to the electors six duplicate originals of  
12 the same certificate, each bearing the great seal of the State.

13 (b) In submitting this State's Certificate of Ascertainment as required by 3 U.S.C. § 6,  
14 the Governor shall certify this State's electors and state in the certificate all of the following:

15 (1) The electors will serve as electors unless a vacancy occurs in the office of

17 which case a substitute elector will fill the vacancy.

18 (2) If a substitute elector is appointed to fill a vacancy, the Governor will submit  
19 an amended Certificate of Ascertainment stating the names on the final list

21 **"§ 163-216.5. Presiding officer; elector vacancy.**

22 (a) The Secretary of State shall preside at the meeting of electors described in this  
23 Article.

24 (b) The position of an elector not present to vote is vacant. The Secretary of State shall  
25 appoint an individual as a substitute elector to fill a vacancy as follows:

26 (1) If the alternate elector is present to vote, by appointing the alternate elector  
27 for the vacant position.

28 (2) If the alternate elector for the vacant position is not present to vote, by  
29 appointing an elector chosen by lot from among the alternate electors present  
30 to vote who were nominated by the same political party.

31 (3) If the number of alternate electors present to vote is insufficient to fill any

43 subdivision (3) of this subsection and, if necessary, subdivision (4) of this  
44 subsection.

45 (c) To qualify as a substitute elector under subsection (b) of this section, an individual  
46 who has not executed the pledge required under G.S. 163-216.2 shall execute the following  
47 pledge: "I agree to serve and to mark my ballots for President and Vice President consistent  
48 with the pledge of the individual to whose elector position I have succeeded."

49 **"§ 163-216.6. Elector voting.**

50 (a) At the time designated for elector voting and after all vacant positions have been  
51 filled under G.S. 163-216.5, the Secretary of State shall provide each elector with a presidential

1 and a vice presidential ballot. The elector shall mark the elector's presidential and vice  
2 presidential ballots with the elector's votes for the offices of President and Vice President,  
3 respectively, along with the elector's signature and the elector's legibly printed name.

4 (b) Each elector shall present both completed ballots to the Secretary of State, who shall  
5 examine the ballots and accept as cast all ballots of electors whose votes are consistent with

7 count either an elector's presidential or vice presidential ballot if the elector has not marked

12 (d) The Secretary of State shall distribute ballots to and collect ballots from a substitute  
13 elector and repeat the process under this section of examining ballots, declaring and filling  
14 vacant positions as required, and recording appropriately completed ballots from the substituted  
15 electors until all of this State's electoral votes have been cast and recorded.

16 **"§ 163-216.7. Elector replacement; associated certificates.**

17 (a) After the vote of this State's electors is completed, if the final list of electors differs  
18 from any list that the Governor previously included on a Certificate of Ascertainment prepared  
19 and transmitted under 3 U.S.C. § 6, the Secretary of State immediately shall prepare an  
20 amended Certificate of Ascertainment and transmit it to the Governor for the Governor's  
21 signature.

22 (b) The Governor immediately shall deliver the signed amended Certificate of  
23 Ascertainment to the Secretary of State and a signed duplicate original of the amended  
24 Certificate of Ascertainment to all individuals entitled to receive this State's Certificate of

30 **"§ 163-216.8. Electors and dual office holding.**

31 (a) Upon receiving the filing of a name as a candidate for elector under G.S. 163-216.1,  
32 the Secretary of State shall notify that candidate of the dual office holding requirements of the  
33 North Carolina Constitution and the General Statutes, including specifically that if an  
34 individual elected as elector holds another elective office at the time of taking the oath of office  
35 as elector, that other office is vacated upon taking the oath of office.

36 (b) During January of each year in which electors are elected, the Secretary of State  
37 shall notify each political party authorized to nominate electors of (i) the requirement under  
38 G.S. 163-1(c) to nominate an elector and an alternate elector and (ii) the dual office holding  
39 requirements of the North Carolina Constitution and the General Statutes, including specifically  
40 that if a person elected as elector holds another elective office at the time of taking the oath of

42 (c) The office of elector may be held in addition to the maximum number of appointive  
43 offices allowed by G.S. 128-1.1.

44 **"§ 163-216.9. Appointment of Presidential Electors by General Assembly in certain**  
45 **circumstances, by the Governor in certain other circumstances.**

46 (a) Appointment by General Assembly if No Proclamation by Six Days Before  
47 Electors' Meeting Day. – As permitted by 3 U.S.C. § 2, whenever the appointment of any  
48 Presidential Elector has not been proclaimed under G.S. 163-216.3 before 12:00 noon on the  
49 date for settling controversies specified by 3 U.S.C. § 5, and upon the call of an extra session  
50 pursuant to the North Carolina Constitution for the purposes of this section, the General



1 Assembly may fill the position of any Presidential Electors whose election is not yet  
2 proclaimed.

3 (b) Appointment by Governor if No Appointment by the Day Before Electors' Meeting  
4 Day. – If the appointment of any Presidential Elector has not been proclaimed under  
5 G.S. 163-216.3 before 12:00 noon on the date for settling controversies specified by 3 U.S.C. §  
6 5, nor appointed by the General Assembly by 12:00 noon on the day before the day set for the  
7 meeting of Presidential Electors by 3 U.S.C. § 7, then the Governor shall appoint that Elector.

8 (c) Standard for Decision by General Assembly and Governor. – In exercising their  
9 authority under subsections (a) and (b) of this section, the General Assembly and the Governor  
10 shall designate Electors in accord with their best judgment of the will of the electorate. The  
11 decisions of the General Assembly or Governor under subsections (a) and (b) of this section are  
12 not subject to judicial review, except to ensure that applicable statutory and constitutional  
13 procedures were followed. The judgment itself of what was the will of the electorate is not  
14 subject to judicial review.

15 (d) Proclamation Before Electors' Meeting Day Controls. – If the proclamation of any  
16 Presidential Elector under G.S. 163-216.3 is made any time before 12:00 noon on the day set  
17 for the meeting of Presidential Electors by 3 U.S.C. § 7, then that proclamation shall control  
18 over an appointment made by the General Assembly or the Governor. This section does not  
19 preclude litigation otherwise provided by law to challenge the validity of the proclamation or  
20 the procedures that resulted in that proclamation."

22 "(c) On Tuesday next after the first Monday in November in the year 1968, and every

39 **"§ 163-227.2. Alternate procedures for requesting application for absentee ballot;**

41 (a) Any voter eligible to vote by absentee ballot under G.S. 163-226 may request an  
42 application for absentee ballots, complete the application, and vote under the provisions of this  
43 ~~section and of G.S. 163-82.6A, as applicable section.~~

45 (b) Not earlier than the ~~third~~second Thursday before an election, in which absentee  
46 ballots are authorized, in which a voter seeks to vote and not later than 1:00 P.M. on the last  
47 Saturday before that election, the voter shall appear in person only at the office of the county  
48 board of elections, except as provided in subsection (g) of this section. A county board of  
49 elections shall conduct one-stop voting on the last Saturday before the election until 1:00 P.M.  
50 and may conduct it until 5:00 P.M. on that Saturday. That voter shall enter the voting enclosure  
51 at the board office through the appropriate entrance and shall at once state his or her name and

1 place of residence to an authorized member or employee of the board. In a primary election, the  
2 voter shall also state the political party with which the voter affiliates and in whose primary the  
3 voter desires to vote, or if the voter is an unaffiliated voter permitted to vote in the primary of a  
4 particular party under G.S. 163-119, the voter shall state the name of the authorizing political  
5 party in whose primary he wishes to vote. The board member or employee to whom the voter  
6 gives this information shall announce the name and residence of the voter in a distinct tone of  
7 voice. After examining the registration records, an employee of the board shall state whether  
8 the person seeking to vote is duly registered. If the voter is found to be registered that voter  
9 may request that the authorized member or employee of the board furnish the voter with an  
10 application form as specified in G.S. 163-227. The voter shall complete the application in the  
11 presence of the authorized member or employee of the board, and shall deliver the application  
12 to that person.

13 (c) If the application is properly filled out, the authorized member or employee shall  
14 enter the voter's name in the register of absentee requests, applications, and ballots issued and  
15 shall furnish the voter with the ballots to which the application for absentee ballots applies. The

17 All actions required by this subsection shall be performed in the office of the board of

21 board who shall sign the application and certificate as the witness and indicate the official title  
22 held by him or her. Notwithstanding G.S. 163-231(a), in the case of this subsection, only one  
23 witness shall be required on the certificate.

24 (d) Only the chairman, member, employee, or director of elections of the board shall  
25 keep the voter's application for absentee ballots in a safe place, separate and apart from other  
26 applications and container-return envelopes. If the voter's application for absentee ballots is  
27 disapproved by the board, the board shall so notify the voter stating the reason for disapproval  
28 by first-class mail addressed to the voter at that voter's residence address and at the address  
29 shown in the application for absentee ballots; and the board shall enter a challenge under  
30 G.S. 163-89.

31 (e) The voter shall vote that voter's absentee ballot in a voting booth in the office of the  
32 county board of elections, and the county board of elections shall provide a voting booth for  
33 that purpose, provided however, that the county board of elections may in the alternative  
34 provide a private room for the voter adjacent to the office of the board, in which case the voter  
35 shall vote that voter's absentee ballot in that room. A voter at a one-stop site shall be entitled to  
36 the same assistance as a voter at a voting place on election day under G.S. 163-166.8. The State  
37 Board of Elections shall, where appropriate, adapt the rules it adopts under G.S. 163-166.8 to  
38 one-stop voting.

39 (e1) If a county uses a voting system with retrievable ballots, that county's board of  
40 elections may by resolution elect to conduct one-stop absentee voting according to the  
41 provisions of this subsection. In a county in which the board has opted to do so, a one-stop  
42 voter shall cast the ballot and then shall deposit the ballot in the ballot box or voting system in  
43 the same manner as if such box or system was in use in a precinct on election day. At the end of  
44 each business day, or at any time when there will be no employee or officer of the board of  
45 elections on the premises, the ballot box or system shall be secured in accordance with a plan  
46 approved by the State Board of Elections, which shall include that no additional ballots have  
47 been placed in the box or system. Any county board desiring to conduct one-stop voting  
48 according to this subsection shall submit a plan for doing so to the State Board of Elections.  
49 The State Board shall adopt standards for conducting one-stop voting under this subsection and  
50 shall approve any county plan that adheres to its standards. The county board shall adhere to its  
51 State Board-approved plan. The plan shall provide that each one-stop ballot shall have a ballot

1 number on it in accordance with G.S. 163-230.1(a2), or shall have an equivalent identifier to  
2 allow for retrievability. The standards shall address retrievability in one-stop voting on direct  
3 record electronic equipment where no paper ballot is used.

4 (e2) A voter who has moved within the county more than 30 days before election day but  
5 has not reported the move to the board of elections shall not be required on that account to vote  
6 a provisional ballot at the one-stop site, as long as the one-stop site has available all the  
7 information necessary to determine whether a voter is registered to vote in the county and  
8 which ballot the voter is eligible to vote based on the voter's proper residence address. The  
9 voter with that kind of unreported move shall be allowed to vote the same kind of absentee  
10 ballot as other one-stop voters.

11 (f) Notwithstanding the exception specified in G.S. 163-36, counties which operate a  
12 modified full-time office shall remain open five days each week during regular business hours  
13 consistent with daily hours presently observed by the county board of elections, commencing  
14 with the date prescribed in G.S. 163-227.2(b) and continuing until 5:00 P.M. on the Friday  
15 prior to that election and shall also be open on the last Saturday before the election. A county  
16 board may conduct one-stop absentee voting during evenings or on weekends, as long as the  
17 hours are part of a plan submitted and approved according to subsection (g) of this section. The  
18 boards of county commissioners shall provide necessary funds for the additional operation of  
19 the office during that time.

20 (g) Notwithstanding any other provision of this section, a county board of elections by  
21 unanimous vote of all its members may provide for one or more sites in that county for  
22 absentee ballots to be applied for and cast under this section. Every individual staffing any of  
23 those sites shall be a member or full-time employee of the county board of elections or an  
24 employee of the county board of elections whom the board has given training equivalent to that  
25 given a full-time employee. Those sites must be approved by the State Board of Elections as  
26 part of a Plan for Implementation approved by both the county board of elections and by the  
27 State Board of Elections which shall also provide adequate security of the ballots and  
28 provisions to avoid allowing persons to vote who have already voted. The Plan for  
29 Implementation shall include a provision for the presence of political party observers at each  
30 one-stop site equivalent to the provisions in G.S. 163-45 for party observers at voting places on  
31 election day. A county board of elections may propose in its Plan not to offer one-stop voting at  
32 the county board of elections office; the State Board may approve that proposal in a Plan only  
33 if the Plan includes at least one site reasonably proximate to the county board of elections  
34 office and the State Board finds that the sites in the Plan as a whole provide adequate coverage  
35 of the county's electorate. If a county board of elections has considered a proposed Plan or  
36 Plans for Implementation and has been unable to reach unanimity in favor of a Plan, a member  
37 or members of that county board of elections may petition the State Board of Elections to adopt  
38 a plan for it. If petitioned, the State Board may also receive and consider alternative petitions  
39 from another member or members of that county board. The State Board of Elections may  
40 adopt a Plan for that county. The State Board, in that plan, shall take into consideration factors  
41 including geographic, demographic, and partisan interests of that county.

42 (g1) The State Board of Elections shall not approve, either in a Plan approved  
43 unanimously by a county board of elections or in an alternative Plan proposed by a member or  
44 members of that board, a one-stop site in a building that the county board of elections is not  
45 entitled under G.S. 163-129 to demand and use as an election-day voting place, unless the State  
46 Board of Elections finds that other equally suitable sites were not available and that the use of  
47 the sites chosen will not unfairly advantage or disadvantage geographic, demographic, or  
48 partisan interests of that county. In providing the site or sites for one-stop absentee voting under  
49 this section, the county board of elections shall make a request to the State, county, city, local  
50 school board, or other entity in control of the building that is supported or maintained, in whole  
51 or in part, by or through tax revenues at least 90 days prior to the start of one-stop absentee

1 voting under this section. The request shall clearly identify the building, or any specific portion  
2 thereof, requested the dates and times for which that building or specific portion thereof is  
3 requested and the requirement of an area for election related activity. If the State, local  
4 governing board, or other entity in control of the building does not respond to the request  
5 within 20 days, the building or specific portion thereof may be used for one-stop absentee  
6 voting as stated in the request. If the State, local governing board, or other entity in control of  
7 the building or specific portion thereof responds negatively to the request within 20 days, that  
8 entity and the county board of elections shall, in good faith, work to identify a building or  
9 specific portion thereof in which to conduct one-stop absentee voting under this section. If no  
10 building or specific portion thereof has been agreed upon within 45 days from the date the  
11 county board of elections received a response to the request, the matter shall be resolved by the  
12 State Board of Elections.

13 (h) Notwithstanding the provisions of G.S. 163-89(a) and (b), a challenge may be  
14 entered against a voter at a one-stop site under subsection (g) of this section or during one-stop  
15 voting at the county board office. The challenge may be entered by a person conducting  
16 one-stop voting under this section or by another registered voter who resides in the same  
17 precinct as the voter being challenged. If challenged at the place where one-stop voting occurs,  
18 the voter shall be allowed to cast a ballot in the same way as other voters. The challenge shall  
19 be made on forms prescribed by the State Board of Elections. The challenge shall be heard by  
20 the county board of elections in accordance with the procedures set forth in G.S. 163-89(e).

21 (i) At any site where one-stop absentee voting is conducted, there shall be a curtained  
22 or otherwise private area where the voter may mark the ballot unobserved."

42 **SECTION 29.** G.S. 163-278.5 reads as rewritten:

43 "**§ 163-278.5. Scope of Article; severability.**

44 The provisions of this Article apply to primaries and elections for North Carolina offices  
45 and to North Carolina referenda and do not apply to primaries and elections for federal offices  
46 or offices in other States or to non-North Carolina referenda. Any provision in this Article that  
47 regulates a non-North Carolina entity does so only to the extent that the entity's actions affect  
48 elections for North Carolina offices or North Carolina referenda.

1 The provisions of this Article are severable. If any provision is held invalid by a court of  
2 competent jurisdiction, the invalidity does not affect other provisions of the Article that can be  
3 given effect without the invalid provision.

4 This section applies to Articles 22B, 22D, ~~22E, 22F,~~ 22G, 22H, ~~22J,~~ and 22M of the  
5 General Statutes to the same extent that it applies to this Article."

6 **SECTION 30.** G.S. 163-278.13 reads as rewritten:

7 **"§ 163-278.13. Limitation on contributions.**

8 (a) No individual, political committee, or other entity shall contribute to any candidate  
9 or other political committee any money or make any other contribution in any election in  
10 excess of four thousand dollars (\$4,000) for that election.

11 (b) No candidate or political committee shall accept or solicit any contribution from any  
12 individual, other political committee, or other entity of any money or any other contribution in  
13 any election in excess of four thousand dollars (\$4,000) for that election.

14 (c) Notwithstanding the provisions of subsections (a) and (b) of this section, it shall be  
15 lawful for a candidate or a candidate's spouse, parents, brothers and sisters to make a  
16 contribution to the candidate or to the candidate's treasurer of any amount of money or to make

23 election" with respect to that candidate.

24 (d1) Notwithstanding subsections (a) and (b) of this section, a candidate or political  
25 committee may accept a contribution knowing that the contribution is to be reimbursed to the  
26 entity making the contribution and knowing the candidate or political committee has funds  
27 sufficient to reimburse the entity making the contribution if all of the following conditions are  
28 met:

- 29 (1) The entity submits sufficient information of the contribution to the candidate  
30 or political committee for reimbursement within 45 days of the contribution.
- 31 (2) The candidate or political committee makes a reimbursement to the entity  
32 making the contribution within seven days of submission of sufficient  
33 information.
- 34 (3) The candidate or political committee indicates on its report under  
35 G.S. 163-278.11 that the good, service, or other item resulting in the  
36 reimbursement is an expenditure of the candidate or political committee, and  
37 notes if the contribution was by credit card.
- 38 (4) The contribution does not exceed one thousand dollars (\$1,000.00).

39 (d2) Any contribution, or portion thereof, made under subsection (d1) of this section that  
40 is not submitted for reimbursement in accordance with subsection (d1) of this section shall be  
41 treated as a contribution for purposes of this section. Any contribution, or portion thereof, made  
42 under subsection (d1) of this section that is not reimbursed in accordance with subsection (d1)  
43 of this section shall be treated as a contribution for purposes of this section.

44 (e) Except as provided in this subsection and subsections (e2), (e3), and (e4)  
45 subsections (e2) and (e3) of this section, this section shall not apply to any national, State,  
46 district or county executive committee of any political party. For the purposes of this section  
47 only, the term "political party" means only those political parties officially recognized under  
48 G.S. 163-96.

49 (e1) No referendum committee which received any contribution from a corporation,  
50 labor union, insurance company, business entity, or professional association may make any  
51 contribution to another referendum committee, to a candidate or to a political committee.



1 (e2) In order to make meaningful the provisions of Article 22D of this Chapter, the  
2 following provisions shall apply with respect to candidates for justice of the Supreme Court and  
3 judge of the Court of Appeals:

4 (1) No candidate shall accept, and no contributor shall make to that candidate, a  
5 contribution in any election exceeding one thousand dollars (\$1,000) except  
6 as provided for elsewhere in this subsection.

7 (2) A candidate may accept, and a family contributor may make to that  
8 candidate, a contribution not exceeding two thousand dollars (\$2,000) in an  
9 election if the contributor is that candidate's parent, child, brother, or sister.

10 (3) Repealed by Session Laws 2008-150, s. 7(a), effective August 2, 2008.

11 As used in this subsection, "candidate" is also a political committee authorized by the

15 (e3) Notwithstanding the provisions of subsections (a) and (b) of this section, no  
16 candidate for superior court judge or district court judge shall accept, and no contributor shall  
17 make to that candidate, a contribution in any election exceeding one thousand dollars (\$1,000),  
18 except as provided in subsection (c) of this section. As used in this subsection, "candidate" is  
19 also a political committee authorized by the candidate for that candidate's election. Nothing in  
20 this subsection shall prohibit a candidate or the spouse of that candidate from making a  
21 contribution or loan secured entirely by that individual's assets to that candidate's own  
22 campaign.

23 ~~(e4) In order to make meaningful the provisions of the North Carolina Voter Owned~~  
24 ~~Elections Act, as set forth in Article 22J of this Chapter, no candidate for an office subject to~~  
25 ~~that Article shall accept, and no contributor shall make to that candidate, a contribution during~~  
26 ~~the period beginning 21 days before the day of the general election and ending the day after the~~  
27 ~~general election if that contribution causes the candidate to exceed the "trigger for matching~~  
28 ~~funds" defined in G.S. 163-278.96(17). As used in this subsection, the term "candidate" also~~  
29 ~~includes "candidate campaign committee" as defined in G.S. 163-278.38Z(3). Nothing in this~~

31 "(d) If, at or prior to such public hearing, there shall be filed with the district board a  
32 petition, signed by not less than ten per centum (10%) of the qualified voters residing in the  
33 district, requesting an election to be held therein on the question of including the political  
34 subdivision or unincorporated area, the district board shall certify a copy of such petition to the  
35 board or boards of commissioners, and the board or boards of commissioners shall request the

49 Any district lying entirely within the corporate limits of a city or town may be merged into  
50 such city or town in accordance with the provisions of this section.

1 The governing body of a city or town, with the approval of the district board, shall call and  
2 conduct a special election within such city or town on the question of the merger of the district

19 city or town.
- 20 (3) All taxes, assessments, sewer charges, and any other debts, charges or fees,

23 by, such district shall not be abated by this section or by the merger herein

27 place and stead of the district and shall pay or cause to be paid any

36 general obligation bonds or bond anticipation notes of such district, and all  
37 the taxable property within such city or town, as well as that formerly  
38 located within the district, shall be and remain subject to taxation for such

- 40 (6) All ordinances, rules, regulations, and policies of such district shall continue  
41 in full force and effect until repealed or amended by the governing body of  
42 such city or town.
- 43 (7) Such district shall be abolished, and shall no longer be constituted a public  
44 body or a body politic and corporate, except for the purposes of carrying into  
45 effect the provisions and the intent of this section.

46 If a majority of the votes are against the merger, then such merger shall not be effective  
47 unless approved by a majority of the qualified voters who vote thereon in a subsequent special  
48 election conducted under authority of this section.

49 Any action or proceeding in any court to set aside a special election held under authority of  
50 this section or the result thereof, or to obtain any other relief upon the ground that such election  
51 or any proceeding or action taken with respect to the holding of such election is invalid, must

2 such period of limitation, no right of action or defense founded upon the invalidity of the

37 Miss, or Ms. Nicknames shall be permitted on an official ballot if used in the  
38 notice of candidacy or qualifying petition, but the nickname shall appear

41 do not mislead the voter or unduly advertise the candidacy. In the case of

15 **SECTION 86.** Except as otherwise provided herein, this act becomes effective  
16 January 1, 2012, and applies to elections held on or after that date.
