1 A BILL TO BE ENTITLED
2 AN ACT TO PROVIDE THAT REGULAR MUNICIPAL ELECTIONS IN THE TOWN OF
3 PILOT MOUNTAIN AND THE TOWN OF DOBSON ARE HELD IN
4 EVEN-NUMBERED YEARS.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** Section 3.3 of the Charter of the Town of Pilot Mountain, being
7 Chapter 28 of the Session Laws of 1971, as amended by Town Ordinance 217, adopted April
8 22, 2002, reads as rewritten:

9 "Sec. 3.3. Terms; Qualifications; Vacancies.

10 (a) The Mayor shall and members of the Board of Commissioners shall serve for terms
11 of four (4) years, beginning the day and hour of the organizational meeting following their
12 election, as established by ordinance in accordance with this Charter; provided, they shall serve
13 until their successors are elected and ~~qualify-qualify, provided further that (i) the Mayor elected~~
14 in 2011 shall serve a term of three years, but the Mayor's successors shall serve terms of four
15 years; and (ii) the members of the board of commissioners elected in 2009 and 2011 shall serve
16 terms of three years, but the members' successors shall serve terms of four years.

18 **SECTION 2.** Section 4.1 of the Charter of the Town of Pilot Mountain, being
19 Chapter 28 of the Session Laws of 1971, is rewritten to read:

20 "Sec. 4.1. Regular Elections. Elections shall be held biennially on the Tuesday after the first
21 Monday in November, beginning in 2012. In the 2014 election and quadrennially thereafter, the
22 candidate for Mayor who receives the largest number of votes cast for Mayor shall be declared
23 elected for a term of four years. In the 2012 election and quadrennially thereafter, the two
24 candidates for Commissioner who receive the largest numbers of votes cast for Commissioner
25 shall be declared elected for terms of four years. In the 2014 election and quadrennially
26 thereafter, the two candidates for Commissioner who receive the largest numbers of votes cast
27 for Commissioner shall be declared elected for terms of four years. Regular municipal elections
28 shall be held biennially in even-numbered years, but shall otherwise be conducted in
29 accordance with the general law governing municipal elections, except that absentee ballots
30 shall be available on the same schedule as for county and State officers at that election."

31 **SECTION 3.** Section 3.3 of the Charter of the Town of Dobson, being Chapter 232
32 of the Session Laws of 1975, as amended by Town Ordinance dated February 18, 2010, reads
33 as rewritten:

34 "Sec. 3.3. Terms; qualifications; vacancies.



1 (a) The members of the Board of Commissioners shall serve for terms of four years,
2 and the Mayor shall serve for a term of four years, beginning the day and hour of the
3 organizational meeting following their election, as established by ordinance in accordance with
4 this Charter; provided, they shall serve until their successors are elected and ~~qualify-qualify,~~
5 provided further that (i) the Mayor elected in 2009 shall serve a term of five years, but the
6 Mayor's successors shall serve terms of four years; and (ii) the members of the board of
7 commissioners elected in 2009 and 2011 shall serve terms of five years, but the members'
8 successors shall serve terms of four years.

9 (b) No person shall be eligible to be a candidate or to be elected as Mayor or as a
10 member of the Board of Commissioners or to serve in such capacity, unless he is a resident and
11 a qualified voter of the Town.

12 (c) In the event a vacancy occurs in the office of Mayor or Commissioner, the Board
13 shall by majority vote appoint some qualified person to fill the same for the remainder of the
14 unexpired term."

15 **SECTION 4.** Section 4.1 of the Charter of the Town of Dobson, being Chapter
16 232 of the Session Laws of 1975, reads as rewritten:

17 "Sec. 4.1. Regular municipal elections. Regular municipal elections shall be held biennially
18 in ~~odd-numbered~~even-numbered years on ~~the day set by general law for municipal elections~~the
19 Tuesday after the first Monday in November, beginning in 2014. In the ~~1975-2014~~ regular
20 municipal election and ~~biennially~~quadrennially thereafter there shall be elected a Mayor for a
21 term of ~~two~~four years. In the ~~1975-2016~~ regular municipal election and quadrennially
22 thereafter, three Commissioners shall be elected to serve terms of four years each. In the ~~1977~~
23 2014 regular municipal election and quadrennially thereafter, two Commissioners shall be
24 elected to serve terms of four years each."

25 **SECTION 5.** This act is effective when it becomes law.
