A BILL TO BE ENTITLED

AN ACT TO MAKE BASE BUDGET APPROPRIATIONS FOR CURRENT OPERATIONS OF
STATE DEPARTMENTS, INSTITUTIONS, AND AGENCIES, AND FOR OTHER
PURPOSES.

The General Assembly of North Carolina enacts:

PART I. INTRODUCTION AND TITLE OF ACT

TITLE OF ACT

SECTION 1.1. This act shall be known as the "Current Operations and Capital
Improvements Appropriations Act of 2016."

INTRODUCTION

SECTION 1.2. The appropriations made in this act are for maximum amounts
necessary to provide the services and accomplish the purposes described in the budget. Savings
shall be effected where the total amounts appropriated are not required to perform these services
and accomplish these purposes and, except as allowed by the State Budget Act or this act, the
savings shall revert to the appropriate fund at the end of each fiscal year.

SECTION 2.1. Appropriations from the General Fund of the State for the

PART VI. GENERAL PROVISIONS

RECURRING TRANSFER TO HIGHWAY TRUST FUND FOR DEBT SERVICE ON FUTURE TRANSPORTATION BONDS

SECTION 6.1A. There is established in the Highway Trust Fund, the Future Transportation Bond Reserve. The Office of the State Controller shall annually transfer from funds available in the General Fund the sum of fifty-two million five hundred thousand dollars (\$52,500,000) in recurring funds to the Future Transportation Bond Reserve established by this section in the Highway Trust Fund. Funds in the Future Transportation Bond Reserve shall be used only for debt service payments on future issuance of General Obligation bonds for critical transportation infrastructure. Unexpended funds shall not revert.

ONE-TIME TRANSFER TO HIGHWAY FUND FOR CRITICAL INFRASTRUCTURE FOR ECONOMIC DEVELOPMENT

SECTION 6.1B.(a) The State Controller shall transfer sixty-eight million dollars (\$68,000,000) from the unreserved fund balance to the Highway Fund on June 30, 2016. This section becomes effective June 30, 2016.

SECTION 6.1B.(b) Of the sixty-eight million dollars (\$68,000,000) transferred in subsection (a) of this section, thirty-five million dollars (\$35,000,000) is appropriated from the Highway Fund to a reserve fund for use by the North Carolina State Ports Authority for prioritized capital improvements to State Port infrastructure and facilities. Thirty-three million dollars (\$33,000,000) is appropriated from the Highway Fund to the Division of Aviation of the Department of Transportation for prioritized capital improvements to public airports and time-sensitive aviation capital improvement projects for economic development purposes.

UNIVERSITY INNOVATION COMMERCIALIZATION GRANT PROGRAM

SECTION 6.1.(a) Purpose. – In order to increase the number of high-tech, start-up companies and enhance job creation resulting from research conducted by North Carolina's universities, the University Innovation Commercialization Grant Program is established.

1 **SECTION 6.1.(b)** Funding. – The sum of two million five hundred thousand dollars
2 (\$2,500,000) for fiscal year 2016-2017 is appropriated to a reserve in the Office of State Budget
3 and Management for the University Innovation Commercialization Grant Program.

4 **SECTION 6.1.(c)** Grants. – The Office of Science, Technology, and Innovation in the
5 Department of Commerce shall establish a competitive award process to provide funding to
6 develop and implement processes for technology proof of concept, validation, IP protection and
7 early/mid-stage product development/production, commercialization, and translation for
8 technologies developed by North Carolina Universities.

9 **SECTION 6.1.(d)** Eligibility. – Upon recommendation and guidance from a nonprofit
10 corporation contracted pursuant to this section, the Department of Commerce may make grant
11 awards from the funds provided in subsection (b) of this section only to a:

12 (1) Constituent institution of The University of North Carolina.

13 (2) Private college or university located in North Carolina.

14 **SECTION 6.1.(e)** Administration. – The Department of Commerce may use up to ten
15 percent (10%) of funds provided in this section to contract with one or more nonprofit
16 corporations to assist with the following:

17 (1) Select university technologies for development based on commercial potential.

18 (2) Create a development plan of key activities to make the technologies more
19 attractive to investors.

20 (3) Guide implementation of these activities to assure efficient deployment of
21 funds and commercial-quality results.

22 Each nonprofit organization must demonstrate expertise in either life science
23 technologies including medical, biological, agricultural or nonlife sciences technologies, including
24 information technology, materials, and cyber security.

25 **SECTION 6.1.(f)** Reports. – The Office of Science, Technology, and Innovation in
26 the Department of Commerce and nonprofit corporation selected in subsection (c) of this section
27 shall provide an annual report to the Office of State Budget and Management and Fiscal Research
28 Division of the General Assembly no later than January 1 of each fiscal year. The report shall
29 detail expenditures and grants made from these funds and provide evidence of return on
30 investment, including, but not limited to, (i) the number of technologies brought to market; (ii) the
31 number of new companies founded; and (iii) data on jobs created, including occupational
32 classifications and salary ranges.

33 **SECTION 6.1.(g)** Oversight. – The Department of Commerce, in consultation with
34 the Office of State Budget and Management, shall provide monitoring and oversight of the
35 performance of a contract entered into pursuant to this section with a North Carolina nonprofit
36 corporation and of the funds granted to institutes of higher education.

37 **SECTION 6.1.(h)** Public Funds. – A North Carolina nonprofit corporation or institute
38 of higher education with which the Department contracts or grants funds pursuant to this section
39 shall use interest earned on State funds after receipt of the funds by the nonprofit corporation only
40 for the same purposes identified in subsection (c) of this section.

41 **RALLYING INVESTORS AND SKILLED ENTREPRENEURS OF NC (RISE NC)**

42 **SECTION 6.2.(a)** Purpose. – In order to increase the number of high-tech, start-up
43 companies and enhance job creation, RISE NC creates a statewide network that develops and
44 leverages existing North Carolina entrepreneurial management talent and recruits world-class
45 investors, skilled entrepreneurs, and managers to North Carolina.

46 **SECTION 6.2.(b)** Funding. – The sum of two million five hundred thousand dollars
47 (\$2,500,000) of nonrecurring funds for fiscal year 2016-2017 is appropriated to a reserve in the
48 Office of State Budget and Management for the Rallying Investors and Skilled Entrepreneurs of
49 NC (RISE NC) program.
50

1 **SECTION 6.2.(c)** Grant. – The Office of Science, Technology, and Innovation in the
2 Department of Commerce shall establish a competitive award process to provide funding to one or
3 more North Carolina nonprofit corporations to perform the following:

4 (1) The development of a statewide entrepreneurial network to connect serial
5 entrepreneurs to university start-ups.

6 (2) The development of an entrepreneurship fellowship program; Grant funds shall
7 be matched on the basis of one dollar (\$1.00) in grant funds for every two
8 dollars (\$2.00) nongrant funds. Matching funds shall not include other State
9 funds.

10 **SECTION 6.2.(d)** Administration. – The Department of Commerce may use up to
11 five percent (5%) of funds provided in this section to administer this program.

12 **SECTION 6.2.(e)** Reports. – The Office of Science, Technology, and Innovation in
13 the Department of Commerce and nonprofit corporation selected in subsection (c) of this section
14 shall provide an annual report to the Office of State Budget and Management and Fiscal Research
15 Division of the General Assembly no later than January 1 of each fiscal year. The report shall
16 detail expenditures and grants made from these funds and provide evidence of return on
17 investment, including, but not limited to, (i) the number of new companies founded and (ii) data
18 on jobs created, including occupational classifications and salary ranges.

19 **SECTION 6.2.(f)** Oversight. – The Department of Commerce, in consultation with
20 the Office of State Budget and Management, shall provide monitoring and oversight of the
21 performance of a contract entered into pursuant to this section with a North Carolina nonprofit
22 corporation.

23 **SECTION 6.2.(g)** Public Funds. – A North Carolina nonprofit corporation with which
24 the Department contracts pursuant to this section shall use interest earned on State funds after
25 receipt of the funds by the nonprofit corporation only for the same purposes identified in
26 subsection (c) of this section.

27 **SECTION 6.2.(h)** Funds appropriated for the 2016-2017 fiscal year shall not revert at
28 the end of the fiscal year but shall remain available until expended.

30 CONTINUING BUDGET AUTHORITY

31 **SECTION 6.3.** G.S. 143C-5-4 reads as rewritten:

32 "**§ 143C-5-4. Enactment ~~deadline~~deadline; procedures to be followed when the Current
33 Operations Appropriations Act does not become law prior to the end of certain
34 fiscal years.**

35 (a) Enactment Deadline. – The General Assembly shall enact the Current Operations
36 Appropriations Act by June 15 of odd-numbered years and by June 30 of even-numbered years in
37 which a Current Operations Appropriations Act is enacted.

38 (b) If Appropriations Act Does Not Become Law Prior to End of Certain Fiscal Years. – If
39 a fiscal year begins for which no current operations appropriations act has become law, then the
40 following procedures shall be followed and the following limitations shall apply:

41 (1) Authority. – Unless otherwise provided by law, the Director of the Budget may
42 continue to allocate funds from all funds for expenditure by State departments,
43 institutions, and agencies at a level not to exceed the level of recurring
44 expenditures from those funds for the prior fiscal year. If the Director of the
45 Budget finds that projected revenues for the fiscal year will not support
46 expenditures at the level of recurring expenditures for the prior fiscal year, the
47 Director of the Budget shall allot funds at a lower level. In making these
48 allocations, the Director of the Budget shall ensure the prompt payment of the
49 principal and interest on bonds and notes of the State according to their terms.
50 Except as otherwise provided by this section, the limitations and directions on
51 the expenditure of funds for the prior fiscal biennium shall remain in effect.

- 1 (2) Appropriation of Funds Necessary to Implement. – There is appropriated from
2 the appropriate State funds, cash balances, federal receipts, and departmental
3 receipts sums sufficient to implement the authority described in this subsection
4 for the applicable fiscal year.
- 5 (3) Relation to Current Operations Appropriations Act. – The appropriations and
6 the authorizations to allocate and spend funds which are set out in this
7 subsection shall remain in effect until the Current Operations Appropriations
8 Act for the applicable biennium becomes law, at which time that act shall
9 become effective and shall govern appropriations and expenditures. When the
10 Current Operations Appropriations Act for that biennium becomes law, the
11 Director of the Budget shall adjust allotments to give effect to that act from July
12 1 of the fiscal year.
- 13 (4) State Employee Salaries. – The salary schedules and specific salaries
14 established for the prior fiscal year and in effect on June 30 of the prior fiscal
15 year for offices and positions shall remain in effect until the Current Operations
16 and Capital Improvements Appropriations Act for the current fiscal year
17 becomes law. State employees subject to G.S. 7A-102(c), 7A-171.1, or
18 20-187.3 shall not move up on salary schedules or receive automatic increases,
19 including automatic step increases, until authorized by the General Assembly.
- 20 (5) School Employee Salaries. – Public school employees paid on the teacher
21 salary schedule or the school-based administrator salary schedule shall not
22 move up on salary schedules or receive automatic step increases until
23 authorized by the General Assembly.
- 24 (6) State's Employer Contribution Rate. – The State's employer contribution rates
25 budgeted for retirement and related benefits for the current fiscal year shall
26 remain the same as they are on June 30 of the prior fiscal year. These rates are
27 effective until the Current Operations Appropriations Act for the current fiscal
28 year becomes law and are subject to revision in that act. If that act modifies
29 those rates, the Director of the Budget shall further modify the rates set in that
30 act for the remainder of the fiscal year so as to compensate for the different

37 **USE OF PROCEEDS FROM SALE OR LEASE OF STATE-OWNED PROPERTY IN**
38 **WAKE COUNTY**

39 **SECTION 6.12.(a)** G.S. 146-30 is amended by adding a new subsection to read:

40 "(d) Notwithstanding subsection (a) of this section, the net proceeds of any disposition by
41 sale or lease of State-owned real property located in Wake County made in accordance with this
42 Subchapter shall be handled in accordance with the following priority: First, in accordance with
43 the provisions of any trust or other instrument of title whereby title to such real property was
44 heretofore acquired or is hereafter acquired; and second, any remaining net proceeds shall be
45 transferred to the State Government Facility Modernization Fund established by G.S. 146-26.2."

46 **SECTION 6.12.(b)** Article 6 of Chapter 146 of the General Statutes is amended by
47 adding a new section to read:

48 "**§ 146-26.2. State Government Facility Modernization Fund.**

49 The State Government Facility Modernization Fund is established as a special fund to be
50 administered by the Office of State Budget and Management. The Fund consists of the net

7 **SECTION 6.12.(c)** G.S. 146-30(d) and G.S. 146-26.2, as enacted by this section, shall
8 not apply to the disposition of proceeds of any portion of the Dorothea Dix property.

10 **HEALTH CONTINGENCY RESERVE**

11 **SECTION 6.13.(a)** Section 12H.38(a) of S.L. 2014-100 reads as rewritten:

12 **"SECTION 12H.38.(a)** There is established in the General Fund the Medicaid Contingency
13 Reserve. The Office of the State Controller shall reserve from funds available in the General Fund
14 the sum of one hundred eighty-six million three hundred seventy-two thousand six hundred
15 seventy-three dollars (\$186,372,673) in recurring funds to the Medicaid Contingency Reserve.
16 Funds in the Medicaid Contingency Reserve shall be ~~used only for budget shortfalls in the~~
17 ~~Medicaid Program that occur during the 2014-2015 fiscal year. These funds shall be available for~~
18 ~~expenditure only upon an appropriation by act of the General Assembly.~~appropriated to a
19 statewide reserve for the following purposes:

20 (1) Seventy-one million dollars (\$71,000,000) for the State Health Plan for
21 Teachers and State Employees if the General Assembly deems that the State
22 Health Plan has met the requirements of Section 30.26 of S.L. 2015-241.

23 (2) Fifty million dollars (\$50,000,000) for the Division of Medical Assistance to
24 cover budget shortfalls in the Medicaid or Health Choice Programs that occur
25 during the 2015-2016 and 2016-2017 fiscal year. These funds shall be available
26 for expenditure only upon an appropriation by act of the General Assembly or
27 approval by the Director of the Budget.

28 a. It is the intent of the Director of the Budget to transfer cash out of
29 reserve, not to exceed fifty million dollars (\$50,000,000) during the
30 2016-2017 fiscal year only if:

31 1. The Director of the Budget, after the State Controller has
32 verified that receipts are being used appropriately, has found that
33 additional funds are needed to cover a shortfall in the Medicaid
34 budget for the State fiscal year.

35 2. The Director of the Budget has reported immediately to the
36 Fiscal Research Division on the amount of the shortfall found in

"SECTION 12H.38.(b) It is the intent of the General Assembly to appropriate funds from the Medicaid Contingency Reserve only if: The sixty-five million three hundred seventy-two thousand six hundred seventy-three dollars (\$65,372,673) remaining in the reserve may only be used for budget shortfalls in the Medicaid Program that occur during the 2016-2017 fiscal year. These funds shall be available for expenditure only upon an appropriation by act of the General Assembly.

- (1) ~~The Director of the Budget, after the State Controller has verified that receipts are being used appropriately, has found that additional funds are needed to cover a shortfall in the Medicaid budget for the State fiscal year.~~
- (2) ~~The Department of Health and Human Services has submitted a State plan amendment to the Centers for Medicare and Medicaid Services to delink eligibility for Medicaid from eligibility for State County Special Assistance, to be effective 90 days after the date of submission of the State plan amendment. At least 45 days prior to submitting that State plan amendment, the Department of Health and Human Services must have submitted a draft of that plan to the Joint Legislative Oversight Committee on Health and Human Services and, if the General Assembly was not in session, must have consulted with the Committee on that draft.~~
- (3) ~~The Director of the Budget has reported immediately to the Fiscal Research Division on the amount of the shortfall found in accordance with subdivision (1) of this subsection. SECTION 6.13.(c) Nothing in this section shall be construed to limit the authority of the Governor to carry out his duties under the Constitution.

14 INFORMATION TECHNOLOGY INTERNAL SERVICE FUND

15 **SECTION 7.2.** Section 7.2 of S.L. 2015-241 reads as rewritten:

16 **"SECTION 7.2.(a)** IT Internal Service Fund. – For the 2015-2016 fiscal year, receipts for the
17 IT Internal Service Fund shall not exceed one hundred eighty-eight million dollars
18 (\$188,000,000). For fiscal year 2016-2017, receipts for the Internal Service Fund shall not exceed
19 ~~one hundred eighty-nine million dollars (\$189,000,000).~~ one hundred eighty million seven
20 hundred thousand dollars (\$180,700,000). For ~~each year of the 2015-2017 fiscal biennium, the~~
21 2015-2016 fiscal year, receipts may be increased for specific purposes to a maximum of one
22 hundred ninety-five million dollars (\$195,000,000). For the 2016-2017 fiscal year, receipts may be
23 increased to a maximum of one hundred eighty-six million seven hundred thousand dollars
24 (\$186,700,000) following consultation with the Joint Legislative Commission on Governmental
25 Operations each time a requirement for an increase is identified. Rates approved by the Office of
26 State Budget and Management (OSBM) to support the IT Internal Service Fund shall be based on
27 this fund limit.

28 **"SECTION 7.2.(b)** For the 2015-2016 fiscal year, receipts in excess of requirements,
29 including information technology equipment and fixtures, shall be maintained in a separate
30 account to be managed by the Office of State Budget and Management. The amounts received
31 shall be used for the following purposes:

- 32 (1) To offset agency budget shortfalls resulting from Department of Information
33 Technology rate increases.
- 34 (2) To offset Department of Information Technology Internal Service Fund budget
35 shortfalls, if approved by the Office of State Budget and Management. Any use
36 of excess receipts shall be reported to the Joint Legislative Oversight
37 Committee of Information Technology and the Fiscal Research Division.

38 **"SECTION 7.2.(c)** For the 2016-2017 fiscal year, budget requirements and associated rates
39 shall be developed based on actual service costs for fiscal year 2014-2015. These budget
40 requirements and associated rates shall be developed and reported to the Joint Legislative
41 Oversight Committee on Information Technology and the Fiscal Research Division by October 1,
42 2016.

43 **"SECTION 7.2.(d)** For the 2016-2017 fiscal year, receipts collected for IT Internal Service
44 Fund services shall only be used for the specific purposes for which they were collected and are
45 hereby appropriated for those purposes. Funds collected for information technology equipment
46 and fixtures shall be separately maintained and accounted for by the Department of Information
47 Technology, and such funds shall be used only for the replacement of the fixtures and equipment
48 for which the funds were collected. ~~By December 1, 2015,~~ December 1, 2016, the Department of
49 Information Technology shall report to the Joint Legislative Oversight Committee on Information
50 Technology and the Fiscal Research Division on the means and methods by which it is in
51 compliance with the requirements of this subsection.

"SECTION 7.2.(e) Agency Billing and Payments. – The State Chief Information Officer shall ensure that bills from the Department of Information Technology are easily understandable and fully transparent. If a State agency fails to pay its IT Internal Service Fund bill within 30 days of receipt, the Office of State Budget and Management may transfer funds from the agency to fully or partially cover the cost of the bill from that agency to the IT Internal Service Fund following notification of the affected agency."

SECTION 7.3. Section 7.3 of S.L. 2015-241, as amended by Section 2.1 of S.L. 2015-268, reads as rewritten:

"SECTION 7.3.(b) Of the funds appropriated for Information Technology Modernization, four hundred twenty-four thousand nine hundred seventy-four dollars (\$424,974) for fiscal year 2015-2016 and four hundred six thousand three hundred seventy-four dollars (\$406,374) for fiscal year 2016-2017 shall be transferred to the Department of Revenue to fund three security positions. The security positions shall include a Security Design Engineer, a Security Impact Analyst, and a Security Specialist.

"SECTION 7.3.(c) The funds appropriated for Maintenance Management System Replacement shall be transferred to the Department of Administration to support the acquisition of a cloud-based facilities management system. The system shall include core system functionality consisting of maintenance, inventory, and utility management systems. The system shall also include three additional modules for system failure alerts, automation of utility bills, and the extension of maintenance management to mobile devices.

"SECTION 7.3.(d) The funds appropriated for IT Restructuring shall be used solely for information technology restructuring planning and implementation.

"SECTION 7.3.(e) Funds appropriated to the Information Technology Reserve Fund shall be spent only as specified in this section unless a change is approved by the State Chief Information Officer after consultation with the Office of State Budget and Management. An authorized change may not result in any degradation to the information technology operations or projects listed in this section for which the funds were originally appropriated. Any changes to the specified uses for the funds shall be reported immediately, in writing, to the chairs of the Joint Legislative Oversight Committee on Information Technology, the chairs of the House Appropriations Committee on Information Technology, and the Fiscal Research Division.

"SECTION 7.3.(f) The Office of State Budget and Management shall establish a fund code for the Information Technology Reserve Fund and shall manage it separately from other funding for the Department of Information Technology and the State Chief Information Officer."

PERMIT REALLOCATION OF FUNDS APPROPRIATED FOR IT RATE INCREASES

SECTION 7.4. The Office of State Budget and Management may reallocate funds, appropriated in this act for the purpose of paying IT Internal Service Fund bills, as necessary

1 between agencies, to fund increases resulting from the new rate structure that was implemented by
2 the Department of Information Technology in the 2015-2016 fiscal year.

3 4 **ADJUST BUDGETS AS NECESSARY DUE TO TRANSFER OF FUNCTIONS**

5 **SECTION 7.4A.** The Office of State Budget and Management may, after coordination
6 with the Department of Information Technology, the Department of Environmental Quality, and
7 the Department of Natural and Cultural Resources, adjust IT budgets as appropriate to support the
8 programs, divisions, entities, commissions, boards, and councils transferred to the Department of
9 Natural and Cultural Resources under S.L. 2015-241.

10 11 **INFORMATION TECHNOLOGY SPENDING TRANSPARENCY**

12 **SECTION 7.5.(a)** In order to provide full transparency into IT spending, all State
13 Agencies identified as participating agencies in G.S. 143B-1305(c), together with all divisions,
14 boards, commissions, or other State entities for which the participating agencies have budgetary
15 authority, shall realign IT budgets and expenditures in a fund code (or codes) separate from the
16 remainder of the agency's budget. Changes shall be completed by September 30, 2016, and
17 effective July 1, 2016.

18 **SECTION 7.5.(b)** As outlined in G.S. 143B-1305(d), the Department of Public
19 Safety, the Community College System Office, and the State Board of Elections shall work with
20 the State CIO to plan their transition to the Department. In preparation for this transition, these
21 entities shall realign IT budgets and expenditures in a fund code (or codes) separate from the
22 remainder of the agency's budget by October 1, 2018.

23 **SECTION 7.5.(c)** It is the intent of this legislation that all remaining State agencies
24 together with all divisions, boards, commissions, or other State entities for which the agencies
25 have budgetary authority, shall realign IT budgets and expenditures in a fund code (or codes)
26 separate from the remainder of the agency's budget by the conclusion of the 2018-2019 fiscal year.
27 This section does not apply to the legislative or judicial branches of government or The University
28 of North Carolina and its constituent institutions, who are exempt under G.S. 143B-1300(b).

29 30 **APPRENTICESHIPS AND CAREER-BASED OPPORTUNITIES IN CYBERSECURITY** 31 **FOR DISABLED VETERANS**

32 **SECTION 7.6.(a)** The cybersecurity apprenticeship program created pursuant to this
33 act shall provide training, apprenticeships and career-based opportunities for disabled veterans
34 within the State of North Carolina. Opportunities may be offered to qualifying veterans with at
35 least a ten percent (10%) disability rating established by the Veterans Administration and at the
36 discretion of the State Chief Information Officer.

37 **SECTION 7.6.(b)** The State Chief Information Officer shall conduct a competitive
38 process to select disabled veterans to participate in the cybersecurity apprenticeship program.
39 Participants will have the opportunity to apply concepts, protocols, and tools acquired through the
40 program by working side-by-side with experts in cybersecurity within the State of North Carolina.

41 **SECTION 7.6.(c)** Of the funds appropriated by this act for the support of the
42 cybersecurity apprenticeship program, the Department of Information Technology may use up to
43 five percent (5%) for costs associated with administering this program.

44 45 **ESTABLISH GENERAL FUND BUDGET**

46 **SECTION 7.7.** Notwithstanding G.S. 143C-6-4, the Office of State Budget and
47 Management shall adjust the Department of Information Technology's certified and authorized
48 budget and expenditures by making transfers among purposes or programs for the purpose of
49 establishing the Department's General Fund appropriated operating budget within General Fund
50 budget code 14660 and thereby reducing the need to utilize the Statewide Reserve budget code
51 19044. Changes shall be completed by September 30, 2016, with an effective date of July 1, 2016.

2 **PART VIII. PUBLIC SCHOOLS**

3
4 **FUNDS FOR CHILDREN WITH DISABILITIES**

5 **SECTION 8.1.** The State Board of Education shall allocate additional funds for
6 children with disabilities on the basis of three thousand nine hundred eighty-five dollars and
7 fifty-three cents (\$3,985.53) per child. Each local school administrative unit shall receive funds for
8 the lesser of (i) all children who are identified as children with disabilities or (ii) twelve and
9 one-half percent (12.5%) of its 2016-2017 allocated average daily membership in the local school
10 administrative unit. The dollar amounts allocated under this section for children with disabilities
11 shall also adjust in accordance with legislative salary increments, retirement rate adjustments, and
12 health benefit adjustments for personnel who serve children with disabilities.

13
14 **FUNDS FOR ACADEMICALLY GIFTED CHILDREN**

15 **SECTION 8.2.(a)** Section 8.2 of S.L. 2015-241 reads as rewritten:

16 **"SECTION 8.2.** The State Board of Education shall allocate additional funds for
17 academically or intellectually gifted children on the basis of one thousand two hundred eighty
18 dollars and seventy cents (\$1,280.70) per child for fiscal ~~years-year~~ 2015-2016 and one thousand
19 two hundred ninety-five dollars and twenty-seven cents (\$1,295.27) per child for fiscal year
20 2016-2017. A local school administrative unit shall receive funds for a maximum of four percent
21 (4%) of its 2015-2016 allocated average daily membership, regardless of the number of children
22 identified as academically or intellectually gifted in the unit. The dollar amounts allocated under
23 this section for academically or intellectually gifted children shall also be adjusted in accordance
24 with legislative salary increments, retirement rate adjustments, and health benefit adjustments for
25 personnel who serve academically or intellectually gifted children."
26

27 **LITIGATION RESERVE FUNDS**

28 **SECTION 8.3.** The State Board of Education may expend up to five hundred
29 thousand dollars (\$500,000) for the 2016-2017 fiscal year from unexpended funds for licensed
30 employees' salaries to pay expenses related to litigation.

31
32 **UMSTEAD ACT EXEMPTION FOR NC VIRTUAL PUBLIC SCHOOL**

33 **SECTION 8.4.(a)** G.S. 66-58(a) reads as rewritten:

34 **"§ 66-58. Sale of merchandise or services by governmental units.**

35 (a) Except as may be provided in this section, it shall be unlawful for any unit, department
36 or agency of the State government, or any division or subdivision of the unit, department or
37 agency, or any individual employee or employees of the unit, department or agency in his, or her,
38 or their capacity as employee or employees thereof, to engage directly or indirectly in the sale of
39 goods, wares or merchandise in competition with citizens of the State, or to engage in the
40 operation of restaurants, cafeterias or other eating places in any building owned by or leased in the
41 name of the State, or to maintain service establishments for the rendering of services to the public
42 ordinarily and customarily rendered by private enterprises, or to provide transportation services, or
43 to contract with any person, firm or corporation for the operation or rendering of the businesses or
44 services on behalf of the unit, department or agency, or to purchase for or sell to any person, firm
45 or corporation any article of merchandise in competition with private enterprise. The leasing or
46 subleasing of space in any building owned, leased or operated by any unit, department or agency
47 or division or subdivision thereof of the State for the purpose of operating or rendering of any of
48 the businesses or services herein referred to is hereby prohibited.

49 (b) The provisions of subsection (a) of this section shall not apply to:

50 (1) Counties and municipalities.

- 1 (2) The Department of Health and Human Services or the Department of
2 Agriculture and Consumer Services for the sale of serums, vaccines, and other
3 like products.
4 (3) The Department of Administration, except that the agency shall not exceed the
5 authority granted in the act creating the agency.
6 (4) The State hospitals for the mentally ill.
7 (5) The Department of Health and Human Services.
8 (6) The North Carolina School for the Blind at Raleigh.
9 (6a) The Division of Juvenile Justice of the Department of Public Safety.
10 (7) The North Carolina Schools for the Deaf.
11 (7a) The North Carolina Virtual Public School.

12"

13 **SECTION 8.4.(b)** G.S. 66-58(c)(20) is repealed.
14

15 **DIGITAL LEARNING PLAN IMPLEMENTATION**

16 **SECTION 8.6.** Funds appropriated in this act for the State Board of Education to
17 implement the Digital Learning Plan shall be used to support local education agencies (LEAs) for
18 (i) delivering educator professional development focused on using digital and other instructional
19 technologies to provide high-quality, integrated digital teaching and learning to all students, (ii)
20 for the State Board of Education to contract with the Friday Institute at NCSU to manage
21 implementation of the NC Digital Learning Plan, and (iii) acquiring quality digital content to
22 enhance instruction. Up to six million dollars (\$6,000,000) may be used by the Department of
23 Public Instruction to (i) provide educational resources that remain current, are aligned with
24 curriculum, selected in collaboration with a task force of superintendents, are electronically
25 available to all local education agencies (LEAs), and are effective for all learners.
26

27 **DIFFERENTIATED PAY FOR ADVANCED TEACHER ROLES**

28 **SECTION 8.7.(a)** Funds appropriated to the North Carolina Endowment Fund shall
29 be used to support the pilot implementation of the Performance Plus initiative. The purpose of this
30 initiative is to provide local school administrative units with funds to prototype advanced teaching
31 roles and pay supplements to teachers based on teachers' demonstrated effectiveness and the
32 assumption of additional responsibilities.

33 **SECTION 8.7.(b)** A teacher, for the purpose of this pilot, is a certified teacher who
34 works in the classroom to provide instruction and who is not instructional support personnel.

35 **SECTION 8.7.(c)** Supplements paid for the purpose of this initiative are in addition to
36 salary earned according to the North Carolina School Personnel salary schedule and other
37 applicable local and State supplements.

38 **SECTION 8.7.(d)** Management. – The State Board of Education shall administer and
39 have complete governance over the program, working in cooperation with the North Carolina
40 Department of Public Instruction, North Carolina universities engaged in teacher preparation,
41 elected officials, business leaders, other organizations and entities supporting educational
42 excellence, superintendents, and principals and teachers in affected schools. The State Board of
43 Education may allocate up to five percent (5%) of an approved individual grant for technical
44 assistance, to the local school administrative unit for the purposes of implementing the local pilot.

45 **SECTION 8.7.(e)** No later than June 1, 2016, the State Board of Education shall issue
46 a Request for Proposals (RFP) for local boards of education to develop advanced teaching roles. In
47 the RFP the State Board of Education shall establish minimum requirements for advanced roles
48 for classroom teachers. Local boards of education shall submit a letter of intent no later than
49 August 31, 2016, that shall focus on the capacity and commitment of the local school
50 administrative unit and the local board of education to develop advanced teaching roles that meet
51 the requirements of subsection (f) of this section, as demonstrated by prior local efforts to advance

1 teaching excellence such as on-the-job development for teachers, teacher leadership, or innovation
2 in school design; and by indication of willingness to reallocate funds to pay at least the minimum
3 supplements as described in subsection (h) of this section. Draft plans shall be submitted to the
4 State Board of Education no later than January 20, 2017. The State Board of Education shall
5 approve plans as soon as is practicable for implementation in the 2017-2018 school year.

6 **SECTION 8.7.(f)** Requirements for Advanced Roles – Advanced teaching role plans
7 developed by participating districts must meet, at a minimum, the following criteria:

8 (1) Advanced teacher role eligibility and duties. –

9 a. Enable eligible classroom teachers to progress within their careers by
10 assuming advanced roles that:

- 11 1. Include accountability for student growth as the teacher of
12 record of all students served by a team of teachers; or
- 13 2. Include accountability for student growth as the teacher of
14 record for more students.

15 (2) Implementation. – Have been implemented previously for the 2015-2016
16 school year.

17 **SECTION 8.7.(g)** Recipient local school administrative units shall ensure that
18 implementation includes:

19 (1) Provide information in a form readily accessible to both teachers and the public
20 on the criteria and procedures for the selection of teachers for advanced roles.

21 (2) Require that supplement recipients are highly effective classroom teachers. A
22 highly effective classroom teacher is a teacher who receives, on the North
23 Carolina Teacher Evaluation instrument, a rating of at least Accomplished on
24 each of the teacher evaluation standards. In addition, teachers who exceed
25 expected student growth on the NC Educator Evaluation instrument for two of
26 the previous three years of teacher evaluation data, or the equivalent on an
27 out-of-state teacher's state or district evaluation are considered highly effective.
28 Teachers without three years of student growth data shall be considered highly
29 effective if their rating on the NC Educator Evaluation instrument rating is at
30 least Accomplished on each of the teacher evaluation standards.

31 (3) Ensure adequate time during the school day for an advanced-role teacher, and
32 that teachers' teaching team if applicable, to plan, collaborate, and participate in
33 on-the-job development or leadership of others.

34 (4) Establish equally stringent eligibility requirements for a teacher to remain in an
35 advanced role as those required to initially attain that role.

36 (5) Establish a procedure for determining whether an advanced-role teacher is
37 successfully performing the additional duties associated with the advanced role.

38 (7) Ensure that advanced-role teachers may opt out of the plan by voluntarily
39 relinquishing additional duties associated with the advanced role. Voluntary
40 relinquishment of duties associated with the advanced role shall not be
41 considered a demotion under Part 3 or Part 3A of Article 22 of Chapter 115C of
42 the General Statutes.

43 **SECTION 8.7.(h)** Advanced Teaching Roles and Supplements. – Local school
44 administrative units shall design and implement pilots to ensure:

45 (1) Supplements for highly effective teachers who are extended reach teachers
46 receive a supplement when there is an increase in their class size of at least
47 thirty-three percent (33%).

48 (2) Supplements for team leads for two or more teachers or teachers who are the
49 teacher of record for all students served by the teaching team, are limited to
50 thirty percent (30%) of teachers in a school.

1 **SECTION 8.7.(i)** The Department of Public Instruction shall ensure the advanced-role
2 supplements paid are not included in the statewide average salary calculation used for budgeting
3 state allotments.

4 **SECTION 8.7.(j)** Methods. – Local school administrative units may use one of two
5 supplement payment methods for the purposes of this initiative:

- 6 (1) Pay specified supplements only for teachers in each designated advanced role
7 directly from funds allocated to the local school administrative unit not to
8 exceed the balance of funds allocated to it for this purpose after deducting funds
9 allocated to it for technical assistance; or
- 10 (2) Allow teacher salary conversions at the beginning salary of the A teacher salary
11 schedule only to pay supplements for each designated advanced role, not to
12 exceed the funds allocated to the local school administrative unit for this
13 purpose after deducting funds allocated to it for technical assistance.

14 **SECTION 8.7.(k)** Pilot Cohorts. – By October 15, 2016, The State Board of
15 Education shall review the letters of intent submitted by local boards of education in accordance
16 with subsection (b) of this section and shall select for the first cohort of the prototype development
17 program seven local school administrative units or consortia of local school administrative units
18 that meet the following criteria:

- 19 (1) One to three school districts (or consortia of districts) each with an average
20 daily membership (ADM) equal to or less than 4,000.
- 21 (2) One to three school districts (or consortia of districts) each with an ADM of
22 4,001 to 10,000.
- 23 (3) One to three school districts (or consortia of districts) each with an ADM of
24 10,001 to 30,000.
- 25 (4) One to three school districts (or consortia of districts) each with an ADM of
26 30,001 or more.

27 **SECTION 8.7.(l)** Cohort 2. – The State Board of Education shall follow the time line
28 and procedures outlined to enable a second cohort of local school administrative units to indicate
29 intent, plan, and participate in the pilot beginning with the 2017-2018 school year.

30 **SECTION 8.7.(m)** Implementation Requirements. – Recipient local school
31 administrative units shall fully implement the pilot in a minimum of twenty-five percent (25%) of
32 schools within the local school administrative unit by the 2017-2018 school year, and fifty percent
33 (50%) of school by 2018-2019.

34 Participating local school administrative units shall submit a plan to the State Board of
35 Education by June 30, 2016, that includes a schedule for full implementation in a minimum of
36 ninety percent (90%) of the schools in the local school administrative unit by the 2021-2022
37 school year.

38 **SECTION 8.7.(n)** Evaluation. – The local board of education of participating local
39 school administrative units shall report no later than August 15, 2017, and by that date each
40 subsequent year on the following:

- 41 (1) The extent to which the advanced roles plan and implementation meets each
42 requirement of section (b) of this section. If the State Board of Education
43 determines that a local school administrative unit's plan does not meet the
44 requirements of section (b) of this section, it shall require the unit to make
45 needed changes in return for continued participation in the program and receipt
46 of transition funds provided pursuant to subdivision (b)(3) of this section.
- 47 (2) The percentage of students with a highly effective teacher as their teacher of
48 record for English Language Arts, math, social studies, and science.
- 49 (3) The Educator Effectiveness ratings of each teacher in advanced roles and the
50 Educator Effectiveness ratings of each member of teams led by teachers in
51 advanced roles.

- 1 (4) The extent to which the advanced teaching roles program has increased the
2 attractiveness of the teaching profession in the district, as measured by the
3 number of applicants per advanced role job posting compared with the typical
4 number of applicants per teaching job posting in the district; and the retention
5 rates of advanced role teachers and members of their teams compared with
6 typical retention rates in the district.
- 7 (5) The use of local or other non-State funds used to support this initiative.
- 8 (6) Documented future sustainability of pilot within State and local resources in the
9 absence of pilot grant funds.
- 10 (7) Other measures determined relevant by the State Board of Education to the
11 purposes of this legislation and to assessing the benefit to the State.

12 **SECTION 8.7.(o)** Reporting. – The State Board of Education shall provide reporting
13 forms and tools to participating local school administrative units to ensure consistency of data
14 gathering.

15 The State Board shall report on implementation status in participating local school
16 administrative units including successes and obstacles annually beginning December 15, 2018, to
17 the President Pro Tempore of the Senate and the Speaker of the House of Representatives, the
18 Senate Appropriations/Base Budget Committee, the House Committee on Appropriations, the
19 Senate Appropriations Committee on Education/Higher Education, the House Appropriations
20 Subcommittee on Education, the Fiscal Research Division, the Joint Legislative Education
21 Oversight Committee, the Governor, the Lieutenant Governor, and the Office of State Budget and
22 Management.

23

24 **SCHOOL PERFORMANCE GRADE SCALE**

25 **SECTION 8.9.** Notwithstanding G.S. 115C-83.15(d), for the 2016-2017 school year
26 only, for all schools, the total school performance score shall be converted to a 100-point scale and
27 used to determine a school performance grade based on the following scale:

- 28 (1) A school performance score of at least 85 is equivalent to an overall school
29 performance grade of A.
- 30 (2) A school performance score of at least 70 is equivalent to an overall school
31 performance grade of B.
- 32 (3) A school performance score of at least 55 is equivalent to an overall school
33 performance grade of C.
- 34 (4) A school performance score of at least 40 is equivalent to an overall school
35 performance grade of D.
- 36 (5) A school performance score of less than 40 is equivalent to an overall school
37 performance grade of F.

38

39 **REMOVE PANIC ALARM CARRY FORWARD LANGUAGE**

40 **SECTION 8.10.** Section 8.8 of S.L. 2013-360, as amended by S.L. 2014-100, is
41 repealed.

42

43 **DIRECT STATE BOARD OF EDUCATION TO ESTABLISH STATEWIDE STRATEGIC**

44 **PLAN FOR FINANCIAL LITERACY**

45 **SECTION 8.15.(a)** The State Board of Education shall develop a statewide strategic
46 plan for financial literacy. The State Board of Education will consult with Financial Literacy
47 Council on the strategic plan, including a review of the proposed Choice\$ Matter campaign.

48 **SECTION 8.15.(b)** The State Board of Education shall include in the strategic an
49 inventory of all financial literacy spending to ensure that efforts are aligned with ongoing
50 programs. This should include, but not limited to, programs within the Department of State

1 Treasurer, the State Board of Education, the Department of Public Instruction, and the Attorney
 2 General.

38 **SECTION 9.1.(b)** Salary Supplements for Teachers Paid on This Salary Schedule.

- 39 (1) Licensed teachers who have NBPTS certification shall receive a salary
 40 supplement each month of twelve percent (12%) of their monthly salary on the
 41 "A" salary schedule.
- 42 (2) Licensed teachers who are classified as "M" teachers shall receive a salary
 43 supplement each month of ten percent (10%) of their monthly salary on the "A"
 44 salary schedule.
- 45 (3) Licensed teachers with licensure based on academic preparation at the six-year
 46 degree level shall receive a salary supplement of one hundred twenty-six dollars
 47 (\$126.00) per month in addition to the supplement provided to them as "M"
 48 teachers.
- 49 (4) Licensed teachers with licensure based on academic preparation at the doctoral
 50 degree level shall receive a salary supplement of two hundred fifty-three dollars

1 (\$253.00) per month in addition to the supplement provided to them as "M"
 2 teachers.

3 (5) Certified school nurses shall receive a salary supplement each month of ten
 4 percent (10%) of their monthly salary on the "A" salary schedule.

5 **SECTION 9.1.(c)** The first step of the salary schedule for (i) school psychologists, (ii)
 6 school speech pathologists who are licensed as speech pathologists at the master's degree level or
 7 higher, and (iii) school audiologists who are licensed as audiologists at the master's degree level of
 8 higher shall be equivalent to Step 5 of the "A" salary schedule. These employees shall receive a
 9 salary supplement each month of ten percent (10%) of their monthly salary and are eligible to
 10 receive salary supplements equivalent to those of teachers for academic preparation at the six-year
 11 degree level or the doctoral degree level.

12 **SECTION 9.1.(d)** The twenty-first step and all subsequent steps of the salary
 13 schedule for (i) school psychologists, (ii) school speech pathologists who are licensed as speech
 14 pathologists at the master's degree level of higher, and (iii) school audiologists who are licensed as
 15 audiologists at the master's degree level or higher shall be seven and one-half percent (7.5%)
 16 higher than the salary received by these same employees on the twentieth step of the salary
 17 schedule.

18 **SECTION 9.1.(e)** Beginning with the 2014-2015 fiscal year, in lieu of providing
 19 annual longevity payments to teacher paid on the teacher salary schedule, the amounts of those
 20 longevity payments are included in the monthly amounts under the teacher salary schedule.

21 **SECTION 9.1.(f)** A teacher compensated in accordance with this salary schedule for
 22 the 2016-2017 school year and all subsequent school years shall receive an amount equal to the
 23 greater of the following:

- 24 (1) The applicable amount on the salary schedule for the applicable school year.
- 25 (2) For teachers who were eligible for longevity for the 2013-2014 school year, the
 26 sum of the following:
 - 27 a. The teacher's salary provided in Section 35.11 of S.L. 2013-360.
 - 28 b. The longevity that the teacher would have received under the longevity
 29 system in effect for the 2013-2014 school year provided in Section
 30 35.11 of S.L. 2013-360, based on the teacher's current years of service.
 - 31 c. The annual bonus provided in Section 9.1(e) of S.L. 2014-100.
- 32 (3) For teachers who were not eligible for longevity for the 2013-2014 school year,
 33 the sum of the teacher's salary and annual bonus provided in Section 9.1 of S.L.
 34 2014-100.

35 **SECTION 9.1.(g)** As used in this section, the term "teacher" shall also include
 36 instructional support personnel.
 37

38 **SCHOOL-BASED ADMINISTRATOR SALARY**

39 **SECTION 9.2.(a)** The following base salary schedule for school-based administrators
 40 shall apply only to principals and assistant principals. This base salary schedule shall apply for the
 41 2015-2016 fiscal year commencing July 1, 2015.

SECTION 9.2.(b) The appropriate classification for placement of principals and assistant principals on the salary schedule, except for principals in alternative schools and in cooperative innovative high schools, shall be determined in accordance with the following schedule:

The number of teachers supervised includes teachers and assistant principals paid from State funds only; it does not include teachers or assistant principals paid from non-State funds or the principal or teacher assistants.

The beginning classification for principals in alternative schools and in cooperative innovative high school programs shall be the Principal III level. Principals in alternative schools who supervise 33 or more teachers shall be classified according to the number of teachers supervised.

SECTION 9.2.(c) A principal shall be placed on the step on the salary schedule that reflects total number of years of experience as a certified employee of the public schools and an additional step for every three years of experience serving as a principal on or before June 30, 2009. A principal or assistant principal shall also continue to receive any additional State-funded percentage increases earned for the 1997-1998, 1998-1999, and 1999-2000 school years for improvement in student performance or maintaining a safe and orderly school.

SECTION 9.2.(d) Principals and assistant principals with certification based on academic preparation at the six-year degree level shall be paid a salary supplement of one hundred twenty-six dollars (\$126.00) per month and at the doctoral degree level shall be paid a salary supplement of two hundred fifty-three dollars (\$253.00) per month.

SECTION 9.2.(e) Longevity pay for principals and assistant principals shall be as provided for State employees under the North Carolina Human Resources Act.

SECTION 9.2.(f) If a principal is reassigned to a higher job classification because the principal is transferred to a school within a local school administrative unit with a larger number of State-allotted teachers, the principal shall be placed on the salary schedule as if the principal had served the principal's entire career as a principal at the higher job classification.

If a principal is reassigned to a lower job classification because the principal is transferred to a school within a local school administrative unit with a smaller number of

1 State-allotted teachers, the principal shall be placed on the salary schedule as if the principal had
2 served the principal's entire career as a principal at the lower job classification.

3 This subsection applies to all transfers on or after the effective date of this section,
4 except transfers in school systems that have been created, or will be created, by merging two or
5 more school systems. Transfers in these merged systems are exempt from the provisions of this
6 subsection for one calendar year following the date of the merger.

7 **SECTION 9.2.(g)** Participants in an approved full-time master's in-school
8 administration program shall receive up to a 10-month stipend at the beginning salary of an
9 assistant principal during the internship period of the master's program. The stipend shall not
10 exceed the difference between the beginning salary of an assistant principal plus the cost of
11 tuition, fees, and books and any fellowship funds received by the intern as a full-time student,
12 including awards of the Principal Fellows Program. The Principal Fellows Program or the school
13 of education where the intern participates in a full-time master's in-school administration program
14 shall supply the Department of Public Instruction with certification of eligible full-time interns.

15 **SECTION 9.2.(h)** During the 2016-2017 fiscal biennium, the placement on the salary
16 schedule of an administrator with a one-year provisional assistant principal's certificate shall be at
17 the entry-level salary for an assistant principal or the appropriate step on the teacher salary
18 schedule, whichever is higher.

19 **SECTION 9.2.(i)** Effective July 1, 2016, any person paid on the State Salary Schedule
20 in the 2014-2015 school year and employed on July 1, 2016, who does not receive a salary
21 increase on this salary schedule shall receive a nonrecurring salary bonus of eight hundred nine
22 dollars (\$809.00).

23 (1) Any employee eligible for this bonus shall continue to receive this bonus in
24 subsequent years whereas the employee does not receive a salary increase on
25 subsequent salary schedules that exceeds the eight hundred nine dollar (\$809)
26 nonrecurring bonus.

27 (2) Should an employee receive a salary increase from a change to the salary
28 schedules, but the amount is less than eight hundred nine dollars (\$809), the
29 bonus shall be reduced by the amount of the increase from the salary schedule.
30

31 **REWARD DEPARTMENT OF PUBLIC INSTRUCTION STAFF WITH ONE-TIME** 32 **BONUS**

33 **SECTION 9.3.** One million four hundred nine thousand nine hundred sixty-three
34 dollars (\$1,409,963) of unreserved fund balance will be used to provide an average three percent
35 (3%) one-time bonus, up to a maximum of three thousand dollars (\$3,000), for Department of
36 Public Instruction staff. The State Board of Education, in consultation with the Office of State
37 Human Resources, will determine the distribution of the bonus. This bonus shall not be considered
38 part of an employee's annual salary or base rate of pay for retirement purposes.
39

40 **COMPENSATION BONUS AWARDED FOR FISCAL YEAR 2016-2017 FOR TEACHERS** 41 **AND OTHER CERTIFIED PERSONNEL**

42 **SECTION 9.4.(a)** Any teacher or other certified personnel (i) whose salary is set by
43 this Section, pursuant to the North Carolina Human Resources Act, or as otherwise authorized in
44 this act and (ii) who is employed in a State-funded position on August 1, 2016, shall receive an
45 award of a one-time, lump-sum compensation bonus of five thousand dollars (\$5,000) if the
46 employee has twenty-five or more years of experience on the Teacher Salary Schedule, or one
47 thousand one hundred dollars (\$1,100) if the employee has twenty-four or fewer years of
48 experience on the Teacher Salary schedule, for the 2016-17 fiscal year, payable during the month
49 of September 2016.

1 **SECTION 9.4.(b)** Notwithstanding G.S. 135-1(7a), the compensation bonus awarded
2 by this section is not compensation under Article 1 of Chapter 135 of the General Statutes, the
3 Teachers' and State Employees' Retirement System.

4 **SECTION 9.4.(c)** The compensation bonus awarded by this section is not part of
5 annual salary and shall be paid out separately. The compensation bonus shall be awarded to
6 eligible permanent employees without regard to an employee's placement within the salary range,
7 including employees at the top of the salary range. The compensation bonus shall be adjusted pro
8 rata for permanent part-time employees.

13 salary is set by this Section, pursuant to the North Carolina Human Resources Act, or as otherwise
14 authorized in this act and (ii) who is employed in a State-funded position on August 1, 2016, is
15 eligible to be considered by each superintendent, or equivalent position for charter schools, for an
16 award of a one-time, lump-sum compensation bonus, up to a maximum of three thousand dollars
17 (\$3,000), for the 2016-2017 fiscal year, payable during the month of September 2016.

18 **SECTION 9.5.(b)** Notwithstanding G.S. 135-1(7a), the compensation bonus awarded
19 by this section is not compensation under Article 1 of Chapter 135 of the General Statutes, the
20 Teachers' and State Employees' Retirement System.

21 **SECTION 9.5.(c)** The compensation bonus awarded by this section is not part of
22 annual salary and shall be paid out separately. The compensation bonus shall be awarded to
23 eligible permanent employees without regard to an employee's placement within the salary range,
24 including employees at the top of the salary range. The compensation bonus shall be adjusted pro
25 rata for permanent part-time employees.

27 **COMPENSATION BONUS AWARDED FOR FISCAL YEAR 2016-2017 FOR SCHOOL**
28 **BASED ADMINISTRATORS**

29 **SECTION 9.6.(a)** Any school based administrator (i) whose salary is set by this
30 Section, pursuant to the North Carolina Human Resources Act, or as otherwise authorized in this
31 act and (ii) who is employed in a State-funded position on August 1, 2016, is eligible to be
32 considered by each superintendent, or equivalent position for charter schools, for an award of a
33 one-time, lump-sum compensation bonus, up to a maximum of three thousand five hundred dollars
34 (\$3,500), for the 2016-2017 fiscal year, payable during the month of September 2016.

35 **SECTION 9.6.(b)** Notwithstanding G.S. 135-1(7a), the compensation bonus awarded
36 by this section is not compensation under Article 1 of Chapter 135 of the General Statutes, the
37 Teachers' and State Employees' Retirement System.

38 **SECTION 9.6.(c)** The compensation bonus awarded by this section is not part of
39 annual salary and shall be paid out separately. The compensation bonus shall be awarded to
40 eligible permanent employees without regard to an employee's placement within the salary range,
41 including employees at the top of the salary range. The compensation bonus shall be adjusted pro
42 rata for permanent part-time employees.

46 **CARRYFORWARD OF COLLEGE INFORMATION SYSTEM FUNDS**

47 **SECTION 10.1.(a)** Of the funds appropriated to the Community Colleges System
48 Office for the 2015-2017 fiscal biennium for the College Information System, up to one million
49 two hundred fifty thousand dollars (\$1,250,000) shall not revert at the end of each fiscal year but
50 shall remain available until expended. These funds may be used only to purchase periodic system
51 upgrades.

1 SECTION 10.1.(b) Subsection (a) of this section becomes effective June 29, 2016.

3 **CODIFY MANUFACTURING SOLUTIONS CENTER AUTHORIZATION**

4 SECTION 10.2. Chapter 115D of the General Statutes is amended by adding a new
5 Article to read:

7 "The Manufacturing Solutions Center at Catawba Valley Community College.

8 "**§ 115D-67.5. Purpose.**

9 The purpose of the Manufacturing Solutions Center is to create and maintain jobs in North
10 Carolina through support of traditional and emerging industries. The Center's services include
11 training, testing, market development, entrepreneur support, product sourcing, prototyping,
12 applied research and managing a manufacturing business incubator.

13 "**§ 115D-67.6. Director and other Center personnel.**

14 The president of Catawba Valley Community College shall appoint an individual to serve as
15 the executive director of the Manufacturing Solutions Center. The executive director shall select
16 other staff members of the Center, subject to approval of the president of Catawba Valley
17 Community College. The executive director and other staff members of the Center are employees
18 of Catawba Valley Community College and are subject to the personnel policies of the college.

19 "**§ 115D-67.7. Fees collected by the Center; purchases using Center funds.**

20 Notwithstanding any other provision of law, all fees collected by the Manufacturing Solutions
21 Center for services to industry shall be retained by the Center and used for the operations of the
22 Center. Purchases made by the Center using these funds are not subject to the provisions of Article
23 3 of Chapter 143 of the General Statutes. The Center shall include in all agreements or contracts to
24 be awarded by the Center under this section a standard clause which provides that the State
25 Auditor and internal auditors of the Center may audit the records of the contractor during and after
26 the term of the contract to verify accounts and data affecting fees and performance. The Center
27 shall not award a cost-plus-percentage-of-cost agreement or contract for any purpose."

28
29 **UPDATE PERFORMANCE MEASURES**

30 SECTION 10.3. G.S. 115D-31.3 reads as rewritten:

31 "**§ 115D-31.3. Institutional performance accountability.**

33 (e) **Mandatory Performance Measures.**—The State Board of Community Colleges shall

46 (9) Attainment of licensure and certifications by students.

47 The State Board may also evaluate each college on additional performance measures.

48 (f) **Publication of Performance Ratings.**—Each college shall publish its performance on the
49 ~~eight~~ measures set out in subsection (e) of this section (i) annually in its electronic catalog or on
50 the Internet and (ii) in its printed catalog each time the catalog is reprinted.

1 The Community Colleges System Office shall publish the performance of all colleges on all
2 ~~eight~~ measures.

3 (g) Recognition of Successful Institutional Performance. – For the purpose of recognition
4 of successful institutional performance, the State Board of Community Colleges shall evaluate
5 each college on the ~~eight~~ performance measures set out in subsection (e) of this section. Subject to
6 the availability of funds, the State Board may allocate funds among colleges based on the
7 evaluation of each institution's performance, including at least the following components:

- 8 (1) Program quality evaluated by determining a college's rate of student success on
9 each measure as compared to a systemwide performance baseline and goal.
- 10 (2) Program impact on student outcomes evaluated by the number of students
11 succeeding on each measure."

13 INCENTIVIZE INSTITUTIONAL PERFORMANCE ACCOUNTABILITY

14 **SECTION 10.4.** G.S. 115D-31.3(g1) reads as rewritten:

17 (g1) Carryforward of Funds Allocated Based on Performance.–A college that receives funds
18 under subsection (g) of this section may retain and carry forward an amount up to or equal to its
19 performance-based funding allocation for that year into the next fiscal year. Funds retained under
20 this subsection may be used for the purposes listed in G.S. 115D-31(a)(1) and (2) as well as
21 one-time faculty and staff bonuses."

23 EXTEND VOLUNTARY SHARED LEAVE TO COMMUNITY COLLEGE EMPLOYEES

24 **SECTION 10.5.** G.S. 115D-25.3 reads as rewritten:

25 "**§ 115D-25.3. Voluntary shared leave.**

26 (a) The State Board of Community Colleges, in cooperation with ~~the State Board of~~
27 ~~Education and~~ the State Human Resources Commission, shall adopt rules and policies to allow
28 any employee at a community college to share leave voluntarily with an immediate family
29 member who is an employee of a community college, public school, or State agency; and with a
30 coworker's immediate family member who is an employee of a community college, public school,
31 or State agency. For the purposes of this section, the term "immediate family member" means a
32 spouse, parent, child, brother, sister, grandparent, or grandchild. The term includes the step, half,
33 and in-law relationships. The term "coworker" means that the employee donating the leave is
34 employed by the same agency, department, institution, university, local school administrative unit,
35 or community college as the employee whose immediate family member is receiving the leave.

36 (b) The State Board of Community Colleges, in cooperation with the State Human
37 Resources Commission, shall adopt rules and policies consistent with policies set forth in the State
38 Human Resources Manual to allow any employee at a community college to share sick leave
39 voluntarily with a non-family member who is an employee of a community college. A community
40 college employee who donates sick leave to a community college employee who is a nonfamily
41 member shall not donate more than five days of sick leave per year to any one nonfamily
42 community college employee. The combined total of sick leave donated to a community college
43 employee from nonfamily community college donors shall not exceed 20 days per year. Donated
44 sick leave shall not be used for retirement purposes, and community college employees who
45 donate sick leave shall be notified in writing of the State retirement credit consequences of
46 donating sick leave."

48 REPORT ON FUNDS REINVESTED FROM ENROLLMENT DECLINE INTO 49 STUDENT SUPPORTS

50 **SECTION 10.6.** The State Board of Community Colleges shall report, no later than
51 February 1, 2017, to the Joint Legislative Education Oversight Committee, the Fiscal Research

2 enrollment decline into student support services that encourage students to complete degrees and

10 **SECTION 11.1.** Section 11.12(b) of S.L. 2015-241, Appropriations Act of 2015,
11 reads as rewritten:

13 institutions of higher education that are Historically Black Colleges and Universities to participate
14 in the internship program which links a minimum of 60 students attending Historically Black
15 Colleges and Universities with North Carolina-based companies. The Board of Governors shall
16 determine the number of institutions that may participate in the program; however, at least two of
17 the institutions shall be private institutions. Funds appropriated by this act for this internship
18 program shall be allocated only to constituent institutions of The University of North Carolina that
19 are designated as an HBCU and private colleges and universities located in North Carolina that are
20 designated as an HBCU."

21
22 **MODIFY NC GUARANTEED ADMISSION PROGRAM (NCGAP)**

23 **SECTION 11.2.(a)** Section 11.7(b) of S.L. 2015-241 reads as rewritten:

24 **"SECTION 11.7.(b)** The Board of Governors of The University of North Carolina and the
25 State Board of Community Colleges shall jointly study and evaluate how a deferred admission
26 program, to be known as the North Carolina Guaranteed Admission Program (NCGAP), for
27 students identified as academically at risk and designed pursuant to subsection (c) of this section,
28 would address the issues and help achieve the goals set out in subsection (a) of this section. In its
29 study the Board of Governors and State Board of Community Colleges shall also consider the best
30 procedure for implementing NCGAP and the fiscal impact it may have with respect to enrollment.
31 The Board of Governors and State Board of Community Colleges shall evaluate other measures
32 currently in place designed to improve completion rates and consider any potential overlap with
33 NCGAP."

34 **SECTION 11.2.(b)** Section 11.7(d) of S.L. 2015-241 reads as rewritten:

35 **"SECTION 11.7.(d)** The Board of Governors of The University of North Carolina and the
36 State Board of Community Colleges shall report their initial finding and recommendations to the
37 Joint Legislative Education Oversight Committee, the Fiscal Research Division, and the Office of
38 State Budget and Management by March 1, ~~2016~~—2016, and their final finding and
39 recommendations by January 1, 2017. The report shall include an analysis of the fiscal impact
40 NCGAP may have with regard to enrollment at constituent institutions of The University of North
41 Carolina and at community colleges, the number of students who may participate in NCGAP, and
42 its effect on FTEs."

43 **SECTION 11.2.(c)** Section 11.7(e) of S.L. 2015-241 reads as rewritten:

44 **"SECTION 11.7.(e)** Based on the analysis conducted by the Board of Governors and the
45 State Board of Community Colleges pursuant to subsection (b) of this section and the
46 recommendations made pursuant to subsection (d) of this section, each constituent institution shall
47 design a deferred admission program as part of NCGAP for implementation at the institution. The
48 institution shall design the program so that it may be implemented at the institution beginning with
49 the ~~2016-2017-2017-2018~~ fiscal year and applied to the institution's admission process for the
50 ~~2017-2018-2018-2019~~ academic year and each subsequent academic year."

51 **SECTION 11.2.(d)** Section 11.7(g) of S.L. 2015-241 reads as rewritten:

1 "SECTION 11.7.(g) NCGAP shall be implemented at all constituent institutions and all
2 community colleges beginning with the ~~2016-2017-2017-2018~~ fiscal year and shall apply to
3 admissions policies at each constituent institution and community college beginning with the

6 **REPORT ON USE OF LOTTERY FUNDS FOR LEVERAGING TECHNOLOGY FOR**
7 **PART-WAY HOME STUDENTS**

8 **SECTION 11.3.** Beginning September 1, 2017, and annually thereafter, the President
9 of the University of North Carolina shall report to the Office of State Budget and Management and
10 the Fiscal Research Division of the General Assembly on prior fiscal year expenditures of
11 Education Lottery funds for the purpose of leveraging technology to recruit, retain, and graduate
12 "part-way home" and other nontraditional students. The report shall include line item
13 expenditures, descriptions of program activities and accomplishments, and data on outcome
14 measures used assess program effectiveness.
15

16 **REPORT ON USE OF LOTTERY FUNDS FOR IMPROVING STUDENT SUCCESS**
17 **WITH DATA-CENTRIC SYSTEMS**

18 **SECTION 11.4.** Beginning September 1, 2017, and annually thereafter, the President
19 of the University of North Carolina shall report to the Office of State Budget and Management and
20 the Fiscal Research Division of the General Assembly on prior fiscal year expenditures of
21 Education Lottery funds for the purpose of improving student success and completion rates
22 through data-centric systems. The report shall include line item expenditures, descriptions of
23 program activities and accomplishments, and data on outcome measures used assess program
24 effectiveness.
25

26 **REPEAL LIMITATION OF STATE FUNDS FOR UNC ADVANCEMENT PROGRAMS**

27 **SECTION 11.5.(a)** Section 11.6 of S.L. 2015-241 is repealed.

28 **SECTION 11.5.(b)** The reduction associated with the advancement activities
29 limitation of sixteen million three hundred fifty-four thousand three hundred ninety-six dollars
30 (\$16,354,396) in recurring funds shall be eliminated for the 2016-2017 fiscal year.

31 **SECTION 11.5.(c)** The management flexibility reduction for the operating budget of
32 the University of North Carolina shall be increased by sixteen million three hundred fifty-four
33 thousand three hundred ninety-six dollars (\$16,354,396) in recurring funds for the 2016-2017
34 fiscal year so that the total management flexibility reduction for the 2016-2017 fiscal year shall be

- 4 2. Received special education or related services through the North
- 5 Carolina public schools as a preschool child with a disability
- 6 during the previous semester.
- 7 3. Was approved for a scholarship for the previous semester.
- 8 4. Is a child who is identified as a child with a disability prior to the
- 9 end of the year of initial enrollment in kindergarten or first
- 10 grade. An award by the Authority based on eligibility under this
- 11 sub-sub-subdivision shall be conditional. If documentation is not
- 12 provided to the Authority that the child is a child with a
- 13 disability prior to the end of the year of initial enrollment, (i) no
- 14 reimbursement shall be awarded and (ii) the child shall not
- 15 qualify the following year as an eligible student under
- 16 sub-sub-subdivision 3. of this section.
- 17 5. Is a child who (i) was enrolled during the previous semester in a
- 18 Department of Defense Elementary and Secondary School
- 19 established pursuant to 10 U.S.C. § 2164 and located within the
- 20 State of North Carolina and (ii) whose parent or legal guardian is
- 21 on full-time duty status in the active uniformed service of the
- 22 United States, including members of the National Guard and
- 23 Reserve on active duty orders pursuant to 10 U.S.C. § 12301, et.
- 24 seq. and 10 U.S.C. § 12401, et seq."

25 **SECTION 11.6.(b)** G.S. 115C-112.6(b1)(1) reads as rewritten:

 3 requirements of Part 1 or Part 2 of Article 39 of this Chapter as
 4 identified by the Department of Administration, Division of Nonpublic
 5 Education, is deemed eligible by the Division pursuant to
 6 G.S. 115C-562.4, and is subject to the requirements of G.S. 115C-562.5.
 7 The parent or guardian shall restrictively endorse the scholarship funds
 8 awarded to the eligible student to the school for deposit into the account
 9 of the school. The parent or guardian shall not designate any entity or
 10 individual associated with the school as the parent's attorney-in-fact to
 11 endorse the scholarship funds but shall endorse the scholarship funds in
 12 person at the site of the school. A parent's or guardian's failure to
 13 comply with this section shall result in forfeiture of the scholarship
 14 funds. A scholarship forfeited for failure to comply with this section
 15 shall be returned to the Authority to be awarded to another student.

16 b. Reimbursement for tuition. – The parent or guardian of an eligible
 17 student who enrolls in a school that is (i) a North Carolina public school
 18 other than the public school to which that student has been assigned as
 19 provided in G.S. 115C-366 or (ii) a nonpublic school that meets the
 20 requirements of Part 1 or Part 2 of Article 39 of this Chapter as
 21 identified by the Department of Administration, Division of Nonpublic
 22 Education, is deemed eligible by the Division pursuant to
 23 G.S. 115C-562.4, and is not subject to G.S. 115C-562.5, shall pay
 24 tuition directly to the school. The Authority shall reimburse the parent
 25 or guardian no sooner than the mid-point of each semester. A parent or
 26 guardian may receive reimbursement for tuition only after the parent or
 27 guardian provides documentation that the student was enrolled in a
 28 school under this sub-subdivision."

29 **SECTION 11.6.(c)** G.S. 115C-112.6 is amended by adding a new subsection to read:

30 "(f) Unexpended Scholarship Funds – Scholarship funds that are unexpended at the end of
 31 each fiscal year shall revert except that the State Education Assistance Authority may carry
 32 forward to the next fiscal year an amount necessary to ensure that all outstanding, allowable
 33 reimbursements can be paid in full. Funds carried forward from a prior fiscal year shall not be
 34 used to award or expand the number of scholarships in subsequent years."

35 **SECTION 11.6.(d)** Except as otherwise provided in this act, this section is effective

7 b. Is eligible to attend a North Carolina public school in accordance with
8 G.S. 115C-366(a), including pursuant to G.S. 115C-366(a1) through
9 G.S. 115C-366(a8).

10 c. Has not enrolled in a postsecondary institution in a matriculated status
11 eligible for 12 hours of academic credit.

12 b.d. Resides in a household with an income level not in excess of one
13 hundred thirty-three percent (133%) of the amount required for the
14 student to qualify for the federal free or reduced-price lunch program."

15 **SECTION 11.7.(b)** G.S. 115C-562.2(a)(2) reads as rewritten:

16 "(2) After scholarship grants have been awarded to prior recipients as provided in
17 subdivision (1) of this subsection, scholarships shall be awarded with remaining
18 funds as follows:

19 a. At least fifty percent (50%) of the remaining funds shall be used to
20 award scholarship grants to eligible students residing in households with
21 an income level not in excess of the amount required for the student to
22 qualify for the federal free or reduced-price lunch program.

23 b. No more than thirty-five percent (35%) of the remaining funds shall be
24 used to award scholarship grants to eligible students entering either
25 kindergarten or first grade.

26 c. Any remaining funds shall be used to award scholarship grants to all
27 other eligible students."

28 **SECTION 11.7.(c)** Except as otherwise provided in this act, this section is effective
29 when it becomes law and applies beginning with the 2016-2017 school year.
30

31 **UNC MERIT SCHOLARSHIP PROGRAM**

32 **SECTION 11.8.(a)** Merit Scholarships for Math, Science, and Health Degrees. – In
33 addition to the funds appropriated in Section 5.2(a) of S.L. 2015-241 for the 2015-2017 biennium,
34 an additional amount not to exceed five million dollars (\$5,000,000) is appropriated from the
35 Education Lottery Fund to the Board of Governors of The University of North Carolina for the
36 2016-2017 fiscal year and allocated to the State Education Assistance Authority (SEAA) for
37 scholarships to exemplary North Carolina students who, as entering freshman, qualified transfer
38 students, and continuing students, exhibit exceptional academic credentials and intend to pursue
39 undergraduate degrees in math, science or health-related programs of study at constituent
40 institutions of The University of North Carolina. Only students who are classified as residents for
41 tuition purposes and admitted to a constituent institution of higher education as a full-time student
42 are eligible for the merit scholarships. The Board of Governors shall establish guidelines for
43 awarding the scholarships on a campus basis not inconsistent with this section. Notwithstanding
44 the foregoing, no scholarship shall be awarded to a qualified student for enrollment commencing
45 prior to August 1, 2017.

46 **SECTION 11.8.(b)** Administration of Merit Scholarships. – The SEAA shall
47 administer the scholarships provided for in this section in consultation with the General
48 Administration of The University of North Carolina and pursuant to guidelines and procedures
49 established by the SEAA consistent with its practices for administering State-funded financial aid,
50 provided that such guidelines and procedures include an application process and schedule,
51 notification and disbursement procedures, standards for reporting, and standards for return of

1 scholarship funds when a student withdraws. The maximum amount of the scholarship for the
2 2017-2018 academic year shall be five thousand dollars (\$5,000) per semester. In no event,
3 however, shall the amount of the scholarship, when accounted for in combination with all other
4 grants, educational benefits, and any other financial aid available to the student, cause the total of
5 all such assistance to exceed the total cost of attendance at the in-State tuition rate at the
6 constituent institution as determined in accordance with Title IV of the Higher Education Act of
7 1965, as amended.

8 The Authority may use five percent (5%) of the funds appropriated for scholarships
9 under this section for administrative purposes.

10 **SECTION 11.8.(c)** North Carolina Math, Science and Health Merit Scholarship Fund.
11 – There is established the North Carolina Math, Science and Health Merit Scholarship Fund to be
12 administered by the SEAA. All funds appropriated to or otherwise received by the SEAA to
13 provide scholarships under this section, all returned scholarship monies, and all interest earned on
14 these funds shall be placed in the Fund. The Fund shall be used only for scholarships made
15 pursuant to this section and the administrative costs of the SEAA, provided that no more than five
16 percent (5%) of the funds appropriated for scholarships is expended for administrative purposes.
17

18 **STEM TEACHER RECRUITMENT SCHOLARSHIP PROGRAM (FORGIVABLE** 19 **LOAN)**

20 **SECTION 11.9.(a)** Part 1 of Article 23 of Chapter 116 of the General Statutes is
21 amended by adding a new section to read:

22 **"§ 116-209.45A. STEM Teacher Recruitment Program.**

23 (a) Policy. – The General Assembly finds that, in response to critical employment
24 shortages of licensed teachers in certain fields, it is in the public interest to target financial
25 assistance in the form of forgivable loans for service to exemplary students who are committed to
26 teaching in the fields of science, technology, engineering, or mathematics (STEM) in the North
27 Carolina public schools as part of the Forgivable Education Loans for Service Program.

28 (b) Definitions. – The following definitions apply in this section:

29 (1) Eligible institution. – Notwithstanding G.S. 116-201(b)(5) and
30 G.S. 116-201(b)(6) and for purposes of this section only, an institution of
31 higher education that is either of the following:

32 a. A postsecondary constituent institution of The University of North
33 Carolina as defined in G.S. 116-2(4).

34 b. An eligible private postsecondary institution as defined in
35 G.S. 116-280(3).

36 (2) Fund. – Has the same meaning as G.S. 116-209.45(b)(2).

37 (3) Loan. – A forgivable loan made under the North Carolina STEM Teacher
38 Recruitment Program.

39 (4) Program. – The North Carolina STEM Teacher Recruitment Program.

40 (c) Establishment of the North Carolina STEM Teacher Recruitment Program. – There is
41 established the North Carolina STEM Teacher Recruitment Program to be administered by the
42 Authority as part of, yet distinct in its purpose, the Forgivable Education Loans for Service
43 Program. The purpose of the Program is to provide forgivable loans for service to exemplary
44 students who are committed to working as licensed teachers in the fields of science, technology,
45 engineering, or mathematics.

46 (d) The North Carolina STEM Teacher Recruitment Funds. – Funds appropriated for the
47 Program shall be allocated to the Forgivable Education Loans for Service Fund established under
48 G.S. 116-209.45(d) and administered by the Authority consistent with this section. All funds
49 appropriated to or otherwise received by the Authority to provide loans through the Program, all
50 funds received as repayment of loans, and all interest earned on these funds shall be placed in the

1 Fund. Such STEM Teacher Recruitment Funds shall be accounted for separately within the Fund
2 and used only for loans made pursuant to this section and the administrative costs of the Authority.

3 (e) Eligibility for Loans. – The Authority shall establish the criteria for initial and
4 continuing eligibility to participate in the Program. All loan recipients shall be residents of North
5 Carolina and shall attend an eligible institution. The Authority shall adopt very stringent standards,
6 including minimum grade point average and scholastic aptitude test scores, for awarding loans to
7 ensure that only highly qualified and committed students receive loans. A recipient of a loan shall
8 not be eligible to receive concurrently a loan under the Forgivable Education Loans for Service
9 Program pursuant to G.S. 116-209.45(c).

10 (f) Loan Terms and Conditions. – The terms and conditions applicable to loans made
11 under the Forgivable Education Loans for Service Program established under G.S. 116-209.45
12 shall apply to loans made under the Program except as follows:

13 (1) Loan amount. – The initial maximum loan amount shall be six thousand five
14 hundred dollars (\$6,500). The maximum loan amount may be adjusted by the
15 Authority for subsequent years of the Program based on funds available for the
16 Program.

17 (2) Repayment. – The Authority shall forgive the loan if, within six years after
18 graduation, the recipient teaches one academic year at a North Carolina public
19 school or at a school operated by the United States government in North
20 Carolina for each year of loan funding received. The Authority may provide an
21 accelerated repayment forgiveness option for any recipient who accepts
22 employment at a North Carolina public school that, at the time the recipient
23 accepts employment with the local school administrative unit in which the
24 school is located, is low-performing as identified by the State Board of
25 Education pursuant to G.S. 115C-105.37. The Authority, in exercise of its sole
26 discretion, shall have the authority to extend the period of time in which
27 repayment must be completed by one additional year due to extenuating
28 circumstances.

29 (3) Other. – The Authority may establish other terms and conditions that are
30 necessary or convenient to effectuate the purpose of the Program and align the
31 administration of the Program with that of the Forgivable Loans for Service
32 Program.

33 (g) Rule-Making Authority. – The Authority may adopt rules as necessary to implement,
34 administer, and enforce the provisions of this section.

35 (h) Report to the General Assembly. – The Authority shall report no later than December
36 1, 2018, and annually thereafter, to the Office of State Budget and Management and the Joint
37 Legislative Education Oversight Committee regarding loans awarded from the Fund for the
38 Program."

39 **SECTION 11.9.(b)** G.S. 116-209.45(h) reads as rewritten:

40 "(h) Use of Fund Monies. – All funds appropriated to or otherwise received by the
41 Authority to provide loans through the Program, all funds received as repayment of loans, and all
42 interest earned on these funds shall be placed in the Fund. The Fund shall be used only for loans
43 made pursuant to this section, loans made pursuant to G.S. 116-209.45A, and ~~for~~ administrative
44 costs of the Authority, including costs of administering the former Teaching Fellows Program
45 transferred to the Authority under G.S. 116-209.27.

46 **SECTION 11.9.(c)** There is appropriated from the General Fund to the Board of
47 Governors of The University of North Carolina the sum of two million one hundred fifty thousand
48 dollars (\$2,000,000) for the 2016-2017 fiscal year to be allocated to the Forgivable Education
49 Loans for Service Fund for the STEM Teacher Recruitment Program administered by the State
50 Education Assistance Authority in accordance with this section. Of these funds:

- 1 (1) Two million dollars (\$1,900,000) shall be used to provide loans under the
 2 STEM Teacher Recruitment Program for enrollment in the 2017-18 academic
 3 year; and
 4 (2) One hundred fifty thousand dollars (\$100,000) shall be transferred to the State
 5 Education Assistance Authority in the 2016-17 fiscal year for the
 6 administration and implementation of the Program.
 7

8 **MODIFY REQUIREMENT FOR NON-GENERAL FUND ADVANCED PLANNING**

9 **SECTION 11.10.** G.S. 143C-3-3 reads as rewritten:

10 **"§ 143C-3-3. Budget requests from State agencies in the executive branch.**

11 ...

12 (b) University of North Carolina System Request.—Notwithstanding the requirement in
 13 G.S. 116-11 that the Board of Governors prepare a unified budget request for all of the constituent
 14 institutions of The University of North Carolina., budget requests of the University shall be
 15 subject to all of the following:

- 16 (1) Repairs and renovations requests, capital fund requests, and information
 17 technology requests shall comply with subsections (c), (d), and (e) of this
 18 section.
 19 (2) The University of North Carolina shall not make a capital funds request
 20 proposing to construct a new facility, expand the building area (square feet) of
 21 an existing facility, or rehabilitate an existing facility to accommodate new or
 22 expanded uses unless the University has completed advanced planning through
 23 schematic design of the ~~project with funds other than General Fund~~
 24 ~~appropriations.~~ project. 12F.7.(g)The Board of Governors shall establish and
 25 implement requirements for constituent institutions to match a minimum of one
 26 dollar (\$1.00) from funds other than General Fund appropriations for every one
 27 dollar (\$1.00) of General Fund appropriations used to complete advance
 28 planning of capital projects. The Board of Governors shall not establish the
 29 minimum matching requirement in this subdivision for all consistent
 30 institutions and shall require higher matching dollar amounts from funds other
 31 than General Fund appropriations based on a constituent institution's financial
 32 ability to generate and contribute funds other than General Fund appropriations.
 33 For purposes of this subdivision, "funds other than General Fund
 34 appropriations" includes funds carried forward from one fiscal year to another
 35 pursuant to G.S. 116-30.3 and G.S. 116-30.3B."

37 **PART XII. DEPARTMENT OF HEALTH AND HUMAN SERVICES**

38 **SUBPART XII-A. CENTRAL MANAGEMENT AND SUPPORT**

39 **FUNDS FOR NTRACKS, THE REPLACEMENT MULTIPAYER MEDICAID** 40 **MANAGEMENT INFORMATION SYSTEM**

41 **SECTION 12A.1.(b)** Beginning on November 15, 2015, and monthly thereafter, the
 42 Department of Health and Human Services shall submit a report to the Joint Legislative Oversight
 43 Committee on Health and Human Services and the Fiscal Research Division on the status of the
 44 implementation of ICD-10. The Department shall continue to submit the report by the 15th of each
 45 month until three consecutive months have passed in which the Department did not issue any
 46 hardship advances. Thereafter, either the new Department of Information Technology (DIT),
 47 created by this act, or the Department, as appropriate, shall submit this report upon request of the
 48 Joint Legislative Oversight Committee on Health and Human Services. The report shall include all
 49 of the following items:
 50
 51

- 1 (1) An analysis of claims payments prior to the implementation compared to post
2 implementation by major provider category that identifies any variations in
3 claims payment levels.
- 4 (2) For variations attributable to the implementation of ICD-10, the report shall
5 include corrective actions and communications that resulted from the
6 identification of the variation.
- 7 (3) An update on hardship advances made to providers for payment issues arising
8 for the implementation of ICD-10 that specifies the total amount advanced and
9 the total amount recovered to date listed by provider.

11 FUNDS FOR NORTH CAROLINA FAMILIES ACCESSING SERVICES THROUGH 12 TECHNOLOGY (NC FAST)

13 **SECTION 12A.2.(a)** Funds appropriated in this act in the amount of five million eight
14 hundred three thousand dollars (\$5,803,000) for the 2015-2016 fiscal year and thirteen million
15 fifty-two thousand dollars (\$13,052,000) for the 2016-2017 fiscal year along with prior year
16 earned revenue in the amount of nine million four hundred thousand dollars (\$9,400,000) for the
17 2015-2016 fiscal year and ten million nine hundred eighty-nine thousand seventeen dollars
18 (\$10,989,017) for the 2016-2017 fiscal year; and the cash balance in Budget Code 24410 Fund
19 2411 for the North Carolina Families Accessing Services through Technology (NC FAST) project
20 shall be used to match federal funds in the 2015-2016 and 2016-2017 fiscal years. In the event the
21 Department does not receive prior year earned revenues in the amounts authorized by this section,
22 or funds are insufficient to advance the project, the Department may, with prior approval from the
23 Office of State Budget and Management (OSBM), utilize overrealized receipts and funds
24 appropriated to the Department to achieve the level of funding specified in this section for NC
25 FAST. The funds shall be utilized to expedite the development and implementation of Child Care,
26 Low Income Energy Assistance, Crisis Intervention Programs, Child Services, NC FAST
27 Federally-Facilitated Marketplace (FFM) Interoperability, and Additional Medicaid Eligibility
28 Requirements & Enterprise Program Integrity components of the NC FAST program. The
29 Department shall report any changes in approved federal funding or federal match rates within 30
30 days after the change to the Joint Legislative Oversight Committees on Health and Human
31 Services and Information Technology and the Fiscal Research Division.

33 FUNDS FOR COMMUNITY PARAMEDICINE PILOT PROGRAM

34 **SECTION 12A.3.** Section 12A.12 of S.L. 2015-241 reads as rewritten:

35 **"SECTION 12A.12.(a)** Of the funds appropriated in this act to the Department of Health and
36 Human Services, Division of Central Management and Support, for the 2015-2016 fiscal year, the
37 sum of three hundred fifty thousand dollars (\$350,000) shall be used to implement a community
38 paramedicine pilot program. The pilot program shall focus on expanding the role of paramedics to
39 allow for community-based initiatives that result in providing care that avoids nonemergency use
40 of emergency rooms and 911 services and avoids unnecessary admissions into health care
41 facilities.

42 **"SECTION 12A.12.(b)** The North Carolina Office of Emergency Medical Services
43 (NCOEMS) shall set the education standards and other requirements necessary to qualify as a
44 community paramedic eligible to participate in the pilot program established in subsection (a) of
45 this section. The Department shall consult with the NCOEMS to define the objectives, set
46 standards, and establish the required outcomes for the pilot program.

47 **"SECTION 12A.12.(c)** The Department of Health and Human Services shall establish up to
48 three program sites to implement the community paramedicine pilot program, one of which shall
49 be New Hanover Regional Emergency Medical Services. For the 2015-2016 fiscal year, the New
50 Hanover Regional Emergency Medical Services program site shall be awarded up to two hundred
51 ten thousand dollars (\$210,000), and each of the remaining program sites may be awarded up to

1 seventy thousand dollars (\$70,000). In selecting the remaining program sites, the Department may
2 give preference to counties that currently have an established community paramedic program.

3 **"SECTION 12A.12.(d)** The Department of Health and Human Services shall submit a report
4 to the Senate Appropriations Committee on Health and Human Services, the House of
5 Representatives Appropriations Committee on Health and Human Services, and the Fiscal
6 Research Division by June 1, 2016, on the progress of the pilot program and shall include an
7 evaluation plan based on the U.S. Department of Health and Human Services, Health Resources
8 and Services Administration Office of Rural Health Policy's Community Paramedicine Evaluation
9 Tool published in March 2012.

10 **"SECTION 12A.12.(e)** The Department of Health and Human Services shall submit a final
11 report to the Joint Legislative Oversight Committee on Health and Human Services and the Fiscal
12 Research Division by ~~November 1, 2016.~~ March 31, 2017. At a minimum, the final report shall
13 include all of the following:

- 14 (1) An updated version of the evaluation plan required by subsection (d) of this
15 section.
- 16 (2) An estimate of the cost to expand the program incrementally and statewide.
- 17 (3) An estimate of any potential savings of State funds associated with expansion
18 of the program.
- 19 (4) If expansion of the program is recommended, a time line for expanding the
20 program."

21 **MEDICAID GRADUATE MEDICAL EDUCATION (GME) FUNDS**

22 **SECTION 12A.4.** The Department of Health and Human Services, Division of
23 Central Management and Support, Office of Rural Health, shall receive the sum of three million
24 five hundred thousand dollars (\$3,500,000) in appropriations for the 2016-2017 fiscal year. These
25 funds shall be used for Graduate Medical Education (GME) residency slots that focus on rural and
26 underserved areas and specialties needed to meet the health care needs of the State's population.
27

28 **SUBPART XII-B. DIVISION OF CHILD DEVELOPMENT AND EARLY EDUCATION**

29 **CHILD CARE ALLOCATION FORMULA**

30 **SECTION 12B.1.(a)** For SFY 2016-2017, the Department of Health and Human
31 Services shall allocate one-time Temporary Assistance for Needy Families funds in the amount of
32 four million two hundred fifty-nine thousand nine hundred eighteen dollars (\$4,259,918) for the
33 purpose of increasing access to high-quality early care and education to children. These funds
34 shall not be allocated according to Section 12B.3(a) of this act, but shall be distributed by the
35 Department for the following purposes:
36

- 37 (1) For eligible four-year-old children who have never been served to receive NC
38 Pre-K services or subsidized child care in child care facilities with ratings of 4
39 or 5 stars.
- 40 (2) For children in vulnerable populations who are eligible for subsidized child
41 care, such as children receiving child welfare services, children experiencing
42 homelessness, children with special needs, etc., to receive subsidized child care
43 in child care facilities with ratings of 4 or 5 stars.
- 44 (3) For children currently receiving subsidized child care services who move to
45 another county within the State where there are insufficient subsidized child
46 care program funds to continue their services.
47

48 **SUBPART XII-C. DIVISION OF SOCIAL SERVICES**

1 **REQUIRE TRANSFER OF CERTAIN SERVICES TO EASTERN BAND OF CHEROKEE**
2 **INDIANS**

3 **SECTION 12C.1.(a)** Approval for the Eastern Band of Cherokee Indians to
4 administer the eligibility process for Medicaid and NC Health Choice is contingent upon federal
5 approval of State Plan amendments and Medicaid waivers by the Centers for Medicare &
6 Medicaid Services (CMS). The Department of Health and Human Services, Division of Medical
7 Assistance (DMA), shall submit any State Plan amendments and Medicaid waivers necessary for
8 the delegation of authority and administrative transfer of function to the Eastern Band of Cherokee
9 Indians or to effectuate the changes required by this section and Section 12C.3 of S.L. 2014-100.
10 All State Plan amendments and Medicaid waivers submitted as allowed under this subsection shall
11 have an effective date of April 1, 2017. DMA shall submit the State Plan amendments and waivers
12 allowed under this subsection and any related responses to CMS requests for additional
13 information to the Eastern Band of Cherokee Indians for review prior to submission to CMS. If
14 CMS does not approve the State Plan amendments and Medicaid waivers allowed by this
15 subsection, the counties shall continue serving individuals living on the federal lands held in trust
16 by the United States.

17 **SECTION 12C.1.(b)** The Department of Health and Human Services shall submit an
18 Advanced Planning Document Update (APDU) to CMS, the United States Department of
19 Agriculture (USDA), and the Administration for Children and Families (ACF). If CMS, USDA,
20 and ACF do not approve the APDU, the counties shall continue serving individuals living on the
21 federal lands held in trust by the United States.

22 **SECTION 12C.1.(c)** Section 12C.3(b) of S.L. 2014-100 reads as rewritten:

23 **"SECTION 12C.3.(b)** Beginning October 1, 2014, or upon federal approval, the Eastern
24 Band of Cherokee Indians may begin assuming the responsibility for the Supplemental Nutrition
25 Assistance Program (SNAP). When the Eastern Band of Cherokee Indians assumes responsibility
26 for SNAP, then any State statutes, portions of statutes, or rules relating to the provision of social
27 services regarding SNAP services by a county department of social services for members of the
28 Eastern Band of Cherokee Indians shall no longer apply to the Tribe, and the functions,
29 administration, and funding requirements relating to those social services are thereby delegated to
30 the Eastern Band of Cherokee Indians.

31 No later than ~~October 1, 2016~~, April 1, 2017, and with the exception of services related to
32 special assistance, childcare, and adult care homes, the Eastern Band of Cherokee Indians may
33 assume responsibility for other programs as described under G.S. 108A-25(e), enacted in
34 subsection (c) of this section. When the Eastern Band of Cherokee Indians assumes responsibility
35 for any of those other programs, then any State statutes, portions of statutes, or rules relating to
36 the provision of services for those programs by a county department of social services for members of
37 the Eastern Band of Cherokee Indians shall no longer apply to the Tribe, and the functions,
38 administration, and funding requirements relating to those programs are thereby delegated to the
39 Eastern Band of Cherokee Indians."
40

41 **ENHANCED CHILD SAFETY: FEDERAL IMPROVEMENT PLAN**
42 **IMPLEMENTATION**

43 **SECTION 12C.2.(a)** It is the intent of the Governor and the General Assembly to
44 fund eight million six hundred thousand dollars (\$8,600,000) in support of the State's federal
45 program improvement plan and other improvements for the Child Welfare System, including
46 Child Protective Services to prevent children from needing Foster Care Services and to provide
47 effective and efficient services to families who have a child served by the Foster Care program to
48 safely return the child(ren) to the family's care in their home. This multi-faceted approach includes
49 the following initiatives:

- 50 (1) Development of a comprehensive plan to provide initial and on-going training
51 and support to county staff providing Child Welfare Services. The plan shall

- 1 address (i) a system to assess the current capacity of a local agency staff, (ii)
 2 identification of a training and support action plan to address the areas
 3 identified in the assessment, and (iii) a local plan to maintain staff
 4 competencies. Further, to develop a competency and performance based Child
 5 Welfare workforce support system through contractual partnerships with public
 6 and private post-secondary schools of social work and community colleges.
 7 (2) Increase the availability and expansion of evidenced-based services to families
 8 in their own homes in order to reduce maltreatment and the likelihood of
 9 children entering care.

10 **SECTION 12C.2.(b)** The Department of Health and Human Services, Division of
 11 Social Services, shall develop a data analytics team under the direction of a project manager. The
 12 data analytics efforts will center on program and fiscal data to identify areas of strengths and
 13 opportunities for improvement in key indicators of Safety, Permanency, and Well-Being for
 14 children and families served by the Foster Care program or are at risk of entering the Foster Care
 15 program.

16
 17 **ENHANCED CHILD SAFETY: PROTECT VULNERABLE CHILDREN**

18 **SECTION 12C.3.(a)** G.S. 7B-101(3) reads as rewritten:

19 **"§ 7B-101. Definitions.**

20 As used in this Subchapter, unless the context clearly requires otherwise, the following words
 21 have the listed meanings:

- 22 ...
 23 (3) Caretaker. – Any person other than a parent, guardian, or custodian who has
 24 responsibility for the health and welfare of a juvenile in a residential setting. A
 25 person responsible for a juvenile's health and welfare means a stepparent, foster
 26 parent, an adult member of the juvenile's household, an adult relative entrusted
 27 with the juvenile's care, a potential adoptive parent during a visit or trial
 28 placement with a juvenile in the custody of a department, any person such as a
 29 house parent or cottage parent who has primary responsibility for supervising a
 30 juvenile's health and welfare in a residential child care facility or residential
 31 educational facility, or any employee or volunteer of a division, institution, or
 32 school operated by the Department of Health and Human Services. Nothing in
 33 this subdivision shall be construed to impose a legal duty of support under
 34 Chapter 50 or Chapter 110 of the General Statutes. The duty imposed upon a
 35 caretaker as defined in this subdivision shall be for the purpose of this
 36 Subchapter only."

37 **SECTION 12C.3.(b)** G.S. 7B-302(a1)(1) reads as rewritten:

38 **"§ 7B-302. Assessment by director; access to confidential information; notification of person**
 39 **making the report.**

40 ...
 41 (a1) All information received by the department of social services, including the identity of
 42 the reporter, shall be held in strictest confidence by the department, except under the following
 43 circumstances:

23 b. Chronic physical or emotional abuse.
24 c. Torture.
25 d. Abandonment.
26 e. Chronic or toxic exposure to alcohol or controlled substances that
27 causes impairment of or addiction in the juvenile.
28 f. Any other act, practice, or conduct that increased the enormity or added
29 to the injurious consequences of the abuse or neglect.
30 (2) A court of competent jurisdiction has terminated involuntarily the parental
31 rights of the parent to another child of the parent.
32 (3) A court of competent jurisdiction has determined that (i) the parent has
33 committed murder or voluntary manslaughter of another child of the parent; (ii)
34 has aided, abetted, attempted, conspired, or solicited to commit murder or
35 voluntary manslaughter of the child or another child of the parent; (iii) has
36 committed a felony assault resulting in serious bodily injury to the child or
37 another child of the parent; (iv) has committed sexual abuse against the child or
38 another child of the parent; or (v) has been required to register as a sex offender
39 on any government-administered registry."

45 **SUBPART XII-D. DIVISION OF AGING AND ADULT SERVICES**

46
47 **INCREASE ACCESS TO PUBLIC BENEFITS FOR OLDER DUAL ELIGIBLE SENIORS**
48 **PILOT PROGRAM**

49 **SECTION 12D.1.(a)** It is the intent of the Governor and the General Assembly to fund
50 and support an evidence-based pilot that will increase access to public benefits for seniors aged 65

1 and older who are enrolled in Medicare and Medicaid to improve the health and independence of
2 seniors and to reduce health care costs.

3 **SECTION 12D.1.(b)** Of the funds appropriated to the Department of Health and
4 Human Services, up to one million two hundred thousand dollars (\$1,200,000) may be used each
5 year for the next three years starting in fiscal year 2016-2017 to establish this pilot program. The
6 Department may leverage any eligible federal funding sources towards this effort.

7 **SECTION 12D.1.(c)** By January 1, 2017, the Department may partner with a
8 not-for-profit firm for the purposing of engaging in a data-driven campaign to help seniors aged 65
9 and over enrolled in Medicare and Medicaid meet their basic social needs. This partner shall have
10 demonstrated experience in this area and the partnership shall accomplish the following:

- 11 (1) Identify through data sharing, dual eligible seniors aged 65 and older who
12 qualify for the Supplemental Nutrition Assistance Program (SNAP) but are not
13 currently enrolled;
- 14 (2) Conduct an outreach program towards those seniors for the purpose of enrolling
15 them into SNAP;
- 16 (3) Provide comprehensive application assistance through outreach specialists to
17 complete public benefits application process;
- 18 (4) Evaluate project-effectiveness and explore how data can be utilized to achieve
19 optimal outcomes; and
- 20 (5) Make recommendations regarding policy options available to the State to
21 streamline access to benefits.

22 **SECTION 12D.1.(d)** The Department shall report back to the Office of the Governor
23 and the Joint Legislative Oversight Committee on Health and Human Services on its progress in
24 the pilot program by February 1 following each year the pilot program is in place. The report
25 should include:

- 26 (1) The number of seniors age 65 and older who are dual eligible but are not
27 enrolled in SNAP;
- 28 (2) The number of those identified that would be included in the sample
29 population;
- 30 (3) Methods of outreach towards those seniors in the sample population;
- 31 (4) Number of to-date enrollments in SNAP as a direct result of outreach during the
32 pilot program;
- 33 (5) Participation rate to-date in SNAP of those seniors in the sample population;
34 and
- 35 (6) Any other findings of interest.

36 **SECTION 12D.1.(e)** If funding and capacity exist, the department may expand this
37 pilot program to include other public benefit programs.

38 **SECTION 12D.1.(f)** The Department shall submit a final report with findings to the
39 Office of the Governor and the Joint Legislative Oversight Committee on Health and Human
40 Services by February 1, 2020. The final report shall include:

- 41 (1) Number of seniors reached during the pilot program;
- 42 (2) Number of applications processed during the pilot program;
- 43 (3) Number of new enrollments as a result of the pilot program;
- 44 (4) Cost per application;
- 45 (5) Total amount of public benefit distributed to the beneficiaries enrolled as a
46 result of the pilot program; and
- 47 (6) Projected reduction in health care utilization costs to the State associated with
48 hospital stays and deferred nursing home placements.

50 **SUBPART XII-E. DIVISION OF PUBLIC HEALTH**
51

PUBLIC HEALTH VECTOR CONTROL PROGRAM

SECTION 12E.1. The Department of Health and Human Services, Division of Public Health, is authorized, through funds appropriated in this act, to establish a Vector Control Program (VCP) to be housed in the Communicable Disease Branch of the Epidemiology Section. The VCP will develop infrastructure to conduct vector surveillance, characterize vector-borne disease risk, recommend appropriate control measures, evaluate the effectiveness of those measures, and provide comprehensive vector-borne disease education.

CONVERSION TO MAGI (MODIFIED ADJUSTED GROSS INCOME) FOR AIDS DRUG ASSISTANCE PROGRAM (ADAP) ELIGIBILITY DETERMINATION

SECTION 12E.2.(a) Effective January 1, 2017, the Department shall initiate the use of the Modified Adjusted Gross Income (MAGI) formula in the calculation of income for the purpose of eligibility determination for the AIDS Drug Assistance Program (ADAP), to ensure consistency with the method of eligibility determination currently used by Medicaid, Medicare, and Qualified Health Plan Subsidies.

SECTION 12E.2.(b) The Department shall use existing State appropriations, federal Ryan White funds, and 340B rebates available to it to develop and implement the conversion to MAGI for determining ADAP financial eligibility.

STATEWIDE STANDING ORDER FOR OPIOID ANTAGONIST BY STATE HEALTH DIRECTOR

SECTION 12E.3. G.S. 90-106.2 reads as rewritten:

"§ 90-106.2. Treatment of overdose with opioid antagonist; immunity.

(a) As used in this section, "opioid antagonist" means naloxone hydrochloride that is approved by the federal Food and Drug Administration for the treatment of a drug overdose.

(b) A practitioner acting in good faith and exercising reasonable care may directly or by standing order prescribe an opioid antagonist to (i) a person at risk of experiencing an opiate-related overdose or (ii) a family member, friend, or other person in a position to assist a person at risk of experiencing an opiate-related overdose. As an indicator of good faith, the practitioner, prior to prescribing an opioid under this subsection, may require receipt of a written communication that provides a factual basis for a reasonable conclusion as to either of the following:

- (1) The person seeking the opioid antagonist is at risk of experiencing an opiate-related overdose.
- (2) The person other than the person who is at risk of experiencing an opiate-related overdose, and who is seeking the opioid antagonist, is in relation to the person at risk of experiencing an opiate-related overdose:
 - a. A family member, friend, or other person.
 - b. In the position to assist a person at risk of experiencing an opiate-related overdose.

(b1) The State Health Director may prescribe an opioid antagonist pursuant to subsection (b) of this section by means of a statewide standing order. A pharmacist may dispense an opioid antagonist to a person described in subsection (b) of this section pursuant to a prescription issued in accordance with subsection (b) of this section. For purposes of this section, the term "pharmacist" is as defined in G.S. 90-85.3.

(c) A person who receives an opioid antagonist that was prescribed pursuant to subsection (b) of this section may administer an opioid antagonist to another person if (i) the person has a good faith belief that the other person is experiencing a drug-related overdose and (ii) the person exercises reasonable care in administering the drug to the other person. Evidence of the use of reasonable care in administering the drug shall include the receipt of basic instruction and information on how to administer the opioid antagonist.

1 (d) All of the following individuals are immune from any civil or criminal liability for
2 actions authorized by this section:

3 (1) ~~Any~~ The State Health Director and any practitioner who prescribes an opioid
4 antagonist pursuant to subsection (b) of this section.

5 (1a) Any pharmacist who dispenses an opioid antagonist pursuant to subsection (b1)
6 of this section.

7 (2) Any person who administers an opioid antagonist pursuant to subsection (c) of
8 this section."
9

10 **SUBPART XII-F. DIVISION OF MH/DD/SAS AND STATE OPERATED HEALTH CARE** 11 **FACILITIES**

12 **FUNDS FOR LOCAL INPATIENT PSYCHIATRIC BEDS OR BED DAYS**

13 **SECTION 12F.1.(a)** Use of Funds. – Of the funds appropriated in Section 2.1 of this
14 act to the Department of Health and Human Services, Division of Mental Health, Developmental
15 Disabilities, and Substance Abuse Services, for crisis services, the sum of forty million five
16 hundred eighty-three thousand three hundred ninety-four dollars (\$40,583,394) for the 2015-2016
17 fiscal year and the sum of forty million five hundred eighty-three thousand three hundred
18 ninety-four dollars (\$40,583,394) for the 2016-2017 fiscal year shall be used to purchase
19 additional new or existing local inpatient psychiatric beds or bed days not currently funded by or
20 through LME/MCOs. The Department shall continue to implement a two-tiered system of payment
21 for purchasing these local inpatient psychiatric beds or bed days based on acuity level with an
22 enhanced rate of payment for inpatient psychiatric beds or bed days for individuals with higher
23 acuity levels, as defined by the Department. The enhanced rate of payment for inpatient
24 psychiatric beds or bed days for individuals with higher acuity levels shall not exceed the lowest
25 average cost per patient bed day among the State psychiatric hospitals. Funds designated in this
26 subsection for the purchase of local inpatient psychiatric beds or bed days shall not be used to
27 supplant other funds appropriated or otherwise available to the Department for the purchase of
28 inpatient psychiatric services through contracts with local hospitals. No more than ten percent
29 (10%) of current recurring three-way funds may be available for use for other services across the
30 crisis service continuum (Facility-Based Crisis and Non-Hospital Detox), to increase access to
31 post acute care medications to 30 days, and to provide peer transition supports to help facilitate
32 stabilization in the community for the first few months.

33 **SECTION 12F.1.(b)** Distribution and Management of Beds or Bed Days. – The
34 Department shall work to ensure that any local inpatient psychiatric beds or bed days purchased in
35 accordance with this section are utilized solely for individuals who are medically indigent, defined
36 as uninsured persons who (i) are financially unable to obtain private insurance coverage as
37 determined by the Department and (ii) are not eligible for government-funded health coverage
38 such as Medicare or Medicaid; and distributed across the State in LME/MCO catchment areas and
39 according to need as determined by the Department. The Department shall ensure that beds or bed
40 days for individuals with higher acuity levels are distributed across the State in LME catchment
41 areas, including any catchment areas served by managed care organizations, and according to
42 greatest need based on hospital bed utilization data. The Department shall enter into contracts with
43 LME/MCOs and local hospitals for the management of these beds or bed days. The Department
44 shall work to ensure that these contracts are awarded equitably around all regions of the State.
45 LME/MCOs shall manage and control these local inpatient psychiatric beds or bed days, including
46 the determination of the specific local hospital or State psychiatric hospital to which an individual
47 should be admitted pursuant to an involuntary commitment order.

48 **SECTION 12F.1.(c)** Funds to Be Held in Statewide Reserve. – Funds appropriated to
49 the Department for the purchase of local inpatient psychiatric beds or bed days shall not be
50 allocated to LME/MCOs but shall be held in a statewide reserve at the Division of Mental Health,
51

1 Developmental Disabilities, and Substance Abuse Services, to pay for services authorized by the
2 LME/MCOs and billed by the hospitals through the LME/MCOs. LME/MCOs shall remit claims
3 for payment to the Department within 15 working days after receipt of a clean claim from the
4 hospital and shall pay the hospital within 30 working days after receipt of payment from the
5 Department.

6 **SECTION 12F.1.(d)** Ineffective LME/MCO Management of Beds or Bed Days. – If
7 the Department determines that (i) an LME/MCO is not effectively managing the beds or bed days
8 for which it has responsibility, as evidenced by beds or bed days in the local hospital not being
9 utilized while demand for services at the State psychiatric hospitals has not reduced or (ii) the
10 LME/MCO has failed to comply with the prompt payment provisions of subsection (c) of this
11 section, the Department may contract with another LME/MCO to manage the beds or bed days or,
12 notwithstanding any other provision of law to the contrary, may pay the hospital directly.

13 **SECTION 12F.1.(e)** Reporting by LME/MCOs. – The Department shall establish
14 reporting requirements for LME/MCOs regarding the utilization of these beds or bed days.

15 **SECTION 12F.1.(f)** Reporting by Department. – By no later than December 1, 2016,
16 and by no later than December 1, 2017, the Department shall report to the Joint Legislative
17 Oversight Committee on Health and Human Services and the Fiscal Research Division on all of
18 the following:

- 19 (1) A uniform system for beds or bed days purchased during the preceding fiscal
20 year from (i) funds appropriated in this act that are designated for this purpose
21 in subsection (a) of this section, (ii) existing State appropriations, and (iii) local
22 funds.
- 23 (2) Other Department initiatives funded by State appropriations to reduce State
24 psychiatric hospital use.

25 **DOROTHEA DIX HOSPITAL PROPERTY FUND AND USE OF FUNDS**

26 **SECTION 12F.2.(a)** Notwithstanding G.S. 146-30 or any other provision of law, the
27 State Controller shall transfer a total of forty-nine million eight hundred ninety-nine thousand four
28 hundred fifty-six dollars (\$49,899,456) for the 2015-2016 fiscal year from the net proceeds of the
29 sale of the Dorothea Dix Hospital property into the Dorothea Dix Hospital Property Fund
30 established in G.S. 143C-9-2(b1), as enacted by subsection (b) of this section. These funds shall be
31 available for expenditure only upon an appropriation by act of the General Assembly and do not
32 constitute an "appropriation made by law," as that phrase is used in Section 7(1) of Article V of
33 the North Carolina Constitution.

34 **SECTION 12F.2.(b)** Section 12F.7(d), (e), and (f) are repealed.

35 **SECTION 12F.2.(c)** Section 12F.7 of S.L. 2015-241 is amended by adding a new
36 subsection to read:

37 **SECTION 12F.7.(g)** Funds appropriated by act of the General Assembly to the Dorothea
38 Dix Hospital Property Fund shall be available until the purposes are fulfilled as outlined below
39 and shall be used in support of increasing availability of short-term behavioral health inpatient
40 services and care of individuals experiencing an acute mental health, substance abuse, or
41 developmental disability crisis and to carry out one-time funding recommendations of the
42 Governor's Task Force on Mental Health and Substance Use as follows:

- 43 (1) Rural Beds: Twelve million dollars (\$12,000,000) is appropriated for the
44 purpose of expanding inpatient capacity, especially in rural areas near counties
45 with limited inpatient capacity relative to their needs through constructing new
46 beds or renovating existing beds to form new inpatient psychiatric units or new
47 facility-based crisis centers, prioritizing rural hospitals in the process.
- 48 (2) Child Facility-Based Crisis: Two million dollars (\$2,000,000) is appropriated to
49 DMHDDSAS for start-up costs (renovation or construction) to establish one- or
50 two-child facility-based crisis centers, at least one of which will be in the
51

1 south/east/central region. Funds will be awarded on a competitive basis and will
 2 be available across two years because construction and renovation tends to take
 3 longer than a year.

4 (3) Veterans Housing: Two hundred fifty thousand dollars (\$250,000) is
 5 appropriated on a one-time basis to expand the TCLI and Veterans Rapid
 6 Rehousing teams and support Rapid Rehousing teams in 10 new counties with
 7 the largest populations of homeless veterans, as well as improve outreach to
 8 100,000 veterans.

9 (4) Broaden Workforce Serving Individuals Who are Deaf/Hard of Hearing: One
 10 hundred fifty thousand dollars (\$150,000) is appropriated to support six
 11 individuals who are proficient in American Sign Language to fund one
 12 behavioral health-related Master's Degree per individual that will result in
 13 licensure in the mental health and/or substance use field, and the individual will
 14 agree to provide services in North Carolina for at least three years. Scholarships
 15 will be provided on a competitive basis.

16 (5) Psychiatric Advanced Directives: Three hundred thousand dollars (\$300,000) is
 17 appropriated to DMHDDSAS to support training and dissemination of
 18 psychiatric advanced directives, which may increase the effectiveness and
 19 efficiency of crisis services, and in many cases, prevent crises.

20 (6) Mental Health First Aid: Two million five hundred thousand dollars
 21 (\$2,500,000) is appropriated to DMHDDSAS to expand Mental Health First
 22 Aid training for youth and adults.

23 (7) Local Efforts to Divert From Jail to Treatment: Three million dollars
 24 (\$3,000,000) is appropriated to DMHDDSAS to offer mini grants to local
 25 community behavioral health and justice system leaders to collaborate to
 26 address the community health and safety needs. To be eligible for funding, the
 27 county or groups of counties must have joined the Stepping Up Initiative, a
 28 national effort spearheaded by the National Association of Counties, to divert
 29 people with behavioral health disorders from jail to treatment
 30 (stepuptogether.org) and agree to use the Sequential Intercept Model as the
 31 framework for planning the interface between the justice and behavioral health
 32 systems. Using the model, a community can develop targeted strategies that
 33 evolve over time to increase diversion from the justice system and linkage to
 34 community treatment."

 36 **IMPROVE CONTROLLED SUBSTANCES REPORTING SYSTEM ACCESS AND**
 37 **UTILIZATION**

38 **SECTION 12F.3.(d)** G.S. 90-113.74(c) reads as rewritten:

39 "(c) The Department shall release data in the controlled substances reporting system to the
 40 following persons only:

41 ...
 42 (8) Any county medical examiner appointed by the Chief Medical Examiner
 43 pursuant to G.S. 130A-382 and the Chief Medical Examiner, for the purpose of
 44 investigating the death of an individual.

45 (9) The federal Drug Enforcement Administration's Office of Diversion
 46 ~~Control~~.Control, through the area Greensboro Office, and who is assigned to
 47 investigate the diversion and illegal use of prescription medication or
 48 pharmaceutical products identified in Article 5 of this Chapter of the General
 49 Statutes as Schedule II through V controlled substances and who is engaged in
 50 a bona fide specific investigation related to the enforcement of laws governing
 51 licit drugs.

- 1 (10) The North Carolina Health Information Exchange Authority (NC HIE
2 Authority), established under Article 29B of this Chapter, through Web-service
3 calls."

5 **IMPROVE CONTROLLED SUBSTANCES REPORTING SYSTEM CONTRACT**

6 **SECTION 12F.4.(a)** The Department of Health and Human Services (DHHS) shall
7 modify the contract for the Controlled Substances Reporting System (CSRS) to improve
8 performance, establish user access controls, establish data security protocols, and ensure
9 availability of data for advanced analytics. Specifically, the contract shall be modified to include
10 the following:

- 11 (1) A connection to the HIE Network administered by the North Carolina Health
12 Information Exchange Authority (NC HIE Authority).
13 (2) The establishment of interstate connectivity.
14 (3) Data security protocols that meet or exceed the Federal Information Processing
15 Standards (FIPS) established by the National Institute of Standards and
16 Technology (NIST).

17 **SECTION 12F.4.(b)** DHHS shall complete the contract modifications required by
18 subsection (f) of this section by December 31, 2015. DHHS shall report by November 15, 2015, to
19 the Joint Legislative Program Evaluation Oversight Committee and the Joint Legislative Oversight
20 Committee on Health and Human Services regarding the progress to modify the contract.

21 **SECTION 12F.4.(c)** DHHS shall apply for grant funding from the National
22 Association of Boards of Pharmacy to establish interstate connectivity. The Department shall
23 request forty thousand thirty-five dollars (\$40,035) to establish the initial interface for interstate
24 connection and thirty thousand dollars (\$30,000) for two years of ongoing service, maintenance,
25 and support for interstate connection in order to create interstate connectivity for the drug
26 monitoring program as required by subdivision (2) of subsection (a) of this section.

27 **SECTION 12F.4.(d)** Funds appropriated in this act to the Department of Health and
28 Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse
29 Services, for the CSRS shall be used as follows:

- 30 (1) For the 2015-2016 fiscal year, the sum of forty thousand thirty-five dollars
31 (\$40,035) shall be used to connect the CSRS and the HIE Network
32 administered by the NC HIE Authority, as required by subdivision (1) of
33 subsection (a) of this section.
34 (2) For the 2015-2016 fiscal year and for the 2016-2017 fiscal year, the sum of
35 fifteen thousand dollars (\$15,000) shall be used to maintain a connection
36 between the CSRS and the HIE Network administered by the NC HIE
37 Authority, as required by subdivision (1) of subsection (a) of this section.
38 (3) For the 2015-2016 fiscal year, the sum of forty thousand thirty-five dollars
39 (\$40,035) shall be used to establish the initial interface for interstate
40 connectivity, as required by subdivision (2) of subsection (a) of this section.
41 This amount shall be adjusted or eliminated if DHHS is successful in obtaining
42 grant awards or identifying other allowable receipts for this purpose. If receipts
43 are used for this purpose, this nonrecurring appropriation shall revert to the
44 General Fund.
45 (4) For the 2015-2016 fiscal year, the sum of fifteen thousand dollars (\$15,000)
46 shall be used for the cost of annual service fees for the interstate connection for
47 the drug monitoring program, as required by subdivision (2) of subsection (a) of
48 this section. This amount shall be adjusted or eliminated if DHHS is successful
49 in obtaining grant awards or identifying other allowable receipts for this
50 purpose. If receipts are used for this purpose, this nonrecurring appropriation
51 shall revert to the General Fund.

STATEWIDE STRATEGIC PLAN

SECTION 12F.5. Section 12F.16(m) of S.L. 2015-241 reads as rewritten:

"SECTION 12F.16.(m) There is hereby created the Prescription Drug Abuse Advisory Committee, to be housed in and staffed by the Department of Health and Human Services (DHHS). The Committee shall develop and, through its members, implement a statewide strategic plan to combat the problem of prescription drug abuse. The Committee shall include representatives from the following, as well as any other persons designated by the Secretary of Health and Human Services:

- (1) The Division of Medical Assistance, DHHS.
- (2) The Division of Mental Health, Developmental Disabilities, and Substance Abuse Services, DHHS.
- (3) The Division of Public Health, DHHS.
- (4) The Rural Health Section of the Division of Public Health, DHHS.
- (5) The State Bureau of Investigation.
- (6) The Attorney General's Office.
- (7) The following health care regulatory boards with oversight of prescribers and dispensers of prescription drugs:
 - a. North Carolina Board of Dental Examiners.
 - b. North Carolina Board of Nursing.
 - c. North Carolina Board of Podiatry Examiners.
 - d. North Carolina Medical Board.
 - e. North Carolina Board of Pharmacy.
- (8) The UNC Injury Prevention Research Center.
- (9) The substance abuse treatment community.
- (10) Governor's Institute on Substance Abuse, Inc.
- (11) The Department of Insurance's drug take-back program.
- (12) The Department of Public Safety (DPS), Division of Adult Correction.

After developing the strategic plan, the Committee shall be the State's steering committee to monitor achievement of strategic objectives and receive regular reports on progress made toward reducing prescription drug abuse in North Carolina."

IMPLEMENTATION OF MENTAL HEALTH AND SUBSTANCE USE TASK FORCE RECOMMENDATIONS

SECTION 12F.6.(a) Whereas the Governor's Task Force on Mental Health and Substance Use was established through Executive Order No. 76 with the purpose of submitting findings and strategic recommendations to the Governor for improving the lives of North Carolina children and adults with mental illness and substance use disorders and their families; the Governor and the General Assembly support the implementation of key recommendations that have been made by this Task Force as follows:

SECTION 12F.6.(b) The sum of thirty million dollars (\$30,000,000) is appropriated to the Department of Health and Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse Services, to address:

- (1) Emergency housing for adults diagnosed with a primary substance use disorder or serious mental illness who are transitioning out of emergency departments, correctional facilities, or institutions.
- (2) Improved connections for individuals with mental health and substance use issues by funding more proactive, regular, and often face-to-face contact and support through case management services. This case management model for adults will work closely with individuals during transition periods to create personalized plans and prevent hospitalization or interactions with the justice

1 system. For children, this type of case management will focus on those in foster
2 care, the juvenile justice system, and children with intellectual and
3 developmental disabilities.

4 (3) The State's heroin and prescription drug use epidemic by increasing access of
5 individuals and families to publicly supported Medication Assisted Treatment
6 (MAT) through the identification and implementation of comprehensive
7 strategies to improve access, quality, safety, and effectiveness in intervention,
8 treatment, and recovery services and implementation of the NC Strategic Plan
9 to Reduce Prescription Drug Abuse.

10 (4) Individuals entering the justice system whose needs are better addressed
11 through treatment by supporting therapeutic courts (mental health, substance
12 use disorder recovery, and veteran courts) and assure sustained funding of these
13 courts and their associated treatment. Further support for diversion from
14 criminal justice is provided through the LEAD program which is a pre-booking
15 jail diversion program that trains law enforcement officers to divert low level
16 drug offenders to services and treatment, rather than jail.

17 The Administrative Office of the Courts shall conduct or contract for a study to
18 develop the most effective program model, develop criteria and standards, and identify appropriate
19 judicial districts of establishing new specialty courts leveraging existing resources for such courts
20 currently operating.

21 22 **SUBPART XII-G. DIVISION OF HEALTH SERVICE REGULATION**

23 24 **MORATORIUM ON HOME CARE AGENCY LICENSES FOR IN-HOME AIDE** 25 **SERVICES**

26 **SECTION 12G.1.(a)** Section 12G.4 of S.L. 2014-100 reads as rewritten:

27 "**SECTION 12G.4.(a)** For the period commencing on the effective date July 1, 2016, of this
28 section, and ending ~~June 30, 2016, June 30, 2017~~, and notwithstanding the provisions of the Home
29 Care Agency Licensure Act set forth in Part 3 of Article 6 of Chapter 131E of the General Statutes
30 or any rules adopted pursuant to that Part, the Department of Health and Human Services shall not
31 issue any licenses for home care agencies as defined in G.S. 131E-136(2) that intend to offer
32 in-home aide services. This prohibition does not apply to companion, ~~and sitter services-sitter, and~~
33 ~~respite services~~ and shall not restrict the Department from doing any of the following:

- 34 (1) Issuing a license to a certified home health agency as defined in
35 G.S. 131E-176(12) that intends to offer in-home aide services.
36 (2) Issuing a license to an agency that needs a new license for an existing home
37 care agency being acquired.
38 (3) Issuing a license for a new home care agency in any area of the State upon a
39 determination by the Secretary of the Department of Health and Human
40 Services that increased access to care is necessary in that area."

41 **SECTION 12G.1.(b)** This section is effective when it becomes law.
42

43 **SUBPART XII-H. DIVISION OF MEDICAL ASSISTANCE (MEDICAID)**

44 45 **ACCOUNTING FOR MEDICAID RECEIVABLES AS NONTAX REVENUE**

46 **SECTION 12H.1.(a)** Receivables reserved at the end of the 2015-2016 and
47 2016-2017 fiscal years shall, when received, be accounted for as nontax revenue for each of those
48 fiscal years.

49 **SECTION 12H.1.(b)** For the 2015-2016 fiscal year, the Department of Health and
50 Human Services shall deposit from its revenues one hundred thirty-nine million dollars
51 (\$139,000,000) with the Department of State Treasurer to be accounted for as nontax revenue. For

1 the 2016-2017 fiscal year, the Department of Health and Human Services shall deposit from its
2 revenues one hundred forty-seven million dollars (\$147,000,000) with the Department of State
3 Treasurer to be accounted for as nontax revenue. These deposits shall represent the total amount of
4 the return of General Fund appropriations, nonfederal revenue, fund balances, or other resources
5 from State-owned and State-operated hospitals which are used to provide indigent and nonindigent
6 care services. The return from State-owned and State-operated hospitals to DHHS will be made
7 from nonfederal resources in an amount equal to the amount of the payments from the Division of
8 Medical Assistance for uncompensated care. The treatment of any revenue derived from federal
9 programs shall be in accordance with the requirements specified in the Code of Federal
10 Regulations, Title 2, Part 225.

11 12 **AUTISM SPECTRUM DISORDER SERVICES FOR MEDICAID BENEFICIARIES**

13 **SECTION 12H.2.(a)** The Department of Health and Human Services shall issue clear
14 guidance to the local management entities/managed care organizations (LME/MCOs) to ensure
15 that children with Autism Spectrum Disorder receive consistent statewide services under Early and
16 Periodic Screening, Diagnostic, and Treatment program, immediately upon the effective date of
17 this act.

18 **SECTION 12H.2.(b)** The Department of Health and Human Services shall submit a
19 Medicaid State Plan Amendment to the CMS to include treatment of Autism Spectrum Disorder
20 for Medicaid beneficiaries as a covered service effective July 1, 2017.

21 **SECTION 12H.2.(c)** The State plan amendment submitted to implement this section
22 shall not be subject to the 90-day prior submission requirement of G.S. 108A-54.1A(d).

23 24 **EXPAND INNOVATIONS WAIVER SLOT AVAILABILITY**

25 **SECTION 12H.3.** In order to achieve cost-savings, improve health outcomes, and
26 allow individuals who meet the requirements for an Intermediate Care Facility for Individuals with
27 Intellectual Disabilities (ICF-IID) level of care to receive services in the least restrictive setting
28 possible, the Department of Health and Human Services, Division of Medical Assistance, shall
29 expand the Innovations Waiver by an additional 250 slots for State Fiscal Year 2016-2017.

30 31 **MEDICAID ESTATE RECOVERY AND ABLE ACCOUNTS**

32 **SECTION 12H.4.** G.S. 147-86.53(g) reads as rewritten:

20 fingerprinting, of provider applicants—applicants, and enrolled providers—providers, and individuals

22 subject to G.S. 108C-3(g) in accordance with federal law and regulation.

50 unless the Division determines that denial or termination of enrollment is not in the best interests
51 of Medicaid and the State Medicaid agency documents that determination in writing. The

1 Department shall honor civil and criminal settlement agreements entered into with a provider or
2 any person with a five percent (5%) or greater direct or indirect ownership interest in the provider
3 within 10 years of the effective date of this act.

4 (c) The Division may deny enrollment or terminate the enrollment of a provider subject to
5 G.S. 108C-3(g) for any of the following offenses of the provider, an owner and/or operator, or
6 employee if, after review of the seriousness, age, and other circumstances involving the offense,
7 the Division determines it is in the best interest of the integrity of Medicaid or Health Choice to do
8 so: any criminal offenses as set forth in any of the following Articles of Chapter 14 of the General
9 Statutes: Article 5, Counterfeiting and Issuing Monetary Substitutes; Article 5A, Endangering
10 Executive, Legislative, and Court Officers; Article 6, Homicide; Article 7B, Rape and Other Sex
11 Offenses; Article 8, Assaults; Article 10, Kidnapping and Abduction; Article 13, Malicious Injury
12 or Damage by Use of Explosive or Incendiary Device or Material; Article 14, Burglary and Other
13 Housebreakings; Article 15, Arson and Other Burnings; Article 16, Larceny; Article 17, Robbery;
14 Article 18, Embezzlement; Article 19, False Pretenses and Cheats; Article 19A, Obtaining
15 Property or Services by False or Fraudulent Use of Credit Device or Other Means; Article 19B,
16 Financial Transaction Card Crime Act; Article 20, Frauds; Article 21, Forgery; Article 26,
17 Offenses Against Public Morality and Decency; Article 26A, Adult Establishments; Article 27,

- 45 3. Holds a PHP license issued by the Department of Insurance.
- 46 (3) Capitated contracts. – The Division of Health Benefits, created in Section 10 of
47 this act, shall enter into capitated contracts with PHPs for the delivery of
48 Medicaid and NC Health Choice services as specified in this act. All capitated
49 contracts shall be the result of requests for proposals (RFPs) issued by the
50 Division of Health Benefits and the submission of competitive bids by PHPs,
51 pursuant to subdivision (6) of Section 5 of this act.

- 1 (4) Services covered by PHPs. – Capitated PHP contracts shall cover all Medicaid
 2 and NC Health Choice services, including physical health services, prescription
 3 drugs, long-term services and supports, and behavioral health services for NC

 18 f. Services for Medicaid program applicants during the three month
 19 retroactive eligibility period authorized by 42 U.S.C. § 1902(a)(34).
 20 Services covered during a prospective, 12-month continuous enrollment
 21 period shall be covered by the capitated contracts.
 22 (5) Populations covered by PHPs. – Capitated PHP contracts shall cover all
 23 Medicaid and NC Health Choice program aid categories except recipients who
 24 ~~are dually~~ are:
 25 a. Dually eligible for Medicaid and Medicare.
 26 b. Qualified aliens subject to the five-year bar for means-tested public
 27 assistance under 8 U.S.C. § 1613 who qualify for emergency services
 28 under 8 U.S.C. § 1611.
 29 c. Undocumented aliens who qualify for emergency services under 8
 30 U.S.C. § 1611.
 31 d. Medically needy Medicaid recipients.
 32 e. Members of federally recognized tribes. – Members of federally
 33 recognized tribes shall have the option to enroll voluntarily in PHPs.
 34 f. Presumptively eligible. – Individuals who submit a full Medicaid
 35 application and qualify for Medicaid program eligibility shall be
 36 covered by capitated contracts during a prospective, 12-month
 37 continuous enrollment period.
 38 g. North Carolina Health Insurance Premium Payment program (NC
 39 HIPP).
 40 Recipients in the aged program aid category that are eligible for Medicare shall
 41 be considered recipients who are dually eligible for Medicaid and Medicare.
 42 The Division of Health Benefits shall develop a long-term strategy to cover
 43 dual eligibles through capitated PHP contracts, as required by subdivision (11)
 44 of Section 5 of this act.
 45 (6) Number and nature of capitated PHP contracts. – The number and nature of the
 46 contracts required under subdivision (3) of this section shall be as follows:
 47 a. Three contracts between the Division of Health Benefits and PHPs to
 48 provide coverage to Medicaid and NC Health Choice recipients
 49 statewide (statewide contracts).
 50 b. Up to ~~10~~12 contracts between the Division of Health Benefits and PLEs
 51 for coverage of regions specified by the Division of Health Benefits

1 pursuant to subdivision (2) of Section 5 of this act (regional contracts).
2 Regional contracts shall be in addition to the three statewide contracts
3 required under sub-subdivision a. of this subdivision. Each regional
4 contract shall provide coverage throughout the entire region for the
5 Medicaid and NC Health Choice services required by subdivision (4) of
6 this section. A PLE may bid for more than one regional contract,
7 provided that the regions are contiguous.

8 c. Initial capitated PHP contracts may be awarded on staggered terms of
9 three to five years in duration to ensure against gaps in coverage that
10 may result from termination of a contract by the PHP or the State.

11 (6a) To the extent allowed by Medicaid federal law and regulations and consistent
12 with the requirements of this act, PHPs shall comply with the requirements of
13 Chapter 58 of the General Statutes. This requirement shall not be construed to
14 require PHPs to cover services that are not covered by the Medicaid program
15 pursuant to federal law and regulations. The Department of Health and Human
16 Services, Division of Health Benefits, and the Department of Insurance shall
17 jointly review the applicability of provisions of Chapter 58 of the General
18 Statutes to PHPs, and report to the Joint Legislative Oversight Committee on
19 Medicaid and NC Health Choice by March 1, 2016, on the following:

20 a. Proposed exceptions to the applicability of Chapter 58 of the General
21 Statutes for PHPs.

22 b. Recommendations for resolving conflicts between Chapter 58 of the
23 General Statutes and the requirements of Medicaid federal law and

26 (7) Defined measures and goals. – The new delivery system and capitated PHP
27 contracts shall be built on defined measures and goals for risk-adjusted health
28 outcomes, quality of care, patient satisfaction, access, and cost. Each
29 component shall be subject to specific accountability measures, including
30 penalties. The Division of Health Benefits may use organizations such as
31 National Committee for Quality Assurance (NCQA), Physician Consortium for
32 Performance Improvement (PCPI), or any others necessary to develop effective
33 measures for outcomes and quality.

34 (8) Administrative functions. – PHPs shall be responsible for all administrative
35 functions for recipients enrolled in their plan, including, but not limited to,
36 claims processing, care and case management, grievances and appeals, and
37 other necessary administrative services.

38 (9) LME/MCOs. – LME/MCOs shall continue to manage the behavioral health
39 services currently covered for their enrollees under all existing waivers,
40 including the 1915(b) and (c) waivers, for four years after the date capitated
41 PHP contracts begin. During this four-year period, the Division of Health
42 Benefits shall continue to negotiate actuarially sound capitation rates directly
43 with the LME/MCOs in the same manner as currently utilized. Capitation
44 payments under contracts between the Division of Health Benefits and the
45 LME/MCOs shall be made directly to the LME/MCO by the Division of Health
46 Benefits during the four-year period."

 6 Department of Health and Human Services to use up to four cents (4¢) per exchange access line

GENERAL PROVISIONS

16 **SECTION 12J.1.(b)** Information to Be Included in Block Grant Plans. – The
 17 Department of Health and Human Services shall submit a separate plan for each Block Grant
 18 received and administered by the Department, and each plan shall include the following:

- 19 (1) A delineation of the proposed allocations by program or activity, including
 20 State and federal match requirements.
- 21 (2) A delineation of the proposed State and local administrative expenditures.
- 22 (3) An identification of all new positions to be established through the Block Grant,
 23 including permanent, temporary, and time-limited positions.
- 24 (4) A comparison of the proposed allocations by program or activity with two prior
 25 years' program and activity budgets and two prior years' actual program or
 26 activity expenditures.
- 27 (5) A projection of current year expenditures by program or activity.
- 28 (6) A projection of federal Block Grant funds available, including unspent federal
 29 funds from the current and prior fiscal years.

30 **SECTION 12J.1.(c)** Changes in Federal Fund Availability. – If the Congress of the
 31 United States increases the federal fund availability for any of the Block Grants or contingency
 32 funds and other grants related to existing Block Grants administered by the Department of Health
 33 and Human Services from the amounts appropriated in this section, the Department shall allocate
 34 the increase proportionally across the program and activity appropriations identified for that Block
 35 Grant in this section. In allocating an increase in federal fund availability, the Office of State
 36 Budget and Management shall not approve funding for new programs or activities not
 37 appropriated in this section.

38 If the Congress of the United States decreases the federal fund availability for any of
 39 the Block Grants or contingency funds and other grants related to existing Block Grants
 40 administered by the Department of Health and Human Services from the amounts appropriated in
 41 this section, the Department shall develop a plan to adjust the block grants based on reduced
 42 federal funding.

43 Notwithstanding the provisions of this subsection, for fiscal years 2013-2014 and
 44 2014-2015, increases in the federal fund availability for the Temporary Assistance to Needy
 45 Families (TANF) Block Grant shall be used only for the North Carolina Child Care Subsidy
 46 program to pay for child care in four- or five-star rated facilities for four-year-old children and
 47 shall not be used to supplant State funds.

48 Prior to allocating the change in federal fund availability, the proposed allocation must
 49 be approved by the Office of State Budget and Management. If the Department adjusts the
 50 allocation of any Block Grant due to changes in federal fund availability, then a report shall be

1 made to the Joint Legislative Oversight Committee on Health and Human Services, the Joint
2 Legislative Commission on Governmental Operations, and the Fiscal Research Division.

3 **SECTION 12J.1.(d)** Except as otherwise provided, appropriations from federal Block
4 Grant funds are made for each year of the fiscal biennium ending June 30, 2015, according to the
5 schedule enacted for State fiscal years 2013-2014 and 2014-2015 or until a new schedule is
6 enacted by the General Assembly.

7 **SECTION 12J.1.(e)** All changes to the budgeted allocations to the Block Grants or
8 contingency funds and other grants related to existing Block Grants administered by the
9 Department of Health and Human Services that are not specifically addressed in this section shall
10 be approved by the Office of State Budget and Management, and the Office of State Budget and
11 Management shall consult with the Joint Legislative Commission on Governmental Operations for
12 review prior to implementing the changes. The report shall include an itemized listing of affected
13 programs, including associated changes in budgeted allocations. All changes to the budgeted
14 allocations to the Block Grants shall be reported immediately to the Joint Legislative Oversight
15 Committee on Health and Human Services and the Fiscal Research Division. This subsection does
16 not apply to Block Grant changes caused by legislative salary increases and benefit adjustments.

17 **SECTION 12J.1.(e1)** Except as otherwise provided, the Department of Health and
18 Human Services shall have flexibility to transfer funding between the Temporary Assistance to
19 Needy Families (TANF) Block Grant and the TANF Emergency Contingency Funds Block Grant
20 so long as the total allocation for the line items within those block grants remains the same.

21 22 **TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) FUNDS**

23 **SECTION 12J.1.(f)** The sum of eighty-two million four hundred eighty-five thousand
24 four hundred ninety-five dollars (\$82,485,495) appropriated in this section in TANF funds to the
25 Department of Health and Human Services, Division of Social Services, for each year of the
26 2013-2015 fiscal biennium shall be used for Work First County Block Grants. The Division shall
27 certify these funds in the appropriate State-level services based on prior year actual expenditures.
28 The Division has the authority to realign the authorized budget for these funds among the
29 State-level services based on current year actual expenditures.

30 **SECTION 12J.1.(g)** The sum of two million four hundred eighty-two thousand two
31 hundred sixty dollars (\$2,482,260) appropriated in this section in TANF funds to the Department
32 of Health and Human Services, Division of Social Services, for each year of the 2013-2015 fiscal
33 biennium shall be used to support administration of TANF-funded programs.

34 **SECTION 12J.1.(h)** The sum of nine million four hundred twelve thousand three
35 hundred ninety-one dollars (\$9,412,391) appropriated in this section to the Department of Health
36 and Human Services, Division of Social Services, in TANF funds for each year of the 2013-2015
37 fiscal biennium for child welfare improvements shall be allocated to the county departments of
38 social services for hiring or contracting staff to investigate and provide services in Child Protective
39 Services cases; to provide foster care and support services; to recruit, train, license, and support
40 prospective foster and adoptive families; and to provide interstate and post-adoption services for
41 eligible families.

42 Counties shall maintain their level of expenditures in local funds for Child Protective
43 Services workers. Of the Block Grant funds appropriated for Child Protective Services workers,
44 the total expenditures from State and local funds for fiscal years 2014-20164 and 2014-2015 shall
45 not be less than the total expended from State and local funds for the 2012-2013 fiscal year.

46 **SECTION 12J.1.(i)** The sum of two million twenty-six thousand eight hundred
47 seventy-seven dollars (\$2,026,877) appropriated in this section in TANF funds to the Department
48 of Health and Human Services, Special Children Adoption Fund, for each year of the 2013-2015
49 fiscal biennium shall be used in accordance with G.S. 108A-50.2. The Division of Social Services,
50 in consultation with the North Carolina Association of County Directors of Social Services and
51 representatives of licensed private adoption agencies, shall develop guidelines for the awarding of

1 funds to licensed public and private adoption agencies upon the adoption of children described in
2 G.S. 108A-50 and in foster care. Payments received from the Special Children Adoption Fund by
3 participating agencies shall be used exclusively to enhance the adoption services program. No
4 local match shall be required as a condition for receipt of these funds.

5 **SECTION 12J.1.(j)** The sum of six hundred thirty-two thousand four hundred sixteen
6 dollars (\$632,416) appropriated in this section to the Department of Health and Human Services in
7 TANF funds for each year of the 2013-2015 fiscal biennium shall be used to continue support for
8 the Child Welfare Collaborative.

9
10 **SOCIAL SERVICES BLOCK GRANT**

11 **SECTION 12J.1.(k)** The sum of twenty-nine million four hundred twenty-two
12 thousand one hundred thirty-seven dollars (\$29,422,137) appropriated in this section in the Social
13 Services Block Grant to the Department of Health and Human Services, Division of Social
14 Services, for the 2013-2014 fiscal year and the sum of twenty-seven million four hundred
15 twenty-seven thousand fifteen dollars (\$27,427,015) appropriated in this section in the Social
16 Services Block Grant for the 2014-2015 fiscal year shall be used for county block grants. The
17 Division shall certify these funds in the appropriate State-level services based on prior year actual
18 expenditures. The Division has the authority to realign the authorized budget for these funds
19 among the State-level services based on current year actual expenditures.

20 **SECTION 12J.1.(l)** The sum of one million three hundred thousand dollars
21 (\$1,300,000) appropriated in this section in the Social Services Block Grant to the Department of
22 Health and Human Services, Division of Social Services, for each year of the 2013-2015 fiscal
23 biennium shall be used to support various child welfare training projects as follows:

- 24 (1) Provide a regional training center in southeastern North Carolina.
- 25 (2) Provide training for residential child caring facilities.
- 26 (3) Provide for various other child welfare training initiatives.

27 **SECTION 12J.1.(m)** The Department of Health and Human Services is authorized,
28 subject to the approval of the Office of State Budget and Management, to transfer Social Services
29 Block Grant funding allocated for departmental administration between divisions that have
30 received administrative allocations from the Social Services Block Grant.

31 **SECTION 12J.1.(n)** Social Services Block Grant funds appropriated for the Special
32 Children's Adoption Incentive Fund will require a fifty percent (50%) local match.

33 **SECTION 12J.1.(o)** The sum of five million forty thousand dollars (\$5,040,000)
34 appropriated in this section in the Social Services Block Grant for each year of the 2013-2015
35 fiscal biennium shall be allocated to the Department of Health and Human Services, Division of
36 Social Services. The Division shall allocate these funds to local departments of social services to
37 replace the loss of Child Protective Services State funds that are currently used by county
38 government to pay for Child Protective Services staff at the local level. These funds shall be used
39 to maintain the number of Child Protective Services workers throughout the State. These Social
40 Services Block Grant funds shall be used to pay for salaries and related expenses only and are
41 exempt from 10A NCAC 71R .0201(3) requiring a local match of twenty-five percent (25%).

42 **SECTION 12J.1.(p)** The sum of three million eight hundred fifty-two thousand five
43 hundred dollars (\$3,852,500) appropriated in this section in the Social Services Block Grant to the
44 Department of Health and Human Services, Division of Central Management and Support, shall
45 be used for DHHS competitive block grants pursuant to Section 12A.2 of this act for each year of
46 the 2013-2015 fiscal biennium. These funds are exempt from the provisions of 10A NCAC 71R
47 .0201(3).

48 **SECTION 12J.1.(q)** The sum of three hundred seventy-five thousand dollars
49 (\$375,000) appropriated in this section in the Social Services Block Grant for each year of the
50 2013-2015 fiscal biennium to the Department of Health and Human Services, Division of Social

1 Services, shall be used to continue support for the Child Advocacy Centers and are exempt from
2 the provisions of 10A NCAC 71R .0201(3).

3 **SECTION 12J.1.(r)** The sum of three million nine hundred seventy-eight thousand
4 three hundred sixty dollars (\$3,978,360) appropriated in this section in the Social Services Block
5 Grant for each year of the 2013-2015 fiscal biennium to the Department of Health and Human
6 Services, Divisions of Social Services and Aging and Adult Services, shall be used for
7 guardianship services pursuant to Chapter 35A of the General Statutes. The Department may
8 expend funds appropriated in this section to support (i) existing corporate guardianship contracts
9 during the 2013-2014 and 2014-2015 fiscal years and (ii) guardianship contracts transferred to the
10 State from local management entities or managed care organizations during the 2013-2014 and
11 2014-2015 fiscal years.

12 **LOW-INCOME HOME ENERGY ASSISTANCE BLOCK GRANT**

13 **SECTION 12J.1.(s)** Additional emergency contingency funds received may be
14 allocated for Energy Assistance Payments or Crisis Intervention Payments without prior
15 consultation with the Joint Legislative Commission on Governmental Operations. Additional
16 funds received shall be reported to the Joint Legislative Commission on Governmental Operations
17 and the Fiscal Research Division upon notification of the award. The Department of Health and
18 Human Services shall not allocate funds for any activities, including increasing administration,
19 other than assistance payments, without prior consultation with the Joint Legislative Commission
20 on Governmental Operations.

21 **SECTION 12J.1.(t)** The sum of fifty million eight hundred seventy-six thousand four
22 hundred forty dollars (\$50,876,440) appropriated in this section in the Low-Income Home Energy
23 Assistance Block Grant for each year of the 2013-2015 fiscal biennium to the Department of
24 Health and Human Services, Division of Social Services, shall be used for energy assistance
25 payments for the households of (i) elderly persons age 60 and above with income up to one
26 hundred thirty percent (130%) of the federal poverty level and (ii) disabled persons eligible for
27 services funded through the Division of Aging and Adult Services.

28 County departments of social services shall submit to the Division of Social Services
29 an outreach plan for targeting households with 60-year-old household members no later than
30 August 1 of each year. The outreach plan shall comply with the following:

- 31 (1) Ensure that eligible households are made aware of the available assistance with
32 particular attention paid to the elderly population age 60 and above and
33 disabled persons receiving services through the Division of Aging and Adult
34 Services.
- 35 (2) Include efforts by the county department of social services to contact other
36 State and local governmental entities and community-based organizations to (i)
37 offer the opportunity to provide outreach and (ii) receive applications for
38 energy assistance.
- 39 (3) Be approved by the local board of social services or human services board prior
40 to submission.

41 **CHILD CARE AND DEVELOPMENT FUND BLOCK GRANT**

42 **SECTION 12J.1.(u)** Payment for subsidized child care services provided with federal
43 TANF funds shall comply with all regulations and policies issued by the Division of Child
44 Development for the subsidized child care program.

45 **SECTION 12J.1.(v)** If funds appropriated through the Child Care and Development
46 Fund Block Grant for any program cannot be obligated or spent in that program within the
47 obligation or liquidation periods allowed by the federal grants, the Department may move funds to
48 child care subsidies, unless otherwise prohibited by federal requirements of the grant, in order to
49 use the federal funds fully.
50
51

SUBSTANCE ABUSE PREVENTION AND TREATMENT BLOCK GRANT

SECTION 12J.1.(v1) The sum of two hundred fifty thousand dollars (\$250,000) appropriated in this section in the Substance Abuse Prevention and Treatment Block Grant to the Department of Health and Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse Services, for the 2014-2015 fiscal year shall be allocated to the Department of Administration, Division of Veterans Affairs, to establish a call-in center to assist veterans in locating service benefits and crisis services. The call-in center shall be staffed by certified veteran peers within the Division of Veterans Affairs and trained by the Division of Mental Health, Developmental Disabilities, and Substance Abuse Services.

MATERNAL AND CHILD HEALTH BLOCK GRANT

SECTION 12J.1.(w) If federal funds are received under the Maternal and Child Health Block Grant for abstinence education, pursuant to section 912 of Public Law 104-193 (42 U.S.C. § 710), for the 2013-2014 fiscal year or the 2014-2015 fiscal year, then those funds shall be transferred to the State Board of Education to be administered by the Department of Public Instruction. The Department of Public Instruction shall use the funds to establish an abstinence until marriage education program and shall delegate to one or more persons the responsibility of implementing the program and G.S. 115C-81(e1)(4) and (4a). The Department of Public Instruction shall carefully and strictly follow federal guidelines in implementing and administering the abstinence education grant funds.

MENTAL HEALTH SERVICES BLOCK GRANT

SECTION 12J.1.(y) The sum of six hundred forty-three thousand four hundred ninety-one dollars (\$643,491) appropriated in this section in the Mental Health Services Block Grant to the Department of Health and Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse Services for each year of the 2015-2017 fiscal biennium is allocated for Mental Health Services First Psychotic Symptom Treatment. The Division shall report on (i) the specific evidence-based treatment and services provided, (ii) the number of persons treated, and (iii) the measured outcomes or impact on the participants served. The Division shall report to the House of Representatives Appropriations Committee on Health and Human Services, the Senate Appropriations Committee on Health and Human Services, and the Fiscal Research Division no later than December 31, 2016.

PART XIII. DEPARTMENT OF AGRICULTURE**AGWRAP CLARIFICATION**

27 (d) Report. – The Department shall submit to the House and Senate appropriations

29 Division by September 30 of each year a report on the State Parks Fund that shall include the
30 source and amounts of all funds credited to the Fund and the purpose and amount of all
31 expenditures from the Fund during the prior fiscal year."

34 risk veterans in the State.

36 providing up to one million dollars (\$1,000,000) in the 2016
37 2017 fiscal year to be used to fund a loan fund for site,
38 infrastructure, and building development. Program income
39 generated from awards made from the loan fund shall be
40 captured in the existing CDBG revolving loan fund.

41 b. Five hundred thousand dollars (\$500,000) for existing CDBG programs
42 that encounter cost overruns.

43 c. Up to seven hundred fifty thousand dollars (\$750,000) for providing
44 training and guidance to local governments relative to the CDBG

42 disputed boundary, they may cause the boundary to be surveyed, marked, and mapped. The
43 counties may appoint special commissioners to supervise the surveying, marking, and mapping. A
44 commissioner so appointed or a person surveying or marking the boundary may enter upon private
45 property to view and survey the boundary or to erect boundary markers. Upon ratification of the
46 survey by the board of commissioners of each county, a map showing the surveyed boundary shall
47 be recorded in the office of the register of deeds of each county in the manner provided by law for
48 the recordation of maps or plats and in the Secretary of State's office. The map shall contain a
49

1 reference to the date of each resolution of ratification and to the page in the minutes of each board
 2 of commissioners where the resolution may be found. Upon recordation, the map is conclusive as
 3 to the location of the boundary. Upon reestablishing all or some portion of a county boundary, and
 4 if after NCGS submits the results of the survey to the requesting counties and the requesting
 5 counties have not ratified the reestablished boundary within one year of receiving the (map)
 6 survey plat denoting the location of the reestablished boundary, the survey plat will become
 7 conclusive as to the location of the boundary and will be recorded in the Register of Deeds in each
 8 affected county and in the Secretary of State's office.

 11 (a), above, ~~by those boundaries defined by natural monuments such as rivers, streams, and~~

 13 ~~said natural monuments are visible~~, which base maps show the monuments of the United States
 14 Geological Survey and North Carolina State Plane Coordinate System established pursuant to
 15 Chapter 102 of the General Statutes. The Orthophotography shall be prepared in compliance with
 16 the States' adopted orthophotography standard. Upon ratification of the location of the boundary
 17 determined from orthophotography by the board of commissioners of each county, the map
 18 showing the boundary and the monuments of the United States Geological Survey and North
 19 Carolina State Plane Coordinate System shall be recorded in the Office of the Register of Deeds of
 20 each county and in the Secretary of State's office. The map shall contain a reference to the date of
 21 each resolution of ratification and to the page in the minutes of each board of commissioners
 22 where the resolution may be found. Upon recordation, the map is conclusive as to the location of
 23 the boundary.

 38 Management System (SRRMS) established pursuant to G.S. 115C-105.49A.
 39 These plans are not a public record as the term "public record" is defined under
 40 G.S. 132-1 and shall not be subject to inspection and examination under
 41 G.S. 132-6."

44 (a) At least once annually, each local school administrative unit shall ~~require each school~~

 49 ~~include local law enforcement agencies and emergency management agencies in their tabletop~~
 50 ~~exercises and drills. The purpose of the tabletop exercises and drills shall be to permit participants~~
 51 ~~to (i) conduct a coordinated school system-wide table top exercise for the purpose of enabling~~

1 schools to (i) view the curriculum and video provided statewide by the NC Center for Safer
2 Schools entitled Critical Incident Response for School Faculty and Staff, (ii) discuss simulated
3 emergency situations in a low-stress environment, ~~(iii)~~-(iii) clarify their roles and responsibilities
4 and the overall logistics of dealing with an emergency, and ~~(iii)~~-(iv) identify areas in which the
5 SRMP needs to be modified. The table top shall test documented procedures associated with, but
6 not limited to, a school lockdown due to an intruder on school grounds. During the table top, each
7 school system is encouraged to test procedures associated with other hazards included in its
8 SRMP. Participants of the table top should include local school unit administrators, school
9 principals, and/or their designees. Schools are strongly encouraged to include local law
10 enforcement and emergency management agencies in their tabletop exercises. Schools may utilize
11 digital conferencing technology to alleviate the need for travel by participants.

12 (b) At least once annually, each local school administrative unit shall ensure that each
13 school under its control shall conduct a drill on a lockdown due to an intruder on school grounds.
14 The purpose of this drill is to apply responses and practices learned from Critical Incident
15 Response for School Faculty and Staff Training that is supported and made available through the
16 NC Center for Safer Schools.

17 ~~(b)(c)~~ For the purposes of this section, a tabletop exercise is an exercise involving key
18 personnel conducting simulated scenarios related to emergency planning. table top is a school-wide
19 simulated emergency for purposes of emergency planning and coordination.

20 ~~(e)(d)~~ For the purposes of this section, a drill is a school-wide school-specific practice
21 exercise in which simulated scenarios related to emergency planning are conducted.

22 ~~(d)(e)~~ The Department of Public Safety, Division of Emergency Management, and the Center
23 for Safer Schools shall provide guidance and recommendations to local school administrative units
24 on the types of multiple hazards to plan and respond to, including intruders on school grounds."

25 **SECTION 17B.1.(c)** G.S. 115C-105.52 reads as rewritten:

37 **SECTION 24.2.(c)** G.S. 20-9.1(c) reads as rewritten:

 43 acting in good faith and without malice. In any proceeding involving liability, good faith and lack
 44 of malice are presumed."

45 **SECTION 24.2.(d)** G.S. 20-15(a) reads as rewritten:

46 "(a) The Division shall have authority to cancel any driver's license upon determining any
 47 of the following:

48 (1) The licensee was not entitled to the issuance of the license under this Chapter.

49 ...

50 (4) The licensee has failed to submit the certificate required as a condition of
 51 licensure under G.S. 20-7(e) or G.S. 20-9(g).

(5) The licensee suffers from a physical or mental disability or disease that affects his or her ability to safely operate a commercial or noncommercial motor vehicle as determined by applicable State and federal statutes and regulations."

ELIMINATE SPECIAL REGISTRATION FEE FOR CERTAIN MILITARY LICENSE PLATES

SECTION 24.3. G.S. 20-79.7(a1) reads as rewritten:

CONTINUATION REVIEW OF CERTAIN FUNDS/PROGRAMS/DIVISIONS

SECTION 24.5.(a) According to Section 6.20 of S.L. 2015-241, certain funding of select funds, agencies, divisions, and programs financed by State government were subject to the Continuation Review Program, which is intended to assist decision-makers in determining whether to continue, reduce, or eliminate funding for the funds, agencies, divisions, and programs subject to continuation review.

SECTION 24.5.(b) Section 6.20(b) of S.L. 2015-241 reads as rewritten:

"**SECTION 6.20.(b)** The Senate Appropriations/Base Budget Committee and the House of Representatives Appropriations Committee may review the funds, programs, divisions, and transfers from the Highway Fund listed in this section and shall determine whether to continue, reduce, or eliminate these funds, programs, divisions, and transfers from the Highway Fund, subject to the Continuation Review Program. The Fiscal Research Division may issue instructions to the State departments and agencies subject to continuation review regarding the expected content and format of the reports required by this section. The following funds, agencies, divisions, programs, and transfers from the Highway Fund are subject to continuation ~~review~~ as provided in this section: review, as well as recommended amounts of funding for fiscal year 2016-2017, are:

- (1) Funds, agencies, divisions, and programs financed by transfers from the Highway Fund:
 - a. Department of ~~Environment and Natural Resources~~ Environmental Quality –
 - 1. Commercial Leaking Petroleum Underground Storage Tank Cleanup ~~Fund~~ Fund–\$20,600,000.
 - 2. Division of Air Quality Inspection and Maintenance ~~Fees~~ Fees–\$2,000,000.
 - 3. Division of Air Quality Water and Air Quality ~~Account~~ Account–\$7,299,805.
 - 4. ~~Shallow Draft Navigation Channel Dredging and Lake Maintenance Fund.~~

1 **"SECTION 30.8.(b)** Salaries and Related Benefits for Positions That Are Funded. –

2 (1) Partially from the General Fund or Highway Fund and partially from sources
3 other than the General Fund or Highway Fund shall be increased from the
4 General Fund or Highway Fund appropriation only to the extent of the
5 proportionate part of the salaries paid from the General Fund or Highway Fund.

6 (2) Fully from sources other than the General Fund or Highway Fund shall be
7 increased as provided by this act. The Director of the Budget may increase
8 expenditures of receipts from these sources by the amount necessary to provide
9 the legislative increase to receipt-supported personnel in the certified budget.

10 **"SECTION 30.8.(c)** Except as otherwise provided, the salary increases provided in this act do
11 not apply to persons separated from State service due to resignation, dismissal, reduction in force,
12 death, or retirement, or whose last workday is prior to July 1, ~~2015~~2016.

13 **"SECTION 30.8.(d)** Employees shall receive the statutory increases provided by
14 G.S. 20-187.3, 7A-102, and 7A-171.1. Notwithstanding G.S. 20-187.3, the increases authorized by
15 that statute for members of the State Highway Patrol become effective ~~January~~July 1, 2016.
16 Notwithstanding any provision of law to the contrary, the salary increases authorized on the
17 employee anniversary date by G.S. 7A-171.1 for magistrates and G.S. 7A-102 for assistant and
18 deputy clerks of superior court shall become effective ~~January~~July 1, 2016.

19 **"SECTION 30.8.(e)** Payroll checks issued to employees after July 1, ~~2015~~2016, that
20 represent payment of services provided prior to July 1, ~~2015~~2016, shall not be eligible for salary
21 increases provided for in this act. This subsection applies to all employees paid from State funds,
22 whether or not subject to or exempt from the North Carolina Human Resources Act, including
23 employees of public schools, community colleges, and The University of North Carolina.

24 **"SECTION 30.8.(f)** Nothing in this act authorizes the transfer of funds between the General
25 Fund and the Highway Fund for salary increases."

28 **SECTION 25.4.(a)** Section 30.12A(b) of S.L. 2015-241 reads as rewritten:

29 **"SECTION 30.12A.(b)** The following salary increases shall be awarded from funds available
30 in the Salary Adjustment Fund for the 2015-2017 fiscal biennium, as follows:

31 (1) To increase the salary of the Secretary of Military and Veterans Affairs, the
32 sum of thirty-three thousand seven hundred forty-nine dollars (\$33,749).

33 (2) To increase the salary of the Transportation Museum Director, the sum of thirty
34 thousand seven hundred fifteen dollars (\$30,715).

35 (3) To increase the salaries of the State Capitol Police, a sum not to exceed one
36 hundred thousand dollars (\$100,000)."

37 **SECTION 25.4.(b)** Section 30.12A(c) of S.L. 2015-241 reads as rewritten:

38 **"SECTION 30.12A.(c)** The Director of the Budget shall ~~consult with~~report to the Joint
39 Legislative Commission on Governmental Operations prior to transferring any salary adjustment
40 funds for any State agency. No increases from the Salary Adjustment Fund shall be effective
41 before January 1, 2016."

42 **SECTION 25.4.(c)** Section 30.12A of S.L. 2015-241 is amended by adding a new
43 subsection to read:

44 **"SECTION 30.12A.(h)** Section 30.11 of S.L. 2015-241 is repealed."

46 **COMPENSATION BONUS AWARDED FOR FISCAL YEAR 2016-2017**

47 **SECTION 25.5.(a)** Any person (i) whose salary is set by this act in Part 9 or this Part,
48 pursuant to the North Carolina Human Resources Act, or as otherwise authorized in this act and
49 (ii) who is employed in a State-funded position on August 1, 2016, is eligible to be considered by
50 each agency head, in consultation with the Office of State Human Resources, for an award of a

1 one-time, lump-sum compensation bonus, up to a maximum bonus of three thousand dollars
2 (\$3,000) for the 2016-2017 fiscal year, payable during the month of September 2016.

3 **SECTION 25.5.(b)** Notwithstanding G.S. 135-1(7a), the compensation bonus
4 awarded by this section is not compensation under Article 1 of Chapter 135 of the General
5 Statutes, the Teachers' and State Employees' Retirement System.

6 **SECTION 25.5.(c)** The compensation bonus awarded by this section is not part of
7 annual salary and shall be paid out separately. The compensation bonus shall be awarded to
8 eligible permanent employees without regard to an employee's placement within the salary range,
9 including employees at the top of the salary range. The compensation bonus shall be adjusted pro
10 rata for permanent part-time employees.

11 12 **SALARY-RELATED CONTRIBUTIONS**

13 **SECTION 25.6.(a)** Section 30.20(a) of S.L. 2015-241 reads as rewritten:

14 "**SECTION 30.20.(a)** Effective for the ~~2015-2017 fiscal biennium,~~ 2015-2016 fiscal year,
15 required employer salary-related contributions for employees whose salaries are paid from
16 department, office, institution, or agency receipts shall be paid from the same source as the source
17 of the employee's salary. If an employee's salary is paid in part from the General Fund or Highway
18 Fund and in part from department, office, institution, or agency receipts, required employer
19 salary-related contributions may be paid from the General Fund or Highway Fund only to the
20 extent of the proportionate part paid from the General Fund or Highway Fund in support of the
21 salary of the employee, and the remainder of the employer's requirements shall be paid from the
22 source that supplies the remainder of the employee's salary. The requirements of this section as to
23 source of payment are also applicable to payments on behalf of the employee for hospital medical
24 benefits, longevity pay, unemployment compensation, accumulated leave, workers' compensation,
25 severance pay, separation allowances, and applicable disability income benefits."

26 **SECTION 25.6.(b)** Effective July 1, 2016, the State's employer contribution rates
27 budgeted for retirement and related benefits as a percentage of covered salaries for the 2015-2017
28 fiscal biennium are (i) fifteen and thirty-two hundredths percent (15.32%) – Teachers and State
29 Employees; (ii) twenty and thirty-two hundredths percent (20.32%) – State Law Enforcement
30 Officers; (iii) twelve and eighty-five hundredths percent (12.85%) – University Employees'
31 Optional Retirement Program; (iv) twelve and eighty-five hundredths percent (12.85%) –
32 Community College Optional Retirement Program; (v) thirty-two and eighty-one hundredths
33 percent (34.81%) – Consolidated Judicial Retirement System; and (vi) seven and forty hundredths
34 percent (7.40%) – Legislative Retirement System. Each of the foregoing contribution rates
35 includes five and sixty hundredths percent (5.60%) for hospital and medical benefits. The rate for
36 the Teachers and State Employees, State Law Enforcement Officers, University Employees'
37 Optional Retirement Program, and the Community College Optional Retirement Program includes
38 forty-one hundredths percent (0.41%) for the Disability Income Plan. The rates for Teachers and
39 State Employees and State Law Enforcement Officers include sixteen hundredths percent (0.16%)
40 for the Death Benefits Plan. The rate for State Law Enforcement Officers includes five percent
41 (5%) for Supplemental Retirement Income. The rate for Teachers and State Employees and State
42 Law Enforcement Officers includes one hundredth percent (0.01%) for the Qualified Excess
43 Benefit Arrangement.

44 **SECTION 25.6.(c)** Effective July 1, 2016, the maximum annual employer
45 contributions, payable monthly, by the State for each covered employee or retiree for the
46 2016-2017 fiscal year to the State Health Plan for Teachers and State Employees are (i)
47 Medicare-eligible employees and retirees – four thousand two hundred fifty-one dollars (\$4,251)
48 and (ii) non-Medicare-eligible employees and retirees – five thousand four hundred seventy-one
49 dollars (\$5,471).

PART XVII. MISCELLANEOUS PROVISIONS

STATE BUDGET ACT APPLIES

SECTION 27.1. The provisions of the State Budget Act, Chapter 143C of the General Statutes, are reenacted and shall remain in full force and effect and are incorporated in this act by reference.

MOST TEXT APPLIES ONLY TO THE 2015-2016 FISCAL YEAR

SECTION 27.2. Except for statutory changes or other provisions that clearly indicate an intention to have effects beyond the 2015-2016 fiscal year, the textual provisions of this act apply only to funds appropriated for, and activities occurring during, the 2015-2016 fiscal year.

EFFECT OF HEADINGS

SECTION 27.3. The headings to the parts and sections of this act are a convenience to the reader and are for reference only. The headings do not expand, limit, or define the text of this act, except for effective dates referring to a Part.

APPROPRIATIONS LIMITATIONS AND DIRECTIONS APPLY

SECTION 27.4.(a) Except where expressly repealed or amended by this act, the provisions of S.L. 2013-360 and S.L. 2013-363 remain in effect.

SECTION 27.4.(b) Notwithstanding any modifications by this act in the amounts appropriated, except where expressly repealed or amended, the limitations and directions for the 2015-2016 fiscal year in S.L. 2013-360 and S.L. 2013-363 that applied to appropriations to particular agencies or for particular purposes apply to the newly enacted appropriations and budget reductions of this act for those same particular purposes.

SEVERABILITY CLAUSE

SECTION 27.5. If any section or provision of this act is declared unconstitutional or invalid by the courts, it does not affect the validity of this act as a whole or any part other than the part so declared to be unconstitutional or invalid.
