7 **PART I. INTRODUCTION AND TITLE OF ACT**

8  
9 **INTRODUCTION**

10 **SECTION 1.1.** The appropriations made in this act are for maximum amounts  
11 necessary to provide the services and accomplish the purposes described in the budget in  
12 accordance with the State Budget Act. Savings shall be affected where the total amounts  
13 appropriated are not required to perform these services and accomplish these purposes, and the  
14 savings shall revert to the appropriate fund at the end of each fiscal year, except as otherwise  
15 provided by law.

17 **TITLE OF ACT**

18 **SECTION 1.2.** This act shall be known as the "Current Operations and Capital  
19 Improvements Appropriations Act of 2015."

24 **SECTION 2.1.** Appropriations from the General Fund of the State for the

27 **PART VI. MISCELLANEOUS PROVISIONS**

29 **STATE BUDGET ACT APPLIES**

30           **SECTION 6.1.** The provisions of the State Budget Act, Chapter 143C of the  
31 General Statutes, are reenacted and shall remain in full force and effect and are incorporated in  
32 this act by reference.  
33

34 **MOST TEXT APPLIES ONLY TO THE 2015-2017 FISCAL BIENNIUM**

35           **SECTION 6.2.** Except for statutory changes or other provisions that clearly  
36 indicate an intention to have effects beyond the 2015-2017 fiscal biennium, the textual  
37 provisions of this act apply only to funds appropriated for, and activities occurring during, the  
38 2015-2017 fiscal biennium.

40 **EFFECT OF HEADINGS**

41           **SECTION 6.3.** The headings to the parts and sections of this act are a convenience  
42 to the reader and are for reference only. The headings do not expand, limit, or define the text of  
43 this act, except for effective dates referring to a Part.  
44

45 **SEVERABILITY CLAUSE**

46           **SECTION 6.4.** If any section or provision of this act is declared unconstitutional or  
47 invalid by the courts, it does not affect the validity of this act as a whole or any part other than  
48 the part so declared to be unconstitutional or invalid.  
49

50 **EFFECTIVE DATE**

1           **SECTION 6.5.** Except as otherwise provided, this act is effective when it becomes  
2 law.
