3 THE TOWN OF FRANKLIN.

4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 160A-58.1 reads as rewritten:

6 "§ 160A-58.1. Petition for annexation; standards.

7 ...

8 (b) A noncontiguous area proposed for annexation must meet all of the following
9 standards:

10 ...

11 (4) ~~If the area proposed for annexation, or any portion thereof, is a subdivision~~
12 ~~as defined in G.S. 160A-376, all of the subdivision must be included.~~

13 (5) The area within the proposed satellite corporate limits, when added to the
14 area within all other satellite corporate limits, may not exceed ten percent
15 (10%) of the area within the primary corporate limits of the annexing city.

16 This subdivision does not apply to the Cities of Belmont, Claremont,
17 Concord, Conover, Durham, Elizabeth City, Gastonia, Greenville, Hickory,
18 Kannapolis, Locust, Marion, Mount Airy, Mount Holly, New Bern, Newton,
19 Oxford, Randleman, Roanoke Rapids, Rockingham, Sanford, Salisbury,
20 Southport, Statesville, and Washington and the Towns of Ahoskie, Angier,
21 Apex, Ayden, Benson, Bladenboro, Bridgeton, Burgaw, Calabash, Catawba,
22 Clayton, Columbia, Columbus, Cramerton, Creswell, Dallas, Dobson, Four
23 Oaks, Franklin, Fuquay-Varina, Garner, Godwin, Granite Quarry, Green
24 Level, Grimesland, Harrisburg, Holly Ridge, Holly Springs, Hookerton,
25 Huntersville, Jamestown, Kenansville, Kenly, Knightdale, Landis, Leland,
26 Lillington, Louisburg, Maggie Valley, Maiden, Mayodan, Maysville,
27 Middlesex, Midland, Mocksville, Morrisville, Mount Pleasant, Nashville,
28 Oak Island, Ocean Isle Beach, Pembroke, Pine Level, Princeton, Ranlo,
29 Richlands, Rolesville, Rutherfordton, Shallotte, Smithfield, Spencer, Stem,
30 Stovall, Surf City, Swansboro, Taylorsville, Troutman, Troy, Wallace,
31 Warsaw, Watha, Waynesville, Weldon, Wendell, Windsor, Yadkinville, and
32 Zebulon.

34 SECTION 2. This act applies to the Town of Franklin only.
