AN ACT TO MODIFY THE CURRENT OPERATIONS AND CAPITAL IMPROVEMENTS
APPROPRIATIONS ACT OF 2015 AND FOR OTHER PURPOSES.

The General Assembly of North Carolina enacts:

PART I. INTRODUCTION AND TITLE OF ACT

INTRODUCTION

SECTION 1.1. The appropriations made in this act are for maximum amounts necessary to provide the services and accomplish the purposes described in the budget in accordance with the State Budget Act. Savings shall be affected where the total amounts appropriated are not required to perform these services and accomplish these purposes, and the savings shall revert to the appropriate fund at the end of each fiscal year, except as otherwise provided by law.

TITLE OF ACT

SECTION 1.2. This act shall be known as the "Current Operations and Capital Improvements Appropriations Act of 2016."

SECTION 2.1. Appropriations from the General Fund of the State for the maintenance of the State departments, institutions, and agencies, and for other purposes as enumerated, are adjusted for the fiscal year ending June 30, 2017, according to the schedule that follows. Amounts set out in parentheses are reductions from General Fund appropriations for the 2016-2017 fiscal year:

38 **SECTION 6.2.** Except for statutory changes or other provisions that clearly indicate
39 an intention to have effects beyond the 2015-2017 fiscal biennium, the textual provisions of this
40 act apply only to funds appropriated for, and activities occurring during, the 2015-2017 fiscal
41 biennium.

43 **EFFECT OF HEADINGS**

44 **SECTION 6.3.** The headings to the parts and sections of this act are a convenience to
45 the reader and are for reference only. The headings do not expand, limit, or define the text of this
46 act, except for effective dates referring to a part.

1 **SECTION 6.4.** If any section or provision of this act is declared unconstitutional or
2 invalid by the courts, it does not affect the validity of this act as a whole or any part other than the
3 part so declared to be unconstitutional or invalid.

6 **SECTION 6.5.** Except as otherwise provided, this act becomes effective July 1, 2016.
