AN ACT TO MAKE BASE BUDGET APPROPRIATIONS FOR CURRENT OPERATIONS OF
STATE DEPARTMENTS, INSTITUTIONS, AND AGENCIES, AND FOR OTHER
PURPOSES.

The General Assembly of North Carolina enacts:

PART I. INTRODUCTION AND TITLE OF ACT

INTRODUCTION

SECTION 1.1. The appropriations made in this act are for maximum amounts necessary to provide the services and accomplish the purposes described in the budget in accordance with the State Budget Act. Savings shall be affected where the total amounts appropriated are not required to perform these services and accomplish these purposes, and the savings shall revert to the appropriate fund at the end of each fiscal year, except as otherwise provided by law.

TITLE OF ACT

SECTION 1.2. This act shall be known as the "Current Operations and Capital Improvements Appropriations Act of 2017."

28 **STATE BUDGET ACT APPLIES**

29 **SECTION 6.1.** The provisions of the State Budget Act, Chapter 143C of the General
30 Statutes, are reenacted and shall remain in full force and effect and are incorporated in this act by
31 reference.

33 **MOST TEXT APPLIES ONLY TO THE 2017-2019 FISCAL BIENNIUM**

34 **SECTION 6.2.** Except for statutory changes or other provisions that clearly indicate
35 an intention to have effects beyond the 2017-2019 fiscal biennium, the textual provisions of this
36 act apply only to funds appropriated for, and activities occurring during, the 2017-2019 fiscal
37 biennium.

39 **EFFECT OF HEADINGS**

40 **SECTION 6.3.** The headings to the parts and sections of this act are a convenience to
41 the reader and are for reference only. The headings do not expand, limit, or define the text of this
42 act, except for effective dates referring to a Part.

44 **SEVERABILITY CLAUSE**

45 **SECTION 6.4.** If any section or provision of this act is declared unconstitutional or
46 invalid by the courts, it does not affect the validity of this act as a whole or any part other than the
47 part so declared to be unconstitutional or invalid.

49 **EFFECTIVE DATE**

50 **SECTION 6.5.** Except as otherwise provided, this act is effective when it becomes
51 law.
