SENATE BILL 452

Short Title: Expand Allowable Medical Uses of CBD Oil. (Public)

1 A BILL TO BE ENTITLED  
2 AN ACT AMENDING THE EXEMPTION FOR USE OR POSSESSION OF  
3 CANNABIDIOL AND EXPANDING THE PERMISSIBLE USE OF CANNABIDIOL AS  
4 AN ALTERNATIVE TREATMENT TO CHRONIC CONDITIONS.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 90-94.1(b) reads as rewritten:

7 "(b) Notwithstanding any other provision of this Chapter, an individual may possess or  
8 use hemp extract, and is not subject to the penalties described in this Chapter, if the individual  
9 satisfies all of the following criteria:

- 10 (1) Possesses or uses the hemp extract only to treat intractable epilepsy, as  
11 defined in ~~G.S. 90-113.101~~G.S. 90-113.101, autism, multiple sclerosis,  
12 Crohn's disease, or Mitochondrial disease.  
13 (2) Possesses, in close proximity to the hemp extract, a certificate of analysis  
14 that indicates the hemp extract's ingredients, including its percentages of  
15 tetrahydrocannabinol and cannabidiol by weight.  
16 (3) Is a caregiver, as defined in G.S. 90-113.101."

17 **SECTION 2.** Article 5G of Chapter 90 of the General Statutes reads as rewritten:

18 "Article 5G.

19 "~~Epilepsy~~-Alternative Treatment Act.

20 "**§ 90-113.100. Short title.**

21 (a) This act may be cited as the "North Carolina ~~Epilepsy~~-Alternative Treatment Act."

22 (b) The purpose of this act is to permit the use of hemp extract as an alternative  
23 treatment for ~~intractable epilepsy~~intractable epilepsy, autism, multiple sclerosis, Crohn's  
24 disease, and Mitochondrial disease.

25 (c) The General Assembly finds that there are ~~children~~individuals in this State  
26 suffering from intractable ~~epilepsy~~epilepsy, autism, multiple sclerosis, Crohn's disease, and  
27 Mitochondrial disease for which currently available treatment options have been ineffective.  
28 Hemp extract shows promise in treating ~~children with intractable epilepsy~~these chronic  
29 conditions.

30 "**§ 90-113.101. Definitions.**

31 The following definitions apply in this Article:

- 32 (1) Caregiver. – An individual that is at least 18 years of age and a resident of  
33 North Carolina who is a parent, legal guardian, ~~or custodian~~custodian, nurse  
34 employed by a home health agency licensed under Part 3 of Article 6 of  
35 Chapter 131E of the General Statutes, or other caregiver of a patient and is



- 1 registered with the Department of Health and Human and Services under  
 2 G.S. 90-113.102 who possesses a written statement dated and signed by a  
 3 neurologist that states all of the following:
- 4 a. The patient has been examined and is under the care of the  
 5 ~~neurologist~~ neurologist or has been examined and is under the care of  
 6 a physician who has consulted with the neurologist about the patient's  
 7 condition.
  - 8 b. The patient suffers from intractable ~~epilepsy~~ epilepsy, autism,  
 9 multiple sclerosis, Crohn's disease, or Mitochondrial disease.
  - 10 c. The patient may benefit from treatment with hemp extract.
  - 11 d. The patient's condition has not responded to three or more treatment  
 12 options overseen by the neurologist or by a physician with whom the  
 13 neurologist has consulted about the patient's condition.

  - 15 (3) Database. – The ~~Intractable Epilepsy~~ Alternative Treatment database,  
 16 established by the Department of Health and Human Services pursuant to  
 17 this Article.
  - 18 (4) Department. – The Department of Health and Human Services.
  - 19 (5) Hemp Extract. – An extract from a cannabis plant, as defined in  
 20 G.S. 90-94.1(a).
  - 21 (6) ~~Intractable Epilepsy.~~ – ~~A seizure disorder that, as determined by a~~  
 22 ~~neurologist, does not respond to three or more treatment options overseen by~~  
 23 ~~the neurologist.~~
  - 24 (7) Neurologist. – An individual who is licensed under Article 1 of Chapter 90  
 25 of the General Statutes, who is board certified in neurology, and is affiliated  
 26 with the neurology department at one or more hospitals licensed in this  
 27 State.
  - 28 (8) Patient. – A person who has been diagnosed ~~by a neurologist~~ with intractable  
 29 ~~epilepsy~~ epilepsy, autism, multiple sclerosis, Crohn's disease, or  
 30 Mitochondrial disease by a neurologist or by a physician with whom the  
 31 neurologist has consulted about the patient's condition.
  - 32 (8a) Physician. – An individual who is licensed under Article 1 of Chapter 90 of  
 33 the General Statutes who is board certified and is affiliated with one or more  
 34 hospitals licensed in this State.
  - 35 (9) Repealed by Session Laws 2015-154, s. 3, effective July 16, 2015.
- 36 **"§ 90-113.102. ~~Intractable Epilepsy~~ Alternative Treatment database; departmental**  
 37 **duties.**
- 38 (a) The Department shall create a secure and electronic ~~Intractable Epilepsy~~ Alternative  
 39 Treatment database registry for the registration of neurologists, caregivers, and patients as  
 40 provided by this Article. All caregivers shall be required to register with the Department. Law  
 41 enforcement agencies are authorized to contact the Department to confirm a caregiver's  
 42 registration. The database shall consist of the following information to be provided by the  
 43 caregivers at the time of registration:
- 44 (1) The name and address of the caregiver.
  - 45 (2) The name and address of the caregiver's patient.
  - 46 (3) Repealed by Session Laws 2015-154, s. 4, effective July 16, 2015.
  - 47 (4) The name, address, and hospital affiliation of the neurologist recommending  
 48 hemp extract as an alternative treatment ~~for intractable epilepsy~~ for the  
 49 ~~patient~~ patient, and the name, address, and hospital affiliation of any  
 50 physician with whom the neurologist consults about the patient's condition in  
 51 making the recommendation.

2 (c) If at any time following registration, the name, address, or hospital affiliation of the  
3 patient's neurologist or physician changes, the caregiver shall notify the Department and  
4 provide the Department with the patient's new neurologist's or physician's name, address, and  
5 hospital affiliation.

7 **SECTION 3.** This act becomes effective December 1, 2017.
