6 The General Assembly of North Carolina enacts:

8 **PART I. PRESIDENT PRO TEMPORE'S RECOMMENDATIONS TO BOARDS AND**
9 **COMMISSIONS**

10 **SECTION 1.1.** Effective January 1, 2018, James S. Stewart of Hoke County is
11 appointed to the 911 Board for a term expiring on December 31, 2021.

12 **SECTION 1.2.** Christine Fernandini of Harnett County is appointed to the North
13 Carolina Brain Injury Advisory Council for a term expiring on September 30, 2019, to fill the
14 unexpired term of Donna White.

15 **SECTION 1.3.** Joan L. Sutton of Mecklenburg County is appointed to the North
