A BILL TO BE ENTITLED

AN ACT TO FUND CERTAIN CAPITAL IMPROVEMENTS FOR THE UNIVERSITY OF
NORTH CAROLINA SYSTEM AND AT THE DEPARTMENT OF HEALTH AND
HUMAN SERVICES.

The General Assembly of North Carolina enacts:

SECTION 1.(a) The following agency capital improvement projects have been assigned a project code for reference to allocations in this act and for intended project support by the General Assembly for future fiscal years:

SECTION 1.(b) There is transferred from the General Fund to the State Capital and Infrastructure Fund the sum of sixty-two million five hundred thousand dollars (\$62,500,000) in nonrecurring funds for the 2020-2021 fiscal year.

SECTION 1.(c) There is appropriated from the State Capital and Infrastructure Fund to the Office of State Budget and Management the sum of sixty-two million five hundred thousand dollars (\$62,500,000) in nonrecurring funds for the 2020-2021 fiscal year to be allocated for the following project codes, as defined in subsection (a) of this section:

SECTION 1.(d) For the capital project code UNC/NCS20-1, North Carolina State University shall commit to providing funding of at least eighty million dollars (\$80,000,000) from non-State sources on or before June 30, 2022, as a match for the intended State allocations totaling eighty million dollars (\$80,000,000) for the project.

SECTION 1.(e) For the capital project code UNC/ECU20-1, allocation of funds for the project in the 2020-2021 fiscal year and subsequent fiscal years shall be conditioned upon the existence of and compliance with an affiliation agreement between The University of North Carolina or East Carolina University and the primary affiliated teaching hospital for the East Carolina University Brody School of Medicine. The affiliation agreement shall require that at least forty-five percent (45%) of the members of the Board of Trustees of the primary affiliated teaching hospital be appointed by the Board of Governors of The University of North Carolina.

SECTION 1.(f) Notwithstanding any provision of law to the contrary, funds allocated in this section for a specific project may be used for planning purposes for that project.

SECTION 2.(a) The provisions of the State Budget Act, Chapter 143C of the General Statutes, are reenacted and shall remain in full force and effect and are incorporated in this act by reference.

SECTION 2.(b) Except where expressly repealed or amended by this act, the provisions of any other legislation enacted during the 2019 Regular Session of the General Assembly expressly appropriating funds to an agency, a department, or an institution covered under this act, shall remain in effect.

SECTION 3. This act becomes effective July 1, 2020.
