HOUSE BILL DRH10217-MKa-118

Short Title: Campus Police/Private IHE/CC Waiver. (Public)

1 A BILL TO BE ENTITLED
2 AN ACT TO ADD A WAIVER OF TUITION AND REGISTRATION FEES FOR
3 COMMUNITY COLLEGE COURSES FOR THE TRAINING NEEDS OF CAMPUS
4 POLICE AGENCIES OF PRIVATE INSTITUTIONS OF HIGHER EDUCATION AND TO
5 APPROPRIATE FUNDS TO COVER THE COST OF THE WAIVER.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 115D-5(b) reads as rewritten:

8 "(b) In order to make instruction as accessible as possible to all citizens, the teaching of
9 curricular courses and of noncurricular extension courses at convenient locations away from
10 institution campuses as well as on campuses is authorized and shall be encouraged. A pro rata
11 portion of the established regular tuition rate charged a full-time student shall be charged a
12 part-time student taking any curriculum course. In lieu of any tuition charge, the State Board of
13 Community Colleges shall establish a uniform registration fee, or a schedule of uniform
14 registration fees, to be charged students enrolling in extension courses for which instruction is
15 financed primarily from State funds. The State Board of Community Colleges may provide by
16 general and uniform regulations for waiver of tuition and registration fees for the following:

- 17 (1) Persons not enrolled in elementary or secondary schools taking courses
18 leading to a high school diploma or equivalent certificate.
- 19 (2) Courses requested by the following entities that support the organizations'
20 training needs and are on a specialized course list approved by the State Board
21 of Community Colleges:
- 22 a. Volunteer fire departments.
 - 23 b. Municipal, county, or State fire departments.
 - 24 c. Volunteer EMS or rescue and lifesaving departments.
 - 25 d. Municipal, county, or State EMS or rescue and lifesaving departments.
 - 26 d1. Law enforcement, fire, EMS or rescue and lifesaving entities serving
27 a lake authority that was created by a county board of commissioners
28 prior to July 1, 2012.
 - 29 e. Radio Emergency Associated Communications Teams (REACT)
30 under contract to a county as an emergency response agency.
 - 31 f. Municipal, county, or State law enforcement agencies.
 - 32 f1. Campus police agencies of private institutions of higher education
33 certified by the Attorney General pursuant to Chapter 74G of the
34 General Statutes.
 - 35 g. The Division of Adult Correction and Juvenile Justice of the
36 Department of Public Safety for the training of full-time custodial

1 employees and employees of the Division required to be certified
2 under Article 1 of Chapter 17C of the General Statutes and the rules
3 of the Criminal Justice and Training Standards Commission.

4 h. Repealed by Session Laws 2017-186, s. 2(hhhhh), effective December
5 1, 2017.

6 i. The Eastern Band of Cherokee Indians law enforcement, fire, EMS or
7 rescue and lifesaving tribal government departments or programs.

8 j. The Criminal Justice Standards Division of the Department of Justice
9 for the training of criminal justice professionals, as defined in
10 G.S. 17C-20(6), who are required to be certified under (i) Article 1 of
11 Chapter 17C of the General Statutes and the rules of the North
12 Carolina Criminal Justice Education and Training Standards
13 Commission or (ii) Chapter 17E of the General Statutes and the rules
14 of the North Carolina Sheriffs' Education and Training Standards
15 Commission. The waivers provided for in this sub-subdivision apply
16 to participants and recent graduates of the North Carolina Criminal
17 Justice Fellows Program to obtain certifications for eligible criminal
18 justice professions as defined in G.S. 17C-20(6).

20 **SECTION 2.** There is appropriated from the General Fund to the Community
21 Colleges System Office the sum of one hundred ten thousand dollars (\$110,000) in recurring
22 funds for the 2020-2021 fiscal year to support the waiver of tuition and fees for community
23 college courses for campus police agencies in accordance with G.S. 115D-5(b)(2)f1., as enacted
24 by this act.

25 **SECTION 3.** This act becomes effective July 1, 2019, and applies beginning with
26 the 2019-2020 academic year.
