1 A BILL TO BE ENTITLED
2 AN ACT TO DECREASE THE TIME REQUIRED TO OBTAIN LICENSURE BY
3 RECIPROCIY AWARDED FROM THE NORTH CAROLINA STATE BOARD OF
4 BARBER EXAMINERS AND TO MODIFY FEES CHARGED BY THE BOARD.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. G.S. 86A-12 reads as rewritten:

7 "§ 86A-12. Applicants licensed in other states.

8 (a) The Board shall issue, without examination, a license to applicants already licensed
9 in another state provided the applicant presents evidence satisfactory to the Board that:

- 10 (1) ~~He~~The applicant is currently an active, competent practitioner in good
11 standing; ~~and~~standing.
- 12 (2) ~~He~~The applicant has practiced at least ~~three~~one out of the five years
13 immediately preceding ~~his application; and~~application in this State.
- 14 (3) ~~He~~The applicant currently holds a valid license in another state; ~~and~~state.
- 15 (4) There is no disciplinary proceeding or unresolved complaint pending against
16 him ~~the applicant~~ at the time a license is to be issued by this State; ~~and~~State.
- 17 (5) The licensure requirements in the other state are the substantive equivalent of
18 those required by this State.

19 (b) The requirements in subdivisions (1) or (5), or both, of subsection (a) of this section
20 may be waived by the Board provided that the applicant presents evidence satisfactory to the
21 Board that the applicant:

- 22 (1) Has met the licensure requirements of the state in which ~~he~~the applicant
23 received ~~his license;~~the license.
- 24 (2) Has at least five years of practical ~~experience; and~~experience.
- 25 (3) Demonstrates ~~his~~knowledge of barbering skills and of the sanitary regulations
26 in North Carolina by passing a practical, written or oral examination.

27 (c) Any license granted pursuant to this section is subject to the same duties and
28 obligations and entitled to the same rights and privileges as a license issued under G.S. 86A-3."

29 SECTION 2. G.S. 86A-25 reads as rewritten:

30 "§ 86A-25. Fees collectible by Board.

31 The State Board of Barber Examiners shall charge fees not to exceed the following:

32 Certificate of registration or renewal as a barber \$
