A BILL TO BE ENTITLED

AN ACT TO ESTABLISH THE SMOKEY COVE FIRE PROTECTION DISTRICT IN HAYWOOD COUNTY.

The General Assembly of North Carolina enacts:

**SECTION 1.** There is hereby created the Smokey Cove Fire Protection District (District) in Haywood County.

**SECTION 2.** The District shall be composed of tracts of land in Haywood County with the following Parcel Identification Numbers:

1           **SECTION 3.** The Haywood County Board of Commissioners may levy a tax of no  
2 more than ten cents (10¢) per one hundred dollars (\$100.00) valuation of all real and personal  
3 property in the District to be kept in a separate and special fund to be used only for furnishing  
4 fire protection within the District, as provided in G.S. 69-25.5.

5           **SECTION 4.** The special fund created from the proceeds of the tax authorized by  
6 this act shall be administered by the Smokey Cove Fire Protection District Commission  
7 (Commission) to be composed of three members appointed by the Haywood County Board of  
8 Commissioners. The Commission shall serve at the discretion of and under the supervision of the  
9 Haywood County Board of Commissioners. The provisions of G.S. 69-25.8 shall apply to the  
10 Commission in exercising its powers under this act.

11           **SECTION 5.** This act applies only to that portion of Haywood County set out in this  
12 act as the Smokey Cove Fire Protection District.

13           **SECTION 6.** This act is effective when it becomes law.
