1 A BILL TO BE ENTITLED  
2 AN ACT TO PROVIDE GRANTS TO NORTH CAROLINA BUSINESSES AFFECTED BY  
3 THE COVID-19 PANDEMIC, TO PROVIDE TAX RELIEF TO BUSINESSES AND  
4 INDIVIDUALS, TO UPDATE THE REFERENCE TO THE INTERNAL REVENUE  
5 CODE, AND TO MAKE VARIOUS OTHER CHANGES.

6 The General Assembly of North Carolina enacts:

7  
8 **PART I. JOBS GRANT PROGRAM**

9 **SECTION 1.1.(a)** Purpose; Use. – The purpose of this section is to use funds from  
10 the American Rescue Plan Act to aid businesses in North Carolina that suffered substantial  
11 economic damage from the COVID-19 pandemic for which they were otherwise not fully  
12 compensated by providing economic support.

13 **SECTION 1.1.(b)** JOBS Grant Program. – There is created the Job Opportunity and  
14 Business Saving Grant Program (the Program) to be administered by the Department of Revenue.  
15 The Department may provide a one-time grant for each award amount to a qualifying business.  
16 Each grant awarded under the Program must include a description of the award amount used to  
17 calculate the grant. The Department's grant determinations are final.

18 **SECTION 1.1.(c)** Maximum Grant Amount. – The maximum grant a qualifying  
19 business may receive per award amount is seven and one-half percent (7.5%) of either the award  
20 amount or two hundred fifty thousand dollars (\$250,000), whichever is less.

21 **SECTION 1.1.(d)** Grant Program Limits. – The total of all funds granted under the  
22 Program, including the administration allocation for the Department of Revenue under Section  
23 1.2 of this act, may not exceed one billion dollars (\$1,000,000,000).

24 **SECTION 1.1.(e)** Automatic Award. – The Department of Revenue shall use  
25 currently available data from the Department, the Small Business Administration, and any other  
26 available sources to identify qualifying businesses in this State that have been approved for an  
27 award amount on or before June 30, 2021. The Department must award a grant under this  
28 subsection to the last known address of an identified qualifying business for each ascertainable  
29 award amount by September 30, 2021.

30 **SECTION 1.1.(f)** Initial Application; Award. – A qualifying business that was  
31 approved for an award amount on or before June 30, 2021, but does not receive a grant under  
32 subsection (e) of this section by September 30, 2021, for that award amount may apply to the



1 Department of Revenue for a grant on a form prescribed by the Department. The applicant must  
2 include any supporting documentation required by the Department, and the Department must  
3 confirm that the applicant did not previously receive a grant under the Program for the applicable  
4 award amount. Grants will be paid on a rolling basis to qualifying businesses that submit their  
5 applications on or before November 19, 2021.

6 **SECTION 1.1.(g)** Secondary Application; Award. – If the limit under subsection (d)  
7 of this section has not been met by December 31, 2021, the Department of Revenue must reopen  
8 the Program for additional applications. A qualifying business that was approved for an award  
9 amount but did not receive a grant for that award amount under subsection (e) or (f) of this section  
10 may file an application with the Department to receive a grant under this subsection. The  
11 applicant must include any supporting documentation required by the Department, and the  
12 Department must confirm that the applicant did not previously receive a grant under the Program  
13 for the applicable award amount. The application must be filed with the Department on or before  
14 February 18, 2022. The Department may not accept late applications. The Department may not  
15 award grants under this subsection until the application deadline has passed. If the total amount  
16 to be awarded for applications submitted pursuant to this subsection, when added to the amounts  
17 awarded under subsections (e) and (f) of this section, exceeds the maximum amount of funds  
18 available under subsection (d) of this section, the Department must reduce each grant awarded  
19 under this subsection on a proportionate basis so the maximum amount is not exceeded. The  
20 Department must award grants under this subsection as soon as practicable after the application  
21 deadline has passed.

22 **SECTION 1.1.(h)** Clawback. – For grants awarded under the Program pursuant to  
23 an application, the Department shall require a business to apply, under oath, on a form prescribed  
24 by the Department that includes (i) a certification that the business was approved for the  
25 applicable award amount, (ii) a certification that the business will promptly inform the  
26 Department of any reduction or recapture of the award amount and return any grant amount  
27 calculated on the reduced or recaptured award amount, and (iii) any information necessary for  
28 the Department to evaluate the application. The Department shall include with every grant  
29 awarded under the Program a notice that (i) the award must be returned or forfeited by a business  
30 to the extent the calculation of the award is premised on an award amount the qualifying business  
31 did not receive or did receive that was subsequently recaptured and (ii) a business is responsible  
32 for returning or forfeiting any amount improperly received.

33 **SECTION 1.1.(i)** Definitions. – The following definitions apply in this section:

34 (1) Award amount. – Amount awarded from any of the following:

- 35 a. COVID-19 Job Retention Program. – Defined in Section 4.2B of S.L.  
36 2020-4, as enacted by Section 1.1(e) of S.L. 2020-80, as amended.
- 37 b. EIDL Advance. – An Economic Injury Disaster Loan Advance defined  
38 in any of the following:
- 39 1. 15 U.S.C. § 9009(e).
  - 40 2. Section 331 of the Economic Aid to Hard-Hit Small  
41 Businesses, Nonprofits, and Venues Act, Title III of Division  
42 N of Public Law 116–260.
  - 43 3. Section 5002 of the American Rescue Plan Act of 2021, P.L.  
44 117-2.
- 45 c. Paycheck Protection Program. – Defined in 15 U.S.C. § 636(a)(36).
- 46 d. Restaurant Revitalization Fund. – Defined in section 5003 of the  
47 American Rescue Plan Act of 2021, P.L. 117-2.
- 48 e. Shuttered Venue Operators Grant Program. – Defined in section 324  
49 of the Economic Aid to Hard-Hit Small Businesses, Nonprofits, and  
50 Venues Act, Title III of Division N of Public Law 116–260.

(2) Qualifying business. – A business that (i) listed a North Carolina address as its business address on the application for an award amount and (ii) was approved for that award amount.

**SECTION 1.1.(j) Outreach.** – The Office of Historically Underutilized Businesses, Department of Administration, is directed to inform and educate minority-owned businesses that may be eligible to apply for the grants provided by the Program as soon as practicable so they may have the opportunity to access the grants provided by it.

**SECTION 1.2.** Appropriation of Funds for JOBS Grant Program. – The State Controller shall transfer the sum of one billion dollars (\$1,000,000,000) for the 2021-2022 fiscal year from the State Fiscal Recovery Reserve established in Section 2.1 of S.L. 2021-25 to the State Fiscal Recovery Fund established in Section 2.2 of S.L. 2021-25. There is appropriated from the State Fiscal Recovery Fund to the Office of State Budget and Management the sum of one billion dollars (\$1,000,000,000) in nonrecurring funds for the 2021-2022 fiscal year to be allocated to the Department of Revenue to be used as provided in Section 1.1 of this act. The Department of Revenue may use up to one quarter of one percent (0.25%) of the funds appropriated in this section for the administration of the Program under Section 1.1 of this act. The Department shall remit any funds remaining after disposition of all timely filed applications under subsection (g) of Section 1.1 of this act to the Office of State Budget and Management which shall deposit the funds into the State Fiscal Recovery Reserve. Amounts deposited into the Reserve under this section are receipts that do not constitute an "appropriation made by law," as that phrase is used in Section 7(1) of Article V of the North Carolina Constitution.

**SECTION 1.3.(a)** G.S. 105-130.5(b) reads as rewritten:

"(b) The following deductions from federal taxable income shall be made in determining State net income:

...

(31a) To the extent included in federal taxable income, the amount received by a taxpayer under the Job Opportunity and Business Saving Grant Program."

**SECTION 1.3.(b)** G.S. 105-153.5(b) reads as rewritten:

"(b) Other Deductions. – In calculating North Carolina taxable income, a taxpayer may deduct from the taxpayer's adjusted gross income any of the following items that are included in the taxpayer's adjusted gross income:

...

(14a) The amount received by a taxpayer under the Job Opportunity and Business Saving Grant Program."

**SECTION 1.3.(c)** This section is effective for taxable years beginning on or after January 1, 2021, and applies to amounts received by a taxpayer on or after that date.

**PART II. TAX POLICY INITIATIVES**

**SUBPART II-A. PERSONAL INCOME TAX REDUCTION**

**SECTION 2A.1.** G.S. 105-153.7(a) reads as rewritten:

"(a) Tax. – A tax is imposed for each taxable year on the North Carolina taxable income of every individual. The tax shall be levied, collected, and paid annually. The tax is ~~five and one-quarter percent (5.25%)~~ four and ninety-nine hundredths percent (4.99%) of the taxpayer's North Carolina taxable income."

**SECTION 2A.2.** G.S. 105-153.5(a)(1) reads as rewritten:

"(1) Standard deduction amount. – The standard deduction amount is zero for a person who is not eligible for a standard deduction under section 63 of the Code. For all other taxpayers, the standard deduction amount is equal to the amount listed in the table below based on the taxpayer's filing status:

**SECTION 2A.3.** G.S. 105-153.5(a1) reads as rewritten:

"(a1) Child Deduction Amount. – A taxpayer who is allowed a federal child tax credit under section 24 of the Code for the taxable year is allowed a deduction under this subsection for each qualifying child for whom the taxpayer is allowed the federal tax credit. The amount of the deduction is equal to the amount listed in the table below based on the taxpayer's adjusted gross income, as calculated under the Code:

12 **SECTION 2A.4.** This Subpart is effective for taxable years beginning on or after  
 13 January 1, 2022.

 15 **SUBPART II-B. PHASE OUT CORPORATE INCOME TAX**

16 **SECTION 2B.1.(a)** G.S. 105-130.3 reads as rewritten:

17 **"§ 105-130.3. Corporations.**

18 A tax is imposed on the State net income of every C Corporation doing business in this State  
 19 ~~at the rate of two and one-half percent (2.5%).~~ State. An S Corporation is not subject to the tax  
 20 levied in this section. The tax is a percentage of the taxpayer's State net income computed as  
 21 follows:

28 **SECTION 2B.1.(b)** This Subpart is effective for taxable years beginning on or after  
 29 January 1, 2024.

 31 **SUBPART II-C. FRANCHISE TAX REDUCTION AND SIMPLIFICATION**

32 **SECTION 2C.1.(a)** G.S. 105-122(d) reads as rewritten:

33 "(d) Tax Base. – A corporation's tax base is the ~~greatest of the following:~~

- 34 (1) ~~The proportion of its net worth as set out in subsection (c1) of this section.~~
- 35 (2) ~~Fifty five percent (55%) of the corporation's appraised value as determined~~  
 36 ~~for ad valorem taxation of all the real and tangible personal property in this~~  
 37 ~~State. For purposes of this subdivision, the appraised value of tangible~~  
 38 ~~property, including real estate, is the ad valorem valuation for the calendar~~  
 39 ~~year next preceding the due date of the franchise tax return.~~
- 40 (3) ~~(Effective for taxable years beginning on or after January 1, 2020, and~~  
 41 ~~applicable to the calculation of franchise tax reported on the 2019 and later~~  
 42 ~~corporate income tax returns) The corporation's total actual investment in~~  
 43 ~~tangible property in this State. For purposes of this subdivision, the total actual~~  
 44 ~~investment in tangible property in this State is the total original purchase price~~  
 45 ~~or consideration to the reporting taxpayer of its tangible properties, including~~  
 46 ~~real estate, in this State plus additions and improvements thereto less (i)~~  
 47 ~~reserve for depreciation as permitted for income tax purposes and (ii) any~~  
 48 ~~indebtedness specifically incurred and existing solely for and as the result of~~  
 49 ~~the purchase of any real estate and any permanent improvements made on the~~  
 50 ~~real estate."~~

51 **SECTION 2C.1.(b)** G.S. 105-114.1(b) reads as rewritten:

1       "(b) Controlled Companies. – If a corporation or an affiliated group of corporations owns  
2 more than fifty percent (50%) of the capital interests in a noncorporate limited liability company,  
3 the corporation or group of corporations must include in its ~~three tax bases~~ base pursuant to  
4 G.S. 105-122 the same percentage of ~~(i) the noncorporate limited liability company's net worth;~~  
5 ~~(ii) fifty five percent (55%) of the noncorporate limited liability company's appraised ad valorem~~  
6 ~~tax value of property; and (iii) the noncorporate limited liability company's actual investment in~~  
7 ~~tangible property in this State, as appropriate, worth."~~

8           **SECTION 2C.1.(c)** G.S. 105-120.2(b) reads as rewritten:

9       "(b) Tax Rate. – Every corporation taxed under this section shall annually pay to the  
10 Secretary of Revenue, at the time the return is due, ~~the greater of the following:~~

11       (1) ~~A~~ a franchise or privilege tax at the rate of one dollar and fifty cents (\$1.50)  
12 per one thousand dollars (\$1,000) of the amount determined under subsection  
13 (a) of this section, but in no case shall the tax be more than one hundred fifty  
14 thousand dollars (\$150,000) nor less than two hundred dollars (\$200.00).

26           **SECTION 2C.1.(d)** This Subpart is effective for taxable years beginning on or after  
27 January 1, 2023, and applicable to the calculation of franchise tax reported on the 2022 and later  
28 corporate income tax return.

29  
30 **SUBPART II-D. EXTEND THE TIME TO COMPLETE AN ELIGIBLE PROJECT**  
31 **UNDER THE MILL REHABILITATION TAX CREDIT PROGRAMS**

32           **SECTION 2D.1.(a)** G.S. 105-129.71(a1) reads as rewritten:

33       "(a1) Credit for Rehabilitated Railroad Station. – A taxpayer who is allowed a credit under  
34 section 47 of the Code for making qualified rehabilitation expenditures of at least ten million  
35 dollars (\$10,000,000) with respect to a certified rehabilitation of an eligible railroad station is  
36 allowed a credit equal to a percentage of the expenditures that qualify for the federal credit. In  
37 order to be eligible for a credit allowed by this Article, the taxpayer must provide to the Secretary  
38 a copy of the eligibility certification and the cost certification. The amount of the credit is equal  
39 to forty percent (40%) of the qualified rehabilitation expenditures. The credit cannot be claimed  
40 for a taxable year beginning prior to January 1, 2021. ~~The tax credit must be taken in two equal~~  
41 ~~installments on returns filed for taxable years 2021 and 2022. The sum of the two installments is~~  
42 ~~equal to the credit amount allowed for qualified rehabilitation expenditures incurred in taxable~~  
43 ~~years 2019, 2020, and 2021. When the eligible site is placed into service in two or more phases~~  
44 ~~in different years, the amount of credit that may be claimed in a year is the amount based on the~~  
45 ~~qualified rehabilitation expenditures associated with the phase placed into service during that~~  
46 ~~year.~~

47       For purposes of this subsection, the term "eligible railroad station" is a site located in this  
48 State that satisfies all of the following conditions:

49       ...  
50       (4) It is a designated local landmark as certified by a city on or before ~~June 30,~~  
51 ~~2019.~~ September 1, 2020.

1 ...

2 (7) It is issued a certificate of occupancy on or before December 31, ~~2021~~,2023."

3 **SECTION 2D.1.(b)** G.S. 105-129.75 reads as rewritten:

4 "**§ 105-129.75. Sunset and applicable expenditures.**

5 (a) Sunset. – Except for credits allowed under G.S. 105-129.71(a1), this Article expires  
6 January 1, 2015, for rehabilitation projects for which an application for an eligibility certification  
7 is submitted on or after that date. Eligibility certifications under this Article expire January 1,  
8 ~~2023~~,2025.

9 (b) Delayed Sunset and Applicable Expenditures. – For credits allowed under  
10 G.S. 105-129.71(a1), the following applies:

11 (1) The qualified rehabilitation expenditures must be incurred on or after January  
12 1, 2019, and before January 1, ~~2022~~,2024.

13 (2) This Article expires, and a tax credit allowed under G.S. 105-127.71(a1) may  
14 not be claimed, for rehabilitation projects not completed and placed in service  
15 prior to ~~January 1, 2022~~,July 1, 2024."

16  
17 **SUBPART II-E. LIMIT GROSS PREMIUMS TAX ON SURETY BONDS**

18 **SECTION 2E.1.(a)** G.S. 105-228.5(b1) reads as rewritten:

19 "(b1) Calculation of Tax Base. – In determining the amount of gross premiums from  
20 business in this State, all gross premiums received in this State, credited to policies written or  
21 procured in this State, or derived from business written in this State shall be deemed to be for  
22 contracts covering persons, property, or risks resident or located in this State unless one of the  
23 following applies:

24 (1) The premiums are properly reported and properly allocated as being received  
25 from business done in some other nation, territory, state, or states.

26 (2) The premiums are from policies written in federal areas for persons in military  
27 service who pay premiums by assignment of service pay.

28 Gross premiums from business done in this State in the case of life insurance contracts,  
29 including supplemental contracts providing for disability benefits, accidental death benefits, or  
30 other special benefits that are not annuities, means all premiums collected in the calendar year,  
31 other than for contracts of reinsurance, for policies the premiums on which are paid by or credited  
32 to persons, firms, or corporations resident in this State, or in the case of group policies, for  
33 contracts of insurance covering persons resident within this State. The only deductions allowed  
34 shall be for premiums refunded on policies rescinded for fraud or other breach of contract and  
35 premiums that were paid in advance on life insurance contracts and subsequently refunded to the  
36 insured, premium payer, beneficiary or estate. Gross premiums shall be deemed to have been  
37 collected for the amounts as provided in the policy contracts for the time in force during the year,  
38 whether satisfied by cash payment, notes, loans, automatic premium loans, applied dividend, or  
39 by any other means except waiver of premiums by companies under a contract for waiver of  
40 premium in case of disability.

41 Gross premiums from business done in this State in the case of an insurer of bail bonds means  
42 the amounts received by an insurer from a surety bondsman during the calendar year for bail  
43 bonds written on behalf of the insurer. An insurer is subject to the definitions of gross premiums  
44 under this section for gross premiums from transacting any other line of insurance business. For  
45 purposes of this paragraph, the terms "bail bonds," "insurer," and "surety bondsman" have the  
46 same meaning as defined in G.S. 58-71-1.

47 Gross premiums from business done in this State for all other health care plans and contracts  
48 of insurance, including contracts of insurance required to be carried by the Workers'  
49 Compensation Act, means all premiums written during the calendar year, or the equivalent  
50 thereof in the case of self-insurers under the Workers' Compensation Act, for contracts covering  
51 property or risks in this State, other than for contracts of reinsurance, whether the premiums are

1 designated as premiums, deposits, premium deposits, policy fees, membership fees, or  
2 assessments. Gross premiums shall be deemed to have been written for the amounts as provided  
3 in the policy contracts, new and renewal, becoming effective during the year irrespective of the  
4 time or method of making payment or settlement for the premiums, and with no deduction for  
5 dividends whether returned in cash or allowed in payment or reduction of premiums or for  
6 additional insurance, and without any other deduction except for return of premiums, deposits,  
7 fees, or assessments for adjustment of policy rates or for cancellation or surrender of policies."

8 **SECTION 2E.1.(b)** This Subpart is effective for taxable years beginning on or after  
9 January 1, 2022.

10  
11 **SUBPART II-F. MODIFY EXCISE TAX ON CIGARS AND CLARIFY DELIVERY**  
12 **SALES AND REMOTE SALES OF TOBACCO PRODUCTS**

13 **SECTION 2F.1.(a)** G.S. 105-113.4 reads as rewritten:

14 **"§ 105-113.4. Definitions.**

15 The following definitions apply in this Article:

- 16 ...
- 17 (2) Cost price. – ~~The actual price a person liable for the tax on tobacco products~~  
18 paid for an item subject to the tax imposed by Part 3-Part 3A of this Article  
19 paid for the products, before any discount, rebate, or allowance or the tax  
20 imposed by that Part by the person liable for the tax. The actual price paid for  
21 an item may be either of the following:
- 22 a. The actual price paid for an item identified as a stock keeping unit by

- (3) Records necessary to document the cost price of purchases of all tobacco products sold to consumers in this State.

A remote seller who violates G.S. 105-113.70 is subject to the following penalties:

- (1) For the first violation, a penalty of one thousand dollars (\$1,000).
- (2) For a subsequent violation, a penalty not to exceed five thousand dollars (\$5,000), as determined by the Secretary.

"Subpart 4. Administrative Provisions.

**"§ 105-113.80. License required.**

(a) Requirement. – A wholesale dealer or a retail dealer must obtain from the Secretary a license for each of the locations listed in this subsection, as applicable, and must pay the required license tax for each license. A license is in effect until June 30 of the year following the second calendar year after the date of issuance or renewal, unless cancelled or revoked prior to expiration. A license is renewable upon signed application with no renewal license tax, unless applied for after the June 30 expiration date. The locations are:

- (1) Each location where a wholesale dealer makes tobacco products.
- (2) Each location where a wholesale dealer or a retail dealer receives or stores non-tax-paid tobacco products.
- (3) Each location from where a retail dealer that is a delivery seller or remote seller ships delivery sales or remote sales if the location is a location other than the location described in subdivision (2) of this subsection.

(b) License Tax Amount. – The license tax amounts are as follows:

(c) Out-of-State Wholesale Dealers. – An out-of-state wholesale dealer of tobacco products that is not a delivery seller or a remote seller may obtain a wholesale dealer's license upon compliance with the provisions of G.S. 105-113.4A and payment of a tax of twenty-five dollars (\$25.00).

**"§ 105-113.81. Payment of tax.**

(a) Monthly Report. – Taxes levied by this Part are payable by the entity that is primarily liable for the tax when a report is required to be filed. A report is due on a monthly basis. A monthly report covers tobacco products sold, shipped, delivered, or otherwise disposed of in this State occurring in a calendar month and is due within 20 days after the end of the month covered by the report. A report must be filed on a form provided by the Secretary and must contain the information required by the Secretary.

(b) Use Tax Report. – A person who is not a licensee under this Part and has acquired non-tax-paid tobacco products for sale, use, or consumption subject to the tax imposed by this Part must, within 96 hours after receipt of the tobacco products, file a report in the form prescribed by the Secretary showing the amount of tobacco products received and any other information required by the Secretary. The report must be accompanied by payment of the full amount of the tax.

(c) Shipping Report. – A person who transports, or causes to transport, tobacco products upon the public highways, roads, or streets of this State must, upon notice from the Secretary, file a report in a form prescribed by and containing the information required by the Secretary.

**"§ 105-113.82. Bond or irrevocable letter of credit.**

1        The Secretary may require a wholesale dealer or a retail dealer to furnish a bond in an amount  
 2 that adequately protects the State from a wholesale dealer's or a retail dealer's failure to pay taxes  
 3 due under this Part. A bond must be conditioned on compliance with this Part, payable to the  
 4 State, and in the form required by the Secretary. The amount of the bond is two times the  
 5 wholesale or retail dealer's average expected monthly tax liability under this Part, as determined  
 6 by the Secretary, provided the amount of the bond may not be less than two thousand dollars  
 7 (\$2,000) and may not be more than two million dollars (\$2,000,000). The Secretary should  
 8 periodically review the sufficiency of bonds required of dealers, increase the amount of a required  
 9 bond when the amount of the bond furnished no longer covers the anticipated tax liability of the  
 10 wholesale dealer or retail dealer, and decrease the amount when the Secretary determines that a  
 11 smaller bond amount will adequately protect the State from loss.

12        For purposes of this section, a wholesale dealer or a retail dealer may substitute an irrevocable  
 13 letter of credit for the secured bond required by this section. The letter of credit must be issued  
 14 by a commercial bank acceptable to the Secretary and available to the State as a beneficiary. The  
 15 letter of credit must be in a form acceptable to the Secretary, conditioned upon compliance with  
 16 this Part, and in the amounts stipulated in this section.

40           (3) The dispensing device that serves the storage facility must be marked.

41           (4) The retail pump or dispensing device at any level of the distribution system  
42 must comply with the marking requirements.

43           (a1) Penalty. – A person who fails to mark the storage facility as required by subsection  
44 (a) of this section is subject to a civil penalty of two hundred fifty dollars (\$250.00). Each  
45 inspection that results in a finding of noncompliance constitutes a separate and distinct offense.

46           (b) Exception. – The marking requirements of this section do not apply to a storage  
47 facility that contains fuel used only for one of the purposes listed in G.S. 105-449.105A(a)(1)  
48 and is installed in a manner that makes use of the fuel for any other purpose improbable."

1 **SUBPART IV-F. LOCAL GOVERNMENT TAX CHANGES**

2 **SECTION 4F.1.(a)** G.S. 105-278(a) reads as rewritten:

4 to former G.S. 160A-399.4 or designated as a historic landmark by a local ordinance adopted

6 under authority of Article V, Sec. 2(2) of the North Carolina Constitution. Property so classified  
7 shall be taxed uniformly as a class in each local taxing unit on the basis of fifty percent (50%) of  
8 the true value of the property as determined pursuant to G.S. 105-285 and 105-286, or 105-287."

9 **SECTION 4F.1.(b)** This section is effective retroactively to June 19, 2020.

11 **PART V. SAVINGS RESERVE TRANSFER**

12 **SECTION 5.(a)** In addition to the amount required under G.S. 143C-4-2, the State  
13 Controller shall transfer from the General Fund to the Savings Reserve the sum of one billion  
14 dollars (\$1,000,000,000) in the 2021-2022 fiscal year and the sum of three hundred eighty-eight  
15 million three hundred sixty-five thousand four hundred fifty-three dollars (\$388,365,453) in the  
16 2022-2023 fiscal year. This transfer is not an "appropriation made by law," as that phrase is used  
17 in Section 7(1) of Article V of the North Carolina Constitution.

18 **SECTION 5.(b)** This Part becomes effective July 1, 2021.
