2 AN ACT REMOVING PSYCHIATRIC FACILITIES, CHEMICAL DEPENDENCY
3 TREATMENT FACILITIES, KIDNEY DISEASE TREATMENT CENTERS, AND
4 CERTAIN OCULAR SURGICAL PROCEDURES FROM CERTIFICATE OF NEED
5 REVIEW.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 131E-175 is amended by adding a new subdivision to read:

8 "(13) That demand for ocular surgical procedures is increasing due to the growth of
9 the elderly population as well as scientific and technological advancements
10 that have increased the safety and efficacy of these procedures."

11 **SECTION 2.** G.S. 131E-176 reads as rewritten:

12 "**§ 131E-176. Definitions.**

13 The following definitions apply in this Article:

14 ...

15 (5) Change in bed capacity. – Any of the following:

- 16 a. Any relocation of health service facility beds, or dialysis stations from
17 one licensed facility or campus to another.
18 b. Any redistribution of health service facility bed capacity among the
19 categories of health service facility bed.
20 c. Any increase in the number of health service facility beds, or dialysis
21 stations in kidney disease treatment centers, including freestanding
22 dialysis units, beds.

23 (5a) ~~Chemical dependency treatment facility. – A public or private facility, or unit~~
24 ~~in a facility, which is engaged in providing 24 hour a day treatment for~~
25 ~~chemical dependency or a substance use disorder. This treatment may include~~
26 ~~detoxification, administration of a therapeutic regimen for the treatment of~~
27 ~~individuals with chemical dependence or substance use disorders, and related~~
28 ~~services. The facility or unit may be any of the following:~~

15 ~~dependency treatment beds. Chemical dependency treatment beds do not~~
16 ~~include beds licensed for detoxification.~~

- 18 (9b) ~~Health service facility. — A hospital; long-term care hospital; psychiatric~~
19 ~~facility; rehabilitation facility; nursing home facility; adult care home; kidney~~

21 ~~intermediate care facility for individuals with intellectual disabilities; home~~
22 ~~health agency office; chemical dependency treatment facility; diagnostic~~
23 ~~center; hospice office, hospice inpatient facility, hospice residential care~~
24 ~~facility; and ambulatory surgical facility.~~
- 25 (9c) ~~Health service facility bed. — A bed licensed for use in a health service facility~~
26 ~~in the categories of (i) acute care beds; (ii) psychiatric beds; (iii) rehabilitation~~
27 ~~beds; (iv) (iii) nursing home beds; (v) (iv) intermediate care beds for~~
28 ~~individuals with intellectual disabilities; (vi) chemical dependency treatment~~
29 ~~beds; (vii) (v) hospice inpatient facility beds; (viii) (vi) hospice residential care~~
30 ~~facility beds; (ix) (vii) adult care home beds; and (x) (viii) long-term care~~

- 37 (16) ~~New institutional health services. — Any of the following:~~

- 43 (17c) Ocular surgical procedure. — A surgical procedure performed on the eye or its
44 adnexa that (i) requires local, regional, or general anesthesia and a period of
45 less than 24 hours of post-operative observation for diagnostic or therapeutic
46 purposes and (ii) does not constitute an ambulatory surgical program as
47 defined in subdivision (1c) of this section.
- 48 (17d) Ocular surgical procedure room. — A room located in the office of an
49 ophthalmologist licensed to practice in this State that is used to perform ocular
50 surgical procedures.

(21) ~~Psychiatric facility.—A public or private facility licensed pursuant to Article 2 of Chapter 122C of the General Statutes and which is primarily engaged in providing to inpatients, by or under the supervision of a physician, psychiatric services for the diagnosis and treatment of individuals with mental illnesses.~~

SECTION 3. G.S. 131E-178 reads as rewritten:

"§ 131E-178. **Activities requiring certificate of ~~need~~need; limited exemption for gastrointestinal endoscopy procedures and ocular surgical procedures.**

(a) No person shall offer or develop a new institutional health service without first obtaining a certificate of need from the ~~Department~~; ~~provided, however, no Department, except as provided in subsections (a1) and (a2) of this section.~~

(a1) No person who provides gastrointestinal endoscopy procedures in one or more gastrointestinal endoscopy rooms located in a nonlicensed setting, shall be required to obtain a certificate of need to license that setting as an ambulatory surgical facility with the existing number of gastrointestinal endoscopy rooms, provided that that the person meets all of the following criteria:

(1) The license application is postmarked for delivery to the Division of Health Service Regulation by December 31, ~~2006~~; 2006.

(2) The applicant verifies, by affidavit submitted to the Division of Health Service Regulation within 60 days of the effective date of this act, that the facility is in operation as of the effective date of this act or that the completed application for the building permit for the facility was submitted by the effective date of this ~~act~~; act.

(3) The facility has been accredited by The Accreditation Association for Ambulatory Health Care, The Joint ~~Commission on Accreditation of Healthcare Organizations~~, Commission, or The American Association for Accreditation of Ambulatory Surgical Facilities by the time the license application is postmarked for delivery to the Division of Health Service Regulation of the ~~Department~~; and Department.

(4) The license application includes a commitment and plan for serving indigent and medically underserved populations.

All other persons proposing to obtain a license to establish an ambulatory surgical facility for the provision of gastrointestinal endoscopy procedures shall be required to obtain a certificate of need. The annual State Medical Facilities Plan shall not include policies or need determinations that limit the number of gastrointestinal endoscopy rooms that may be approved.

(a2) No ophthalmologist licensed to practice in this State who provides ocular surgical procedures in one or more ocular surgical procedure rooms shall be required to obtain a certificate of need to license that setting as an ambulatory surgical facility with the existing number of ocular surgical procedure rooms, provided that the ophthalmologist meets all of the following criteria:

(1) The license application is postmarked for delivery to the Division of Health Service Regulation by December 31, 2021.

(2) The applicant verifies, by affidavit submitted to the Division of Health Service Regulation within 60 days after the effective date of this subsection, that the facility is in operation as of the effective date of this subsection or that the completed application for the building permit for the facility was submitted by the effective date of this subsection.

(3) The facility has been accredited by The Accreditation Association for Ambulatory Health Care, The Joint Commission, or The American Association for Accreditation of Ambulatory Surgical Facilities by the time the license application is postmarked for delivery to the Division of Health Service Regulation of the Department.

1 (4) The license application includes a commitment and plan for serving indigent
2 and medically underserved populations.

3 All other persons proposing to obtain a license to establish an ambulatory surgical facility for
4 the provision of ocular surgical procedures shall be required to obtain a certificate of need. The
5 annual State Medical Facilities Plan shall not include policies or need determinations that limit

8 **SECTION 4.** G.S. 131E-184 reads as rewritten:

9 **"§ 131E-184. Exemptions from review.**

10 (a) Except as provided in subsection (b) of this section, the Department shall exempt from
11 certificate of need review a new institutional health service if it receives prior written notice from
12 the entity proposing the new institutional health service, which notice includes an explanation of
13 why the new institutional health service is required, for any of the following:

14 ...

15 (10) To develop, acquire, construct, expand, or replace a health service facility or
16 service that obtained certificate of need approval prior to October 1, 2021, for
17 any of the following:

18 a. A chemical dependency treatment center, defined as a public or private
19 facility, or unit in a facility, which is engaged in providing 24-hour a
20 day treatment for chemical dependency or a substance use disorder.
21 This treatment may include detoxification, administration of a
22 therapeutic regimen for the treatment of individuals with chemical
23 dependence or substance use disorders, and related services. The
24 facility or unit may be any of the following:

25 1. A unit within a general hospital or an attached or freestanding
26 unit of a general hospital licensed under Article 5 of this
27 Chapter.

28 2. A unit within a psychiatric hospital or an attached or
29 freestanding unit of a psychiatric hospital licensed under
30 Article 1A of former Chapter 122 of the General Statutes or
31 Article 2 of Chapter 122C of the General Statutes.

32 3. A freestanding facility specializing in treatment of individuals
33 with chemical dependence or substance use disorders that is
34 licensed under Article 1A of former Chapter 122 of the General
35 Statutes or Article 2 of Chapter 122C of the General Statutes.
36 The facility may be identified as "chemical dependency,
37 substance abuse, alcoholism, or drug abuse treatment units,"
38 "residential chemical dependency, substance use disorder,
39 alcoholism or drug abuse facilities," or by other names if the
40 purpose is to provide treatment of individuals with chemical
41 dependence or substance use disorders. The term, however,
42 does not include social setting detoxification facilities, medical
43 detoxification facilities, halfway houses, or recovery farms.

44 b. A kidney disease treatment center, defined as a facility that is certified
45 as an end stage renal disease facility by the Centers for Medicare and
46 Medicaid Services, Department of Health and Human Services,
47 pursuant to 42 C.F.R. § 405.

48 c. A psychiatric facility, defined as a public or private facility licensed
49 pursuant to Article 2 of Chapter 122C of the General Statutes and
50 which is primarily engaged in providing to inpatients, by or under the

1 supervision of a physician, psychiatric services for the diagnosis and
2 treatment of individuals with mental illness.

4 **SECTION 5.** This act becomes effective October 1, 2021.
