A BILL TO BE ENTITLED
AN ACT TO REVISE THE EDUCATION REQUIREMENTS FOR LICENSURE OF A
PROFESSIONAL LAND SURVEYOR AND MAKE VARIOUS TECHNICAL
CHANGES.

The General Assembly of North Carolina enacts:

SECTION 1.(a) G.S. 89C-13 reads as rewritten:

"§ 89C-13. General requirements for licensure.

...

(b) Land Surveyor Applicant. – The evaluation of a land surveyor applicant's qualifications shall involve a consideration of the applicant's education, technical, and land surveying experience, exhibits of land surveying projects with which the applicant has been associated, and recommendations by references. The land surveyor applicant's qualifications may be reviewed at an interview if the Board determines it necessary. Educational credit for institute courses, correspondence courses, or other courses shall be determined by the Board.

The following shall be considered as minimum evidence satisfactory to the Board that the applicant is qualified for licensure as a professional land surveyor:

- (1) To be certified as a land surveyor intern, an applicant shall (i) pass the fundamentals of land surveying examination and make application to the Board, (ii) be of good character and reputation, (iii) submit three character references to the Board, one of whom is a professional land surveyor, (iv) comply with the requirements of this Chapter, and (v) satisfy one of the following requirements related to education ~~and-or~~ experience:
 - a. Be a graduate of a surveying curriculum of four years or more or other equivalent curriculum in surveying approved by the Board.
 - b. Have rightful possession of an associate degree in surveying technology approved by the Board, a record satisfactory to the Board of ~~four-three~~ years of progressive practical experience, ~~two years of~~ which shall have been under a practicing professional land surveyor, and have satisfactorily passed a written and oral examination as required by the Board.
 - c. Have graduated from high school or completed a high school equivalency certificate with a record satisfactory to the Board of ~~10~~ seven years of progressive, practical experience, ~~six years of~~ which shall have been under a practicing licensed land surveyor, and have satisfactorily passed any oral and written examinations required by the Board.



1 (1a) To be licensed as a professional land surveyor, an applicant shall (i) be of good
2 character and reputation, (ii) submit five character references to the Board,
3 three of whom are professional land surveyors or individuals acceptable to the
4 Board, with personal knowledge of the applicant's land surveying experience,
5 (iii) comply with the requirements of this Chapter, and (iv) meet one of the
6 following requirements:

7 a. Rightful possession of a bachelor of science degree in surveying or
8 other equivalent curricula, all approved by the Board and meets all of
9 the following:

10 1. Has a record satisfactory to the Board of two years or more of
11 progressive practical experience, one year of which shall have
12 been under a practicing professional land surveyor if the
13 applicant has successfully passed the first examination
14 (Fundamentals of Surveying) on or before January 1, 2013, or
15 if the applicant has not successfully passed the first
16 examination on or before January 1, 2013, two years of
17 experience which shall have been under a practicing
18 professional land surveyor, and surveyor.

19 2. satisfactorily passing—Has successfully passed the
20 Fundamentals of Surveying examination.

21 3. Has successfully passed any additional oral and written
22 examination required by the Board, all of which shall
23 determine and indicate that the applicant is competent to
24 practice land surveying.

25 Upon passing the first examination and successful completion of the
26 experience required by this subdivision, the ~~The~~ applicant may then
27 apply to take the second examination (Principles—Principles and
28 Practice—Practices of Land Surveying). An applicant who passes both
29 examinations—Surveying examination and completes the educational
30 and experience requirements of this subdivision upon passing this
31 examination, shall be granted licensure as a professional land
32 surveyor.

33 b. Rightful possession of an associate degree in surveying technology
34 approved by the Board and meets all of the following:

35 1. Has a record satisfactory to the Board of ~~four~~ five years or
36 more of progressive practical experience, ~~three~~ years of
37 experience which shall have been under a practicing licensed
38 land surveyor if the applicant has successfully passed the first
39 examination (Fundamentals of Surveying) on or before
40 January 1, 2013, or if the applicant has not surveyor.

41 2. Has successfully passed the first examination on or before
42 January 1, 2013, eight years of progressive practical
43 experience, four years of which shall have been under a
44 practicing professional land surveyor, and satisfactorily
45 passing Fundamentals of Surveying examination.

46 3. Has successfully passed any additional written and oral
47 examination required by the Board, all of which shall
48 determine and indicate that the applicant is competent to
49 practice land surveying.

50 ~~If the~~ The applicant has not successfully completed the first
51 examination on or before January 1, 2013, the applicant may then

1 apply to the Board to take the first examination after obtaining the
 2 associate degree and completing four years of practical experience,
 3 two years of which shall have been under a practicing professional
 4 land surveyor at the first regularly scheduled examination thereafter.
 5 Upon passing the first examination and successfully completing the
 6 practical experience required under this subdivision, the applicant may
 7 apply to the Board to take the second examination (Principles
 8 Principles and Practice Practices of Land Surveying). An applicant
 9 who passes both examinations and successfully completes the
 10 educational and experience requirements of this subdivision
 11 Surveying examination and upon passing this examination, shall be
 12 granted licensure as a professional land surveyor.

14 d. Graduation from a high school or the completion of a high school
 15 equivalency certificate and meets all of the following:

- 16 1. Has a record satisfactory to the Board of seven-nine years or
 17 more of progressive practical experience, six years of
 18 experience which shall have been under a practicing licensed
 19 professional land surveyor-surveyor.
- 20 2. ~~if the applicant has~~ Has successfully passed the first
 21 ~~examination (Fundamentals Fundamentals of Surveying)~~
 22 Surveying examination.
- 23 3. ~~on or before January 1, 2013, or if the applicant has not~~ Has
 24 ~~successfully passed the first examination on or before January~~

- 40 k. Have successfully passed all of the following:
- 41 1. The Fundamentals of Surveying examination.
 - 42 2. The Principles and Practices of Land Surveying examination.
 - 43 3. Any additional oral and written examinations required by the
 44 Board, all of which shall determine and indicate that the
 45 candidate is competent to practice land surveying.

47 **SECTION 1.(b)** G.S. 89C-10 reads as rewritten:

48 **"§ 89C-10. Board powers.**

49 ...

50 (f) It shall be the responsibility and duty of the Board to conduct a regular program of
 51 investigation concerning all matters within its jurisdiction under the provisions of this Chapter.

1 The investigation of a licensee is confidential until the Board issues a citation to the licensee. The
2 investigation of a nonlicensee is confidential until the Board approves any action authorized
3 under this Chapter against the nonlicensee. The Board may expend its funds for salaries, fees,
4 and per diem expenses, in connection with its investigations, provided that no funds other than
5 per diem expenses shall be paid to any member of the Board in connection with its investigations,
6 nor may any member of the Board give testimony and later sit in deciding on any matter which
7 may directly involve punitive action for the testimony.

9 **SECTION 1.(c)** G.S. 89C-11 reads as rewritten:

10 **"§ 89C-11. Secretary; duties and liabilities; expenditures.**

11 The secretary of the Board shall receive and account for all moneys derived from the
12 operation of the Board as provided in this Chapter, and shall deposit them in one or more special
13 funds in banks or other financial institutions carrying deposit insurance and authorized to do
14 business in North Carolina. The fund or funds shall be designated as "Fund of the Board of
15 Examiners for Engineers and Surveyors" and shall be drawn against only for the purpose of
16 implementing provisions of this Chapter as herein provided. All expenses certified by the Board
17 as properly and necessarily incurred in the discharge of its duties, including authorized
18 compensation, shall be paid out of this ~~fund on the warrant signed by the secretary of the Board-~~
19 fund. At no time shall the total of ~~warrants such certified expenses~~ issued exceed the total amount
20 of funds accumulated under this Chapter. The secretary of the Board shall give a surety bond
21 satisfactory to the State Board of Examiners for Engineers and Surveyors, conditioned upon the
22 faithful performance of the duties assigned. The premium on the bond is a proper and necessary
23 expense of the Board. The secretary of the Board may delegate to the executive director certain
24 routine duties, such as receipt and disbursement of funds in stated amounts by a written
25 authorization, which has the majority approval of the Board."

26 **SECTION 1.(d)** G.S. 89C-17 reads as rewritten:

27 **"§ 89C-17. Expirations and renewals of certificates.**

28 Certificates for licensure of corporations and business firms that engage in the practice of
29 engineering or land surveying shall expire on the last day of the month of June following their
30 issuance or renewal and shall become invalid on that date unless renewed. All other certificates
31 for licensure shall expire on the last day of the month of December next following their issuance
32 or renewal, and shall become invalid on that date unless renewed. When necessary to protect the
33 public health, safety, or welfare, the Board shall require any evidence necessary to establish the
34 continuing competency of engineers and land surveyors as a condition of renewal of licenses.
35 When the Board is satisfied as to the continuing competency of an applicant, it shall issue a
36 renewal of the certificate upon payment by the applicant of a fee fixed by the Board but not to
37 exceed seventy-five dollars (\$75.00). The secretary of the Board shall notify by mail or email
38 every person licensed under this Chapter of the date of expiration of the certificate, the amount
39 of the fee required for its renewal for one year, and any requirement as to evidence of continued
40 competency. The notice shall be sent by email or mailed at least one month in advance of the
41 expiration date of the certificate. Renewal shall be effected at any time during the month
42 immediately following the month of expiration, by payment to the secretary of the Board of a
43 renewal fee, as determined by the Board, which shall not exceed seventy-five dollars (\$75.00).
44 Failure on the part of any licensee to renew the certificate annually in the month immediately
45 following the month of expiration, as required above, shall deprive the licensee of the right to
46 practice until reinstatement of the license. The license may be reinstated at anytime during the
47 first 12 months immediately following the date the license became invalid by payment of a
48 reinstatement fee of one hundred dollars (\$100.00) in addition to the established renewal fee.
49 Failure of a licensee to reinstate the license during the first 12 months immediately following the
50 date the license became invalid shall require the individual, prior to resuming practice in North
51 Carolina, to submit an application on the prescribed form, and to meet all other requirements for

1 licensure as set forth in Chapter 89C. The secretary of the Board is instructed to remove from the
2 official roster of engineers and land surveyors the names of all licensees who have not effected
3 their renewal by the first day of the month immediately following the renewal period. The Board
4 may adopt rules to provide for renewals in distress or hardship cases due to military service,
5 prolonged illness, or prolonged absence from the State, where the applicant for renewal
6 demonstrates to the Board that the applicant has maintained active knowledge and professional
7 status as an engineer or land surveyor, as the case may be. It shall be the responsibility of each
8 licensee to inform the Board promptly concerning change in address. A licensee may request and
9 be granted inactive status. No inactive licensee may practice in this State unless otherwise
10 exempted in this Chapter. A licensee granted inactive status shall pay annual renewal fees but
11 shall not be subject to annual continuing professional competency requirements. A licensee
12 granted inactive status may return to active status by meeting all requirements of the Board,
13 including demonstration of continuing professional competency as a condition of reinstatement."

14 **SECTION 1.(e)** G.S. 89C-22 reads as rewritten:

15 "**§ 89C-22. Disciplinary action – Charges; procedure.**

16 (a) Any person may prefer charges of fraud, deceit, gross negligence, incompetence,
17 misconduct, or violations of this Chapter, the rules of professional conduct, or any rules adopted
18 by the Board against any Board licensee. The charges shall be in writing ~~and shall be sworn to~~
19 ~~by the person or persons making them and or submitted electronically and~~ shall be filed with the
20 Board.

22 **SECTION 2.** This act becomes effective October 1, 2021, and applies to applications
23 for licensure on or after that date.
