1 A BILL TO BE ENTITLED
2 AN ACT TO RENAME THE ONE NORTH CAROLINA SMALL BUSINESS ACCOUNT
3 THE SMALL BUSINESS RESEARCH AND TECHNOLOGY ACCOUNT, TO MAKE
4 VARIOUS ECONOMIC DEVELOPMENT MODIFICATIONS, AND TO APPROPRIATE
5 MONEY FOR VARIOUS ECONOMIC DEVELOPMENT PURPOSES.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.(a)** G.S. 143B-437.71 reads as rewritten:

8 "**§ 143B-437.71. One North Carolina Fund established as a special revenue fund.**

9 (a) Establishment. – The One North Carolina Fund is established as a special revenue
10 fund in the Department of Commerce.

11 (b) Purposes. – Moneys in the One North Carolina Fund may only be allocated pursuant
12 to this subsection. Moneys may be allocated to local governments for use in connection with
13 securing commitments for the recruitment, expansion, or retention of new and existing businesses
14 and to the ~~One North Carolina Small Business Account~~ Small Business Research and Technology
15 Account created pursuant to subsection (c) of this section in an amount not to exceed three million
16 dollars (\$3,000,000). Moneys in the One North Carolina Fund allocated to local governments
17 shall be used for the following purposes only:

- 18 (1) Installation or purchase of equipment.
19 (2) Structural repairs, improvements, or renovations to existing buildings to be
20 used for expansion.
21 (3) Construction of or improvements to new or existing water, sewer, gas, or
22 electric utility distribution lines or equipment for existing buildings.
23 (4) Construction of or improvements to new or existing water, sewer, gas, or
24 electric utility distribution lines or equipment for new or proposed buildings
25 to be used for manufacturing and industrial operations.

26 (4a) Competitive grants for eligible small businesses that locate a new or expand
27 an existing facility in the State to offset costs associated with the facility. The
28 Department shall prioritize grants to recipients that will have the greatest net
29 benefit at the regional and State levels. Grants to a recipient under this
30 subdivision may not exceed (i) five hundred thousand dollars (\$500,000) in
31 any single calendar year, (ii) two million five hundred thousand dollars
32 (\$2,500,000) total, or (iii) a term of distribution over five years. An eligible
33 small business is a business that meets all of the following requirements:

- 34 a. Has 250 or fewer full-time employees, including full-time equivalents
35 or has less than five million dollars (\$5,000,000) in annual gross
36 revenue.



- 1 b. Will invest at least ten million dollars (\$10,000,000) but not more than
2 thirty million dollars (\$30,000,000) in private funds, and hire not more
3 than 250 new employees, as defined in G.S. 143B-437.51, in this State.
4 c. Pays employees an average weekly wage that is at least equal to one
5 hundred ten percent (110%) of the average wage for all insured private
6 employers in the county.

7 (5) Any other purposes specifically provided by an act of the General Assembly.

8 (b1) Awards. – The amounts committed in Governor's Letters issued in a single fiscal year
9 may not exceed seventeen million dollars (\$17,000,000). Of the amount authorized in this
10 subsection, three million dollars (\$3,000,000) is reserved for agreements with local governments
11 located in development tier three areas, as defined in G.S. 143B-437.08, with total employment
12 of 115,000 or less, using the data specified in G.S. 143B-437.52(c)(3).

13 (c) Small Business Research and Technology Account. – There is created in the One
14 North Carolina Fund a special account, the ~~One North Carolina Small Business Account~~, Small
15 Business Research and Technology Account, to be used for the North Carolina SBIR/STTR
16 Incentive Program and the North Carolina SBIR/STTR Matching Funds Program, as specified in
17 Part 2I of Article 10 of Chapter 143B of the General Statutes."

18 **SECTION 1.(b)** G.S. 143B-437.80(a) reads as rewritten:

19 "(a) Program. – There is established the North Carolina SBIR/STTR Incentive Program
20 to be administered by the North Carolina Board of Science, Technology, and Innovation. In order
21 to foster job creation and economic development throughout the State, the Board may provide
22 grants to eligible businesses to offset costs associated with applying for federal Small Business
23 Innovative Research (SBIR) grants or Small Business Technology Transfer Research (STTR)
24 grants. The grants shall be paid from the ~~One North Carolina Small Business Account~~ Small
25 Business Research and Technology Account established in G.S. 143B-437.71."

26 **SECTION 1.(c)** G.S. 143B-437.83 reads as rewritten:

27 "**§ 143B-437.83. Reports.**

28 The Department of Commerce shall publish a report on the use of funds in the ~~One North~~
29 ~~Carolina Small Business Account~~ Small Business Research and Technology Account on
30 September 1 of each year until all funds have been expended. The report shall contain information
31 on the disbursement and use of funds allocated under the One North Carolina Small Business
32 Program. The report must be submitted to the following:

33 "

34 **SECTION 2.** There is appropriated from the General Fund to the Main Street
35 Solutions Fund established in G.S. 143B-472.35 the sum of twenty-five million dollars
36 (\$25,000,000) for the 2024-2025 fiscal year for the Department of Commerce to use for purposes
37 consistent with that Fund.

38 **SECTION 3.** There is appropriated from the General Fund to the Rural Infrastructure
39 Authority the sum of fifteen million dollars (\$15,000,000) for the 2024-2025 fiscal year for the
40 Authority to use for the purposes set forth in G.S. 143B-472.127(a)(2).

41 **SECTION 4.** There is appropriated from the General Fund to the Department of
42 Transportation the sum of thirty million dollars (\$30,000,000) for the 2024-2025 fiscal year to
43 be allocated to the North Carolina Ports Authority for the Authority to use for the construction
44 of a roll-on-roll-off facility for the Port of Morehead City.

45 **SECTION 5.** There is appropriated from the General Fund to the Department of
46 Commerce, Rural Economic Developmental Division (REDD), the sum of fifteen million dollars
47 (\$15,000,000) for the 2024-2025 fiscal year to be used for purposes consistent with the Rural
48 Downtown Transformation Grant Program established in Section 11.12 of S.L. 2021-180. REDD
49 may use up to five percent (5%) of the funds appropriated in this section to administer the
50 Program.

1 **SECTION 6.** Sections 2, 3, 4, and 5 of this act become effective July 1, 2024. Except
2 as otherwise provided, the remainder of this act is effective when it becomes law.
