HOUSE BILL DRH10031-NK-10

Short Title: Make North Carolina Home Act of 2023. (Public)

AN ACT TO TRANSLATE THE NORTH CAROLINA STATE BUILDING CODE INTO
SPANISH; TO DIRECT THE DEPARTMENT OF COMMERCE TO ESTABLISH A
WEBSITE TO TRACK ALL LOCAL PLANNING, ZONING, AND LAND-USE
REGULATIONS; AND TO DIRECT THE DEPARTMENT OF COMMERCE TO
DEVELOP A PROGRAM TO PARTNER WITH COUNTIES ON RESIDENTIAL SITE
SELECTION.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 143-138(g) reads as rewritten:

"(g) Publication and Distribution of Code. – ~~The Building Code Council shall cause to be printed, after adoption by the Council, the North Carolina State Building Code and each amendment thereto.~~ After the Building Code Council adopts the North Carolina State Building Code, the Council shall cause the Code and each amendment thereto to be printed in English and to be translated into Spanish. It shall, at the State's expense, distribute copies of the Code and each amendment to State and local governmental officials, departments, agencies, and educational institutions, as is set out in the table below. It shall also make the translated Spanish copies of the Code available for distribution on written request to the Council. (Those marked by an asterisk will receive copies only on written request to the Council.)

18 In addition, the Building Code Council shall make additional copies available at such price
19 as it shall deem reasonable to members of the general public. The proceeds from sales of the
20 Building Code shall be credited to the Insurance Regulatory Fund under G.S. 58-6-25."

21 **SECTION 2.** The Building Code Council shall submit a report on its progress
22 regarding the translation and publication of the North Carolina State Building Code in the
23 Spanish language to the Joint Legislative Oversight Committee on General Government by April
24 1, 2024.

25 **SECTION 3.** The Department of Commerce shall establish and maintain a public
26 website to track all local planning, zoning, and land-use regulations pursuant to G.S. 160D for
27 the following purposes:

- 28 (1) Create transparency for the public in the various land-use and building
29 permitting processes across localities.
- 30 (2) Allow prospective developers to understand, compare, and contrast the
31 various markets and building requirements in different areas.
- 32 (3) Provide a central location of information to assist local planning departments
33 and board members in obtaining details on policies.

34 **SECTION 4.** The Department of Commerce shall develop and establish a program
35 to partner with counties on residential site selection in the State, establishing measurable goals
36 to fulfill housing needs in growing areas of the State by the year 2033. The website should contain
37 a repository of sites and locations to allow interested parties to make an informed site location
38 decision. The website would allow developers looking to build residential spaces in the State to
39 determine a suitable market and the prospective profitability of a given site.

40 **SECTION 5.** Section 1 of this act becomes effective January 1, 2025. Section 3 of
41 this act becomes effective July 1, 2023. Section 4 of this act becomes effective August 1, 2023.
42 The remainder of this act is effective when it becomes law.
