21 Gaston County is appointed to the Brain Injury Advisory Council for a term expiring June 30,
22 2029.

23 **SECTION 2.114.** Effective January 1, 2025, Ronald Jackson of Moore County is
24 appointed to the Residential Code Council for a term expiring December 31, 2030.

25 **SECTION 2.115.** Effective January 1, 2025, Robert Privott of Lee County is
26 appointed to the Residential Code Council for a term expiring December 31, 2028.

27 **SECTION 2.116.** Effective January 1, 2025, E. Landon Weaver of Pitt County is
28 appointed to the Residential Code Council for a term expiring December 31, 2026.
