General Assembly Of North Carolina

1 **SECTION 2.** The Criminal Justice Education and Training Standards Commission 2 and the Sheriffs' Education and Training Standards Commission shall promulgate rules 3 consistent with G.S. 17F-15, as created by Section 1 of this act.

4 **SECTION 3.** This act is effective when it becomes law and applies to assistance 5 provided on or after that date.
