HOUSE BILL DRH30039-NG-18

Short Title: Study Commission for LEA Size. (Public)

Sponsors: Representative Lambeth.

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO ESTABLISH THE STUDY COMMISSION ON LARGE LOCAL SCHOOL  
3 ADMINISTRATIVE UNITS.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.(a)** There is created the Study Commission on Large Local School  
6 Administrative Units (Commission). The purpose of the Commission is to study whether the  
7 local school administrative units with the five largest student populations in the State experience  
8 any negative outcomes due to the large student populations and to suggest remedies to any  
9 negative outcomes caused by the size of the student populations.

10 **SECTION 1.(b)** The Commission shall consist of nine voting members as follows:

- 11 (1) A chair, jointly appointed by the Speaker of the House of Representatives and  
12 the President Pro Tempore of the Senate from among the membership of the  
13 General Assembly. Resignation of the member from membership in the  
14 General Assembly shall be deemed a resignation from the Commission.
- 15 (2) Two members of the House of Representatives appointed by the Speaker of  
16 the House of Representatives. Resignation of the member from the House of  
17 Representatives shall be deemed a resignation from the Commission.
- 18 (3) Two members of the Senate appointed by the President Pro Tempore of the  
19 Senate. Resignation of the member from the Senate shall be deemed a  
20 resignation from the Commission.
- 21 (4) One member from a local board of education of one of the five local school  
22 administrative units with the largest student populations to be appointed by  
23 the Speaker of the House of Representatives. The member shall be from a  
24 different local board of education than the member appointed pursuant to  
25 subdivision (5) of this subsection. Resignation of the member from the local  
26 board of education shall be deemed a resignation from the Commission.
- 27 (5) One member from a local board of education of one of the five local school  
28 administrative units with the largest student populations to be appointed by  
29 the President Pro Tempore of the Senate. The member shall be from a different  
30 local board of education than the member appointed pursuant to subdivision  
31 (4) of this subsection. Resignation of the member from the local board of  
32 education shall be deemed a resignation from the Commission.
- 33 (6) Two members shall be recommended by the Department of Public Instruction  
34 and shall be jointly appointed by the Speaker of the House of Representatives  
35 and the President Pro Tempore of the Senate.



1           **SECTION 1.(c)** The Commission shall meet upon the call of the chair. Any vacancy  
2 on the Commission shall be filled by the original appointing authority within 30 days of the  
3 vacancy occurring. If a recommendation is required for the initial appointment of a member, the  
4 recommending authority shall provide a recommendation to fill the vacancy. A quorum of the  
5 Commission shall be a majority of its members.

6           **SECTION 1.(d)** The Commission shall study any negative outcomes in the five  
7 largest local school administrative units in the State, determine if any of those outcomes are  
8 caused by the large population of the unit, and develop recommendations on methods of  
9 addressing the outcomes.

10          **SECTION 1.(e)** Members of the Commission shall receive per diem, subsistence,  
11 and travel allowances in accordance with G.S. 120-3.1, 138-5, or 138-6, as appropriate. The  
12 Commission, while in the discharge of its official duties, may exercise all powers provided for  
13 under G.S. 120-19 and G.S. 120-19.1 through G.S. 120-19.4. The Commission may meet in the  
14 Legislative Building or the Legislative Office Building.

15          With approval of the Legislative Services Commission, the Legislative Services  
16 Officer shall assign professional staff to assist the Commission in its work. The House of  
17 Representatives' and the Senate's Directors of Legislative Assistants shall assign clerical staff to  
18 the Commission, and the expenses relating to the clerical employees shall be borne by the  
19 Commission. The Commission may contract for professional, clerical, or consultant services as  
20 provided by G.S. 120-32.02. If the Commission hires a consultant, the consultant shall not be a  
21 State employee or a person currently under contract with the State to provide services.

22          All State departments and agencies and local governments and their subdivisions shall  
23 furnish the Commission with any information in their possession or available to them.

24          **SECTION 1.(f)** The Commission shall report the results of its study and its  
25 recommendations, including any proposed legislative changes, to the 2026 Regular Session of  
26 the 2025 General Assembly. The Commission shall terminate on December 31, 2026, or upon  
27 the filing of its final report, whichever occurs first.

28          **SECTION 1.(g)** Of the funds appropriated to the General Assembly, the Legislative  
29 Services Commission shall allocate funds for the expenses of the Study Commission on Large  
30 Local School Administrative Units.

31          **SECTION 2.** This act is effective when it becomes law.
