4 The General Assembly of North Carolina enacts:

6 **PART I. REORGANIZATION OF CHAPTER 115D**

7 **SECTION 1.(a)** Article 1 of Chapter 115D of the General Statutes reads as rewritten:
8 "Article 1.

9 "General Provisions for State Administration.

10 "Part 1. Establishment and Administration of the North Carolina Community Colleges System.

11 "**§ 115D-1. Statement of purpose.**

12 The purposes of this Chapter are to provide for the establishment, organization, and
13 administration of a system of educational institutions throughout the State offering courses of
14 instruction in one or more of the general areas of two-year college parallel, technical, vocational,
15 and adult education programs, to serve as a legislative charter for such institutions, and to
16 authorize the levying of local taxes and the issuing of local bonds for the support thereof. The
17 major purpose of each and every institution operating under the provisions of this Chapter shall
18 be and shall continue to be the offering of vocational and technical education and training, and
19 of basic, high school level, academic education needed in order to profit from vocational and
20 technical education, for students who are high school graduates or who are beyond the
21 compulsory age limit of the public school system and who have left the public schools, provided,
22 juveniles of any age committed to the Division of Juvenile Justice of the Department of Public
23 Safety by a court of competent jurisdiction may, if approved by the director of the youth
24 development center to which they are assigned, take courses offered by institutions of the system
25 if they are otherwise qualified for admission.

26 The Community Colleges System Office is designated as the primary lead agency for
27 delivering workforce development training, adult literacy training, and adult education programs
28 in the State.

30 "~~§ 115D-1.3. Accreditation of secondary school located in North Carolina shall not be a~~
31 ~~factor in admissions, loans, scholarships, or other educational policies.~~

32 (a) ~~For purposes of this section, the term "accreditation" shall include certification or any~~
33 ~~other similar approval process.~~

34 (b) ~~The State Board of Community Colleges shall adopt a policy that prohibits any~~
35 ~~community college from soliciting or using information regarding the accreditation of a~~
36 ~~secondary school located in North Carolina that a person attended as a factor affecting~~

5 reporting requirements.~~

7 (b) ~~The State Board of Community Colleges may approve the addition of the college
8 transfer program to a community college. If addition of the college transfer program to an
9 institution would require a substantial increase in funds, State Board approval shall be subject to
10 appropriation of funds by the General Assembly for this purpose.~~

11 (c) ~~Addition of the college transfer program shall not decrease an institution's ability to
12 provide programs within its basic mission of vocational and technical training and basic academic
13 education.~~

14 (d) ~~The State Board of Community Colleges shall develop appropriate criteria and
15 standards to regulate the addition of the college transfer program to institutions.~~

16 (e) ~~The State Board of Community Colleges shall develop appropriate criteria and
17 standards to regulate the operation of college transfer programs.~~

18 (f) ~~The Board of Governors of The University of North Carolina shall report to each
19 community college and to the State Board of Community Colleges in accordance with
20 G.S. 116-11(10b) on the academic performance of that community college's transfer students. If
21 the State Board of Community Colleges finds that college transfer students from a community
22 college are not consistently performing adequately at a four-year college, the Board shall review
23 the community college's program and determine what steps are necessary to remedy the problem.
24 The Board shall report annually to the General Assembly on the reports it receives and on what
25 steps it is taking to remedy problems that it finds.~~

26 (g) ~~The Community Colleges System Office shall report by April 15, 2011, and annually
27 thereafter, to the Joint Legislative Education Oversight Committee, the State Board of Education,
28 the Office of State Budget and Management, and the Fiscal Research Division of the General
29 Assembly on the implementation of the UNC-NCCCS 2+2 E-Learning Initiative. This report
30 shall include:~~

31 (1) ~~The courses and programs within the 2+2 E-Learning Initiative;~~

32 (2) ~~The total number of prospective teachers that have taken or are taking part in
33 this initiative to date broken down by the current academic period and each of
34 the previous academic periods since the program's inception;~~

36 school administrative unit, who have taken part in this initiative;~~

37 (4) ~~The change in the number of teachers available to schools since the program's
38 inception;~~

39 (5) ~~The qualitative data from students, teachers, local school administrative unit
40 personnel, university personnel, and community college personnel as to the
41 impact of this initiative on our State's teaching pool; and~~

42 (6) ~~An explanation of the expenditures and collaborative programs between the
43 North Carolina Community College System and The University of North
44 Carolina, including recommendations for improvement.~~

45 ~~"§ 115D-5. Administration of institutions by State Board of Community Colleges;
46 personnel exempt from North Carolina Human Resources Act; extension
47 courses; tuition waiver; in-plant training; contracting, etc., for establishment
48 and operation of extension units of the community college system; use of existing
49 public school facilities.~~

50 (a) ~~The State Board of Community Colleges may adopt and execute such policies,
51 regulations and standards concerning the establishment, administration, and operation of~~

1 institutions as the State Board may deem necessary to insure the quality of educational programs,
2 to promote the systematic meeting of educational needs of the State, and to provide for the
3 equitable distribution of State and federal funds to the several institutions.

4 The State Board of Community Colleges shall establish standards and scales for salaries and
5 allotments paid from funds administered by the State Board, and all employees of the institutions
6 shall be exempt from the provisions of the North Carolina Human Resources Act. Any and all
7 salary caps set by the State Board for community college presidents shall apply only to the
8 State-paid portion of the salary. Except as otherwise provided by law, the employer contribution
9 rate on the local-paid portion of the salary, to be paid from local funds, shall be set by the State
10 Treasurer based on actuarial recommendations. The State Board shall have authority with respect
11 to individual institutions: to approve sites, capital improvement projects, budgets; to approve the
12 selection of the chief administrative officer; to establish and administer standards for professional
13 personnel, curricula, admissions, and graduation; to regulate the awarding of degrees, diplomas,
14 and certificates; to establish and regulate student tuition and fees within policies for tuition and
15 fees established by the General Assembly; and to establish and regulate financial accounting
16 procedures.

17 The State Board of Community Colleges shall require each community college to meet the
18 faculty credential requirements of its accrediting agency for all community college programs.

19 (a1) Notwithstanding G.S. 66-58(c)(3) or any other provisions of law, the State Board of
20 Community Colleges may adopt rules governing the expenditure of funds derived from bookstore
21 sales by community colleges. These expenditures shall be consistent with the mission and
22 purpose of the Community College System. Profits may be used in the support and enhancement
23 of the bookstores, for student aid or scholarships, for expenditures of direct benefit to students,
24 and for other similar expenditures authorized by the board of trustees, subject to rules adopted
25 by the State Board. These funds shall not be used to supplement salaries of any personnel.

26 (a2) The State Board of Community Colleges shall comply with the provisions of
27 G.S. 116-11(10a) to plan and implement an exchange of information between the public schools
28 and the institutions of higher education in the State.

29 (a3) The State Board of Community Colleges shall adopt the following rules to assist
30 community colleges in their administration of procedures necessary to implement G.S. 20-11 and
31 G.S. 20-13.2:

- 32 (1) To establish the procedures a person who is or was enrolled in a community
33 college must follow and the requirements that person must meet to obtain a
34 driving eligibility certificate.
- 35 (2) To require the person who is required under G.S. 20-11(n) to sign the driving
36 eligibility certificate to provide the certificate if he or she determines that one
37 of the following requirements is met:
 - 38 a. The person seeking the certificate is eligible for the certificate under
39 G.S. 20-11(n)(1) and is not subject to G.S. 20-11(n1).
 - 40 b. The person seeking the certificate is eligible for the certificate under
41 G.S. 20-11(n)(1) and G.S. 20-11(n1).
- 42 (3) To provide for an appeal through the grievance procedures established by the
43 board of trustees of each community college by a person who is denied a
44 driving eligibility certificate.
- 45 (4) To define exemplary student behavior and to define what constitutes the
46 successful completion of a drug or alcohol treatment counseling program.

47 The State Board also shall develop policies as to when it is appropriate to
48 notify the Division of Motor Vehicles that a person who is or was enrolled in
49 a community college no longer meets the requirements for a driving eligibility
50 certificate. The State Board also shall adopt guidelines to assist the presidents

1 of community colleges in their designation of representatives to sign driving
2 eligibility certificates.

3 ~~The State Board shall develop a form for the appropriate individuals to~~
4 ~~provide their written, irrevocable consent for a community college to disclose~~
5 ~~to the Division of Motor Vehicles that the student no longer meets the~~
6 ~~conditions for a driving eligibility certificate under G.S. 20-11(n)(1) or~~
7 ~~G.S. 20-11(n1), if applicable, in the event that this disclosure is necessary to~~
8 ~~comply with G.S. 20-11 or G.S. 20-13.2. Other than identifying under which~~
9 ~~statutory subsection the student is no longer eligible, no other details or~~
10 ~~information concerning the student's school record shall be released pursuant~~

12 (b) ~~In order to make instruction as accessible as possible to all citizens, the teaching of~~
13 ~~curricular courses and of noncurricular extension courses at convenient locations away from~~
14 ~~institution campuses as well as on campuses is authorized and shall be encouraged. A pro rata~~
15 ~~portion of the established regular tuition rate charged a full time student shall be charged a~~
16 ~~part time student taking any curriculum course. In lieu of any tuition charge, the State Board of~~
17 ~~Community Colleges shall establish a uniform registration fee, or a schedule of uniform~~
18 ~~registration fees, to be charged students enrolling in extension courses for which instruction is~~
19 ~~financed primarily from State funds. The State Board of Community Colleges may provide by~~
20 ~~general and uniform regulations for waiver of tuition and registration fees for the following:~~

Community colleges may also use State and local funds to pay tuition and registration fees~~

1 for professional development courses and for other courses consistent with the academic
2 assistance program authorized by the State Human Resources Commission.

3 (b2) ~~Beginning February 1, 2018, and annually thereafter, the Community Colleges
4 System Office shall report to the Joint Legislative Education Oversight Committee on the number
5 and type of waivers granted pursuant to subsection (b) of this section.~~

6 (c) ~~No course of instruction shall be offered by any community college at State expense
7 or partial State expense to any captive or co-opted group of students, as defined by the State

45 in accordance with G.S. 115D-6.2.~~

46 (g) ~~Funds appropriated to the Community Colleges System Office as operating expenses
47 for allocation to the institutions comprising the North Carolina Community College System shall
48 not be used to support recreation extension courses. The financing of these courses by any
49 institution shall be on a self-supporting basis, and membership hours produced from these
50 activities shall not be counted when computing full-time equivalent students (FTE) for use in
51 budget funding formulas at the State level.~~

1 (h) ~~Whenever a community college offers real estate continuing education courses~~

22 State Board of Community Colleges may approve the use of up to eight percent (8%) for the
23 training and support of regional community college personnel to deliver Customized Training
24 Program services to business and industry.

25 **(f)** The State Board shall adopt guidelines to implement this section. At least 20 days
26 before the effective date of any criteria or nontechnical amendments to guidelines, the State
27 Board must publish the proposed guidelines on the Community Colleges System Office's website
28 and provide notice to persons who have requested notice of proposed guidelines. In addition, the
29 State Board must accept oral and written comments on the proposed guidelines during the 15
30 business days beginning on the first day that the State Board has completed these notifications.
31 For the purpose of this subsection, a technical amendment is either of the following:

32 **(1)** An amendment that corrects a spelling or grammatical error.

33 **(2)** An amendment that makes a clarification based on public comment and could
34 have been anticipated by the public notice that immediately preceded the
35 public comment.

36 **"§ 115D-10.19. Short-Term Workforce Development Grant Program.**

37 **(a)** Program Established. – There is established the North Carolina Community College
38 Short-Term Workforce Development Grant Program (Program) to be administered by the State
39 Board of Community Colleges. The State Board shall adopt rules for the disbursement of the
40 grants pursuant to this section.

41 **(b)** Programs of Study. – The State Board of Community Colleges, in collaboration with
42 the Department of Commerce, shall determine the eligible programs of study for the Program,
43 according to the occupations that are in the highest demand in the State. The eligible programs
44 of study shall include programs such as architecture and construction, health sciences,
45 information technology, electrical line worker, and manufacturing programs and may include
46 other programs to meet local workforce needs.

47 **(c)** Award Amounts. – To the extent funds are made available for the Program, the State
48 Board of Community Colleges shall award grants in an amount of up to seven hundred fifty
49 dollars (\$750.00) to students pursuing short-term, noncredit State and industry workforce
50 credentials. The State Board of Community Colleges shall establish criteria for initial and
51 continuing eligibility for students. At a minimum, students shall be required to qualify as a

1 resident for tuition purposes under the criteria set forth in G.S. 116-143.1 and in accordance with
2 the coordinated and centralized residency determination process administered by the State
3 Education Assistance Authority.

4 (d) Report. – The State Board shall submit a report by April 1 annually on the Program
5 to the Joint Legislative Education Oversight Committee and the Fiscal Research Division. The
6 report shall contain, for each academic year and by programs of study, the amount of grant funds
7 disbursed and the number of eligible students receiving funds.

8 **"§ 115D-10.21. Training programs for students with intellectual and developmental**
9 **disabilities.**

10 (a) The State Board of Community Colleges shall establish a community college training
11 program for up to 15 community colleges. The program shall provide opportunities for
12 micro-credentials or other credentials that lead to increased employment outcomes for
13 individuals with intellectual and developmental disabilities (IDD). To the extent funds are
14 appropriated for this purpose, the program shall improve the ability of participating community
15 colleges to offer training and educational components that include improving employability skills
16 and providing on-the-job training and apprenticeships with business and industry for individuals
17 with IDD. The goal of the program shall be to inform community colleges and address
18 cross-departmental supports within the individual community colleges on programs for
19 individuals with IDD related to at least the following:

- 20 (1) Establishing best practices for providing vocational training for individuals
21 with IDD.
- 22 (2) Providing financial and benefits counseling.
- 23 (3) Developing strategies on integrating assistive technology.
- 24 (4) Maximizing access, with supports, to credential and degree programs,
25 including micro-credentials that are established by the State Board.
- 26 (5) Identifying methods to increase orientation and integration of individuals with
27 IDD into the college community to the greatest extent possible.
- 28 (6) Determining a needs assessment, marketing, and evaluation to serve a broad
29 array of individuals with developmental and other similar disabilities or
30 learning challenges to assure adequate demand for new or existing programs.

31 (b) No later than May 1 of each year, the Community Colleges System Office shall report
32 on the funds appropriated to the System Office for the purposes of this section to the Joint
33 Legislative Education Oversight Committee and the Fiscal Research Division. At a minimum,
34 the report shall address the impact of the program, the use of any additional positions created at
35 community colleges, professional development training for staff, and funding sources identified
36 for individuals with IDD to build programs at community colleges that support postsecondary
37 trainings and certifications that enable individuals with IDD to engage in competitive, sustainable
38 employment.

39 **"§ 115D-10.25. Commercial fishing and aquaculture classes.**

40 (a) The General Assembly urges all community colleges serving the coastal area of the
41 State to offer classes on commercial fishing and aquaculture.

42 (b) The North Carolina Community Colleges System Office shall provide technical
43 assistance to these colleges on offering such classes.

44 (c) The North Carolina Community Colleges System Office shall report to the Joint
45 Legislative Education Oversight Committee on any fiscal and administrative issues it identifies
46 that limit colleges' ability to offer such courses.

47 **"§ 115D-10.30. Correction education programs.**

48 (a) Approval. – No course of instruction shall be offered by any community college at
49 State expense or partial State expense to any captive or co-opted group of students, as defined by
50 the State Board of Community Colleges, without prior approval of the State Board. All course
51 offerings approved for State prison inmates or prisoners in local jails must be tied to clearly

1 identified job skills, transition needs, or both. Approval by the State Board shall be presumed to
2 constitute approval of both the course and the group served by that institution. The State Board
3 may delegate to the President the power to make an initial approval, with final approval to be
4 made by the State Board. A course taught without such approval will not yield any full-time
5 equivalent students, as defined by the State Board. Community colleges shall report full-time
6 equivalent (FTE) student hours for correction education programs on the basis of student
7 membership hours. Funds appropriated for community college courses for prison inmates shall
8 be used only for inmates in State prisons. The first priority for the use of these funds shall be to
9 restore the FTE for basic skills courses to the FY 2008-2009 level. Funds not needed for this
10 purpose may be used for continuing education and curriculum courses related to job skills
11 training. No community college shall operate a multi-entry/multi-exit class or program in a prison
12 facility, except for a literacy class or program. The State Board shall work with the Division of
13 Adult Correction and Juvenile Justice of the Department of Public Safety on offering classes and
14 programs that match the average length of stay of an inmate in a prison facility.

15 (b) Courses in Federal Prisons. – Courses in federal prisons shall not earn regular budget
16 full-time equivalents but may be offered on a self-supporting basis.

17 **"§ 115D-10.35. Teacher residency licensure courses.**

18 The North Carolina Community College System may offer courses, in accordance with
19 Article 17D of Subchapter V of Chapter 115C of the General Statutes, to individuals who choose
20 to enter the teaching profession through residency licensure.

21 **"§ 115D-10.40. American Sign Language courses.**

22 The State Board of Community Colleges shall develop curriculum and continuing education
23 standards for courses of instruction in American Sign Language and shall encourage community
24 colleges to offer courses in American Sign Language as a modern foreign language.

25 **"§ 115D-10.45. Adult high school equivalency diploma test.**

26 The State Board of Community Colleges may establish, retain, and budget fees charged to
27 students taking an adult high school equivalency diploma test, including fees for retesting. Fees
28 collected for this purpose shall be used only to (i) offset the costs of the test, including the cost
29 of scoring the test, (ii) offset the costs of printing adult high school equivalency diplomas, and
30 (iii) meet federal and State reporting requirements related to the test.

31 **"§ 115D-10.50. Motorcycle Safety Instruction Program.**

32 (a) There is created a Motorcycle Safety Instruction Program for the purpose of
33 establishing statewide motorcycle safety instruction to be delivered through the Community
34 Colleges System Office. The Program may be administered by a motorcycle safety coordinator
35 who shall be responsible for the planning, curriculum, and completion requirements of the
36 Program. The State Board of Community Colleges may elect a motorcycle safety coordinator
37 upon nomination of the President of the Community College System, and the compensation of
38 the motorcycle safety coordinator shall be fixed by the State Board upon recommendation of the
39 President of the Community College System pursuant to G.S. 115D-3. The State Board of
40 Community Colleges may contract with an appropriate public or private agency or person to
41 carry out the duties of the motorcycle safety coordinator.

42 (b) The Motorcycle Safety Instruction Program shall be implemented through the
43 Community Colleges System Office at institutions which choose to provide the Program. The
44 motorcycle safety coordinator shall select and facilitate the training and certification of
45 instructors who will implement the Program.

46 "Part 4. Students.

47 **"§ 115D-10.65. Accreditation of secondary school located in North Carolina shall not be a**
48 **factor in admissions, loans, scholarships, or other educational policies.**

49 (a) For purposes of this section, the term "accreditation" shall include certification or any
50 other similar approval process.

1 **(b) The State Board of Community Colleges shall adopt a policy that prohibits any**
2 **community college from soliciting or using information regarding the accreditation of a**
3 **secondary school located in North Carolina that a person attended as a factor affecting**
4 **admissions, loans, scholarships, or other educational activity at the community college, unless**
5 **the accreditation was conducted by a State agency.**

6 **"§ 115D-10.70. Driving eligibility certificates.**

7 **(a) The State Board of Community Colleges shall adopt the following rules to assist**
8 **community colleges in their administration of procedures necessary to implement G.S. 20-11 and**
9 **G.S. 20-13.2:**

10 **(1) To establish the procedures a person who is or was enrolled in a community**
11 **college must follow and the requirements that person must meet to obtain a**
12 **driving eligibility certificate.**

13 **(2) To require the person who is required under G.S. 20-11(n) to sign the driving**
14 **eligibility certificate to provide the certificate if he or she determines that one**
15 **of the following requirements is met:**

16 **a. The person seeking the certificate is eligible for the certificate under**
17 **G.S. 20-11(n)(1) and is not subject to G.S. 20-11(n1).**

18 **b. The person seeking the certificate is eligible for the certificate under**
19 **G.S. 20-11(n)(1) and G.S. 20-11(n1).**

20 **(3) To provide for an appeal through the grievance procedures established by the**
21 **board of trustees of each community college by a person who is denied a**
22 **driving eligibility certificate.**

23 **(4) To define exemplary student behavior and to define what constitutes the**
24 **successful completion of a drug or alcohol treatment counseling program.**

25 **(b) The State Board shall develop policies as to when it is appropriate to notify the**
26 **Division of Motor Vehicles that a person who is or was enrolled in a community college no**
27 **longer meets the requirements for a driving eligibility certificate. The State Board also shall adopt**
28 **guidelines to assist the presidents of community colleges in their designation of representatives**
29 **to sign driving eligibility certificates.**

30 **(c) The State Board shall develop a form for the appropriate individuals to provide their**
31 **written, irrevocable consent for a community college to disclose to the Division of Motor**
32 **Vehicles that the student no longer meets the conditions for a driving eligibility certificate under**
33 **G.S. 20-11(n)(1) or G.S. 20-11(n1), if applicable, in the event that this disclosure is necessary to**
34 **comply with G.S. 20-11 or G.S. 20-13.2. Other than identifying under which statutory subsection**
35 **the student is no longer eligible, no other details or information concerning the student's school**
36 **record shall be released pursuant to this consent.**

37 **"§ 115D-10.75. Excused absences for religious observances.**

38 **The State Board of Community Colleges shall direct each community college to adopt a**
39 **policy that authorizes a minimum of two excused absences each academic year for religious**
40 **observances required by the faith of a student. The policy may require that the student provide**
41 **written notice of the request for an excused absence a reasonable time prior to the religious**
42 **observance. The policy shall also provide that the student shall be given the opportunity to make**
43 **up any tests or other work missed due to an excused absence for a religious observance.**

44 **"§ 115D-10.76. Excused absences for National Guard service members.**

45 **The State Board of Community Colleges shall adopt a policy to be applied uniformly**
46 **throughout the Community College System to provide that any student enrolled in a community**
47 **college who is a National Guard service member placed onto State active duty status during an**
48 **academic term shall be given an excused absence for the period of time the student is on active**
49 **duty. The policy shall further provide all of the following:**

50 **(1) The student shall be given the opportunity to make up any test or other work**
51 **missed during the excused absence.**

- 1 (2) The student shall be given the option, when feasible, to continue classes and
 2 coursework during the academic term through online participation for the
 3 period of time the student is placed on active duty.
- 4 (3) The student shall be given the option of receiving a temporary grade of
 5 "incomplete (IN)" or "absent from the final exam (AB)" for any course that
 6 the student was unable to complete as a result of being placed on State active
 7 duty status; however, the student must complete the course requirements
 8 within the period of time specified by the community college to avoid
 9 receiving a failing grade for the course.
- 10 (4) The student shall be permitted to drop, with no penalty, any course that the
 11 student was unable to complete as a result of being placed on State active duty
 12 status."

13 local school administrative unit.

20 **"§ 115D-30.5. Evaluation of Career and College Promise Program.**

21 (a) Evaluation. – In addition to the evaluation of cooperative innovative high schools by
22 the State Board of Education pursuant to G.S. 115C-238.55, the State Board of Community
23 Colleges, in conjunction with the State Board of Education and the Board of Governors of The
24 University of North Carolina, shall evaluate the success of students participating in the Career
25 and College Promise Program, including the College Transfer pathway and the Career and
26 Technical Education pathway.

27 (b) Metrics. – Success shall be measured by high school retention rates, high school
28 completion rates, high school dropout rates, certification and associate degree completion,
29 admission to four-year institutions, postgraduation employment in career or study-related fields,
30 and employer satisfaction of employees who participated in the programs. The evaluation shall
31 also include an analysis of the cost of students participating in each of the programs within the

40 (3) Any additional costs of a student attending courses on campus if a student is
41 not attending public school in a local school administrative unit for the
42 majority of the student's instructional time.

43 (c) Report. – The Boards shall jointly report by March 15 of each year to the Joint
44 Legislative Education Oversight Committee, the Senate Appropriations Committee on
45 Education/Higher Education, the House Appropriations Committee on Education, and the Fiscal
46 Research Division of the General Assembly. The report shall be combined with the evaluation
47 of cooperative innovative high schools required by G.S. 115C-238.55, and the Community
48 Colleges System Office shall be responsible for submitting the combined report.

49 **"§ 115D-30.10. Cooperative innovative high schools.**

1 Subject to the approval of the State Board of Community Colleges, local community colleges
2 may collaborate with local school administrative units to offer cooperative innovative high
3 school programs, as provided by Part 9 of Article 16 of Chapter 115C of the General Statutes.

4 **"§ 115D-30.15. Noncredit courses.**

5 Subject to rules adopted by the State Board of Community Colleges, local community
6 colleges may provide for the following:

- 7 (1) During the summer quarter, persons less than 16 years old may be permitted
8 to take noncredit courses on a self-supporting basis.
- 9 (2) High school students may be permitted to take noncredit courses in safe
10 driving on a self-supporting basis during the academic year or the summer.
- 11 (3) High school students 16 years and older may be permitted to take noncredit
12 courses, except adult basic skills.
- 13 (4) Notwithstanding any other provision of this Article, qualified youth 15 years

18 **"§ 115D-30.20. Gateway to College Program.**

19 The purpose of the first semester of the Gateway to College Program is to address additional
20 support to successfully complete the Program. Students may need to take developmental courses
21 necessary for the transition to more challenging courses; therefore, the State Board of Community
22 Colleges shall (i) permit high school students who are enrolled in Gateway to College Programs
23 to enroll in developmental courses based on an assessment of their individual student needs by a
24 high school and community college staff team and (ii) include this coursework in computing the
25 budget FTE for the colleges.

26 **"§ 115D-30.25. NC Career Coach Program.**

27 (a) Purpose. – There is established the NC Career Coach Program to place community
28 college career coaches in high schools to assist students with determining career goals and
29 identifying community college programs that would enable students to achieve these goals.

30 (b) Memorandum of Understanding. – The board of trustees of a community college and
31 a local board of education of a local school administrative unit within the service area of the
32 community college shall enter into a memorandum of understanding for the placement of career
33 coaches employed by the board of trustees of the community college in schools within the local
34 school administrative unit. At a minimum, the memorandum of understanding shall include the
35 following:

- 36 (1) Requirement that the community college provides the following:
 - 37 a. Hiring, training, and supervision of career coaches. The board of
38 trustees may include a local board of education liaison on the hiring
39 committee to participate in the decision making regarding hiring for
40 the coach positions.
 - 41 b. Salary, benefits, and all other expenses related to the employment of
42 the career coach. The coach will be an employee of the board of
43 trustees and will not be an agent or employee of the local board of
44 education.
 - 45 c. Development of pedagogical materials and technologies needed to
46 enhance the advising process.
 - 47 d. Criminal background checks required by the local school
48 administrative unit for employees working directly with students.
 - 49 e. Agreement that, while on any school campus, the career coach will
50 obey all local board of education rules and will be subject to the
51 authority of the school building administration.

- 1 (2) Requirement that the local school administrative unit provides the following
2 to career coaches:
3 a. Access to student records, as needed to carry out the coach's job
4 responsibilities.
5 b. Office space on site appropriate for student advising.
6 c. Information technology resources, including, but not limited to,
7 internet access, telephone, and copying.
8 d. Initial school orientation and ongoing integration into the faculty and
9 staff community.
10 e. Promotion of school-wide awareness of coach duties.
11 f. Facilitation of the coach's access to individual classes and larger
12 assemblies for the purposes of awareness building.

13 (c) Application for NC Career Coach Program Funding. – The board of trustees of a
14 community college and a local board of education of a local school administrative unit within the
15 service area of the community college jointly may apply for available funds for NC Career Coach
16 Program funding from the State Board of Community Colleges. The State Board of Community
17 Colleges shall establish a process for award of funds as follows:

- 18 (1) Advisory committee. – Establishment of an advisory committee, which shall
19 include representatives from the NC Community College System, the
20 Department of Public Instruction, the Department of Commerce, and at least
21 three representatives of the business community, to review applications and
22 make recommendations for funding awards to the State Board.

- 23 (2) Application submission requirements. – The State Board of Community
24 Colleges shall require at least the following:

25 a. Evidence of a signed memorandum of understanding that meets, at a
26 minimum, the requirements of this section.

27 b. Evidence that the funding request will be matched with local funds in
28 accordance with the following:

29 1. Matching funds may come from public or private sources.

30 2. The match amount shall be determined based on the
31 development tier designation of the county in which the local
32 school administrative unit is located where the career coach is
33 assigned on the date of the award of funds by the State Board
34 of Community Colleges according to the following:

35 I. If located in a tier one county as defined in
36 G.S. 143B-437.08, no local match shall be required.

37 II. If located in a tier two county as defined in
38 G.S. 143B-437.08, one dollar (\$1.00) of local funds for
39 every two dollars (\$2.00) in State funds shall be
40 required.

41 III. If located in a tier three county as defined in
42 G.S. 143B-437.08, one dollar (\$1.00) of local funds for
43 every one dollar (\$1.00) in State funds shall be
44 required.

- 45 (3) Awards criteria. – The State Board of Community Colleges shall develop
46 criteria for consideration in determining the award of funds that shall include
47 the following:

48 a. Consideration of the workforce needs of business and industry in the
49 region.

50 b. Targeting of resources to enhance ongoing economic activity within
51 the community college service area and surrounding counties.

- 1 c. Geographic diversity of awards.
- 2 (d) Annual Report. –
- 3 (1) The board of trustees of a community college that employs one or more career
- 4 coaches shall report annually to the State Board of Community Colleges on
- 5 implementation and outcomes of the Program, including the following
- 6 information:
- 7 a. Number of career coaches employed.
- 8 b. Number of local school administrative units served and names of
- 9 schools in which career coaches are placed.
- 10 c. Number of students annually counseled by career coaches.
- 11 d. Impact of career coaches on student choices, as determined by a valid
- 12 measure selected by the State Board of Community Colleges.
- 13 (2) The State Board of Community Colleges shall report annually no later than
- 14 October 1 to the Joint Legislative Education Oversight Committee on the
- 15 following:
- 16 a. A compilation of the information reported by the board of trustees of
- 17 community colleges, as provided in subdivision (1) of this subsection.
- 18 b. Number and names of partnership applicants for NC Career Coach
- 19 Program funding.
- 20 c. Number, names, and amounts of those awarded NC Career Coach
- 21 Program funding."

22 **SECTION 1.(g)** G.S. 115D-39, 115D-39.1, 115D-40.1, and 115D-40.5 are codified

23 into Part 2 of Article 3 of Chapter 115D of the General Statutes, which shall be entitled "Tuition

24 and Fees." The remaining sections of Article 3 of Chapter 115D of the General Statutes are

25 codified into Part 1 of Article 3 of Chapter 115D of the General Statutes, which shall be entitled

26 "Funding of Community Colleges."

27 **SECTION 1.(h)** Part 2 of Article 3 of Chapter 115D of the General Statutes is

28 amended by adding new sections to read:

29 **"§ 115D-39.2. Pro rata tuition and uniform registration fees.**

30 In order to make instruction as accessible as possible to all citizens, the teaching of curricular

31 courses and of noncurricular extension courses at convenient locations away from institution

32 campuses as well as on campuses is authorized and shall be encouraged. A pro rata portion of

33 the established regular tuition rate charged a full-time student shall be charged a part-time student

34 taking any curriculum course. In lieu of any tuition charge, the State Board of Community

35 Colleges shall establish a uniform registration fee, or a schedule of uniform registration fees, to

36 be charged students enrolling in extension courses for which instruction is financed primarily

37 from State funds.

38 **"§ 115D-39.5. Tuition waivers.**

39 (a) Allowed Tuition Waivers. – The State Board of Community Colleges shall not waive

40 tuition and registration fees for any individuals, except the State Board may, as provided by

41 general and uniform regulations, waive tuition and registration fees for the following:

- 42 (1) Persons not enrolled in elementary or secondary schools taking courses
- 43 leading to a high school diploma or equivalent certificate.
- 44 (2) Courses requested by the following entities that support the organizations'
- 45 training needs and are on a specialized course list approved by the State Board:
- 46 a. Volunteer fire departments.
- 47 b. Municipal, county, or State fire departments.
- 48 c. Volunteer EMS or rescue and lifesaving departments.
- 49 d. Municipal, county, or State EMS or rescue and lifesaving departments.

- 1 e. Law enforcement, fire, or EMS or rescue and lifesaving entities
2 servng a lake authority that was created by a county board of
3 commissioners prior to July 1, 2012.
- 4 f. Radio Emergency Associated Communications Teams (REACT)
5 under contract to a county as an emergency response agency.
- 6 g. Municipal, county, or State law enforcement agencies.
- 7 h. Campus police agencies of private institutions of higher education
8 certified by the Attorney General pursuant to Chapter 74G of the
9 General Statutes.
- 10 i. The Division of Prisons of the Department of Adult Correction and the
11 Division of Juvenile Justice of the Department of Public Safety for the
12 training of full-time custodial employees and employees of the
13 Divisions required to be certified under Article 1 of Chapter 17C of
14 the General Statutes and the rules of the Criminal Justice and Training
15 Standards Commission.
- 16 j. The Eastern Band of Cherokee Indians law enforcement, fire, or EMS
17 or rescue and lifesaving tribal government departments or programs.
- 18 k. The Criminal Justice Standards Division of the Department of Justice
19 for the training of criminal justice professionals, as defined in
20 G.S. 17C-20(6), who are required to be certified under (i) Article 1 of
21 Chapter 17C of the General Statutes and the rules of the North
22 Carolina Criminal Justice Education and Training Standards
23 Commission or (ii) Chapter 17E of the General Statutes and the rules
24 of the North Carolina Sheriffs' Education and Training Standards
25 Commission. The waivers provided for in this sub-subdivision apply
26 to participants and recent graduates of the North Carolina Criminal
27 Justice Fellows Program to obtain certifications for eligible criminal
28 justice professions, as defined in G.S. 17C-20(6).
- 29 (3) Firefighters, EMS personnel, and rescue and lifesaving personnel whose duty
30 station is located on a military installation within North Carolina for courses
31 that support their organizations' training needs and are approved for this
32 purpose by the State Board.
- 33 (4) Trainees enrolled in courses conducted under the Customized Training
34 Program.
- 35 (5) Elementary and secondary school employees enrolled in courses in first aid or
36 cardiopulmonary resuscitation (CPR).
- 37 (6) All courses taken by high school students at community colleges, in
38 accordance with this section and Article 2B of this Chapter.
- 39 (7) Human resources development courses for any individual who (i) is
40 unemployed, (ii) has received notification of a pending layoff, (iii) is working
41 and is eligible for the Federal Earned Income Tax Credit (FEITC), or (iv) is
42 working and earning wages at or below two hundred percent (200%) of the
43 federal poverty guidelines.
- 44 (8) Courses providing employability skills, job-specific occupational or technical
45 skills, or developmental education instruction to certain students who are
46 concurrently enrolled in an eligible community college literacy course, in
47 accordance with rules adopted by the State Board.
- 48 (9) Courses provided to students who are participating in a pre-apprenticeship or
49 apprenticeship program that meets all of the following criteria:
- 50 a. Meets one of the following:

1. Is a registered apprenticeship program recognized by the United States Department of Labor.
2. Is a pre-apprenticeship program recognized and approved by the State agency administering the statewide apprenticeship program.
- b. Has a documented plan of study with courses relating to a job-specific occupational or technical skill.
- c. Requires the participants in the program to be North Carolina high school students when entering the program.

(b) Faculty and Staff. – The State Board shall not waive tuition and registration fees for community college faculty or staff members. Community colleges may, however, use State or local funds to pay tuition and registration fees for one course per semester for full-time community college faculty or staff members employed for a nine-, 10-, 11-, or 12-month term. Community colleges may also use State and local funds to pay tuition and registration fees for professional development courses and for other courses consistent with the academic assistance program authorized by the State Human Resources Commission.

(c) Annual Report. – Annually by February 1, the Community Colleges System Office shall report to the Joint Legislative Education Oversight Committee on the number and type of waivers granted pursuant to subsection (a) of this section."

 - b. The person who seeks a permit or license issued under this section is subject to subsection (n1) of this section and is eligible for the certificate under that subsection.
- (2) It must be on a form approved by the Division.
- (3) It must be dated within 30 days of the date the person applies for a permit or license issuable under this section.
- (4) It must be signed by the applicable person named below:
 - a. The principal, or the principal's designee, of the public school in which the person is enrolled.

- 1 b. The administrator, or the administrator's designee, of the nonpublic
2 school in which the person is enrolled.
- 3 c. The person who provides the academic instruction in the home school
4 in which the person is enrolled.
- 5 c1. The person who provides the academic instruction in the home in
6 accordance with an educational program found by a court, prior to July
7 1, 1998, to comply with the compulsory attendance law.
- 8 d. The designee of the board of directors of the charter school in which
9 the person is enrolled.
- 10 e. The president, or the president's designee, of the community college
11 in which the person is enrolled.

12 Notwithstanding any other law, the decision concerning whether a driving eligibility
13 certificate was properly issued or improperly denied shall be appealed only as provided under
14 the rules adopted in accordance with G.S. 115C-12(28), ~~115D-5(a3)~~, 115D-10.70, or 115C-566,
15 whichever is applicable, and may not be appealed under this Chapter."

16 **SECTION 2.(b)** G.S. 20-13.2(c1) reads as rewritten:

17 "(c1) Upon receipt of notification from the proper school authority that a person no longer
18 meets the requirements for a driving eligibility certificate under G.S. 20-11(n), the Division must
19 expeditiously notify the person that his or her permit or license is revoked effective on the
20 thirtieth calendar day after the mailing of the revocation notice. The Division must revoke the
21 permit or license of that person on the thirtieth calendar day after the mailing of the revocation
22 notice. Notwithstanding subsection (d) of this section, the length of revocation must last for the
23 following periods:

- 24 (1) If the revocation is because of ineligibility for a driving eligibility certificate
25 under G.S. 20-11(n)(1), then the revocation shall last until the person's
26 eighteenth birthday.
- 27 (2) If the revocation is because of ineligibility for a driving eligibility certificate
28 under G.S. 20-11(n1), then the revocation shall be for a period of one year.

29 For a person whose permit or license was revoked due to ineligibility for a driving eligibility
30 certificate under G.S. 20-11(n)(1), the Division must restore a person's permit or license before
31 the person's eighteenth birthday, if the person submits to the Division one of the following:

- 32 (1) A high school diploma or its equivalent.
- 33 (2) A driving eligibility certificate as required under G.S. 20-11(n).

34 If the Division restores a permit or license that was revoked due to ineligibility for a driving
35 eligibility certificate under G.S. 20-11(n)(1), any record of revocation or suspension shall be
36 expunged by the Division from the person's driving record. The Division shall not expunge a
37 suspension or revocation record if a person has had a prior expunction from the person's driving
38 record for any reason.

39 For a person whose permit or license was revoked due to ineligibility for a driving eligibility
40 certificate under G.S. 20-11(n1), the Division shall restore a person's permit or license before the
41 end of the revocation period, if the person submits to the Division a driving eligibility certificate
42 as required under G.S. 20-11(n).

43 Notwithstanding any other law, the decision concerning whether a driving eligibility
44 certificate was properly issued or improperly denied shall be appealed only as provided under
45 the rules adopted in accordance with G.S. 115C-12(28), ~~115D-5(a3)~~, 115D-10.70, or 115C-566,
46 whichever is applicable, and may not be appealed under this Chapter."

47 **SECTION 2.(c)** G.S. 90-631(b) reads as rewritten:

48 "(b) A massage and bodywork therapy program operated by a North Carolina community
49 college that is accredited by a regional accrediting agency, as defined in ~~G.S. 115D-6.2~~,
50 G.S. 115D-21.2, is exempt from the approval process, licensure process, or both, established by
51 the Board. The college shall certify annually to the Board that the program meets or exceeds the

1 minimum standards for curriculum, faculty, and learning resources established by the Board.
2 Students who complete the program shall qualify for licenses from the Board as if the program
3 were approved, licensed, or both, by the Board."

4 **SECTION 2.(d)** G.S. 93A-4(a2) reads as rewritten:

5 "(a2) A certified real estate education provider shall pay a fee of ten dollars (\$10.00) per
6 licensee to the Commission for each licensee completing a postlicensing education course
7 conducted by the school, provided that these fees shall not be charged to a community college,
8 junior college, college, or university located in this State and accredited by a regional accrediting
9 agency, as defined in ~~G.S. 115D-6.2~~ G.S. 115D-21.2 and G.S. 116-11.4, respectively."

10 **SECTION 2.(e)** G.S. 93A-38.5(e) reads as rewritten:

27 college, or community or technical college accredited by a regional accrediting agency, as
28 defined in ~~G.S. 115D-6.2~~ G.S. 115D-21.2 and G.S. 116-11.4, respectively, or an agency of the
29 federal, State, or local government."

30 **SECTION 2.(g)** G.S. 93E-1-8 reads as rewritten:

31 "**§ 93E-1-8. Education program approval and fees.**

32 ...

33 (b) The Board may by rule set nonrefundable fees chargeable to private real estate
34 appraisal schools or course sponsors, including appraisal trade organizations, for the approval
35 and annual renewal of approval of their qualifying courses required by G.S. 93E-1-6(a), or
36 equivalent courses. The fees shall be one hundred dollars (\$100.00) per course for approval and
37 fifty dollars (\$50.00) per course for renewal of approval. No fees shall be charged for the approval
38 or renewal of approval to conduct appraiser qualifying courses where such courses are offered
39 by a North Carolina college, university, junior college, or community or technical college
40 accredited by a regional accrediting agency, as defined in ~~G.S. 115D-6.2~~ G.S. 115D-21.2 and
41 G.S. 116-11.4, respectively, or an agency of the federal, State, or local government.

43 (d) Nonrefundable fees of one hundred dollars (\$100.00) per course may be charged to
44 schools and course sponsors for the approval to conduct appraiser continuing education courses
45 and fifty dollars (\$50.00) per course for renewal of approval. However, no fees shall be charged
46 for the approval or renewal of approval to conduct appraiser continuing education courses where
47 such courses are offered by a North Carolina college, university, junior college, or community
48 or technical college accredited by a regional accrediting agency, as defined in ~~G.S. 115D-6.2~~
49 G.S. 115D-21.2 and G.S. 116-11.4, respectively, or by an agency of the federal, State, or local
50 government. A nonrefundable fee of fifty dollars (\$50.00) per course may be charged to current
51 or former licensees or certificate holders requesting approval by the Board of a course for

1 continuing education credit when approval of such course has not been previously obtained by
2 the offering school or course sponsor."

3 **SECTION 2.(h)** G.S. 95-25.5(n) reads as rewritten:

4 "(n) Nothing in this section prohibits qualified youths under 18 years of age from
5 participating in training through their fire department, the Office of State Fire Marshal, or the
6 North Carolina Community College System. As used in this subsection, the term "qualified youth
7 under 18 years of age" means an uncompensated fire department or rescue squad member who
8 is at least the age of 15 and under the age of 18 and who is a member of a bona fide fire

17 Statutes."

18 **SECTION 2.(j)** G.S. 115C-238.55 reads as rewritten:

19 **"§ 115C-238.55. Evaluation of cooperative innovative high schools.**

20 The State Board of Education and the governing Boards shall evaluate the success of students
21 in cooperative innovative high schools approved under this Part. Success shall be measured by
22 high school retention rates, high school completion rates, high school dropout rates, certification
23 and associate degree completion, admission to four-year institutions, postgraduation employment
24 in career or study-related fields, and employer satisfaction of employees who participated in and
25 graduated from the schools. The Boards shall jointly report by March 15 of each year to the Joint
26 Legislative Education Oversight Committee, the Senate Appropriations Committee on
27 Education/Higher Education, the House Appropriations Committee on Education, and the Fiscal
28 Research Division of the General Assembly on the evaluation of these schools. The report shall
29 be combined with the evaluation of and analysis of cost of students participating in the Career
30 and College Promise Program required by ~~G.S. 115D-5(x)~~G.S. 115D-30.5, and the Community
31 Colleges System Office shall be responsible for submitting the combined report."

32 **SECTION 2.(k)** G.S. 115D-2(2) reads as rewritten:

33 "(2) The term "community college" is defined as an educational institution
34 operating under the provisions of this Chapter and dedicated primarily to the
35 educational needs of the service area which it serves, and may offer any of the
36 following:

- 37 a. The freshmen and sophomore courses of a college of arts and sciences,
38 authorized by ~~G.S. 115D-4.1~~G.S. 115D-10.10.
- 39 b. Organized credit curricula for the training of technicians; curricular
40 courses may carry transfer credit to a senior college or university
41 where the course is comparable in content and quality and is
42 appropriate to a chosen course of ~~study~~study.
- 43 c. Vocational, trade, and technical specialty courses and ~~programs~~
44 and programs.
- 45 d. Courses in general adult education."

46 **SECTION 2.(l)** G.S. 115D-39(a1) reads as rewritten:

47 "(a1) In addition, federal law enforcement officers, firefighters, EMS personnel, and rescue
48 and lifesaving personnel whose permanent duty station is within North Carolina and who do not
49 otherwise qualify for tuition waivers under ~~G.S. 115D-5(b)(2a)~~G.S. 115D-39.5(a)(3) shall also
50 be eligible for the State resident community college tuition rate for courses that support their

1 organizations' training needs and are approved for this purpose by the State Board of Community
2 Colleges."

3 **SECTION 2.(m)** G.S. 115D-41(a) reads as rewritten:

4 "(a) Community college contracts with local school administrative units shall not be used
5 by these agencies to supplant funding for a public school high school teacher providing courses

7 local school administrative unit. In no event shall a community college contract with a local
8 school administrative unit to provide high school level courses."

15 by a regional accrediting agency, as defined in ~~G.S. 115D-6.2~~ G.S. 115D-21.2
16 and G.S. 116-11.4, or the Transnational Association of Christian Colleges and
17 Schools, or, in the case of institutions that are not eligible to be considered for
18 accreditation, accredited in those categories and by those nationally
19 recognized accrediting agencies that the Authority may designate;"

20 **SECTION 2.(p)** G.S. 116-280(3) reads as rewritten:

21 "(3) Eligible private postsecondary institution. – A school that is any of the
22 following:

23 a. A nonprofit postsecondary educational institution with a main
24 permanent campus located in this State that is not owned or operated
25 by the State of North Carolina or by an agency or political subdivision
26 of the State or by any combination thereof that satisfies all of the
27 following:

28 1. Is either (i) accredited by a regional accrediting agency, as
29 defined in ~~G.S. 115D-6.2~~ G.S. 115D-21.2 and G.S. 116-11.4,
30 or the Transnational Association of Christian Colleges and
31 Schools or (ii) was accredited by ~~SACSCOC~~ the Southern
32 Association of Colleges and Schools Commission on Colleges
33 on January 1, 2021, and, beginning January 1, 2021, was a
34 member of the Transnational Association of Christian Colleges
35 and Schools.

36 2. Awards a postsecondary degree as defined in G.S. 116-15.

37 b. A postsecondary institution owned or operated by a hospital authority
38 as defined in G.S. 131E-16(14) or school of nursing affiliated with a

40 sub-subdivision a. of this subsection."

41 **SECTION 2.(q)** G.S. 126-5(c2)(3) reads as rewritten:

42 "(3) Employees of community colleges whose salaries are fixed in accordance with
43 ~~G.S. 115D-5~~ G.S. 115D-6.1 and G.S. 115D-20 and employees of the
44 Community Colleges System Office whose salaries are fixed by the State
45 Board of Community Colleges in accordance with G.S. 115D-3."

46 **SECTION 2.(r)** Section 6.9(b) of S.L. 2023-134 reads as rewritten:

47 "**SECTION 6.9.(b)** Of the recurring funds appropriated in this act to the Community
48 Colleges System Office for the 2023-2025 fiscal biennium to support increasing program
49 offerings for individuals with IDD pursuant to ~~G.S. 115D-44~~, ~~as enacted by this section,~~
50 G.S. 115D-10.21, the System Office shall establish at least two statewide positions for program
51 support, provide professional development training for college advising staff to assist students

1 with IDD for career pathway exploration and the identification of credentials leading to
2 competitive employment, and explore funding sources to sustain programs for students with
3 IDD."

6 **SECTION 3.** This act is effective when it becomes law.
